### Construction To Begin At Pickwick Site

Construction is scheduled to start immediately on a new million dollar plant at Pickwick which will manufacture precision equipment.

Frank Berry, president of the firm, Kinematicks, Inc., said Saturday the Small Business Administration in Washington had approved a \$347,782 loan to help get the new company into operation. Production is scheduled to begin next March.

Berry said the plant would start with an initial employment of 15 persons but that plans called for 100 workers after a three-year period. It will manufacture various precision products, including tools, marine and sawmill drives, and transmissions.

H. Wayne Hammontree of Nashville will be chairman of the board of the new firm, Berry said.

### Tax Collections For November

The City of Iuka reported a total of \$5,115.70 in sales tax collections for the month of November. This figure shows an increase of \$316.01 over last year's figure of \$4,799.69.

Belmont, operating on the one half percent rate, showed a total of \$999.74, decreasing \$64.95 from last year's figure of \$1,064.69.

In Tishomingo, the report showed a total of \$831.34, a much higher increase than last year's figure of \$384.74.

Other nearby cities showed the following figures: Baldwyn \$4,385.80; Booneville, \$8,601.01; Corinth, \$22,810.28; Fulton, \$6,236.28; and Ripley, operating on the one-half percent rate, showed a total of \$3,674.82.

### Vacation Payments; Retirement & Savings Programs Announced

L. K. THE DIFFERENCE  
NORTH AND SOUTH

The attitude of Southern people towards Negroes is entirely different than that of Northern people. The difference lies primarily in the fact that Southern people like and understand Negroes, as individuals, while Northern people, not understanding them, like Negroes in the abstract. Northerners tender Negroes a sort of lip-service liking. To a Northerner, there is something foreign about a Negro, whereas Southerners accept colored people as "part of the place".

This has always been so. And I think the reason is obvious. Northerners ("those people", as General Lee called them) have never had the experience with Negroes Southern people have had, that is, centuries of intimate, morning-noon-and-night contact.

As a result of this experience, Southern people have come to understand that Negroes are different.

Northerners, on the other hand, are prone to look upon Negroes as White people with black faces. Then, when Negroes do not act as do White people, disappointment sets in. This is followed by dislike, then by contempt, and if the rub continues, by hatred.

That never happens in the South; Southern people, as I can, understand the differences.

Let me point this up for you: During the four years it took the North to subdue the rebellious South, slave trouble in Dixie was almost unheard of. What trouble arose was on an individual nature, some Negro or another would turn "rogue", that was all. Moreover, when things got tough, when Southern people found themselves approaching starvation, Negroes shared equally in what little was to be had. Southerners, during those lean years, didn't give the first thought to blaming the colored people for their troubles. There was no impulse to "get" the Negroes. There wasn't, then, and there isn't, now.

But see the difference in the North, once the going got rough up there.

In the North, by July 1863, rank-and-file opposition to the war had grown to such an extent the authorities could not fill their draft quotas. From the very beginning they had had trouble in this regard; Northerners of draft age would not respond. And when Lincoln, by his Emancipation Proclamation, changed the conflict from a war-for-union into one of free-the-slaves, the situation got out of hand, enlistments ground to a halt.

Bounties to \$750 were offered as stimulus. (Southern soldiers,

nearly all volunteers, were paid \$11 per month, Confederate). But that didn't work, either. In desperation, U. S. agents were dispatched to sweep Europe. As a result, some 400,000 to 500,000 Irish and German people were imported to serve in the Northern army—as many men as the South enrolled, first to last.

When even that didn't suffice, when the New York authorities, for instance, were forced to go after "enlistees" at the point of a bayonet, trouble ensued, trouble known in history as "draft" riots that were, in fact, "race" riots.

Beginning July 10, White mobs began to roam the streets of New York, screaming, "Kill all niggers". And did their best to do so. For four days terror reigned. Whenever a Negro could be caught, he was either lynched, bludgeoned to death, or burned alive. Kill-all-niggers reached such proportions a mob even swarmed onto a British ship then in New York harbor and cruelly beat up its Negro crew. In 10 days time, 350 people, White and Black, were murdered. Not even cannon fire and charging cavalry could quell the bubbling race hatred that rocked Little Old New York, that July of '63. Quiet came only when the authorities capitulated, promised to suspend the draft—and not another Negro was to be found.

Nothing like this has ever happened in the South. Hardly. Southern people understand and accept the differences between races; Northern people do not.

We are on a parallel course today. As today's race problems degenerate, the worst results will occur—as indeed they are occurring—in the North.

Left alone, Southern Whites and Blacks get along just dandy.

But the abolitionists can't stand that, so they make trouble and, in time, suffer the backlash.

Retributive justice; isn't that the phrase?

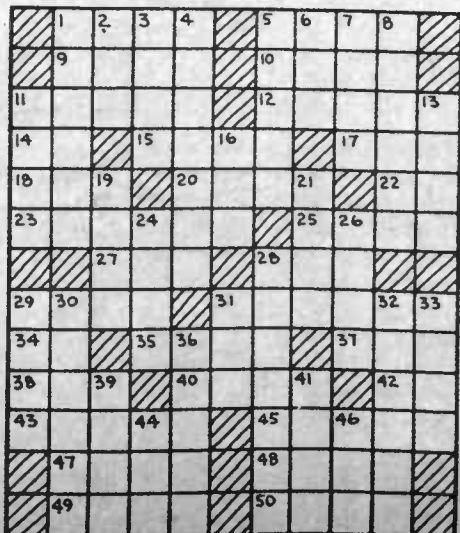

## SENSING THE NEWS

Suppressing History

The public issue in the private dispute between the Kennedy family and the publishers of a book on President Kennedy's assassination is the issue of threatened suppression of the facts of history.

If the Kennedy family had a contractual relationship with the author, which has been violated, that is one thing. The courts are competent to deal with matters of contract. But it has to be acknowledged that the violent death of a President of the United States is a matter of enduring national concern. Thus those persons who have knowledge of the circumstances of Mr. Kennedy's death, including friends and members of his family, have a civic obligation to assist those who seek to give the nation the whole truth and nothing but the truth.

Unfortunately, the Kennedys have a well-documented record of trying to prevent publication of certain books on the late President or of insisting on various editorial changes. The country has a right, therefore, to note that an attempt has been made on a number of occasions to impose a kind of private censorship on a story that belongs to the public. True, the Presidents' death was a terrible family tragedy, but it also was a national tragedy—as has been the case with the other presidential assassinations in American history.

One well-known author, who sought to write a book on the last day in President Kennedy's life, alleged that the word was sent around to friends and other knowledgeable individuals that they should not cooperate. This distinguished author complained, with justice, that the Kennedy family had tried to shut the door on history.

This cannot be done in our kind of free society. We say that we have an open society, and it is very wrong if the Kennedys try to make it a closed society when it comes to writing history.

Senator Robert F. Kennedy's complaint about the publication of a book dealing with his brother on the grounds of invasion of privacy, makes strange reading in view of the recent news reports that he knew about and sanctioned widespread wire-tapping. True, Senator Kennedy had denied sanctioning the "bugging" of telephone lines, but FBI Director J. Edgar Hoover insists that this was the case—and Mr. Hoover's word commands the highest respect among Americans.

The Kennedys, it must be realized, feel that they own the legend and image of the slain President. Some citizens believe that they also try to exploit the legend and image, not simply to honor the dead President but to advance the political goals of Robert F. Kennedy. The Kennedys themselves will have to wrestle with the morality of such manipulation of the memory of a brave and charming man, but the country at large can hardly join in justification of such an exercise. The Kennedy legend is not something to be turned on and off, as the political demands of his two U.

S. Senator brothers dictate. This isn't the need of the nation.

What is needed is a full, factual understanding of the man who occupied the White House from 1961 until his assassination in November 1963. The country also needs to know more about the character of his administration and the people brought into Washington. This knowledge should not be sought in a vindictive or partisan manner, neither as an exercise in pro or con political maneuvering, but with the dignity, authority and fairness of real historical research. The authors of such research should let the chips fall where they may, touching—if the record makes it necessary—persons both living and dead, the lowly and those in the highest offices of the land.

In a free Republic, the people should treasure objective history. Totalitarian states twist and re-write history to suit the demands of powerful individuals and factions. Thus Russian history has been written and re-written since Lenin. Intelligent Russians consequently don't know what to believe. The American people should never be put in this position.

American history, including presidential history, belongs to the American people—not to one family or to one or more ambitious politicians within that family.

IT'S A TIME TO WALK TALL

You who are past age 55 get another gray hair or two with the coming of a new year. At 62 or 65 you'll have to retire, and the years seem to be speeding up. You worry.

Nobody can stop your worrying because by now you have enough savvy to know the world is not waiting for you with open arms out in retirement country. Any more than it is waiting for school graduates who get that sort of pap every June.

However, there are a couple of matters you might mull over. And in mulling you may take on the new year with more faith.

Nearly 4,000 people in the U.S. are reaching age 65 every day now. That's every DAY. Very few of these are jumping off buildings or into rivers. In fact, they are rather happy, and with Social Security, Medicare, and a pension they are comfortable. If all these people are managing—and some of them are pretty nutty—don't you think you can make it?

You'll have to do some adjusting to retirement. All the experts tell you that. Well, you're something of a professional at adjusting. In your lifetime you have adjusted to the Depression; to TVA, WPA, NRA, and that socialist scheme called Social Security; to labor unions, the 40-hour week, and the drastic deductions from your pay-check; to 80-mile-an-hour autos; to assaults on your religious beliefs from the Scopes Monkey Trial to Bishop Pike; to four rough wars; to Civil Rights; to Outer Space. In your generation you have adjusted to some of the most profound developments man has yet faced. The odds favor your adjustment to retirement.

You are, of course, old-fashioned. Any college professor past age 40 and everybody else below age 40 can assure you of this. And the nearer to 65 you are the more old-fashioned you are. You don't know what makes a computer work.

Well, in view of technological advances you have mastered in your lifetime, this is an interesting presumption. You progressed from horse-and-buggy to jets. Along the way you took on the gasoline engine which—as you'll remember—was first known as the "Infernal Gasoline Machine." You progressed from oil lamps to electricity, from Gramophones to TV, from ice-boxes to freezers, from stove-wood to gas, from pasteboard fans to air-conditioning, from high-button shoes to loafers, from Spencerian handwriting to a typewriter, from a vicious blade to an electric razor, from stairs to an elevator, from a change box to a cash register, from castor oil to birth-control pills.

Yet there are those who would send you into retirement wearing

sackcloth because you don't know why a computer works. You never learned how an auto engine works or why an electric lamp turns on. You never had to. And nobody, until the electronics and physics boys came along, ever labeled you as "dated" because of it.

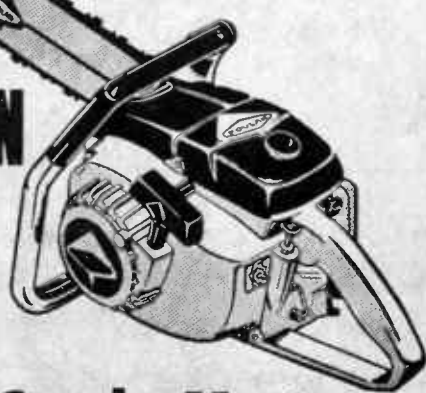
