

TVA's Yellow Creek Nuclear Power Plant Marks First Anniversary Of Construction

The first anniversary of the two-unit Yellow Creek Nuclear Plant is being observed this week and in conjunction a news conference was held on Tuesday, Feb. 13, at the plant site, located on a 1,160 acre tract of land, six air miles from Iuka. Approximately 600 of these acres are cleared.

Mr. John Sibley, Coordinator of Public Information, Office of Engineering Design and Instruction, Knoxville, told the group, representing radio, T.V. and the press, that the project is running according to schedule, following receipt of a Limited Work Authorization from the Nuclear Regulatory Commission on February 9, 1978. Construction equipment was moved to the site in preparation for initial construction activities, and excavation, building erection, and preliminary work in the turbine building area comprised major work activities until receipt of the Construction Permit on November 30, 1978.

Yellow Creek, the seventh in a series of TVA nuclear power projects, will consist of two pressurized water reactor units purchased from Combustion Engineering and having a generating capacity of 1,375 megawatts each (the largest two-unit powerplant in the TVA system). The two units are scheduled for commercial operation at one year intervals, starting with unit one in March, 1985, and unit two in March, 1986. Upon completion, the dual units will add 2,750,000 kilowatts of generating capacity to TVA's power distribution system. Primary containment fabrication and erection for the two reactor buildings will be by the Chicago Bridge and Iron Co., and the turbogenerators will be supplied by General Electric.

A dominant feature of the plant will be two natural draft cooling towers, each rising to a height of approximately 500 feet above ground level. Major structures of the plant are: Reactor Building, Fuel Building, Control Building, Diesel

Generator Building, Waste-Management Building, and Turbine Building.

During construction of the project, employment is expected to build to a peak of about 4,300 employees and then gradually decrease over the total construction period of about eight years.

Mr. John Hendrix, Project Coordinator, stated that approximately 23,000 applications for work had been filed, with a ceiling of 1,575 at present. He reports that this ceiling is reviewed periodically. He also said that community attitude toward the project has been excellent and with few problems. Relationship and support with the people in the surrounding communities has been very good. He reported that 60% of the work force had come from the six counties in Alabama, Mississippi, and Tennessee, surrounding the project.

Mr. Hendrix told the group that the project has had three major impacts on the area with the first being the problem of traffic to and from the plant. A mass transportation system has been implemented. Workers are transported to and from the site in buses, and TVA is surfacing many of the roads in the area. The

second impact involves the school systems with money being made available to the area schools for additional classrooms and buses. Housing is the third major impact with much of this problem being alleviated with private sector providing housing.

Mr. Milton Price, Project Manager, Division of Construction, informs that after construction is completed, a permanent operating staff of about 250 employees will be maintained. He pointed out that this number is subject to change. Total estimated project cost is approximately \$2.2 billion.

TVA's Personnel Office Relocates

The Tennessee Valley Authority announced today that the personnel office for the Yellow Creek Nuclear Plant Project will be moved from its temporary location on the Yellow Creek Port property to a permanent location on the nuclear plant site. Beginning Wednesday, February 14, 1979 persons wanting to file job applications or obtain employment information should report to the new location on site.

The Yellow Creek Nuclear Plant site is located approximately nine miles north of Iuka. Persons wanting to come to the site should turn east off Mississippi Highway 25 at the Coleman Park Road. Signs

will direct them to the site. Upon reaching the site, the location of the personnel office and parking area will be marked. Persons who have already filed applications do not need to re-file. Applications filed at the temporary office are still in effect.

TVA personnel officer Robert McDaniel indicated that over 23,000 people had visited the temporary personnel office since it had opened in early February 1978. Currently over 1700 are employed at the site. Employment is currently estimated to reach a peak of about 4300 workers in 1982. The majority of the work force will be composed of highly skilled journeymen craftsmen.

This is the first time in several years the TCCF has reached its goal. Numerous individuals expressed satisfaction to see the TCCF take on a new "Breath of Life."

Billy Rainey, TCCF Campaign Chairman, acknowledged a great sigh of relief that the drive had reached its goal. He said, "It is gratifying to see the county work towards a mutual goal. I am encouraged to observe the new image the TCCF has developed this year. Our sincere thanks go out to this year's contributors and workers."

New 16-Mile Stretch Of Natchez Trace To Open

Northeast Missisippians can begin using a less congested highway route to major Pickwick Lake recreation areas by late spring with the opening of a new 16-mile stretch of the Natchez Trace, a parkway official said Friday.

Chief Park Interpreter John Molhenrich said portions of the Natchez Trace between Highway 25 north of Tupelo and Kirkville will open for traffic this spring, providing a new link to the popular Tennessee River recreation areas via Mississippi Highways 371, 4 and 25. The new segment will not require travel on Hwys. 45 and 30, the most heavily used route to the Iuka area.

Natchez Trace officials, Molhenrich said, expect the new segment of the state highway detours to become the preferred route for most recreation traffic from the Tupelo area to Tishomingo

County. No exact opening date has been set, he said.

In anticipation of the route's popularity, Molhenrich said all detours from Kirkville to Highway 25 at Dennis will be clearly marked.

The cost of the 16-mile stretch averages more than \$1 million per mile, Molhenrich said, adding that a total cost figure would be difficult to quickly calculate because several separate contracts are involved. Completion of the new mileage, he noted in a Tupelo Kiwanis Club speech, will leave only 14 miles of the national parkway incomplete between Tupelo and the Alabama state line. That mileage involves a crossing of the Tenn-Tom Waterway at Bay Springs.

Prohibitions against commercial traffic on the Trace will apply on the new link, Molhenrich said. He stressed that recreation vehicles, including mobile campers, camping trailers and boat trailers, are permitted.

The Tupelo-to-Kirkville link, he said, includes several of the most important archaeological and historic sites on the Natchez-to-Nashville route.

Molhenrich expressed optimism about chances for congressional adoption of a five-year Natchez Trace completion funding program. Sen John Stennis, D-Miss., appears to be making headway in his efforts to gain support for the funding plan, said Molhenrich.

Actual construction, if a plan were adopted, would take longer than five years, Molhenrich said.

HOME ECONOMIST'S NOTES

FOOD SHOPPING
 Has food shopping behavior changed along with the increase in food prices? Some answers were found in a three-year survey of some 1,400 households. The main food shopper in each survey household was asked about major food shopping practices and one-stop shopping for such items as bread, milk and similar products. The most prevalent food shopping pattern was to do the main shopping once each week, in only one store, and do most of the shopping at a supermarket. About 60 percent did their main food shopping once each week. There was a significant decline in the "every two weeks" shoppers, from 20 percent in 1976 to 16 per-

cent in 1978. Twice-a-week main food shopping was mentioned by only slightly more than 10 percent, and they were more apt to be from the large metropolitan areas than from rural areas. Supermarket shopping is apparently on the increase, from 89 percent in 1976 to 94 percent in 1978. Findings indicate persons 65 or older are using the small store for most food shopping more than younger people. In 1978, only 26 percent were using two stores each time the main food shopping was done. In 1976, 60 percent of the food shoppers were using only one store each time they did their main food shopping; by 1978, 65 percent were shopping in only one store.

REPORT TO MISSISSIPPIANS

Federal regulations have grown out of control. A maze of rules haphazardly concocted by government agencies hinder every aspect of American life, business and industry in particular. One of the most damaging effects of these often conflicting and confusing regulations is that the high cost of compliance worsens inflation. The lawsuit recently filed by Sears Roebuck and Company against 10 federal agencies is evidence of the growing alarm over the burden of regulations. Sears claims it has spent \$100 million trying to comply with federal anti-discrimination laws, but has been unable to do so because the rules and regulations issued by various federal agencies are themselves contradictory and self-defeating. American business and industry can no longer function at maximum efficiency because of the web of bureaucratic regulation. Numbers clearly illustrate the problem. At the federal level, there are 44 independent regulatory agencies and over 1200 other boards, commissions, and organizations with the power to issue rules and regulations. Over 80,000 individuals are employed as regulators. The direct cost to the taxpayer to finance regulatory activities has risen from about \$2.3 billion in 1974 to an estimated \$4.8 billion this year. Overall, federal regulatory expenditures are about six times the level of 1970. Increased regulations greatly add to the amount of paperwork which must be done. A study made in 1976 revealed that there were 4,418 different forms in existence, excluding tax and banking forms. Over 143 million man-hours a year were spent in filling them out. Certainly the paperwork burden has grown even more severe since that study was made. Although government's cost of developing and implementing federal regulations is great, the cost of compliance, or at least attempting to comply, is even more awesome. And that is a cost we all bear. The cost of compliance falls first upon business, then its direct customers, and finally on the general public in the form of price increases, slower economic growth, and fewer jobs. Current cost estimates are as high as \$200 billion a year. The burden is especially great for small business. It is estimated that small business -- the least able to cope with the additional work required by regulations -- spend an average of \$3000 yearly on federal regulatory compliance and paperwork. It is another factor which hurts small businesses, which should and must remain the backbone of our economy. Some regulations -- it must be said -- are essential, and I have supported those -- for example, highway construction standards, pure food and drugs regulation, meat inspection, etc. But outside these essential areas, the government has by and large neglected to consider the far reaching effects of many regulations. Each proposed regulation should be analyzed to determine whether it is worthwhile in view of its cost. We must demand that all proposed regulations be put through such an analysis. There are signs, both in the Administration and the Congress, that there is an increasing awareness of the burden of federal regulations. I hope we can work together to find a sensible and reasonable solution to this very serious problem. I am glad that a start has been made.

COUNTY AGENT'S NOTES

PREVENT SOIL EROSION:
 Most cropland soil losses occur in winter and early spring. However, erosion can be reduced by good management practices. Avoid tilling soil subject to severe erosion until just before planting time. Chisel plowing or subsoiling on the contour early this spring will improve water intake and reduce erosion on these soils. Establish sod on borders, drain ditches and adjustment strips to slow runoff and erosion.

SELECT RIGHT PIG FEED:
 The most important consideration when selecting a swine creep feed is your pig's performance. Starter feed for pigs is not the place to cut corners or pick up bargains. The best bargain may be the highest priced feed if your pigs make the best gains on it. The location of feeders is also important. Make feeders easily accessible in clean, well-lighted areas. Keep the feed fresh. Don't

put too much feed in at once. Remove old feed and replace it routinely with clean feed. Encourage pigs to start eating sooner by wetting the feed or placing a small amount on the floor of the sleeping area. After pigs start tasting the feed, they may be lured to the self feeder.

INVESTMENT CREDIT:
 The Tax Reform Act of 1978 made investment credit permanent at the 10 percent level. Many taxpayers pay more taxes each year than they should because they do not claim investment credit on qualifying property used in business. If the taxpayer acquired new or used tangible depreciable property to use in his business and placed the property in service in the tax year, he may qualify for the investment credit. Investment credit, like all other tax credits, reduces taxes owed dollar for dollar. See your tax consultant for more information.

DRY BEANS AMOUNT TO BUY
 Dried Lima Beans (as purchased), 1 lb. - 2 1/2 cups, (cooked) 1 lb. - 2 lbs. 9 oz. which yields 6 cups; Kidney Beans (as purchased), 1 lb. - 2-2/3 cups, (cooked) 1 lb. - 2 lbs. 6 oz. which yields 7 cups; Navy Beans (as purchased), 1 lb. - 2-1/2 cups, cooked, 1 lb. - 2 lbs. 3 oz. which yields 6 cups.

SHORT METHOD COOKERY
 To one cup of dry beans, add 2-1/2 cups of water. Bring to boil and boil for 2 minutes. Remove from heat and soak 1 hour. Cook at simmer until done (30 to 45 minutes). One teaspoon salt in the cooking water with one cup of beans or peas is about right for average taste. You will want less salt, of course, if you use ham or salt pork for seasoning. For special flavor, add onions, herbs or meat. If you add tomatoes, catsup or vinegar when boiling beans or peas, wait until they are cooked almost tender because acids added earlier will delay the softening.

SET-ASIDE, DIVERSION PROGRAM IMPORTANT:
 On February 15, the Tishomingo County Agricultural Stabilization & Conservation Service begins accepting applications for the 1979 wheat and feed grain program. Mr. Elmer A. South, Chairperson of the ASC Committee, said the program gives the farmers opportunity to adjust their grain production and increase the price they will get for it. "The importance of farmers using the program cannot be over-emphasized," South said. "Strong participation is necessary to begin balancing supply with demand so that the market will pay a profitable price. Producers need to participate to re-

support loans on all eligible commodities produced, deficiency and disaster payments for barley, corn, sorghum, wheat or upland cotton on the participating farm. "The program is voluntary," South said; "however, farmers must file their intentions to participate during the sign-up period to be eligible for program benefits." The sign-up period will be conducted until April 30, 1979.



Does a member of your family have special sight or hearing problems? Persons with these or other handicaps may find it worthwhile to explore South Central Bell's current offerings of telephone aids for special needs. The Bell System has a tradition of helping the handicapped to communicate. Alexander Graham Bell was a teacher of the deaf. And today, if anyone has difficulty in using the telephone, for whatever reason, we want to help. We have several pieces of equipment designed especially for use by handicapped persons. For example, the electronic larynx is for people who have lost the use of their larynx. It substitutes electronic vibrations for the voice. The user can learn to speak conversationally using his tongue, lips, and teeth normally. For people who have impaired hearing and cannot hear an ordinary telephone bell, we have signals in different frequencies -- a tone ringer, and a loud bell, for example. For those with more serious hearing impairments, a specially designed "beehive" lamp can be installed to indicate visually that a telephone is ringing. If a person has trouble hearing or being heard, "volume control handsets" amplify the voice being received, or increase the volume of the speaker's voice. Each is adjustable for normal use. Other aids are available for other special uses. If you might be helped by one of these aids, call us at 286-9901 today. We'll be glad to try to help your special situation.

Amusing and interesting facts, old and some not so old: The youngest person to win a Nobel Peace Prize was the Rev. Martin Luther King, Jr., Civil Rights leader. He was 35 when awarded the prize. He was assassinated four years later. Joe Louis was the heavyweight champion for eleven years, 8 months and seven days. He retired on March 1, 1949.

The youngest author to have a book published was Janet Aitchison, of England. She wrote "The Pirates Tale". She was six and one-half years old when it was published. The highest IQ known of modern times is Kim Ung-Yong, of South Korea. It was 210. He could speak four languages, compose poetry and solve problems of calculus at four years and eight months old - in 1967.

The first man to swim across the English Channel did it in 1875. Matthew Weob - Dover England to Gris Nez, France. I crossed the English Channel in September of 1972 on a Hover Craft from Colvir, France to Canterbury, England - the narrowest place in the channel and it took us 30 minutes. A Hover Craft is an air cushioned vehicle that travels on a layer of compressed air just above the surface - going as fast as 100 miles per hour. It cost the four of us and with our mini-car \$36.00 to cross.

Walt Disney won more "Oscars" from the Academy of Modern Pictures and Arts than anyone. He died in 1966. The modern game of basketball was devised by a man named Dr. James Naismith, of Springfield, Mass. in December, 1891. The first public contest was held March 11, 1892.

Perry Como began his career as a barber. In 1969 he was paid \$20,833 per minute for four - one hour T.V. specials on NBC. He paid the others who helped him with the performance. The late Elvis Presley with his 120 golden discs leads in honors and popularity.

I crossed the English Channel in September of 1972 on a Hover Craft from Colvir, France to Canterbury, England - the narrowest place in the channel and it took us 30 minutes. A Hover Craft is an air cushioned vehicle that travels on a layer of compressed air just above the surface - going as fast as 100 miles per hour. It cost the four of us and with our mini-car \$36.00 to cross.





Both baths have outside windows and are back to back for plumbing economy. Note too, the bedroom doorway to the wide, luxurious sun deck.

This plan has 1438 square feet of living area and a basement version is available entering under the staircase. Also another model has the washer-dryer inside off the kitchen-living room hall with a slightly revised bathroom area.

Cold Weather Produces High Power Bills

Many consumers with electric heat have been shocked and dismayed at their higher - than - ever electric bills this winter, according to Cecil H. Brown, manager of Tishomingo County Electric Power Association.

The sharp increase in the electric bills is caused by the colder weather, which makes electric heating systems use more kilowatt-hours, plus the rise in the cost of electricity since last year.

"January, while about the same as last January, was 44 percent colder than normal and was 62 percent colder than December. And the colder than usual weather is continuing into February. Heating costs are up accordingly. We advised people early in the season to insulate their homes, put up storm doors and windows, caulk around window and door frames and cut their use of hot water," Brown said.

Again, we urge consumers to invest in insulation for their homes --- at least six inches (or R-19 value) of insulation under the ceiling. Insulation under floors and storm windows will reduce heating costs also.

Mr. Brown said consumers who keep their thermostats at 68 or lower should realize savings. Each degree temperatures are kept above this level add about six percent to heating costs. Put another way, it costs about 40 percent more to maintain 75 degrees than to maintain 68 degrees in your home.

Limiting the use of hot

water also helps reduce electric bills.

Mr. Brown pointed out the contrast between the purchase of electricity and the purchase of gasoline. "When you fill your tank with gasoline you know how much you've bought and how long it has to last before you can afford to buy more."

"But unless you know how to read your meter, you have to guess at how many kilowatt-hours of electricity you're buying."

He said all consumers should learn how to read their meters so they can check kilowatt-hour use regularly and anticipate how much their bills will be. "If you see that you're using more than you can afford, you can make sacrifices and cut back."

Free information on how to read the meter is available along with booklets on how to cut electricity use at the Tishomingo County Electric Power Association Office in Iuka.

Girls State

June 8 - 14, the 32nd session of the American Legion Auxiliary Girls State will be in session at Hinds Junior College, Raymond, Miss.

The purpose of Girls State is to provide citizenship training for girls of high school age in every unit of the American Legion Auxiliary; to afford them an opportunity to live together as self-governing citizens; to inform them about the duties, privileges, rights, and responsibilities of American citizenship; so they may understand and participate in the functioning of their government; and to help them grasp the meaning of many of the responsibilities which they must assume when they become adults.

1. Only authorized American Legion Auxiliary Units may sponsor girls to Girls State. 2. However, patrons of the program may help financially. Patrons may be individuals or other organizations. Girls State is state-wide.

After a girl has participated in a session, she is expected to appear before her patron and sponsoring unit to make a report on her impressions of the program.

Iuka's quota is only one girl, but each year we have asked for additional quotas

and have sent as many as three.

Special Farm Conference

Small farm families and rural low income families in Tishomingo County are urged to attend a special small farm conference set for 7 p.m. on February 22, at the County Fair Building, according to Percie B. Stricklen, County Agent.

"Residents in every county in the state will have a chance to attend a local small farm conference like the one we're holding here, said Stricklen. These conferences are being held to tell rural low income families and small farm families about programs which can help them improve their incomes and the quality of their lives."

"The small farmer is an important segment of Mississippi's agricultural framework. We're dedicated to preserving small farms and helping small farmers make a better living," said Stricklen. After all, the farm family is still basic to a healthy farm and rural economy."

At the conference, representatives from four agencies of the U. S. Department of Agriculture and the Mississippi Forestry Commission will explain how their agencies can help small farm families and low income Mississippians. Agencies are: Mississippi Cooperative Extension Service, Agricultural Stabilization and Conservation Service, Farmers Home Administration and the Soil Conservation Service.

"Farmers will also have a chance to talk to speakers and get information on how to solve some of their specific problems," said Stricklen. "We hope all small farmers in the county will attend this important conference."

taxpayers to double check their returns, especially the computations, before filing. Error-filled returns can delay any refund due.

Taxpayers can also save time this year by checking their tax instructions, which are keyed to lines on the form for easier reference. The instructions often can lead a taxpayer to some overlooked deductions, according to the IRS.

QUESTION:

Do I still have to earn \$50 in each calendar quarter to get a quarter of coverage for social security?

ANSWER:

No. The social security amendments of 1977 provide a quarter of coverage for each \$250 of covered wages earned any time during 1978, up to four quarters on \$1,000 earned. In 1979, \$260 of covered wages needs to be earned for a quarter of coverage, up to four quarters if \$1,040 or more is earned.

QUESTION:

My employer told me I should check my W-2 carefully this year. Why?

ANSWER:

This year, for the first time, the W-2 is being used to report your wages to the Social Security Administration as well as to report your income to the Internal Revenue Service. The benefits you received from social security when you retire, become disabled or die will be based on the F.I.C.A. wages reported on your W-2. It is important

that you check your name and social security number as well as the wage amount.

QUESTION:

I got a W-2 form that does not look like the W-2's that my friends got where they work. Is this O.K.?

ANSWER:

If your company is filing its copy of the W-2 on some sort of magnetic tape, your W-2 could look different than that of your friends. Companies that are not using the paper copy of the W-2 to send to the Social Security Administration are allowed to print out your wage information in a format that is compatible with their computers.

QUESTION:

I am an office manager. The W-2 forms our company got were not perforated into three separate forms on the first page (Copy A). Should I just use scissors to cut them into three W-2's?

ANSWER:

No. The sheet of Copy A's for the W-2 should be unperforated. This is so the Social Security Administration can optically scan the sheets and more efficiently process the wage records. This cannot be done if the copies are torn, or if information is illegible.

QUESTION:

I found an error on my W-2. What should I do?

ANSWER:

Report the error to your employer immediately. He will file a corrected W-2 form with the correct in-

formation. The incorrect information will not be posted to your record.

Annual Wage Reporting

March 1, 1979, is the deadline for some farmers and commercial fishermen to file their 1978 federal income tax return and pay any tax due, the Internal Revenue Service said. Persons who earned at least two-thirds of their 1978 gross income from farming or fishing and did not file a declaration of estimated federal individual income tax by January 15, 1979, or pay any amount of the estimated tax by this date, must file their return and pay all tax due by March 1, 1979, to avoid a penalty. IRS Publication 225, "Farmer's Tax Guide," 595, "Tax Guide for Commercial Fishermen," and 505, "Tax Withholding and Declaration of Estimated Tax," provide additional information and are available free from local IRS offices.

Taxpayers who file their federal income tax returns early in the tax filing season will get their refunds sooner than those who file closer to April 15th deadline, the Internal Revenue Service says.

Due to the lower volume of returns processed in January and February, taxpayers who file during those months may expect to receive their refunds in four to five weeks, according to the IRS. Those who do not file until April may wait as long as eight weeks for their refunds.
