## Recreational Site For **Burnsville**

According to a letter received by Burnsville's Mayor, A.T. Marlar, from Charles B. Hooper, Chief, Real Estate Division, Department of the Army, the proposed lease to the Town of Burnsville of 142.64 acres of the Tennessee-Tombigbee Waterway Project for recreational purposes has been approved and executed on behalf of the Government. Two archeological sites have been discovered in the lease area. According to the letter, the Nashville District has nominated these sites to be included in the National Register of Historic Places, but whether the State of Mississippi will agree and place them on the Register is not known. If the sites should be eligible for the National Register, the lease may need to be amended to protect these areas further, and the Town of Burnsville would be responsible for their mitigation.

# **Arson Fires Destroy Barns**, Hay and Vacant Houses

Tishomingo County Sheriff Amos Bates said a rash of arson fires were set north of luka on Sunday evening, December 7, burning barns, vacant houses and hay in one

of Harmony, New Salem, Rocky Springs, Patrick and on the Cagle Road, all within a 10 mile radius. The first act of destruction was reported at approximately 8:00 p.m.

open field in the communities to the Sheriff's Department at approximately 8:00 p.m., and within a short period of time the other fires were started. Sheriff Bates reported that his department received a call

reporting large bales of hay burning on the Robert Akers farm in the Harmony Community. Sheriff Bates said about 20 bales of hay was in the field and tractors were used to quickly move the bales from the fire. Three large bales were destroyed.

During the attempts to extinguish the blaze at the Akers farm, fire was set to the Dr. Bostick vacant farm house in the New Salem Community.

The next arson fire occurred, the sheriff believes, only minutes later at the Edgar Hannon barn on Cagle Road. The barn contained lumber and hay, which was destroyed in the blaze.

The Eston McCollough barn was the next site of destruction of the arson chain. The McCollouch barn, located in the Rocky Springs Community, contained 200 bales of hay and crushed feed.

The vacant house of the late Mr. Finch Grisham, located in the Patrick Community, was the last to be burned. The house contained furniture and some household items.

Sheriff Bates said the fires were set so quickly that fire fighters could not get to a fire in time to save the building nor its contents. "We have several good leads," Sheriff Bates said, "and investigation of the destructive fires will continue."

There were no injuries reported from the fires and several people assisted in controlling the blazes: The Tishomingo County Sheriff's Department, First District Fire Department, County Foresters, G



According to Mr. Floyd Whitaker, luka Fire Chief, his department received a call at approximately 7:30 p.m. alerting the department that a boxcar on a Southern Railway train was burning. According to Chief Whitaker, the fire had been spotted in Cherokee, Ala., as the train was traveling in a westerly direction. The Cherokee Fire Department followed the train to the Oldham Crossing where the train was stopped and the luka and Cherokee Departments attempted to extinguish the fire. Due to a shortage of water, the departments were unable to get the fire under control. The front section of the 195 car train was disconnected at the burning boxcar and proceeded

to luka where both departments fought the blaze for approximately three hours before the fire was extinguished. After the burning boxcar was sidetracked in

As the train started across the Fulton Street Crossing (in front of the Old J.C. Jourdan Hardware), Mrs. Fay Poindexter, of 208 W. Quitman St., luka, was traveling south on Fulton Street, and according to Chief Whitaker, she apparently failed to see the flagman and approaching train. As she came upon the crossing, Mrs. Poindexter realized the train was about to hit her. She jumped from her car and was running east down the track. At this point the train struck her car and drug the car over Mrs. Poindexter. The Tishomingo County Hospital Ambulance Service was called and Mrs. Poindexter was carried immediately to the hospital. As part of the announcement made on November 14. all producers of corn, sorghum, and barley will be eligible for target price protection, price support loans and for participation in the farmer-owned grain reserve in 1981.

The 1981 Feed Grain Program will assure producers at least the same 1981 feed grain loan rates as in 1980. The loan price will be at least \$2.25 per bushel for corn and other feed grain loan prices will be based upon a feed value relationship to corn, South said.

Additional details of the 1981 Feed Grain Program will be available in a few days. South said. Persons desiring additional details should contact their county ASCS office.

## **Peanut Marketing Quota Referendum** In December

Peanut growers will vote in a mail referendum during the period December 8-11, 1980. to determine whether marketing quotas on the 1981, 1982, and 1983 crops of peanuts will remain in effect The announcement came from Elmer South, Chairperson of the Tishomingo County Agricultural Stabilization and Conservation Service. According to South, at least two-thirds of the eligible voters who vote must favor quotas for them to be in effect for the next three years. If quotas are approved (1) the minimum national peanut allotment for 1981 will be 1.739,000 acres; (2) the minimum national poundage quota for 1981 will be 1,440,000 tons; (3) marketing quota penalties of not less than \$504 per ton will apply on peanuts harvested from acreage planted in excess of the farm peanut acreage allotment. The same penalty rate will apply to any peanuts marketed or considered marketed in excess of the farm poundage quota which will be established for the farm; and (4) price support on peanuts eligible for domestic edible use will be not less than \$420 per ton on peanuts marketed within the farm poundage quota. A lesser price support rate will apply to other peanut marketings. If quotas are disapproved (1) price support will be available on peanuts eligible

# County **Agents Notes**

By: Percie B. Stricklen Vegetable consumption is up in the United States. Extension Marketing Specialist. Ted Pullin, says per capita consumption of fresh market vegetables and melons increased to 124 and one-half pounds in 1979, Pullin attributes the increase to greater vegetable production and lower prices. Consumption of canned vegetables

also rose in 1979. Pullin says a decrease in vegetable production this season could mean higher prices for producers and consumers. He says the supply of fresh vegetables for the 1980 season is about 10 percent less than last year. \*\*\*\*\*\*\*

When farmers complete harvest, they need to store equipment for the winter. Extension Agricultural Engineer. Lee Miller. says try to store your equipment in a dry shed. If you don't have room for all your equipment with precision working parts is protected this winter. This fertilizer and includes pesticide applicators, combines, planters, drills and balers. Another possibility is to build additional storage facilities. Miller says increased storage area will pay for itself in reduced repair costs, extended machinery life, increased trade-in value

After discontinuing basketball season in luka High School for the season of 1942-43, the school's 1943-44 season opened on December 7, 1943, with a pair of wins over the Glen High School of Alcorn County.

An Army plane crashed near the Eastport Tower, killing the pilot, Robert L. Guilfail, instantly. Sgt. Guilfail was stationed at Courtland Air Base, Courtland, Ala. His home was in Rochester, N.Y.

Mr. A.C. Roberts, of Paden, Route 1, killed a registered Poland China Big Bone hog on November 30, 1943. The weight of the hog dressed was 808 pounds and rendered-255 pounds of lard.
