An empty coffee can with a plastic lid makes a good applicator. Cut holes in the plastic top to make a shaker. You may have to refill several times to apply the amount needed.

After applying, water the plants and soil thoroughly to dissolve the fertilizer and carry it to the roots. Don't use more than the recommended rate, and don't use a fertilizer mixture stronger than 10-10-

Verse 2: "A bishop then must be blameless, the husband of one wife." (It does not read "or the wife of one husband")

Verse 4: "One that ruleth well his (not her) own house ...

Verse 11: "Even so must their wives be grave ... (it does not read "or even so wives be must their grave . . . ").

Verse 12: "Let the deacons be the husband of one wife . . ." (It does not read "Or let the wife be of one husband").
