VALLEY GROVE WATER RECEIVES LOAN & GRANT

A community water system is one step closer for residents of the Valley Grove area of Tishomingo County.

On April 21, during loan closing ceremonies in the office of Finch and Finch, Iuka, the first check was delivered by Farmers Home Administration to association officials to begin construction. The check represents a

portion of the total project cost of \$312,000.

Representing Valley Grove Water Association, Inc. at the loan closing were Dale Cagle, President; Mildred H. Underwood, Secretary/Treasurer; J. Barry Finch, Attorney; and David Moore, Engineer. Farmers Home Administration officials who delivered the loan check were O. Harold Shows, Acting Community

Program Chief, Jackson, MS.; and James E. Huddleston, Assistant District Director, Booneville, MS. Association directors in addition to Mr. Cagle and Mrs. Underwood are Kary Daily, Norman Holman and Grady Taylor.

The new water system was designed by G & E Engineers, Booneville, MS. It will consist of a well, storage tank and approximately 23 miles of

water mains. When completed the system will serve 95 customers. Additional users are expected to be added as growth occurs in the community.

J. Barry Finch, of Finch and Finch, Iuka, handled legal organization for the Association and closed the FmHA loan, which will be repaid over a 40 year period with revenue from the sale of water.

Construction has begun on the distribution system with T.J. & L. of Henderson, TN. It is expected that other contractors will be on the scene in a few weeks.

**Chatting With

**Colorful Import Is
Easy To Grow**

Zinnias are reliable, easy to grow, and come in a wide variety of colors. They adapt to a number of different growing conditions and climates.

Their Mexican origin gives testimony to their hardiness and tolerance for hot, dry surroundings.

Probably no other environmental factor affects the success of zinnias as drastically as sunlight. Zin-

nias must have lots of it.

In most climates even partial shade reduces growth, causes weak stems, fewer flowers and increases susceptibility to disease.

It is only in extremely hot, desert climates that zinnias benefit from a small amount of late afternoon shade.

Zinnias like hot temperatures and must be protected from frost. In fact, there is no point in planting them while there is any danger of frost since the flowers do not begin to grow until the weather warms considerably and the days lengthen.

Once they begin to grow, they can reach maturity in as little as six weeks.

They can be planted as late as the last part of July, or even later in mild climates,

and still provide fresh flowers into the fall.

Zinnias succeed in almost any type of soil as long as there is adequate drainage. If the zinnias are subjected to standing water after a rain their growth rate will slow and their foliage will become yellow and anemic-looking. Zinnias are moderate feeders. Plants in average soil should be given a balanced fertilizer at least twice during the growing season. This will ensure a top quality zinnia crop.

Despite their desert heritage, garden zinnias need regular watering. If it does not rain, the zinnias need to be watered every 10 to 14 days to the point that the top 12 inches of soil are thoroughly moistened.

Overhead irrigation should be avoided for zinnias. Damp foliage and flowers lead to mildew. The plants should be located in an area where they will get plenty of ventilation. Otherwise even the rain can cause mildew.

Zinnias are not plagued by many insect pests, and are usually subject only to fungus diseases. Fungicide effectively control those problems.

Once the danger of frost is past, zinnia seeds can be safely planted.

The successful gardener makes a furrow about 1/2 inch deep in thoroughly moist, but not soggy, soil, and sows the seed at a rate of about 10 seeds per foot of furrow.

Small seeds are covered with 1/4 inch of soil, 1/2 inch of soil for the larger seeds, and thoroughly watered.

When the seedlings, which appear within four to six days, have formed two pairs of leaves they can be transplanted to their permanent sites and arrangement.

The low growing varieties are usually spaced about seven inches apart, the intermediate types do well at 10-inch intervals, and the

giant zinnias require as much as 18 inches of undisputed growing room.

To assure successful transplanting, zinnias should be moved in the late afternoon, after the peak heat period of the day has passed.

With only moderate care and concern even the most casual gardener should be able to enjoy a colorful, long lasting crop of zinnias.

**Broccoli & Onion
Casserole**

1 bunch fresh broccoli
(about 2 pounds)
1/2 cup water
1 teaspoon salt

1 cup grated Cheddar cheese
2 1/2 tsp. French dressing mix
Evaporated milk plus cooking liquid to make 2/3 cup
1 (3 1/2 oz.) can French-fried onions
1 (10 1/2 oz.) can cream of mushroom soup

Wash broccoli. Trim off woody stem ends. Slash through large stems from bottom to blossom ends.

Add salt to water in a heavy sauce pan. Bring to boil. Place broccoli in boiling water. Heat till water returns to boiling temperature. Lower heat and simmer 10 to 15 minutes till broccoli is crisp

tender, but still a bright color.

Place cooked broccoli in a greased 1 1/2 quart casserole. Sprinkle with cheese, 2 teaspoons French dressing and 1/2 can onions. Combine soup, milk and cooking liquid and pour over casserole. Sprinkle with remaining French dressing mix. Bake 325 degrees for 25 minutes. Top with remaining onions; bake for 3 to 5 minutes longer. Yield: 8 servings.

UNDETECTED FAR-SIGHTEDNESS

Also, wheat growing on acreage designated as conserving use acreage after this May 11 date, will result in the acreage being ineligible, thereby causing the farm to be out of compliance.

The chairman said that the May 11 final disposition date this year represents a change from last year when wheat was required to be destroyed by the time the grain heads reached hard dough stage.

Bridges said that participants should check with their local ASCS office concerning the eligibility of land designated as conserving use acreage under the ARP and PIK Programs.





CARING FOR YOUR PET

INFECTIOUS CANINE HEPATITIS

The good news is that canine hepatitis is not related to the human variety and cannot infect people. The bad news is that this disease can be fatal to unprotected dogs, and that they can sometimes contact the disease and die without displaying any of the recognized symptoms. What are these symptoms? Generally these include drowsiness, loss of appetite, abdominal tenderness, and a high fever. There may also be a cough and a tenderness in the dog's throat. As with any suspected illness, the dog should be taken immediately to the veterinarian for diagnosis and treatment. Though it can be fatal, particularly among puppies, your veterinarian does have a serum

treatment which save the older puppy dog. Fortunately, it is possible to protect from this disease through use of vaccine. Usually, a veterinarian will administer this as a combination vaccine - protecting against distemper, leptospirosis and parainfluenza.


