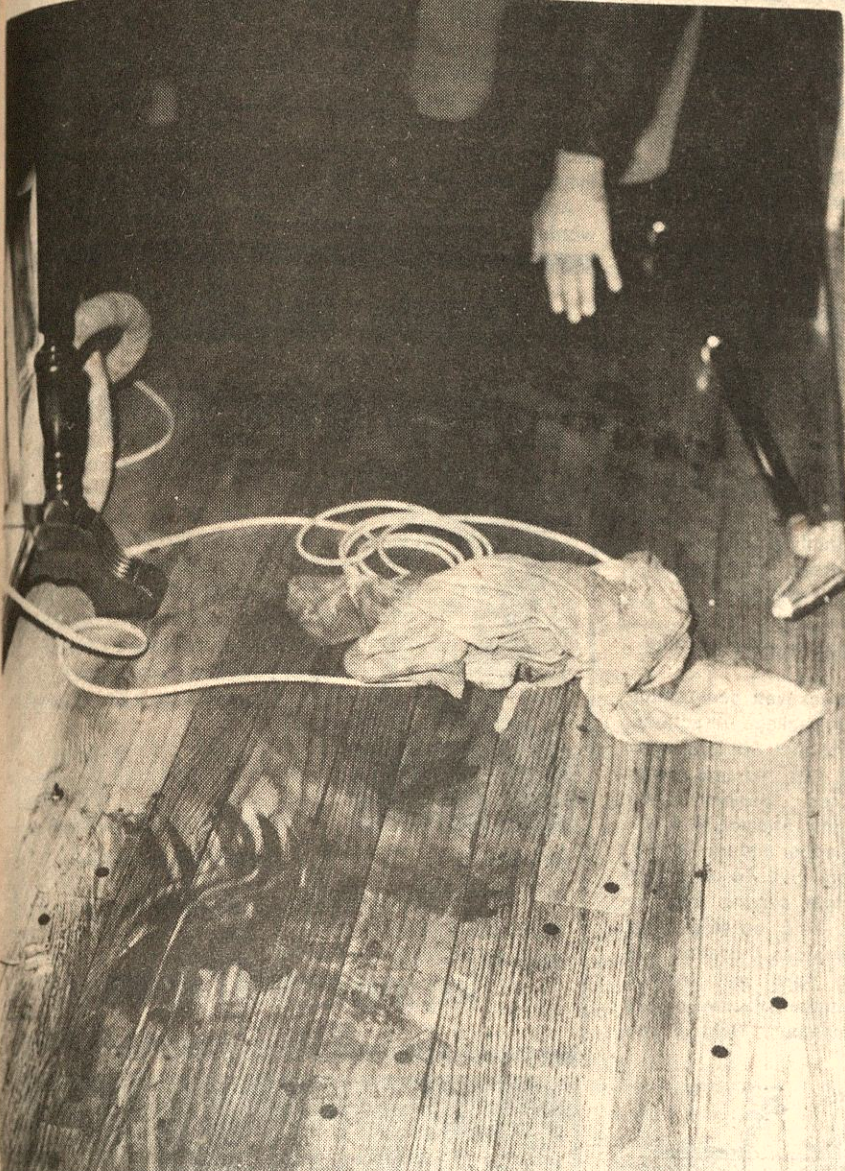

BRUTAL ATTACK LEAVES ELDERLY MAN DEAD, WIFE SERIOUSLY INJURED



Message In Blood

Letters written in blood named the alleged assailant and the type of weapon used as an elderly couple were attacked Sunday morning in their Route 4, Goat Island residence. Mrs. Elma Crawford managed to survive

a shotgun blast to her upper abdomen. W.D. Crawford received shotgun wounds to the back of his right shoulder, officials said; however, an autopsy showed that the elderly man was beaten to death with a blunt object. A small hammer was found by

investigating law officials at the scene, but the shotgun had not been recovered at press time. An arrest warrant has been issued for the Crawford's 20-year-old grandson, Keir D. Sanders who was staying with the retired couple at the time.

Tishomingo County and state law officials are on the alert for the arrest of 20-year-old Keir "K.D." Sanders in connection with the ghastly Sunday morning slaying of his grandfather and the attempted murder of his grandmother.

The body of 70-year-old W.D. Crawford was found lying face down in the blood splattered kitchen/living area of his water front cabin at Goat Island when sheriff deputies went to "check up" on the elderly couple at the request of their daughter. Chief Deputy Mike Kemp said that when he and deputy David Johnson arrived around 9 p.m. Mrs. Elma Crawford, 67, was found suffering from a shotgun wound, but con-

scious in the den of the home the retired couple shared with their grandson. It was stated that the tragic merciless shootings had probably happened around 7:30 Sunday morning, and that Mrs. Crawford had been left to suffer throughout the day and into the night. It was assumed that Sanders probably believed Mrs. Crawford was dead too.

Kemp quoted Mrs. Crawford as saying "K.D. has shot me and killed W.D." when he and Johnson entered the room. A Tishomingo County Hospital ambulance was dispatched and coroner Dale White pronounced Mr. Crawford dead at the scene. Mrs. Crawford underwent surgery for gunshot wounds to the upper abdomen at Tishomingo County Hospital and was listed in stable condition in the intensive care unit at press time.

home during the past in connection with other dealings with K.D. Sanders. He sensed that something was wrong immediately upon arrival when he noticed an inside light being on and the front wooden door open. According to Kemp, the Crawfords generally went to bed at an early hour.

Investigations made by Kemp and Johnson revealed that Mrs. Crawford said she was still in bed Sunday morning when she overheard what appeared to be a disagreement between her husband and grandson who were in the kitchen at the time fixing breakfast. Mrs. Crawford then related to the officers that she heard a gunshot and that K.D. then came into the bedroom and shot her. After being shot she managed to make her way out of the upstairs bedroom dragging and crawling down the hallway where she witnessed through the stair railings K.D. as he beat her wounded and bleeding

husband on the head with a hammer before leaving the house.

Mrs. Crawford continued to crawl down a flight of stairs, past the body of her husband as she struggled to get to the telephone only to find that it had been pulled from the wall, Kemp said.

Apparently afraid that she might die before help would come or that perhaps K.D. would return and further harm her, she scrawled the name of her assailant in the blood on the floor and beneath that she named the weapon (shotgun).

Sanders, a former mental patient, has been described by authorities as being a white male medium blond hair, blue-green eyes, weighing 165 lbs. and standing about 5ft. 9 inches tall. He is thought to have fled driving an old model Rambler

station wagon, rusty-orange in color with woodgrain side panels. The window of the car on the driver's side was broken and covered with plastic. He is considered to be armed and extremely dangerous.

Funeral services for W.D. Crawford Jr., were held at 1 p.m. Wednesday, January 1, in Selmer, Tennessee at the Shackelford Funeral Home Chapel.

He was a member of the Liberty Hill Baptist Church in Memphis, Tennessee, and a retired carpenter being a house builder. He was 70

years old and a native of Mississippi.

Burial was in the Oak Hill Cemetery in Selmer. Shackelford's Funeral Directors were in charge of the arrangements.

Survivors include his wife, Mrs. Elma Lee Crawford, Iuka; one daughter, Mrs. Jannie Lynn Hadley, Ramer, TN; one son, Wayne Crawford, Memphis, TN; two sisters, Mrs. Hazel Thrasher, Selmer, Tenn., and Miss Virginia Crawford, Memphis, TN; three brothers, Cecil Crawford, Cecil Crawford, and Harold Crawford, all of Memphis, Tenn., two grandchildren.

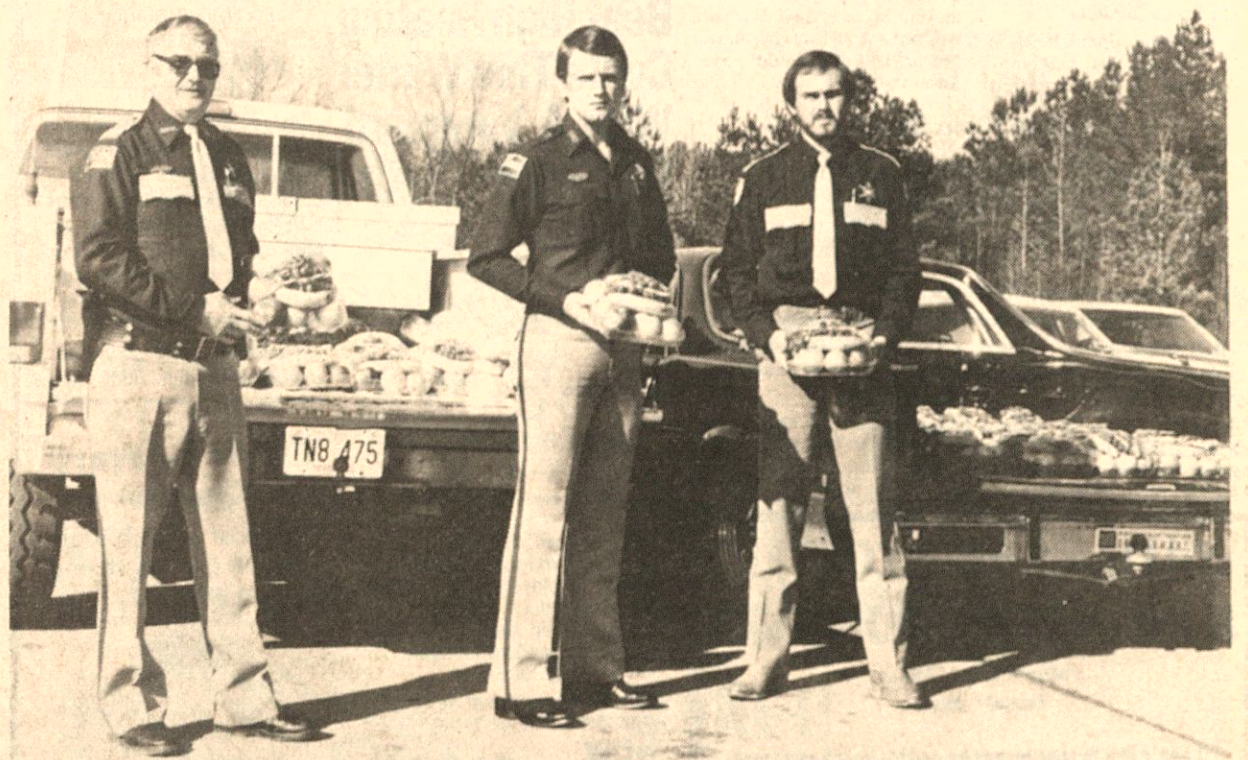

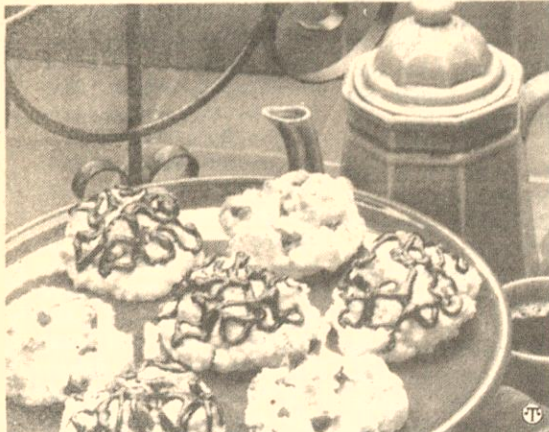

Biscuits...Bueno!



What could be more all-American than piping hot biscuits, fresh out of the oven? Or chocolate—so favorite a treat that Americans consume more chocolate per capita than anyone else.

All-American? Not quite! "Biscuit" comes from the Latin root words meaning "twice cooked." The original biscuits were baked a second time to make them long-lasting for sailors, soldiers and travelers—perfect for that long voyage to the New World.

Spanish cooks perfected the recipe and called them *bizcochos*. Maria Theresa, Spanish bride of Louis XIV of France, liked them so well she brought the *bizcocho* to the royal French court. The French liked them, too, and called them *biscuits*.

The same Spanish bride also brought us chocolate. *Chocolatl*, a beverage first

served to Spanish conquistadores by their Aztec hosts, was long considered an aphrodisiac. Whether because of this power, or simply because it tasted good, Maria Theresa drank chocolate enthusiastically.

From Spain to France and back to the New World, chocolate has come a long way—just like biscuits. Now biscuits are high and moist and, like chocolate, made even more tempting with a variety of flavors.

There's no guarantee these chocolate-chip biscuits will make a Latin lover out of you, but you'll certainly be enamored with the combination.

These light, tender drop biscuits, made from a sweetened dough and richly studded with chocolate chips, are made so simply with ingredients you probably have on your kitchen shelf. With or without a drizzle of chocolate, Maria Theresa would have loved them, too.

Chocolate Chip Biscuits

Heat oven to 450°
2 cups Bisquick baking mix
1/2 cup semisweet chocolate chips
2/3 cup whipping cream
2 tbsp. sugar

MIX all ingredients until dough forms.
DROP dough by 12 spoonfuls onto greased cookie sheet.
BAKE until golden brown, 8 to 10 min. Drizzle with Chocolate Chip Glaze (below) while warm if desired. 1 doz. biscuits.

Chocolate Chip Glaze: Heat 1/4 cup semisweet chocolate chips, 1 tbsp. margarine or butter and 2 tsp. light corn syrup in 1-qt. saucepan over low heat, stirring constantly, until chocolate is melted; cool slightly.

**Use And Store
Pesticides Safely**

Here is some more information which will add to your happiness and safety during the Holiday and winter season.

Although the 1985 crop season is history for most Tishomingo County farmers, thinking about safe pesticide use is never out of season.

Chemical pesticides are necessary weapons in today's agriculture. They kill plants, insects and animals that damage farm commodities and livestock.

But negligent use and storage of these chemicals can cause accidental poisonings in people and animals. Several hundred calls related to accidental pesticide poisoning reach poison control centers each year in Mississippi.

Some farmers suspect that high exposure to chemicals contribute to allergies, nervous disorders and poor health. It is well-known that chemicals are connected to cancer in laboratory animals and are suspected to affect humans.

Too much of a chemical on the crop or land can cause either immediate or delayed

damage. Likewise, mild poisoning of the body through unnecessary exposure can cause immediate or later damage to health.

All this points to the need to use and store chemicals according to recommendation.

When storing pesticides for the winter, keep them in the original container to avoid possibility of misuse. You also should protect chemicals against low temperature extremes this winter.

Keep inexperienced individuals away from the pesticide storage area. Store the chemicals in an area that is not accessible to pets and other animals.

Before you use or store a chemical, read the label. If you have any questions about safe pesticide use and storage, contact the Tishomingo County Extension office.

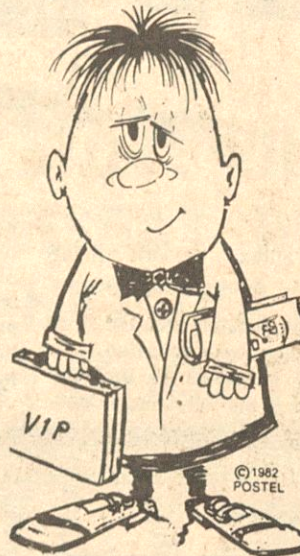
Hypothermia

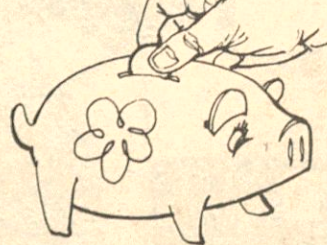

sists of rewarming the person under a doctor's supervision, preferably in a hospital.

PROTECTIVE MEASURES: There is no strong scientific basis for recommending a particular room temperature for older people. However, setting the heat at 65 degrees Fahrenheit in living and sleeping areas should be adequate in most cases, although sick people may need more heat.

**To Prevent
Hypothermia**

*Dress warmly even when indoors, eat enough food and stay as active as possible.

*Because hypothermia may start during sleep, keep warm in bed by wearing enough clothing and using blankets.

*Ask your doctor whether or not medication you are taking might affect the control of body temperature.

*Ask friends or neighbors to look in on you once or twice a day, particularly during a cold spell. See if your community has a telephone check-in or personal visit service for the elderly or homebound.

Caution, common sense and prompt medical attention can help older people avoid illnesses due to cold.

**Marinated Blackeyed
Pea Salad**

1 (16-oz) bag frozen blackeyed peas
1/2 cup cider vinegar
1/2 cup olive or salad oil
2 tsp salt
1/2 tsp dry mustard
1/2 cup sugar
1/4 tsp ground hot, red pepper
1/2 cup thinly sliced scallion, green tops included
1/2 cup slivered green pepper
Tomatoes, wedged or sliced

Cook blackeyed peas according to package directions; drain and cool. Stir in vinegar; add oil, salt, mustard, sugar and red pepper; mix thoroughly. Add scallions and green pepper and mix lightly. Cover and chill. To serve, turn salad into serving bowl or platter; ring outside edge with tomatoes. If desired, line serving bowl with lettuce before adding blackeyed peas and tomatoes. Yield: 6 servings.

**Parvo
A Viral Killer!**

Since 1980, a dangerous viral killer has been stalking Tennessee dogs.

It's canine parvovirus infection (CPV) or parvo! There are no specific drugs to kill the virus in infected dogs. Only the symptoms can be treated in order to prevent dehydration and additional infections that frequently occur when an animal is weakened.

Left untreated, parvo is frequently fatal -- especially among puppies less than five months old. An estimated 75 percent of the young dogs succumb to CPV within 24 to 48 hours after being infected.

But canine parvovirus infection can be prevented. Several effective vaccines have become available to veterinarians since the first vaccine was introduced in 1981.

A highly contagious disease, CPV is thought to be spread by dog-to-dog contact and has been diagnosed wherever dogs congregate. During summer months, when dogs tend to be more sociable, the disease frequently reaches near epidemic stages among those animals not vaccinated.

Parvo is readily transmitted from place-to-place on the hair or feet of infected dogs or by contaminated cages, shoes or other objects. Humans, insects and even other species of animals are thought to transport the disease. At this time, however, there

is no evidence to show that parvo can be transmitted to people or to other types of animals.

There is no breed, age or sex predilection to the parvo virus. Young animals, however, tend to suffer the highest fatalities.

Currently, there are two forms of CPV known -- gastroenteritis, which is the most common and affects the intestinal tract, and myocarditis, which most often appears in puppies less than three months of age and affects the heart.

The first signs of gastrointestinal CPV, usually vomiting and severe diarrhea, most often appear 5 to 7 days after the dog is first exposed to the virus. Depression and loss of appetite soon follow. Younger dogs may have a rise in temperature.

Puppies affected with the myocarditis form of CPV become listless, cry, have difficulty breathing and die of heart failure within a few hours. Frequently, they are found dead without being observed as having any difficulties at all. Those puppies that recover from this form of CPV often suffer permanent heart damage.

**Money Management
Behaviors For Youth**

Money takes on a new meaning when there are children in the family. Not only is there added pressure on the family's income to cover more wants and needs, but parents also are concerned about helping their children develop healthy, positive attitudes about money.

Attitudes and habits about money are learned at an early age. Very young children begin to learn about money by observing how their parents feel about money and react to it. They notice whether parents argue or discuss calmly how money is to be spent, who pays the bill, and who keeps the records.

This role as observer while still a child will be a subtle but significant influence on how a person feels about money through life.

One way parents can teach children that money will be a positive factor in their adult lives is to set a good example. Actions speak louder than words in forming attitudes

about money. Is money used in the family by parents as a bribe, reward or means of control? Are material goods craved? Is there an effort to keep up with the Joneses? Is more emphasis placed on the cost of a gift than the feeling of giving it?

Since children are masters at spotting inconsistencies when parents say one thing and do another, parents should be sure to practice what is preached.

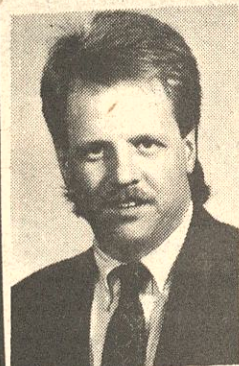
Parents need to use every opportunity possible to teach smart buymanship. They can help children learn to read labels, to ask clerks questions when they do not find information they need on labels, and to recognize a good buy.

On occasion, parents should take children with them when they shop, and explain why they choose to buy one item over another. They can also offer guidance and suggestions when children are doing their own shopping.

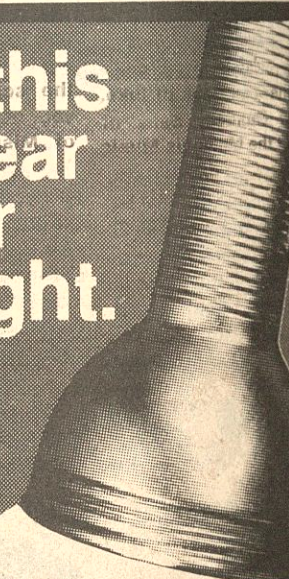

What to do during an outage.

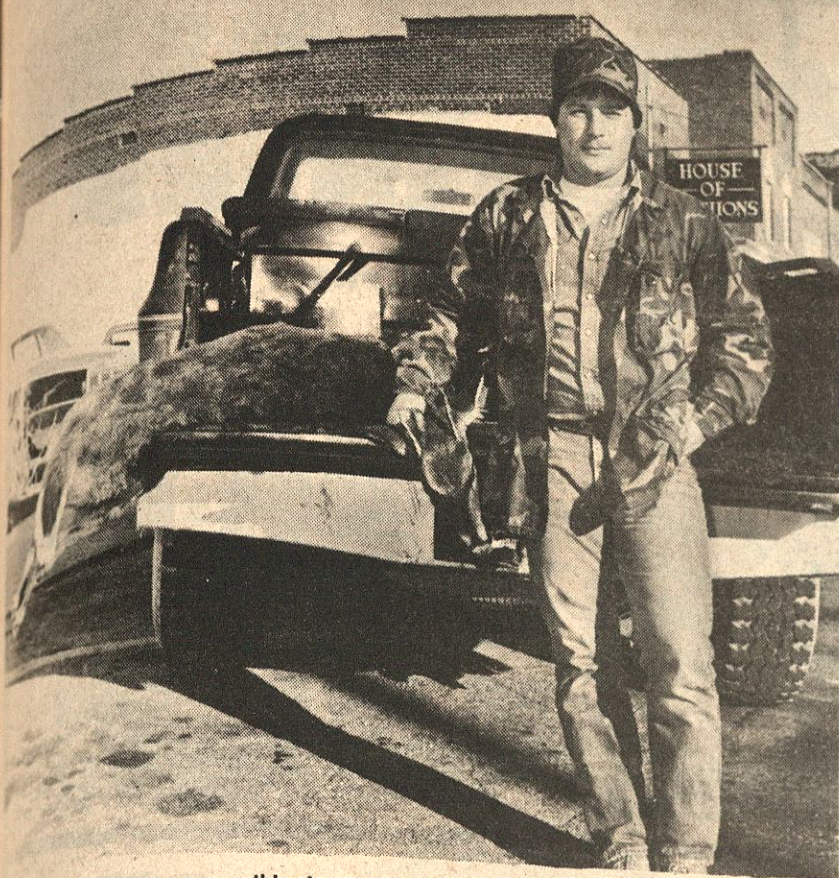
1. STAY AWAY FROM DOWNED POWER LINES and broken utility poles. Please note the location and call us immediately. Even lines that look harmless can be dangerous.
2. If your power is out, check your neighbors. If they still have electricity, check your fuses or circuit breakers. If that doesn't solve the problem, give us a call.
3. Once you've called us, there's no need to keep calling; your request will be handled as soon as possible. However, if your power is still out once your neighbors' have been returned to service, you should call again.
4. When service is restored, overloaded lines could cause another outage. You can help prevent this by switching off your heating and cooling equipment and other appliances during the outage. Leave a light on so you'll know when service is back on.
5. Don't keep checking the refrigerator and freezer. Food will keep much longer if the doors are left closed.
6. Prepare a "lights out" kit: keep a flashlight, spare fuses, and battery-powered radio handy. Know where the electric service panel for your home is located and how to reset circuit breakers or replace blown fuses. Make sure your family knows where the kit is and what to do if you are not at home.

Bridges Asks Producers To Report Farm Changes

Howard Bridges, Chairperson of the Tishomingo County Agricultural Stabilization and Conservation Service, today urged producers to report any changes in their farm operations which could affect farm program benefits for 1986.

"In order for us to help producers get full program benefits, farm records must be up-to-date," said Bridges. "If a farm will have a new owner effective for 1986, or if a change is made in the operation of an existing unit, producers should notify our office."

Bridges said plans to combine farms or divide a farm should be requested as soon as possible because reconstitutions require special processing as well as county committee approval.

"Additionally, farmers who want to establish proven yields for 1986 feed grains or wheat should assemble proof of production records for this year's crop."

To request a proven yield, the ASCS official said farmers are required to collect data for all farms on which the crop was grown, and to keep all production evidence separate for each year and each farm. Farmers will be given the opportunity to request a proven yield until April 1 for wheat and July 1 for corn, grain sorghum and cotton if production evidence so warrants.

Ask Ochsner

Q. I am concerned when my husband goes out hunting or fishing in the winter time. I tell him he doesn't dress warmly enough, but he says it rarely gets cold enough here to warrant him taking heavy clothes and an extra jacket. Am I concerned needlessly?

A. Dr. Chesner Hines, Jr. of the Ochsner Clinic staff, and himself an avid outdoorsman, says that hunters and fishermen in the south are misled by the fact that temperatures are rarely in the freezing range in the Gulf South, and many fail to take proper precautions. Sometimes, a condition known as hypothermia -- abnormally low body temperature -- can result.

Hypothermia is usually caused by a combination of cold and wetness, and can not only cause severe illness but even death. It can occur even when the temperature is in the 40's, if the sportsman

should fall into the water or meet a heavy rain, Dr. Hines says.

For those who carry liquor in the boat and tend to drink some when they are chilled and wet, "don't do it," Dr. Hines says. "A drink of alcohol rather than warming you up, actually dilates the blood vessels in the skin and causes further loss of heat," he says, urging outdoorsmen to wait until they are safely back at camp before taking a drink.

All of the problems of hypothermia can be avoided with the use of proper protective clothing. This includes a hat. About 40 percent of body heat is lost through the head. Wearing a hat, which is both warm and waterproof, can go a long way toward protecting you if you're caught in a winter rain.

Layered clothing, including thermal or long underwear, is a must in cold weather. A careful outdoorsman living in our mild climate always takes an extra layer of clothing with him in case there is a sudden

weather change. Down-filled clothing is no good if you get wet. Dr. Hines says it's better to have clothing filled with the new synthetic waterproof materials which are as warm as down. These can be taken off, wrung out, and put back on to allow body heat to dry them out.

Dr. Hines also suggests stowing matches in a waterproof package aboard the boat just in case you have to spend the night in the marshes and need to make a fire.

The Role Of Prescribed Burning In Managing Your Pine Forest

What is prescribed burning? Prescribed burning is the deliberate use of fire under specified and controlled conditions to accomplish one or more of several objectives of forest land management. It is a practice that provides the forest manager with an effective and economical means of performing many necessary management tasks.

Do prescribed fires damage timber? All fires in a natural environment do some damage. Prescribed burns are no exception. However, properly planned and executed, prescribed burning can accomplish many objectives at reasonable cost and with minimum damage to the forest.

Is a permit required? Air pollution control regulations must be observed during all burning. A burning permit is required. Prescribed burning permits, guidelines, advice, and assistance with actual burning are available through the Mississippi Forestry Commission.

What are some uses of prescribed burning? One of the major benefits of prescribed burning is fuel reduction. Fuels - grass, weeds, pine needles, hardwood leaves - accumulate in pine stands of all ages. This accumulation of fuels threatens destruction by wildfires in young stands and hinders regeneration in older ones. Regular, periodic removal by prescribed burning eliminates this problem in an effective and inexpensive way. Secondly, prescribed burning aids in the control of hardwoods. In areas better suited to growing pine, hardwoods creep in early and, if not

treated, grow increasingly bothersome. They sap moisture and nutrients from pines, impede visibility and access through the stand, and interfere with natural regeneration. A well planned burning program is the most economical way to deal with this problem.

Another benefit of prescribed burning is wildlife habitat improvement. Many of the burns prescribed for other purposes will benefit wildlife as well. For example, hardwood control burns in immature stands encourage fresh, low sprout growth which is within the reach of browsing deer. Quail and turkey benefit from fuel reduction burns that remove heavy brush and encourage growth of annual plants.

Prescribed burns are also very important in the site preparation phase of both natural and artificial pine regeneration. The prescribed burn helps control the competitive hardwood vegetation as well as improving the area for seeding or planting.

Farm Bill... A Timely Effort

When it comes right down to it, Congress must be applauded for pushing the 1985 farm bill through to passage just in the nick of time and showing a concern for the needs of U.S. farmers at decision making time.

And like the proverbial stitch in time, it may spare a lot of farm plans from unraveling at the beginning of a new year, but an examination of its seams may portend trouble before the end of its five year life expectancy.

Major changes in farm program direction provided by the measure include several mechanisms to

reduce price support loan rates and make U.S. crops export-competitive; a new whole-herd buyout program for dairy cattle; an aggressive export promotion program; and conservation provisions aimed at retiring about 10 percent of U.S. cropland and preventing payments to producers who cultivate highly erodible lands.

One seam to be wary of is the cost of the program. Although the measure is aimed at cutting some benefits for farmers, its commodity provisions have been estimated to cost a minimum of \$52 billion over the next three years which is close to recent record levels of farm spending. And this seam must hold in fiscal integrity which today is a sore spot in U.S. government operations.

On the commendable side the act freezes target prices for wheat and feed grains for two years and possibly three. In 1988 those target prices are scheduled for a 2 percent cut, but USDA is directed to make up for the reduction with PIK (payment in kind) payments if it is practical to do so. Both target prices will then drop by 3 and 5 percent the next two years. Over the five year lifespan of the farm bill, target prices for wheat and feed grain are slated for a 10 percent cut.

Another 10 percent cut is provided for cotton and rice, and after a one-year freeze a drop will be phased in for 1987. So the reductions of 2 and 3 percent for crops between 1987 and 1990 will be gradual. And that's good, for it gives farmers a little breathing room even as their belts are cinched.

The dairy compromise retains the current support price \$11.60 per hundred-weight of milk during 1986, but lets it drop by 25 cents in January 1987 and by yet another 25 cents in October.

For dairymen there will be no diversion program such as the House wanted, but in-

stead there will be a new, 18-month whole-herd buyout program which will give dissatisfied dairymen an opportunity to close down their operations if they care to.

More stress at the seams of the farm bill comes through uncertain effects of the Gramm-Rudman-Hollings balanced budget legislation, as commendable as it may be, but which is expected to trigger across-the-board automatic cuts in most government spending whenever Congress and the administration fail to agree on deficit reduction moves.

No one can be quite sure how such cuts will affect the farm programs, since the balanced budget law appears to exempt benefits that are under contract, as are many farm transactions. So the timing of the cuts or when farmers sign contracts may be key factors that strain on the farm bill wrappings.

Dairymen are immediately vulnerable to Gramm-Rudman cuts since price supports are not subject to pricing contracts.

All of these points mean farmers still have their ears to the ground. They appreciate the fact that Congress got on the ball and passed a compromise farm bill largely in time for them to make and finance their 1986 crop plans. But they will keep on listening and watching for stresspoint rips in the fragile fabric with which the 1985 Christmas present from Congress and the administration is wrapped.

Rural Referral Center At Magnolia

Recognition as a rural referral center is expected to help Magnolia Hospital hold down healthcare costs.

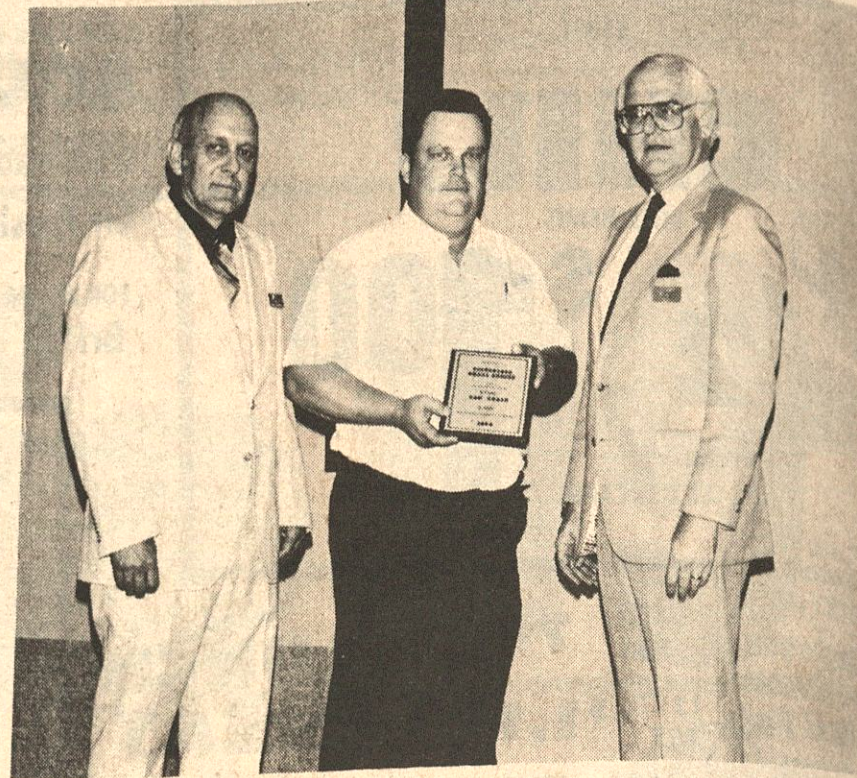
Officials of the 178-bed medical center were notified recently of designation as a rural referral center by the Department of Health and Human Services. Attaining rural referral center status means Magnolia Hospital will receive higher payments from the federal agency for the treatment of Medicare patients.

"We are extremely pleased to be recognized as the referral center which the hospital has been for several years," said Winston C. Whitfield, Magnolia Hospital Administrator. "The increased Medicare reimbursements will be a significant help in our efforts to provide top quality medical care while holding down its costs."

"The significant impact of our gaining rural referral center status is the elimination of some cost shifting from the public to the private sector," said Benny Brewster, Director of Finance for the hospital. "Medicare payments have never covered all the costs for treating Medicare patients. Those costs not covered by the federal government have always been borne by the private sector."

"As a rural referral center, the hospital will receive a higher level of payment for treating Medicare patients," he explained. "This increase will mean less of the cost of treating Medicare patients that will be covered by self-pay and commercial insurance patients."

"In effect, rural referral

center status means the federal government will pay more of its fair share of the cost of treating Magnolia Hospital patients under the Medicare program."

Brewster revealed the new federal designation more accurately reflects the intensity and sophistication of services being provided at Magnolia Hospital. Three criteria which the hospital exceeded to gain its new referral status involved the number of discharges annually, the specialization of its physician staff and the sophistication of services.

"In addition to having over 6,000 discharges annually, rural referral center status requires over 50 percent of the hospital's physician staff be specialists. This criteria Magnolia Hospital met easily, as 24 of the 34 physicians on staff are specialists," said Brewster.

"In determining the intensity and sophistication of services, the Medicare program uses a number called a 'case mix'. This number was derived by designating the treatment of a particular medical condition as having a weight of one and establishing numbers for treating all other diagnoses relative to it.

"Under this system each diagnosis carries a particular weight. The total of all these weights times the number of

patients with each diagnosis divided by the total number of patients treated by a hospital is a hospital's case mix. This case mix figure is one of the criteria used to determine rural referral center status.

"Magnolia Hospital's case mix is sufficient to reach rural referral center status because of the sophisticated procedures which our specialists perform in our hospital," said Brewster. "The more esoteric the procedure, the heavier the case mix weight for that particular diagnosis."

"Our physician staff covers every major specialty area and many of the subspecialty areas," he continued. "Such procedures as cardiac catheterization, total hip joint replacement and transurethral resection of prostate pushed our case mix well over the figure required for rural referral center status."

Brewster indicated the hospital will retain its newly won status for at least three years.

Trend Toward Alcohol-Free Teenage Nightclubs

Mississippi is experiencing a trend toward non-alcoholic teenage nightclubs, according to the Highway Safety Division, Governor's Office of Federal-State Programs.

"Each year approximately 46 teenagers are killed in alcohol-related highway crashes," said Roy Thigpen, governor's representative for highway safety and director of Federal-State Programs' Department of Criminal Justice Planning. "Non-alcoholic teenage nightclubs can make an important contribution to combating this problem, and we believe more and more non-alcoholic nightclubs will be seen in Mississippi."

An example of such a nightclub is the Marz Bar in Jackson. Shelly Ann Bailey, its originator, was a Chicago junior college instructor when she heard from Mississippi relatives that teenagers were having difficulty finding wholesome recreational opportunities. She recognized this as a likely factor in Mississippi's teenage highway deaths and injuries and decided to move to Jackson and do something about the problem.

"Chicago has many alcohol-free recreational

outlets for teenagers," Mrs. Bailey, the mother of a 15-year-old girl, said. "I felt that moving to Mississippi would give me the best opportunity to help teenagers."

The Marz Bar opened last month and already "appears to be just what the teenagers needed," she said. In a setting similar to adult nightclubs, the teenage facility can accommodate 225 teenagers enjoying dancing, talent competitions, video games, soft drinks, sparkling grape juice, hot dogs, nachos and a combination of chips, sour cream, chili, lettuce, tomatoes and cheese that Mrs. Bailey refers to as the "supreme".

She noted that "the Marz Bar is giving teenagers a wholesome alternative to frequenting parking lots and other areas where they consumed alcoholic beverages and then drove home or to another location. We had our grand opening on November 27, and we've had big crowds ever since," Mrs. Bailey said.

The Marz Bar is open from 3 p.m. to 10:30 p.m. Wednesdays and Thursdays, from 3 p.m. to 1 a.m. Fridays and Saturdays and from 23 p.m. to 7 p.m. on Sundays.

Last spring, the Highway Safety Division launched an "Only Dorks Drink and Drive" campaign to reduce alcohol-related teenage deaths and injuries on Mississippi highways. "We met with many teenagers in planning this campaign," said Checky Herrington, Federal-State Programs' director of program information, "and we, too, found that there was

a need for more wholesome recreational outlets for teenagers. The Marz Bar and other alcohol-free teenage nightclubs in Mississippi are meeting a real need."

The term "dork", Herrington noted, is widely used by teenagers to describe a person who has little sense and is not respected by other teenagers. The campaign includes radio and television public service announcements, newspaper fillers, T-shirts, bumper stickers and a one-act play about the dangers of drinking and driving. The play is being made available to high schools across Mississippi.

"Teenage drivers are involved in one of five fatal highway crashes, and almost 60 percent of fatally injured teenage drivers were found to have alcohol in their blood in an Institute for Highway Safety study," Thigpen said. He referred to some alarming statistics about teenage drinking that resulted from a recent survey of Jackson high school students. The study showed that 86.7 percent of the students questioned said they had experimented with alcohol, 12 percent said they drink daily and 27 percent said they had experienced at least one "blackout" due to alcoholic consumption.

"The Department of Criminal Justice Planning believes that one of the best deterrents to undesirable behavior is to provide an atmosphere where desirable behavior is encouraged," Thigpen said. "The Marz Bar and other alcohol-free teenage nightclubs give teenagers the recreational opportunities they need."

LIHEAP Assistance Information Clarified

The Office of Energy and Community Services of the Governor's Office of Federal-State Programs today clarified information about the amount of Food Stamp benefits to be received by those households which receive help through the Low-Income Home Energy Assistance Program (LIHEAP).

"Even though policies were changed October 1, to prevent the loss of Food Stamp benefits to LIHEAP recipients, the Office of Energy and Community Services continues to receive reports that applicants are being told that they will lose their Food Stamp benefits if they apply for help through the Low-Income Home Energy Assistance Program," said Linda S. Harvey, director of the Office of Energy and Community Services.

The eligibility requirement for LIHEAP assistance is based upon family size, type of fuel used and household income. The maximum income for eligibility is 125 percent of the poverty level.

"Everything possible is being done to clear up this situation," Ms. Harvey added. "But for any LIHEAP applicant who has lost Food Stamp benefits because he or she received a check to help with utilities or has cancelled an appointment to make application for help for fear of losing Food Stamp benefits, please call the Governor's Service Line, toll-free at 1-800-

222-7622. Jackson area residents should call 354-4540 or 949-2011."

Narcotics News

Q. Is caffeine considered a drug and what are some of the effects?

(L.S. Pickens, MS)
A. Caffeine is the worlds most popular drug. In nature form its a white, bitter, crystal-like substance mostly found in coffee, tea and cola. The effects of caffeine begin in approximately 15-30 minutes after drinking only 2 cups of coffee. A persons body temperature and blood pressure may increase due to the effects. Other effects include an increased urine production, higher blood sugar levels, hand tremors, decreased appetite and delayed sleep. Higher doses cause nausea, diarrhea, headaches and nervousness. Extremely high doses have occurred and may result in breathing failure which could cause death. It is almost impossible for death to occur from drinking coffee, however misuse of tablets containing caffeine have been the result in some deaths.

Last Date For Men Turning 26 To Register

The Selective Service System reaches an important milestone in the registration of young men on January 1, 1986.

Beginning on this date, men who were required in 1980 to register with Selective Service will be turning 26. Selective Service does not have the authority to accept registrations of men after they turn 26. Men who failed to register will have permanently forfeited their right to certain Federal student aid and job training benefits as well as Federal employment. Additionally, registration with Selective Service is a requirement in some states for various employment opportunities, such as law enforcement agencies and permission to practice law.

Men born in 1960 who have registered, will reach age 26 in 1986 and, under present law, will no longer be eligible for selection for induction. Over 15 million men, age 18 through 25, have registered with Selective Service since President Carter initiated registration in 1980.

SOCIAL SECURITY CHANGES FOR 1986

Both the Social Security tax rate and the amount of earnings subject to tax will increase beginning January 1, 1986. Hugh Tigrett, Social Security manager in Tupelo, said recently. The tax rate will increase from 7.05 to 7.15 per cent under present law. The earnings base will increase automatically from \$39,600 to \$42,000, based on increases in average wage levels.

Under the law, the tax rate for self-employed people will rise from 14.1 per cent in 1985 to 14.3 per cent in 1986. Tax credits of 2.3 per cent and 2.0 per cent are available for 1985 and 1986 respectively, making the effective tax rate 11.8 per cent in 1985 and 12.3 per cent in 1986.

Social Security benefit amounts are based on covered annual earnings paid over a working lifetime. In general, the higher the covered annual earnings on which Social Security taxes are paid, the higher the benefit received.

Two other changes for 1986 include the annual earnings test amounts and a cost-of-living increase for beneficiaries, Tigrett said. Social Security beneficiaries who work will be able to earn more in 1986 without affecting their Social Security benefits. In addition, Social Security and Supplemental Security Income benefits to some 40 million persons will increase by 3.1 per cent with the January payments. The automatic increase reflects increases in the cost-of-living as indicated by an increase in the Consumer Price Index of 3.1 per cent.

The annual earnings limits have increased from \$7,320 to \$7,800 for people 65 through 69, and from \$5,400 to \$5,760 for people under age 65. The earnings test does not apply to people 70 or over. Benefits are reduced \$1 for each \$2 of earnings above the annual exempt amount.

Working beneficiaries who earned over the annual limit in 1985 should begin thinking now about preparing their annual earnings report which is due to Social Security by April 15. This earnings report is used to determine if benefits were correctly paid in 1985 and what benefits are payable in 1986.

If you get Social Security checks, sometime in January you will also receive a Social Security Benefit Statement in the mail. This form will show the total amount of benefits you received in 1985. For some people, up to half of their Social Security benefits may be taxable, but only if they have substantial income in addition to their Social Security benefits. If you have questions about the infor-

mation on the statement, you can call Social Security at the toll-free number shown.

Q. What is title insurance and does a buyer need to purchase it?

A. If the buyer is obtaining a mortgage loan, the lender will require title insurance in the amount of the loan to protect himself against possible loss. This insurance however does not protect the owner in the event that defects are found in the title. Owners title insurance insures the new owners' equity in the property. It is optional.

Q. How should a buyer take title?

A. Title may be taken by an individual or by two or more parties in a joint ownership. If the parties are husband and wife, it is common to take title as joint owners with right of survivorship, so that the death of one party, title to the entire property is turned over to the survivor. However, estate taxes should be considered before deciding on this form of ownership.

ties, but chances for a slow-down in the concentration and spread of the dreaded pine tree killer are looking better in some areas of the State as winter approaches."

That's the gist of a recent report by Forestry Commission Entomologist Bill Lambert.

Lambert said the beetles had already done more than 5 million dollars worth of damage to pine forests in the Southwest and Central parts of the State this year.

He said the situation is keeping an eye on the situation both from aerial survey flights and ground inspections. Landowners affected by the bark beetles are being notified and quick salvage and/or treatment is being urged. An estimated 13 percent of damaged trees has been salvaged to this point.

Lambert said the Southern Pine Beetle damage was much worse in Louisiana and Texas, but that this year (1985) has been the third worst on record for our State of Mississippi.

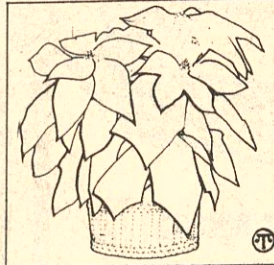

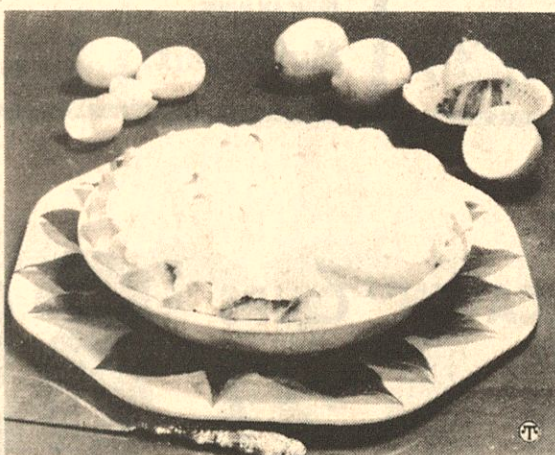

With lemons in good supply twelve months of the year, Lemon Meringue Pie is no longer a seasonal dessert. The recipe for Lemon Meringue Pie first appeared on the corn starch box in the early 1900's. This is an updated version, made without the need for a double boiler.

Lemon Meringue Pie

1 cup sugar	1/4 cup lemon juice
3 tablespoons Argo corn starch	1 tablespoon corn oil
1 1/2 cups cold water	margarine
3 egg yolks, slightly beaten	1 baked (9-inch) pastry shell
Grated rind of 1 lemon	3 egg whites
	1/3 cup sugar

In 2-quart saucepan, stir together 1 cup sugar and corn starch. Gradually stir in water until smooth. Stir in egg yolks. Stirring constantly, bring to boil over medium heat and boil 1 minute. Remove from heat. Stir in lemon rind, lemon juice and margarine. Cool slightly (no longer than 1 hour). Turn into pastry shell. In small bowl with mixer at high speed, beat egg whites until foamy. Add 1/3 cup sugar, 1 tablespoon at a time, beating well after each addition. Continue beating until stiff peaks form. Spread some meringue around edge of filling first touching crust all around, then fill in center. Bake in 350°F oven 15 to 20 minutes. Cool at room temperature away from drafts. Makes 8 servings.

Senate News

Senator Irb Benjamin

A Senate subcommittee concerned about the critical financial status of the agricultural industry heard four recommendations from the Mississippi Cooperative Extension Service on how the state can be of assistance to farmers.

Suggestions presented to the Senate Agricultural Finance Subcommittee, of which Senator Irb Benjamin of Rienzi is a member, included encourage the production of high profit margin crops not traditionally produced in the state; sponsor an interest rate buy-down program; broaden the promotion of specialty products; and include certain crops in tax benefits offered to businesses.

Dr. Charles Walden, MCES Economist, presented details of a proposal called the Emerging Agricultural Products Act of 1986. Emerging crops are those which consumers are beginning to demand but the amount produced is small.

"Soybeans represent a mature market. The total value of the crop is high but demand is stable. On the other hand, muscadines are an emerging crop. Demand is growing rapidly but the total value of the crop is small compared to soybeans," explained Walden.

"The state of Mississippi does not have the financial resources to have any impact on the soybean market. However, it does have resources to encourage selected emerging crops."

The proposal calls for the Legislature either to appropriate or issue general obligation bonds in the amount of \$10 million to establish the Emerging Crops Fund. Money from the fund would be used to pay interest on loans secured by farmers for non-land capital costs of establishing production of an emerging crop. When commercial production is established, the farmer must repay the Fund. The state makes no guarantee on the loan.

MCES recommendations for emerging crops at the present include blueberries, muscadines, Christmas trees, and rabbits.

Explaining the interest rate buy-down program, Dr. O.A. Cleveland, MCES Marketing Specialist, said that evidence of a serious financial crisis in Mississippi agriculture continues to accumulate and the 1985 farm bill being considered will not help.

"Early warnings of this debt/financial crisis have been loan delinquency rate increases, selected rural bank difficulties and deteriorating farm balance sheets," said Cleveland.

He added that there has been a nine percent decline in land values from 1984 to 1985 and that almost 2 percent of Mississippi farmers are facing a severe financial crisis.

Cleveland said that the interest buy-down program is viewed as a short run program that would allow the state to provide immediate assistance to all types of farmers regardless of size or production enterprise but should be targeted to those who have a reasonable chance of survival. The total expected yearly cost to the state for each percentage point of buy-down would be about \$3.852 million, using an average interest cost of \$642 for each percentage point with 6,000 farms expected to qualify.

Another suggestion would be an operating interest adjustment loan in which the farmer would pay a portion of his operating loan interest with the remaining interest paid by the state. The farmer would pay back the state over five years with no interest.

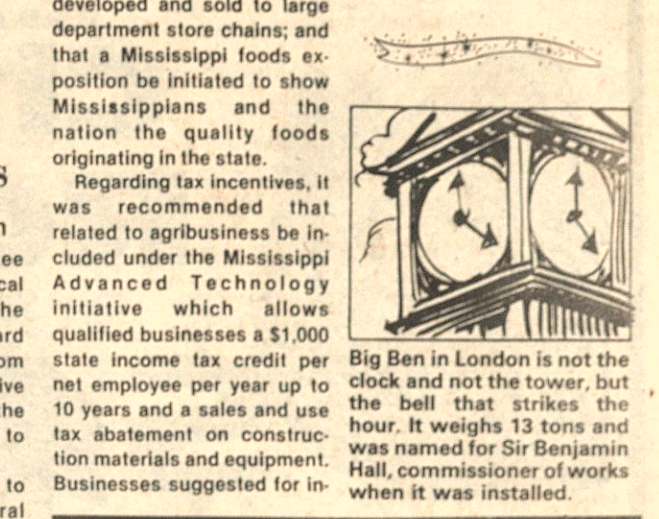
The proposal to promote specialty products centered around pooling the resources of several state agencies to identify agribusinesses of a specialty food and/or fiber

products nature in order to print a directory and a mail order catalog. Examples of specialty products include jams, jellies, juices, nuts, mixes, sauces, cured meats, furs, wool wreaths, native crafts.

It was also suggested that the state secure exhibition space at major food and gift shows to promote the products; that a promotional package centered around a theme of hospitality, food and other products be developed and sold to large department store chains; and that a Mississippi foods exposition be initiated to show Mississippians and the nation the quality foods originating in the state.

Regarding tax incentives, it was recommended that related to agribusiness be included under the Mississippi Advanced Technology initiative which allows qualified businesses a \$1,000 state income tax credit per net employee per year up to 10 years and a sales and use tax abatement on construction materials and equipment. Businesses suggested for inclusion were meat packing plants; sausage and other prepared meat products; condensed and evaporated milk; canned and preserved fruits and vegetables; cereal and breakfast foods; fats and oils; malt beverages; canned and cured fish and seafoods; soybean processing facilities; and cottonseed nuts and cottonseed flour.

The MCES suggests including only those industries which would not normally locate in Mississippi.
