The job of constable is not a job that should be taken lightly. When you have papers that need to be served, you don't want to wait four or five weeks for someone to serve them. I promise you that IF I am elected to this office that my first priority will be to get your papers served and served quickly.

After accomplishing that, my duty will be to protect and serve the people of Tishomingo County. I don't care if you're rich or poor, what color you are, or whether you're a farmer or a banker, everyone will be treated with dignity, respect, and most of all equality. And I promise you that I will work with any law enforcement agency that requests my help.

I would be honored to lead the funerals in this county and this is not because it's the constables' duty, but rather, out of respect.

Anytime that any of you people need my help, I will do my best to respond. There's no way that I'll tell you that I'll be available 24 hours a day because it's physically impossible. If elected I will publish a number for you to call. If it's an emergency please give me the number of the county road that you live on. This simple act in itself could possible save someone's life.

Two great concerns of mine are our children and the handicapped. If catch your child breaking the law, and by this I mean a misdemeanor, I will bring the child home. Then we'll all sit down and discuss the situation and try to solve the problem. Jail is no place for a teenager. I believe that it only gives them contempt for the law later on in life.

As for the handicapped, they've been getting a raw deal for quite a while and I can identify with these people because I lost a leg in the Vietnam conflict. It's time that normal healthy people realize that these handicapped parking spaces are tere for a reason. And if I am elected I am going to put an end to this illegal parking. Either that or it's going to get awful expensive for the people who abuse this law.

I know that I didn't get to see each one of you personally due to the shortness of time before the run-off but I respectfully ask you for your con-

Can Tishomingo and Alcorn counties afford to wait until the year 2004 for a new member of the Legislature from this district to gain seniority and experience? We don't think so. Belmont First Baptist To Dedicate Sanctuary

On Sunday, October 6, at 3:00 p.m., Belmont First Baptist Church will dedicate its newly renovated sanctuary, the first major renovation since the present sanctuary was completed in 1954.

According to a church history compiled by Jerry McAnally, the church was organized in 1875 as Ebeneezer Missionary Baptist Church. The first building was damaged or destroyed by fire and was rebuilt on the same site. By 1899, Ebeneezer had 55 members. The first pastor was W.W. Gilbert

On September 11, 1909, the church

primarily built under the leadership of Mr. Olen Yarber. Due to the depression construction on the building was slow, and it was not completed until 1939.

Again quoting Mr. McAnally, "On the first Sunday of December, 1950, a mid-morning fire totally destroyed the building that was barely 10 years old." Service were first held in the Belmont Courthouse, then in the basement of the burned structure until the new building was completed in 1954.

Monitor young trees for aphids and mites, and spray when necessary. **BLUEBERRIES**

Keep blueberry plantings watered and weed-free. Remove any dead or broken branches by selective pruning into live, healthy wood.

If you don't have blueberries in the landscape, consider planting several bushes. The planting season runs from December through February. The earlier in the planting season bushes are planted the better. Proven varieties are Climax, Premiere, and Tifblue. Climax ripens around June 1, followed by Premiere June 15, and Tifblue extending until July 15-20.

Research shows that plants deficient in potassium are more susceptible to freezes than are plants with adequate potassium. Plants over-fertilized with nitrogen with resulting escessive cane growth and a delay in the plant hardening off in the fall are predisposed to winter injury.







EFFECT OF DIABETES **ON VISION**

Even if you have only a mild case of diabetes, one that can be kept under control through diet and exercise, you should be constantly concerned about your vision. Those who have diabetes are more vulnerable than people in general to such eye diseases as cataracts, glaucoma, and disorders involving the cornea.

Another problem commonly associated with diabetes is diabetic retinopathy. In this disease tiny blood vessels that nourish the retina are damaged and may leak. This causes the retina to swell, resulting in blurred vision. Like many other eye diseases, however, this can be treated and loss of vision can often be prevented if it is detected early enough.

Protecting the health of your eyes and making sure you have the vision correction necessary to see well are two good reasons why you should have your eyes examined regularly. If you haven't had your eyes checked recently, make an appointment with your eye doctor now.

RAID NETS 38 MARIJUANA PLANTS

The Tishomingo County Sheriff's Department confiscated 38 marijuana plants Monday. The plants ranged from 3 to 12 feet in height and had an estimated street value of \$48,000. The Sheriff's Department had the plants under surveillance for 5 to 6 weeks when hunters walked upon the plants. At that time the department decided they could not wait any longer risking the plants being harvested. They raided the property located in the Midway Community between 2:30 to 3:30 Monday afternoon.

The marijuana had been well maintained with chicken wire around it. The plants were pulled up and taken to the county jail. Officers participating in the raid were State Parole Officer Mike LaRue, State Trooper, Jerry Boyd, County Officer Joel Holliman, Sheriff Richard Dobbs, County Officer Mike Higginbottom and Officer Raymond Vaughn.

Dennis Couple **Arrested On Drug Charges**

According to Tishomingo County Sheriff Richard Dobbs a Dennis couple, Jerry W. Ables and his wife Ellaween Ables were arrested Thursday night September 26th. The suspects were charged with possession of marijuana, over a kilogram, with intent to sell. Ellaween Ables additionally was charged with conspiracy to sell marijuana.

The arrests were made when authorities executed a search warrant on their home between 9:00 p.m. and 10:00 p.m. Tishomingo County Sheriff Richard Dobbs said, "Seized in the raid were \$404.00 in cash, about 51/2

Ibs. of marijuana and three firearms. Mrs. Ables made a initial appearance Friday morning before Justice Court Judge Willie Joe Sparks, who set bond at \$25,000. No bond had been set for her husband late Friday

Jerry W. Ables was arrested in July 1990 on charges of manufacturing marijuana, Dobbs said. He was sentenced to 15 years in prison but the term was suspended pending good behavior, court records show. If convicted this time the suspension would be revoked and he could face the full 15 year term in prison.

The Sheriff's Department was assisted in the raid by the Mississippi Bureau of Narcotics, North Mississippi Narcotics Division and the Tupelo Police Department SWAT Team and K-9 Unit.



NOW IT CAN BE TOLD (The Secret of fall Colors)

Few sights satisfy the soul of Mississippians like the brilliant colors splashed across our hardwood forests each fall. Refusing to slip quietly into winter, Nature marches out with great fanfare, trumpeting the bright oranges, purples and yellows of Sweetgum, blaring the gold and rusty browns of hickories and blowing sultry notes acros the landscape in the deep scarlet of red oaks and black gums.

Ever wonder what determines what color tone is assigned to a particular tree? About how the color change is triggered? According to the experts the secret is in the sap. The chemical composition of each tree's sap provides "instructions" on what fall color its leaves should turn.

The amount of iron, magnesium, phosphorus or sodium in the tree, and the acidity of the chemicals in the leaves determines whether the tree turns amber, gold, red, orange, purple, or just fades from green to brown. For example, scarlet oaks, red maples, and sumacs have a slightly acidic sap which causes their leaves to turn bright red. On the other hand, the leaves of some varieties of ash, growing in areas where limestone (alkaline) is present, will turn a regal purplish-blue. Sweetgums can be spectacularly multi-colored or almost a solid purple, depending upon the soil they stand on.

What triggers the change? Popular myth credits Jack Frost with orchestrating the color transformation, but in reality, the thermometer has little to do with it. The answer lies in the shifting rhythm of day and night. As the days grow shorter and the nights longer, a chemical clock inside the trees starts up, releasing a hormone right) Melissa Wilson, president; Shonicie Parrish, vice-president; Craig Middleton, secretary; Jason Wigginton, treasurer; and Melody

which restricts the flow of sap to each leaf. As autumn progresses, the sap flow slows and chlorophyll, the chemical that gives leaves their green color in the spring and summer, disappears. The residual sap becomes more concentrated as it dries, creating the colors of fall.

In a way, the green hue of spring and summer masks the promised beauty of the fall leaf, as a child's black crayon covers the bright colors underneath on a scratch board art project. Then, when the green chlorophyll withdraws at a chemical signal, the brilliant beauty of the fall color is revealed.

Autumn leaves are not merely pretty. As leaves die and fall to earth, minerals that were taken up into the tree return to the soil. Mammals, insects, fungi, and bacteria on the forest floor help decompose the leaves, releasing their nutrients to growing plants and trees, and adding organic material to the soil.

Even as this year's leaves fall, next spring's leaves are tightly wrapped in buds. When they unfurl next March and April they will replenish the air as they absorb carbon dioxide and "exhale" oxygen.

It's a far less dramatic event than with hardwoods, but Mississippi's pines also lose their three-year-old "leaves" or needles, in the fall. And each spring, tender green shoots grow at the end of the pine limbs in a cycle of renewal.

The renewal of fall's color reflects the renewal of our forests. Just as the trees prepare themselves for spring by putting forth buds, we foresters prepare the future generations by planting forests. And as our forests flourish, we will have ample forestland for recreation and timber needs, and plenty of opportunities to enjoy the glorious colors of autumn.



October Designated As Crime

Prevention Month

October is Crime Prevention Month, a time to highlight local crime prevention needs, concerns and activities.

"Polls show that the crime problem is in the forefront of concerns among Americans," said Herbert Terry, director of the Mississippi Department of Public Safety's Division of Public Safety Planning. "Traditionally, crime prevention has been thought of as a problem for the police. But it's everybody's problem and cooperation is necessary to improve the safety of neighborhoods and cities."

Crime Prevention Month was designated by the Crime Prevention Coaliticn, a national coalition of crime prevention programs. Exercise Can Play Role In Lowering Cancer Risk

While a great deal of research has shown that staying fit may help fight heart disease, new research reports are indicating that physical fitness may also offer a defense against some forms of cancer. In presentations at the American Institue for Cancer Research's 1991 Research Conference in Washington, D.C. last week, several researchers reported on findings showing reduced cancer risk as the result of exercise programs.

A study by Dr. Ralph Paffenbarger, Jr., of Stanford University has found a lower incidence of colon cancer among alumni of Harvard University who reported being the most physcially active. Like most human studies, not all dietary and other

who exercised at moderate to high levels, and maintained that level of physical activity over a long period, the potential was there for a 25 to 50 percent decrease in colon cancer risk

Dr. Leonard Cohen of the American Health Foundation in Valhalla, New York, reported his studies had also shown that exercise seemed to have a protective effect against certain cancers. In laboratory studies Dr. Cohen found that when the animals he studied were allowed to exercise, there were significantly lower numbers of tumors, despite the type of diet the animals were being fed. Most studies have found that high fat diets encourage tumor growth, and population studies find that countries with diets high in fat also have high rates of breast cancer.

Studies by Dr. Henry Thompson of the AMC Cancer Research Center in Denver found that there may be an exercise threshold which can offer a protective effect against cancer. His laboratory studies found that when animals were exercised vigorously for sustained periods there were significant reductions in the number of tumors.

While Dr. Thompson cautioned that his studies to date have only been with research animals in the laboratory, he expressed hope that there soon may be research which could give people patterns of exercise that might provide protection against cancer. He noted that this could offer help for those who find it difficult to switch to a low fat diet, the current advice for lowering risk for many cancers. He also indicated that such studies may find that exercise types and levels may be different from those currently recommended for general fitness. The American Institute for Cancer Research's 1991 Research Conference brought together almost two hundred cancer researchers studying the

links between fat, calories, exercise and cancer. The Institute is the only national organization which focuses exclusively_on the link between diet and cancer

Start The School Year With Good Study Habits

For some, studying is a pleasant experience. Some students have even called studying a fun experience. But for many, studying is a chore and No. 1 on the list of things to do -- later.

The beginning of a new school year is a good time for students in the last category to develop study habits that will enhance learning and make studying less of a chore.

Dr. Ann Jarratt, youth development specialist with the Mississippi Cooperative Extension Service, said concentration, organization and time management are necessarv ingredients in a recipe for studying success.

"Without concentration, students may deceive themselves into thinking they are learning when, in fact, they are looking at the words or problems, but learning is not taking place," Jarratt said.

"Lack of concentration may be caused by a conflict between what one wants to be doing and what they feel they must do," she said. "If students are trying to read 'X' number of pages so they can go out on a date, chances are they are concentrating more on the date than on understanding and remembering what they are reading.

Jarratt's suggestion is to study as if there was a test at 7 p.m. instead of a date.

Students should study at a desk or table in a quiet room in a comfortable straight-backed chair. Sitting in front of a TV is a bad choice, as is sitting on the bed where the student is much more likely to get sleepy. Good lighting also is important.

"Know what you will study first and about how much time you will spend on that subject," Jarratt said. "A good rule of thumb is a minimum of 30 minutes per subject -- more if you have special assignments or feel you're having trouble keeping up."


Other hints include developing, writing down and following a study schedule. Students should schedule study time for the hardest subjects when they are most rested and their mind is fresh.

Schedule a break after about 50 minutes of studying. About 10 minutes should rest mind and body. Scan reading material for main

Cooking Corner Tips To Help You

Great baking can be easy with the help of fresh California summer fruits. Fresh California peaches, plums and nectarines find their way to market in May through September with peaches in the market until October. Bartlett pear season is from mid-July into November. Select fruit that is full-colored for its variety and firm except for a slightly soft tip end-a good indication of ripeness.

Fruits can be ripened to the peak of eating perfection by putting them in a loosely closed paper bag at room temperature. Ripened fruits are best stored in the refrigerator until ready to eat-slightly chilled, juicy and delicious.

FRUIT BASKET PIE

Pastry for double-crust 9-inch pie 1/2 cup sugar 1/3 cup flour 1/2 teaspoon nutmeg 1/2 cup half-and-half 3 medium fresh California peaches, sliced (2 cups) 5 medium fresh California plums, sliced (2 cups) 3 medium fresh California nectarines, sliced (2 cups) 2 medium fresh California Bartlett pears, sliced (2 cups) Milk Sugar

Line bottom of 9-inch pie plate with 2/3 the pastry. In bowl, combine sugar, flour, nutmeg and half-and-half; add fruit; toss thoroughly. Pour into pie shell. Cut remaining dough into strips; make lattice top. Brush pastry with milk; sprinkle with sugar. Bake in 425°F oven 45 to 50 minutes or until crust is golden brown and fruit is tender. 8 servings.



Superior Home Health/Hospice is a division of Magnolia Hospital in Corinth. During its 12-year history, home. Home care allows the patient to remain at home while receiving quality, professional health care. The services may include skilled nursing, physical therapy, medical social services, speech therapy and home health aides in the home. 

Exercise-Induced Asthma and Athletics

More than 10 million Americans or about four percent of the U.S. population have asthma. According to a recent article in Phar. macy Times, one in ten persons with asthma suffers from a condition referred to as exercise-induced asthma (EIA). EIA can affect an otherwise healthy individual, resulting in serious breathing problems. This can be troublesome for highly active individuals, including athletes - amateur and professional.

EIA is a health problem that is receiving a lot of attention because it affects one of our most vital functions-breathing. Typically, after three to eight minutes of vigorous exercise, EIA causes the air passages leading to the lungs to constrict. Constriction may be mild or severe. Severe constriction of air passages interferes with the normal exchange of oxygen and carbon dioxide in the lungs.







Newman sent out letters recently to some 60 well-heeled business and professional men as potential financial contributors, endorsing Bryan for re-election and praising him as the type legislator the state needs to 'establish sound priorities beneficial to this and future generations.

Newman, who apparently still has symbiotic ties to BIPEC, urged that election of such legislators as Bryan was essential to "maintain a good business climate" needed for economic progress of the state.

Significantly, McBride is pointing out to voters that while he was working aggressively to bring in new jobs with the Panola County Industrial Development Foundation, Bryan was nowhere to be found. Meantime, Bryan, an ex-radio announcer, is sniping at McBride in early morning radio spots aimed at rural folks. In one, Bryan says McBride and his wife "eat gourmet meals."

In Northeast Mississippi's Senate District 4, vacated by Sen. Irb Benjamin of Rienzi, Mississippi FIRST-backed JoAnn Biggers, a long-time teacher at Corinth

High School and community worker, captured 45 percent of the vote in the first primary, 10 points ahead of Alcorn County Supervisor Travis Little, who has the support of BIPEC. They face each other in a hotly contested Democratic runoff Oct. 8.

Travis Little is the youngest of four brothers who have been part of what is regarded as the "Little machine" in Alcorn County politics dating back some 30 years. The Littles had been closely allied with the late Sen. James O. Eastland and the late Gov. Paul B. Johnson Jr.

Two of the Littles - Thurston and Bobby — have been sent off to federal prison in recent years for crimes related to receiving or giving bribes. Both the other brothers -Harold and Travis - have been in the toils of the law on civil matters.

Bobby Little was snared in the FBI's "Operation Pretense" in 1987. Thurston Little was sentenced to serve 10 months and pay a \$10,000 fine in a 1989 bid-rigging scheme.

Former Alcorn County Supervisor Harold Little was hit with a demand by then-State Auditor Ray Mabus in 1985 to repay

\$567,950 in misappropriated county funds. Harold did not run for re-election in 1987. The state State Department of Audit says the demand has never been paid.

Travis Little, who was elected a supervisor in 1987, is president of a construction company, which in 1988 was accused in a federal civil lawsuit of paying \$180,750 in kickbacks in connection with FMHA lowincome apartment projects in Northeast Mississippi. Little's company in May 1990 repaid \$72,000 in an agreed settlement with the government.

BIPEC President Liles Williams said the group gave its endorsement to Travis Little in the Senate race based on the recommendation of the local business community and Little's answers to a questionnaire.

Meantime Biggers, the ex-wife of U.S. District Judge Neal Biggers, is campaigning as an advocate of changing the rules in the state Senate to trim the powers of the lieutenant governor. Little, on the other hand, is saying that he is a good friend of Lt. Gov. Brad Dve and is assured of choice committee assignments from Dye.

GRAZING RESTRICTIONS LIFTED The Agricultural Stabilization and conservation Service OPENED the official grazing period October 1, 1991 for acreage conservation reserve (ACR), or land designated as conserving use (CU) for payment under the 1991 acreage reduction programs. Farm program participants are now authorized to graze their ACR and CU acreage.

and a The acreage reduction programs prohibit farmers from grazing ACR or luals a CU for payment land during the 5month nongrazing period set by the /ernma State ASC committee. The nt shou nongrazing period in Tishomingo e have County runs from May to September ur state 30.

Under the 1991 programs, 968 acres of Tishomingo County cropland needst were diverted from production to the cive to ACR and CU for payment. These acres have since been planted to cover crops such as grasses, legumes, small grains or put into approved conservation pratices.

> Now that grazing restrictions have been lifted, farmers should not overgraze the acreage so as to mainin sufficient cover to prevent wind and water erosion. Farm program participants are also required to carry out adequate control measures on idled cropland to prevent weeds, rodent and insects. To maintain farm program benefits, producers must comply with grazing and conservation regulations as



Soldiers Memoralized On Anniversary

A memorial ceremony was held on the morning of September 19th to mark the 129th anniversary of the Battle of luka. 1t was held at the Confederate Trench in Shady Grove Cemetery where 263 of the battle's confederate dead were laid to rest. The group attending the ceremony consisted of students from the PEEP Class at luka Middle School who worked on a cleaning and restoration project with the trench last spring. Also in attendance were representatives of the luka Chamber of Commerce, the Tishomingo County Courthouse Museum, and period reenactors who took. part in the ceremony. Fresh cut flowers were donated by Mr. and Mrs. Wayne Oaks.

A short speech was made to mark the occasion by Christian Evans. The students, with teacher Edna Murrah and Chamber of Commerce representative Bette Nelson watched Confederate reenactor Jon Riley standing at attention while Jenny Stalsworth, dressed in beautiful antebellum attire, placed a basket of fresh golden flowers at the head of the trench.

It was a brief yet fitting memorial to honor those who fought in the Battle of luka, the bloodiest little battle of the Civil War.

pting to lead his forces down the Fulton Road when Rosencrans attempted to cut him off from the Southwest.

Price suffered heavy casualties, yet still managed to take his men south in order to divert the Union Forces from the Memphis & Charleston Rail Line that runs through the town. The rail line here has switched hands several times thus far in the war. Grant is hoping to keep the line secure and eventually take the key city of Corinth to the West. The Federal Troops advanced in order to capture 9 Confederate Cannons. The rebels abandoned them in their hastened departure.

The cannons have been turned toward the city where a barrage of shots have been fired causing an undetermined amount of damage. Reports by local sources indicate that several homes sustained holes in their roofs.

Reports also indicate that General Little of Maryland, was killed. Confederate soldiers buried him at the home used as his headquarters. Little and the other casualties numbered between 1,000 and 1,500 dead or wounded.

Many homes, churches and hotels here are being used as hospitals. The Blythe Hotel was burned by Union forces as well as some of the homes during the ordeal today.

Uncomfirmed reports indicate General Grant was conspiciously absent from the battle. He is rumored to have been drunk at the time of the battle at a railroad station only eight miles away in Burnsville. Grant arrived after the battle in a vain relief effort. Grant claims he did not hear the battle due to "wind direction".

This battle appears to have been a northern victory. From an objective standpoint, the thirteen regiments and one infantry company fought a battle that can only be classified as a draw.

Thinking about this, I put on my Confederate Uniform and went to my neighbors, the Oakes, who helped me fill a flower basket. I then met Mrs. Edna Murrah at the luka Elementary School and went to pick up the new Middle School PEEP Class that helped in a cleanup project of the Confederate Trench in Shady Grove Cemetery, which was our final destination.

We were met there by Mrs. Bette Nelson from the Chamber of Commerce who also serves on the luka Preservation Commission set up by the Mayor in 1989. They are attempting to place a marble marker on the trench when a pedestal is built to support the slab. Jon Riley and Jenny Stolsworth also met us there. Jon served as Honor Guard for the ceremony in a Confederate Uniform while Miss Stolsworth, who was also in period antebellum clothing, was given the honor of placing the basket of golden flowers to memoralize the unknown 263 soldiers buried in the trench. We unfurled the Stars and Bars, then gathered near brick lined

trench to begin the ceremony. I made a brief statement about the purpose of marking the day. Afterward, I asked all to bow their heads

He suggested that in addition to the long-range planning that must be done, we should select projects that are attainable in a reasonable short period of time that newcomers can see and be convinced that luka does care and we are committed to community improvement. "In talking with chamber members, several attainable goals were suggested, including improvements to Jay Bird Park, supporting Heritage Day, more Christmas activities, beautification and industrial appreciation," Nerren said.

Nerren concluded by emphasizing that if we are successful, we must demonstrate that all of the communities in Tishomingo are working together to provide an environment where families will want to live. "It is essential that we work together in improving the educational, shopping, residential, cultural, religious and social atmospherre if we expect to attract more people to live in our area,' he said.





Particpants Exchange Ideas Of Opportunities Of Tenn-Tom Waterway

A full complement of speakers and participants spent the better part of two days exchanging ideas across the broad spectrum of recreation and tourism opportunities along the multi-state Tennessee-Tombigbee Waterway Corridor.

Over 75 professionals and interested entrepreneurs, representing over 47 communities from at least four states, participated in the meeting at Pickwick Lodge sponsored by the Tennessee-Tombigbee Waterway Development Authority and the Tennessee-Tombigbee Waterway Development Council in cooperation with Tennessee Valley Authority and Appalachian Regional Commission. Also assisting was the Hardin County Chamber of commerce Economic Development Program, Savannah, Tennessee.

initiative as presented by one of the authors of the concept, Glenn Weaver of the University of Missouri. He said he expects the new effort with result in establishing a strong national policy on tourism with heavy emphasis on rural America. Mr. Weaver expects that funding for demonstration programs will be provided through a number of agencies, including most of the federal and state arms that are usually related to agribusiness development. He also forecast the establishment of tourism development areas, similar to national recreation areas, with

economically deprived areas. Afterwards, Mr. Donald G. Waldon,

recreation and tourism opportunities; and that each preceding conference has resulted in significant cooperative steps in recreation and tourism development throughout the Tenn-Tom Corridor.

Dr. Martin Darity, on intergovernmental agency loan from the Small Business Administration to head the Alabama Advantage for Retirees Program set the stage for the entire conference by projecting ahead to people the wishes and needs of the average tourist/recreationist of the year 2000. He assured listeners that over the next two decades businesses will exist in a "mailbox" economy with every transaction handled by mail or computer. He called tourism the "recession-proof" industry of the 21st Century.

Bill Owens, Senior Vice President of Economic Research Associates (ERA), further confirmed Dr. Darity as he led a frank and spirited discussion of tourism in the Tenn-Tom Corridor. Earlier this year, Mr. Owens led a study team sponsored by the Tenn-Tom Waterway Council to assess opprortunities for tourism development in the Tenn-Tom region. ERA, a well respected Washington, D.C., area firm specializing in tourism development, includes, among its clients, Marriott, Six Flags, the U.S. Travel and Tourism Administration and the States of Georgia, Maryland, West Virginia and Indiana.

Mr. Owens presided over a full panel discussion of such specific issues as Development of Regional Attractions, Activities and Accommodations; Campgrounds as a Sourspecial emphasis on rural ce for Revenues and Local Jobs; Marina Development and Related Amenities; Capitalizing on Organized Members of the panel included: Mr. Council and the newly formed Tenn- Tom Davidson, Principal and Chief of the goals of the rural tourism Douglas Blom, Publisher, Heartland

Between the Lakes Association, Golden Pond, Kentucky; and Ms. Barbara Staff, Executive Director, Historic Rugby Association, Rugby, Tennessee

Leading off the second seminar was a discussion on developing regional tourism through cooperation, moderated by Gordon Nichols who serves on the staff of Lt. Governor Brereton Jones of Kentucky, and is the Lt. Governor's representative on the Board of the Tennessee-Tombigbee Waterway Development Authority. Ray Kisiah, Sr., head of Asheville, North Carolina's award winning Parks and Recreation program, talked about the success of the Mountain Outdoor Recreation Alliance of North Carolina. He noted the importance of cooperation on the local and regional level between tourism officials and parks and recreation professionals to total program development.

Ms. Carolyn Denton, Director, Mississippi, Columbus-Lowndes, Convention and Visitors Bureau, commented on the successful formation of the Tenn-tom Tourism Association, which held its first annual meeting immediately prior to the start of the conference. Ms. Denton. who has been instrumental in organizing the group, was elected President at the Meeting. As part of her presentation, she displayed their new brochure entitled "City Sidewalks and Country Roads", which, while produced by the Colum**bus-Lowndes Convention & Visitors** Bureau, crosses not only county lines, but also state lines. She observed that tourists have not interest or concern with such legal boundaries but are affected by the total tourism experience, regardless of state or county.

Ms. Sherry Elmes, Director of Sales, Touch Information, Inc., Chattanooga, Tennessee, explained the function of the East Tennessee Tourism Council and its varied activities.

"Marketing Tourism on a Shoestring Budget" was a topic that drew rapt audience attention. Sylvia Higginbotham, Higginbotham Communications, Columbus, Mississippi, led off by discussing ways to capture the attention of magazine and travel writers. A well-known travel writer herself, Ms. Higginbotham explained how travel writer tours are set up and what approaches to take when writers visit your attraction. Ms. Brenda Thomas of Red Boiling Springs, Tennessee, gave the group insight into how to use innovations to develop a totally unknown property, without benefit of budget, into a tourist destination - a magical feat she has performed for Red Boiling Springs.

He offered the Center for Southern Culture, located at the University of Mississippi, as a nationally recognized resource. It is the only such center in the country.

Dillsboro, North Carolina, Town Clerk, Herbert Nolan, provided insight into development of a small town downtown business district into a shopping destination attraction for tourists.

Dr. Margaret Wyde, Director, Advanced Living Systems Division, and Vice President, Institute for Technology Development, Oxford, Mississippi, presented a segment on targeting the mature market for tourism growth. She noted that not only are the over 50 age group the fastest growing population segement, but they also have the most discretionary money and the leisure time to spend it.

The importance of recreation, tourism and cultural pursuits to industrial development peaked interests as Dr. Joria Turnipseed and Dr. Charles Campbell of Mississippi

In addition, there may be a northward migration of the earth's vegetation as once-temperature climates warm, allowing tropical and temperate species to flourish further north.

The greenhouse effect is increased, according to some scientists, by deforestation via the "slash and burn" method - currently being utilized on a widespread basis in the tropical rainforests to convert forest land to agricultural uses. Forest clearing on this sale adds large quantities of carbon dioxide to the atmosphere.

Although few scientists dispute the likelihood that increased concertrations of greenhouse gases will result in rising temperatures, the big question is how much of a rise will occur, and when. Some have cited evidence of dramatic temperature increases of up to one degree Fahrenheit since the turn of the century. Some experts theorize that the greenhouse effect can be offset or delayed if more of the atmosphere's carbon dioxide can be e consumed of converted. They point out that trees are nature's most efficient converters of carbon dioxide to oxygen. Forests act as giant carbon dioxide converters and storers. Scientists calculate that for every ton of wood a forest grows, it removes 1.47 tons of carbon dioxide from the atmosphere and replaces it with 1.07 tons of oxygen. A tree's ability to convert carbon dioxide to oxygen largely depends on that tree's age and health. A young, vibrant forest is a veritable oxygen factory. But as the forest ages, the conversion ratio slows and eventually reverses itself. As older trees begin to die, they release stored carbon

dioxide.

potential contribution, particularly in an urban setting. Planting more trees in cities can help reduce the "heat island" effect by producting shade, thus dropping both the temperature and cooling costs.

In Mississippi we have an outstanding reforestation and forest management record. Our private forest landowners plant an average of about 60 milion seedlings per year, covering tens of thousands of acres. These future forests can consume up to one-quarter million tons of carbon dioxide per year.

If other states and countries will practice sound forest management and follow our example of regenerating forests the earth's ability to consume carbon dioxide will be tremendously increased. Senator Cochran, a member of the Defense Appropriations subcommittee, said the level of Fiscal Year 1992 defense spending in Mississippi is higher than last year.

"Defense spending contributes substantially to the economy of the Mississippi," Cochran said following the panel's meeting.






