Former Iuka City Employee Leads Guilty

Minutes before a jury was to hear the trial of former Iuka city employee Jeannie Deaton, she pleaded guilty to eight counts of embezzlement and agreed to pay the city a total of \$62,500.

The case was scheduled to be heard by a jury and Circuit Judge Thomas Gardner last Wednesday, June 12, 1996, in Tishomingo County Circuit Court.

Deaton was sentenced to 20 years in prison, but Judge Gardner suspended the time pending restitution and satisfactory completion of five years' probation. She was also fined \$500, and at the request of the state, she was ordered to pay \$200 for the cost of calling a jury panel.

Deaton's bonding company has already paid \$10,000 to the city. According to the court order, she must repay another \$15,000 by June 21 and \$420 each month until the entire \$62,500 is repaid.

Should she fail to make any payment, she could be ordered to prison to serve the 20-year sentence. Iuka City Attorney Mike Cooke and Mayor David Nichols agreed to the settlement on behalf of the city.

"The city of Iuka always maintained that full restitution should be a part of any settlement. This insures full restitution to the citizens of Iuka," said Mayor David Nichols in a statement. The city is pleased with this settlement and feels that it is proper under the circumstances."

Deaton formerly worked as a utilities clerk, taking payments for gas and water customers. It was discovered in September 1994 that funds were missing from the department. The embezzlement occurred over a two-year period.

Local Authorities Increase Patrols Following Burning Of Kossuth Churches

While these church burnings have been happening all over the South, northeast Mississippi had been spared up to now.

"This has a different meaning when it strikes this close," said Rev. Robert Powell, a resident of Carter's Branch Community near Tishomingo, who pastors Mason-St. Luke Baptist Church in Corinth. Mason-St. Luke is in the same church association as Mt. Pleasant. "We hope who ever is responsible is brought to justice," Rev. Powell said of the fires.

Tishomingo Co. Sheriff David Smith said he is working with other local law authorities to step up surveillance of any areas he feels there may be trouble and urges congregations to keep an eye on their own as well.

Though no motive, cause or even suspects are known in the Alcorn Co. fires as yet, the incidents are especially shocking, considering the relatively good racial relations in the region.

"There is a good atmosphere between races here," said Powell.

But many fear the national attention on the region and anticipate the negative "Mississippi Burning" type publicity. National media will probably not mention much about the racial harmony that exists throughout the region.

Surely some of them will take note of the outpouring of community support for those devastated by the tragedy.

Local churches and organizations are already mobilizing to help resurrect these neighbor churches.

Two Alcorn County Churches Destroyed In Monday Night Fires

Two rural black churches in Alcorn County were destroyed by fire Monday night, in what is feared to be part of the series of black church fires that has plagued the South in the past 18 months.

The two rural churches, Mount Pleasant and Central Grove Baptist Church, are both near Kossuth, about 6 miles southwest of Corinth. The Mount Pleasant fire was reported at 9:11 p.m. on June 17, and an officer spotted the other fire on the way to Mount Pleasant, according to wire reports. The brick and wood churches were empty when the fire broke out.

An incendiary device was also found on the grounds of the Kossuth Church of Christ at 11 a.m. Tuesday by the pastor while he was mowing. A small patch of burned grass and pry marks discovered on the rear door of the church make this a third possible crime scene. The 30-member congregation is white.

The national media has focused a great deal of attention on the series of fires, and two other fires occurred the same day; one in a rural black church in Rocky Point, North Carolina, and another destroyed the sanctuary of a mostly white congregation in Pine Lake, Georgia.

The FBI and Federal Bureau of Alcohol, Tobacco and Firearms

agents were called into the investigation and Alcorn County Sheriff Jimmy Taylor ordered patrols for every other rural black church in the county.

Taylor described the fires as "extremely suspicious" because of the timing and proximity of the churches, according to wire reports.

"Two black churches burn the same night and they are not that far apart. It certainly makes you think it was arson," said Alcorn County Deputy Sheriff Bill Dillworth, who is a deacon at Mt. Pleasant.

Taylor has said that he suspects local individuals since the churches are so remotely located.

Alcorn County NAACP Chapter President Milus Copeland said that while it is possible that the fires were racially motivated, he believes it is more likely a copycat case because there have been few racial problems in the community.

President Clinton has mobilized federal agencies to help local authorities in their investigations of the dozens of church fires across the South since January 1995. There have been a total of 39 church fires in the past 18 months, according to Jim Cavanaugh, ATF Special Agent in charge of Alabama and Mississippi.

Ormet On Strike

Thirty-eight employees of Ormet Aluminum Mill Products Corporation walked off the job Friday at midnight when contract renewal talks broke down.

Production is shut down at the plant on Paul Edmondson Drive in Iuka and members of Local 206 chapter of the Aluminum, Brick and Glass Workers Union are set up outside the gates of the facility.

According to Local 206 President Troy South, the disagreement concerns insurance that was previously paid for by the company. Now the company wants hourly employees to use an HMO plan and to pick up the cost in paycheck deductions to the point where, says striker James Bates, "in four years we will be

making less than we are now."

Employees will also only be able to use Mississippi doctors, said South. Which is an issue in this tri-state, mostly rural region.

Many local people have said that the aluminum plant jobs are the best paying around, and the union members said that the reason for that is because of the union. The striking employees say that they have "worked smart to exalt this plant to its present position of second to none in the U.S."

The striking employees say that they are prepared to stay out "as long as it takes" and that at this time the company refuses to negotiate further.

Local plant officials would not provide comment on the issue.

Town of Burnsville Receives Grant

The Town of Burnsville has received a \$183,000 economic development grant, Governor Kirk Fordice announced recently.

The Burnsville grant will be used to construct an access road and provide water, gas and sewer services to expand Travis Brewer Trucking, Inc. The homegrown transportation company will invest \$745,810 in construction and equipment purchases, creating 44 jobs.

"I am delighted that the State of Mississippi can help Burnsville support the Travis Brewer expansion," Gov. Fordice said. "This addition will bring new job opportunities to Mississippians in the area."

Of the 44 jobs created, at least 51 percent will be for low- and moderate-income persons. The grant is issued through the CDBG program by the Mississippi Department of

Economic and Community Development (MDECD).

"Travis Brewer Trucking had its beginning in the Burnsville community and is no stranger to the people of this area," said Jimmy Heidel, MDECD executive director. "This expansion will continue to strengthen employment and may spark new job opportunities in ancillary services in the area."

"I want to thank Burnsville Mayor Bobby H. Johnson and others at the local level who provided the leadership to make this project a success."

The CDBG program provides funding to localities with populations of 50,000 or less for economic development, housing, public facilities and demonstration projects. The U. S. Department of Housing and Urban Development funds the CDBG program.

fish. Keep the cooler full. A full cooler will maintain cold temperatures better than a partially filled one.

If the trip is a long one that will include snacks, lunch and supper later, pack two coolers - one for short-term storage and one for your destination which will be intended for long term storage.

Preserve the Temperature. Preserve the cold temperature by replenishing the ice as soon as it starts to melt and by opening the cooler as little as possible.

Pitch Foods in Question. Throw away any perishable food that warms to temperatures above refrigerator temperatures (40 F). Bacteria that cause foodborne illness grow rapidly at warm temperatures and do not necessarily change the smell, appearance or taste of the food. So, it is doubtful - throw it out.

Protect Your Family. Keeping hands and utensils clean is one key way to protect you and your family from bacteria. If soap and water will not be available, pack some moist towelettes. Bag and set aside dishes and utensils to wash with hot soapy water when you reach your destination.

Enjoy lunch at roadside picnic spots often can be one of the very fondest memories of family trips. By keeping the five rules of traveling with food in mind, the risk of fond memories turning into vacation nightmares can be reduced greatly.

FSA Farm News

Price Support Benefits Linked To Production Flexibility Contracts

The one-time sign-up period for producers wishing to enroll their farms in a Production Flexibility Contract began May 20, 1996. The contracts, authorized by the Federal Agriculture Improvement and Reform Act (FAIR) of 1996, are for seven years, beginning in 1996 and ending in 2002.

According to Norris Faust, State Executive director of the Mississippi State Farm Service Agency (FSA), "except for land coming out of the Conservation Reserve Program, the sign-up ending July 12, 1996, is the only opportunity producers have to enroll in the program." Producers should remember that price support benefits on contract crops (cotton, corn, rice, grain sorghum, wheat, oats) are "linked" to

participation in Production Flexibility Contracts. Therefore, it is very important for all producers with contract crop acreage bases to consider enrollment no matter how small the farm's acreage base may be. Price Support benefits include Commodity Credit Corporation (CCC) loans, and loan deficiency payments.

"An example of this Faust said," would be a farm with a 3 acre wheat base. Should cotton be planted on the farm in future years, then in order for the cotton to be eligible for loan, the farm would have to be covered under a Production Flexibility Contract, for the 3 acre wheat base." Failure to enroll the farm by the July 12, 1996 deadline, will, in this case, make the cotton ineligible for any price support benefits at least


HEARTWORM DISEASE

Because this disease is often fatal, it is best to take the steps your veterinarian recommends to prevent your pet from getting heartworms. Heartworms are spread from dog to dog by mosquitoes. Your veterinarian can prescribe a heartworm preventive to be given as recommended. In the past, depending on your geographic location, dosage was limited to the beginning of mosquito season and continued two months past the first hard freeze. But with pets traveling with their owners to all parts of the country, many veterinarians now believe year-round heartworm prevention is the safest route. Heartworm preventive can be given once a month or every day as a treat. Ask your veterinarian which would be best for your pet.

through the year 2002. This provision applies to all farms with crop acreage bases, no matter how small, and is applicable to any contract crop planted in later years on the farm.

Faust urges all producers with questions concerning the enrollment of their farms in Production Flexibility Contracts to immediately contact their local FSA office.

There were 8 pontoon boats, 3 fishing boats, and 1 Run-About.


Judy Schaper, of Eastport Marina, supplied all attendees with a sandwich, chips, drink and a snack.

County Agents Notes

Tomato diseases are becoming a serious problem in the county this year.

The most common and the most serious seems to be "spotted wilt virus". This disease has many symptoms because the virus has several strains but the most typical symptoms are small, dark spots appear on the leaves around the top of the plant. These leaves may curl up and later die back.

Plants may produce fruit that are small and unsightly or produce no fruit at all. The fruit may develop irregular yellow blotches that have a "ringspot" appearance. Control is difficult.

The disease is mainly transmitted by insects called "thrips". A fungicide will not control this disease but these insects can be controlled by spraying with "malathion" or "Cygon" on a regular basis.

It is recommended that you pull up infected plants and get rid of them. The disease is not in the soil so you can replant. The disease overwinters and survives in weeds. Removing the weeds around the garden is recommended but is limited in value because thrips are small and can be blown by the wind for great distances.

Using a shiny mulch (aluminum foil or plastic sprayed with aluminum paint) can be helpful. Research shows that thrips have a hard time locating the plants because of the light reflection.

It is a good idea to include a fungicide with the insecticide for the prevention of other diseases because weather conditions thus far have been excellent for disease development. A good spray schedule is essential.

GROWING ALFALFA

Can you grow alfalfa in Tishomingo County? Absolutely--if you have deep, well-drained soil and you use proper management.

If you land is droughty, has restrictive layers in the top 3 feet, or stays wet during the winter and spring then you should probably stay away from alfalfa.

On good soils and proper management, stands can be maintained for several years.

The pH needs to be 6.5 or above. Get a soil test and follow recommendations but if a test is not available and no lime has been applied in the last few years then apply 2 tons of lime and 500 lbs. of 0-24-24 plus 2 lbs. of actual boron







Tishomingo Living Center Cited By State For Deficiencies; Takes Immediate Action To Make Changes

Tishomingo Living Center staff and administration are working with the Mississippi Department of Health and patients' families to correct several deficient areas found in a recent state inspection.

The Mississippi State Department of Health completed its annual state licensure survey of Tishomingo Living Center (TLC) on May 31, 1996, with several findings that require correction.

The report is posted at the TLC facility, according to administrator and part owner Carolyn Rollins.

"All nursing homes are subject to state inspection that accept Medicaid or Medicare payments," said Rollins in a Monday interview. "They are obliged to cite anything they find, and we are obliged to correct [deficiencies]."

"The state identified several," said Rollins. "We are still investigating everything they found, and looking at how we can take corrective action." She said TLC has hired some outside consultants to help in their assessment and correction plan.

They have filed a corrective action plan with the state and are now subject to another inspection, where the state will verify that TLC is working to correct problems.

One area of deficiency was too many restrained patients, according to the state. Rollins said

some patients are restrained for safety or support reasons, belted in their wheel chairs for example, often according to the family's request. But according to federal guidelines, safety alone is not a reason to restrain a patient and the person has a right to be free to fall.

"Getting up from a sitting position is not something one consciously thinks of," said Rollins. "If you have been standing up all your life, you don't always remember that maybe your legs don't work anymore." In cases like these the families often ask that the patient be restrained to avoid potentially dangerous falls, according to Rollins. TLC is working with families to do the best thing for the patient and remain within federal guidelines.

Another issue was a number of patients whose families have declined to let the TLC staff tube feed patients who are no longer able to feed themselves. In such cases, Rollins said, they just do the best they can to feed the patient. Federal guidelines state that if a patient does not make the decision himself, while he is competent to do so, and if no family member has been given medical power of attorney, the family cannot dictate what treatment the facility should take, said Rollins. This will allow the facility to determine what is best for the patient on an individual basis.

Deficiencies were also noted in the administrative area, Rollins said. "Required care plans or

resident assessments were not always done on the exact date required, although they were complete," she reported.

The state also cited various facility problems, but Rollins said that they have been working to correct the many problems the former Iuka Hospital facility has, since it was built in 1959. "We anticipated all the facility problems, and have been working on it since we bought the building in December 1994, but we are committed to renovating and utilizing this existing facility to benefit this community," Rollins

said.

Rollins, a licensed practical nurse and state-licensed administrator who has been in the business since 1963, went on to describe some of the many successes the Tishomingo Living Center has enjoyed since it started operation 18 months ago. They have served 188 patients in the past year and are committed to rehabilitating those who are able so that they can return to life in their own homes, with help from hospice nurses and family. She said the object is not to get full and stay full; if they did, they would then have to turn people away. The 44 full-time residents are those who require constant nursing care.

"We are committed to do whatever it takes to give quality care," Rollins summed up.


