David Nichols announces his candidacy for re-election as Mayor of the City of Iuka. In making the announcement, Nichols has these comments:

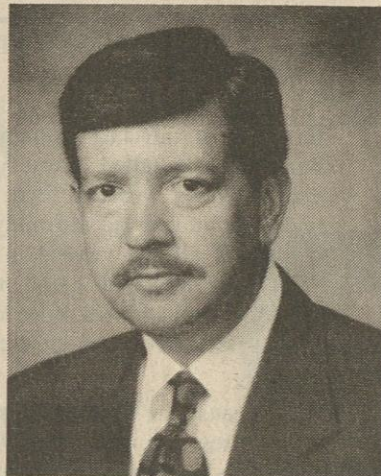

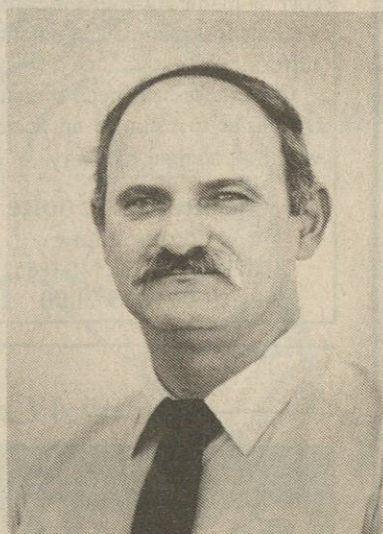
Ricky Smith Asks For Your Support In The Race For Iuka Alderman

Iuka Dixie Girls Softball Celebrate New "Field of Dreams" at Opening Day Festival This Saturday

One of the most outstanding examples in this county of what cooperation, dedication and hard work will produce will be open to the public for the first time this Saturday when the first games are played on the newly renovated Iuka Dixie Girls Softball field.

There are big plans for all kinds of fun and games in addition to the start of the season, according to Iuka Dixie Girls Softball League President Ed Kennedy. Beginning at 11 a.m. and ending with a special ceremonial first game under the new field lights beginning at 8 p.m., all 170 girls will reap the results of volunteer efforts of the past few months.

The Road to the Dream

Progress on the renovation began with the commitment of league parents to improve the facility. They pulled together and organized into an association with the stability that the Iuka City Board recognized back in March, when they agreed to fund proposed improvements to the park that is adjacent to the Tishomingo County Fairgrounds.

The league took over from there, taking the promised \$42,000 from the city of Iuka and fencing four fields, sowing grass, and adding lights. An agreement was reached with a local contractor, and a two-story concession stand and press box building, has been completed. An additional donation from Coca-Cola has provided four electronic scoreboards in exchange for the league serving Coke products.

All the renovation work started only about one month ago, and the field ranks right up there

with impressive boys' fields in the area. Most all of the labor was volunteer, and the total price tag was considerably less than \$42,000, said Kennedy.

Saturday's Festivities

There will be lots of food, Kennedy said. Volunteers are serving barbecue, hot dogs, hamburgers, homemade ice cream, and lots more.

There will be big kid games and little kid games, face painting, and some brave teachers have volunteered for a dunking booth, which alone could bring lots of people out. Just some of those agreeing to be dunked are Iuka Middle School Principal Benny McClung, IMS Basketball Coach Cindy Howie, Iuka Elementary's Coach Cain and Beth James, and from Tishomingo County High School, Malcolm and Lori Brown, and Vicki Bullard.

They also will have special "Field of Dreams" t-shirts for sale for \$10.

The official opening ceremonies are planned to begin at 7 p.m., and all the girls who have ever played in the league are invited to come out and be recognized, as well as past presidents of the league. All the current teams will be there for the opening ceremonies, national anthem and Iuka Mayor David Nichols will be throwing the first pitch for the 8 o'clock game that will be first one played under the new lights.

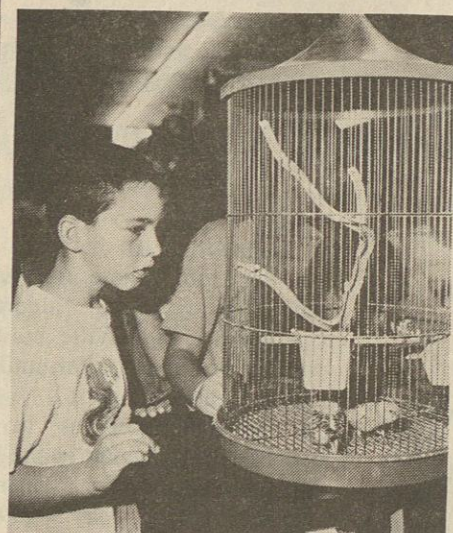

Volunteer Week

The week of April 27-May 3 has been proclaimed state-wide as a time to recognize Mississippi Homemaker Volunteers for the contribution they make to families and communities throughout the state. In cooperation with the

Cooperative Extension Service, members of MHV interpret and promote programs of importance in the protection and development of the home. Their mission is to strengthen families through programs of community leadership and continuing education, and to empower

citizens to participate in public decision-making on issues that concern children, families and home life.

Local clubs in Alcorn and Tishomingo Counties are involved in numerous activities that help to carry out this mission. Tishomingo County clubs have undertaken to renovate the old Midway School building as a community center for various groups. The Midway MHV Club is in the process of landscaping the grounds. Dennis Club keeps up an old and historic cemetery. Tishomingo club maintains a community park. Alcorn County clubs have landscaped a highway intersection, assisted with litter control and planted wildflowers. Five-Point club supports the local volunteer fire department; Town & Country assists the Abuse Center and two nursing homes in providing needed supplies.

Throughout the state MHV members are conducting a "Blue Ribbon Campaign" to fight child abuse, as well as a campaign to

promote child passenger safety through use of seat belts and restraints. These ladies (mostly, though membership is open to men) give freely of their time, energy and material resources to make our communities better places to live. Why not make a special effort this week to let them know that you appreciate them?

To elaborate on one of the MHV projects: Mississippi MHV members are cooperating with the Mississippi State Department of Human Services to recognize April as National Child Abuse Month. You may have seen someone wearing a small blue ribbon pinned to their lapel and wondered why? The blue ribbon was first used as a symbol of child abuse and neglect in Virginia in 1989 by a Chesapeake grandmother as a memorial for her 3-year-old grandson who was murdered by his mother's abusive boyfriend. The grandmother, Bonnie Finney, tied a blue ribbon on her own van as a reminder of the bruises of child abuse, and she recruited friends, neighbors, and finally the local child abuse prevention agency to do the same. The blue ribbon campaign was taken up by the Virginia Child Abuse Prevention Month Coalition in 1990, and has since spread across the country. Each year, hundreds of thousands of blue ribbons are distributed across the country by organizations who are interested in solving the problem of child abuse and neglect.

Now you know — and you, too, can become part of the solution. You can help by being alert to signs of child abuse. You can and should report suspected cases to authorities or agencies

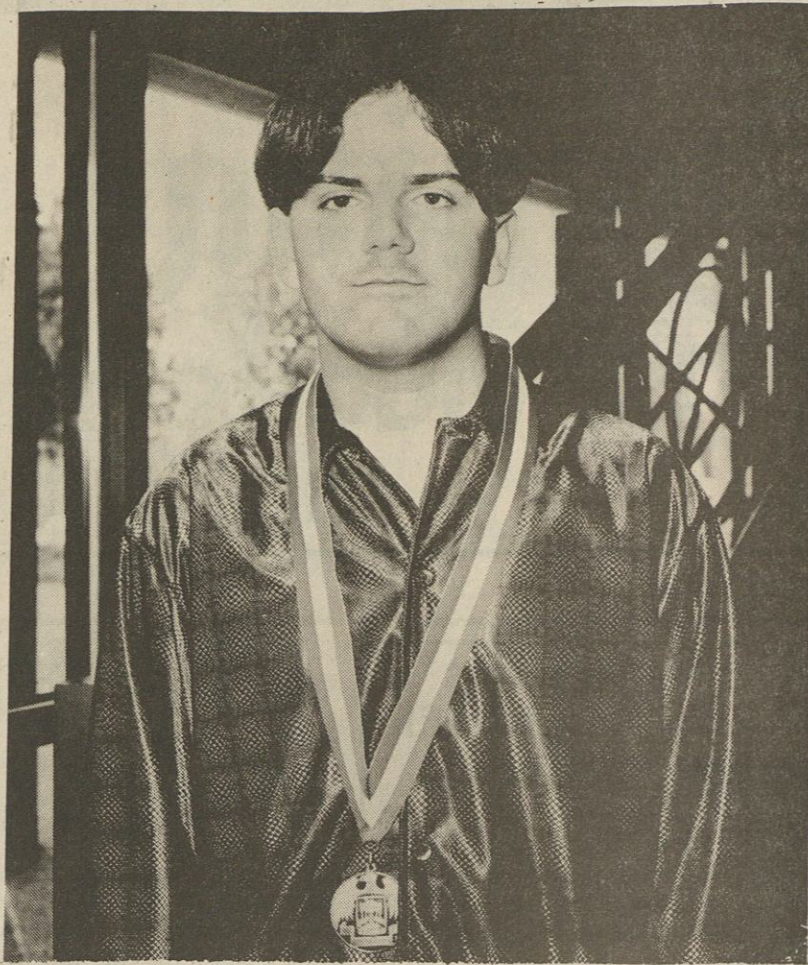


Dry Eyes

If you wear contact lenses and lately your eyes have seemed drier than they should be, ask your eye doctor what he would recommend to solve the problem. One thing you can do is to make sure your contacts are kept clean daily as well as with weekly cleaners. If the problem is in the cleaning solution, your eye doctor may recommend another type that would be more compatible with your eyes and at the same time eliminate the dryness.

Some contact lens wearers use special re-wetting drops to relieve dryness. Another alternative to consider is to have new contact lenses made from material that has better "wetting" characteristics. In other words, a different lens material may be more easily coated with tears so they feel less dry.

There may be other reasons for that dry feeling with your contacts. Whatever the reason, take the problem to the person who can give you the relief you need: your eye doctor.

that can help. Too often child abuse goes unreported because people who could help "don't want to get involved."

You must, however, use caution and good sense and remember that every parent makes errors in judgment and action at some times. Some signs to watch are: repeated physical injuries, very aggressive or very withdrawn behavior or neglected appearance of the child, super-critical harsh discipline by parents, and self-imposed family isolation.

Be aware that child abuse does occur, sometimes in outwardly "nice" families. So — do what you can, and call attention to the problem: TIE A BLUE RIBBON FOR THE SAFETY OF OUR CHILDREN.

Your Heart Is Important

Your heart is a muscle which pumps blood through your entire body continuously. Every day, the average heart beats 100,000 times and pumps over 2,000 gallons of blood. By the time you are 70 years old, the average heart will

have beat more than 2.5 billion times.

The heart pumps blood through an intricate system of blood vessels called arteries and veins. These vessels feed the body's cells and rid the body of wastes. If all the vessels in the body were laid end-to-end, they would be about 60,000 miles long. Your vessels could circle the earth twice.

Because the heart is a muscle, it requires an adequate blood supply to stay healthy. When the blood supply to the heart does not meet what the heart needs, the heart is damaged. Blood is supplied to the heart by coronary arteries. If you have chest pain, one or more of these arteries may be blocked. Blockages cause damage to the heart muscle.

How well the heart functions affects every other system in your body. It is essential that you take

How Much For An Injury?

Most people have heard about accident victims who recover large sums of money for their injuries. If you are hurt in an accident, one of the key things you will want to know in deciding whether to make a claim is how much you may recover.

Estimating a potential recovery requires evaluating factors that courts consider when awarding money for an injury. These include: the type of injury; the duration and severity of the pain; whether the damage is permanent; the length and cost of medical treatment; and the victim's lost income and emotional suffering.

Once these have been evaluated, it's easier to estimate an accident victim's potential recovery.

Feeding Your Pet
Feeding your pet properly is the single most important responsibility a pet owner has. Frequently, however, the diet is incorrect — in the dog's or cat's interest.

Most of the mistakes come from misinformation or unintentional. With the correct facts and guidelines, many problems of vomiting, diarrhea, overweight pets and over supplementation can be prevented.

Generally, good quality commercially available foods are best. Most of these meet or exceed national research council recommendations.

Occasionally, special diets and foods are needed in order to manage certain illnesses. Your veterinarian can advise you in these situations.

The amount of food a pet given depends on the animal's age. Pregnant and lactating animals need more. Active growing dogs need more than inactive, older counterparts. Overfeeding is most often the cause of dogs becoming overweight.

Vitamin supplements may be necessary to control certain diseases where the pet has a high loss of a particular vitamin or cannot utilize properly. Again, your veterinarian can best advise you regarding the proper supplement. Do not use vitamins indiscriminately since high doses can lead to problems.

The animal's diet should include plenty of clean, fresh water. Some animals have problems drinking milk, while others develop diarrhea. The best, therefore, to include in a pet's diet is fresh water.

The practice of feeding table food and leftovers often causes bowel problems, vomiting and diarrhea. In addition, this food can contain excessive calories, which lead to an overweight pet.

MDECD Official Provides Status Report on Yellow Creek Progress at Iuka Rotary

At last week's meeting of the Iuka Rotary Club, guest speaker Florian Yoste provided a status report on the State's progress with the infamous Tri-State Commerce Park, formerly known as the Yellow Creek Site.

Though the bottom line remains that no agreements have yet been finalized that would put industry (and the associated jobs) in the 4,000-acre industrial site, Yoste was surprisingly forthcoming about prospects and current status of negotiations with those prospects.

Yoste, who is Senior Special Assistant to Mississippi Department of Economic and Community Development (MDECD) Executive Director Jimmy Heide, has become somewhat of a spokesman for the Park, since the state acquired it more than a year ago, regularly representing Heide and the State at meetings of the Yellow Creek Regional Project Board, and at many other functions at the site. Wednesday, he was the guest of Rotarian John Castleberry.

Consultant Report Status

He explained the current status of the consultant team's work on the project, including the name change from Yellow Creek to the Tri-State Commerce Park, which the Yellow Creek Regional Project Board approved at their

April meeting. He explained the name change as a move toward changing the image problem that Yellow Creek, with its three failed federal project, and the state of Mississippi share.

In July, the final plan for marketing, developing and operating the Park will be released by the consulting team, headed up by Fluor-Daniel Consultants. The team includes North American Realty Associates, Lockwood Greene, and Dean McRae Engineering of Iuka. Representing the consulting team at the Rotary Club lunch were Tommy Dean and Kirby McRae from Dean McRae Engineering.

When the final report comes in, the consultants will increase their efforts and begin a worldwide marketing campaign, Yoste said.

Yoste explained that negotiations with prospective industrial clients has been ongoing since the state received control of the site, but stressed the importance of the final consultant report when decisions are being made on where to place companies on the Park site.

"For instance, we are not going to place a company in one of the old TVA warehouses if we know they [the consultant] are going to recommend demolishing that building to accommodate other prospects," Yoste explained,

and further described the complications and logistics involved in planning how to place different manufacturers on the site. For instance, there would be a potentially disastrous problem if an industry that generated a magnetic field was located too close to a computer hardware manufacturing operation. Or the possibility that if a large petrochemical company set up operation, it could negate other industries coming in.

Pressure Increasing

Since the state acquired the site about a year ago, little progress has been observed by the public, and some around the area are starting to look for answers, and progress at the Park. Yoste commended the Yellow Creek Regional Project Board, with members from Tishomingo County and the surrounding three counties, on their persistence with state personnel, always pushing them not only to get some industry in, but to start utilizing the assets of the site for the benefit of the surrounding area.

Yoste has often compared the acquisition of the 4,000-acre federal facility to the military base closings that other states have had to deal with, since Yellow Creek has such an extensive infrastructure system and existing high-tech buildings. He explained at the meeting that in such cases

the transition time is usually about two years, but that there has been much progress behind the scenes.

The increase in the people's desire to see progress could be why Yoste was much more forthcoming about the status of negotiations than state and site spokesmen have been up to now. Additionally, it could be a positive indication that negotiations are closer than ever with some prospects.

In response to Rotarian Harold Lomenick's request for verification of rumors about current negotiations with a large industry, Yoste said that the state is in serious negotiations with a specific company, but that the information is proprietary at this time, and that the prospect is also looking at sites in Alabama and Florida, as well as the Park. Yoste then added that actually they are in "serious" negotiations with two or three large companies, with employment possibilities of 250, 2,000 or 300 jobs.

Park Site Manager Jerry Wilemon also confirmed that they are "actively pursuing" a client that would place a coal-fired power production plant at the Park, and that within the next 20 days meetings were arranged for negotiations. They said such an operation would bring about 130 permanent jobs and 1,000 construction jobs.

When asked, Yoste said the focus for potential industrial tenants ranges from small manufacturing jobs, high-tech federal jobs that could support government programs elsewhere, to prospects in the music industry. He stressed that they are concentrating on diversity, with several industries locating in the site, rather than one big operation.

Tishomingo Countians have learned what happens when large, successful companies pick up their toys and go home.

Mississippi Rises with Lott

"The ascendancy of Senator Lott has helped tremendously," Yoste said.

Mississippi Senator Trent Lott, who was selected majority leader in the U.S. Senate after Bob Dole resigned to pursue a presidential bid, has been supportive of previous Yellow Creek operations, and has most recently added his considerable clout to state's search for tenants by calling major defense industry suppliers and computer companies, "suggesting" they look toward the South to locate new operations, instead of California and Massachusetts. Yoste says that MDECD has gotten a flood of calls lately from companies wanting to see what Mississippi has to offer, and the Tri-State Commerce Park is one of the most attractive sites the state has to offer right now.

But the competition is fierce for attracting industry. "Every state has a congressional delegation," Yoste said. Regionalism is also taken into consideration. Alabama and Tennessee have been advised of the potential of the Tri-State Commerce Park, and understand that the location of industry there would bring new residents and new support

questions, Yoste responded that the buffer zone, a 2,700-acre area to the north and east of the site acquired during the NASA years for blast protection, would indeed be used when necessary.

"We own it, we will use it if it meets a prospect's needs," he confirmed. He said that previous litigation problems regarding the buffer zone property have been resolved, and that since the need for a buffer zone no longer exists, it is just a part of the overall Park property.

For the past four years, I have tried to work for the people of Iuka to provide you with honest government. I came into city government with no personal agendas nor favors to return. When I ran, I promised to do the best I knew how to represent you, and that is what I have tried to do. Many times I have been blamed, lied about, and lied to during this term because I ask questions that no one wanted to answer, or I brought to light things that were taking place that should not have been. Faxes have been sent to newspapers that were not true, but all of this is to be expected when you ask questions or push for fairness.

These are the things that I know to be true...

1. When I came into office, the mayor had been receiving a non-accountable travel allowance for the past five years that did not comply with the Mississippi code 25-3-41. When I questioned this practice, it stopped.

2. The mayor came to the board asking that the city pay into the state retirement fund on his behalf the time that he had worked as an independent accountant for the city before he became mayor. Because I did not believe that the taxpayers should provide these funds for an independent contractor, I voted against it. The funds were not applied to his retirement.

3. I voted against the mayor's recommendation for buying a new police car and a new fire truck this year because I did not think that the city could afford it. We have five police cars under four years old and only two officers on duty at a time. We have one fireman on duty and two brand new double-seated trucks. You were told that the trucks were purchased at no cost to the taxpayer. According to the January 31, 1997, Summary of Revenue and Expenditure Accounts, the state fire fund will provide only \$14,000.00 per year. It doesn't take an accountant to figure out that this won't pay for two trucks that cost over \$135,000.00 each in the eight-year period for which they are financed. It is obvious who will foot the bill in the end. The second truck was not required at this time to lower fire ratings; the recommendation was at some time in the future. I am not against

progress, but I do believe that you have to buy as you can afford.

4. I voted against paving dead-end streets when our main thoroughfares are filled with potholes and broken pavement.

5. I believe that a budget should be drawn up, and that it should be adhered to as closely as possible. The auditors have repeatedly stated that the accounting practices used by the city lack strict controls. This was made evident by the embezzlement of city funds that might have been prevented had the controls been in place.

6. I will actively pursue industry and jobs for the citizens of Iuka. As your vice-mayor, I have been involved in meeting with people who are interested in our area. I can meet people, and I can let them know that we do have a workforce who wants good jobs and who are willing to work.

7. I believe that everyone deserves fairness regardless of who you are, who you know, what color you are, whether you are rich or poor. You and I both know that this hasn't been the way the system works in Iuka. I have been used as the scapegoat in many of these instances. When I made a decision, I have put much thought

and research into it. That is why I am man enough to stand behind what I believe to be the right thing; I don't need to pass the buck. I haven't lied to any of you, and you know that if I felt that I could not support you, I told you so. One thing I don't do is talk out both sides of my mouth just to get rid of you.

Iuka does need a change so that we can move in the right

direction. If you elect James E. Bates as your next mayor, I promise to do my best to provide the best government and representation that I possibly can. The only agenda that I have is to see Iuka be what it can and should be and to provide the taxpayers and our children the best place to live and work.

Steve Rye Asks For Your Vote In Chief Of Police Race

I am 49 years old and I have lived in Iuka over forty of those years. Iuka is and always will be my home. I am married to the former Shirley Carpenter of Burnsville and we have six children and five grandchildren.

There were approximately 60 inmates incarcerated there and we dealt with drug and alcohol abuse and other contraband on a daily basis.

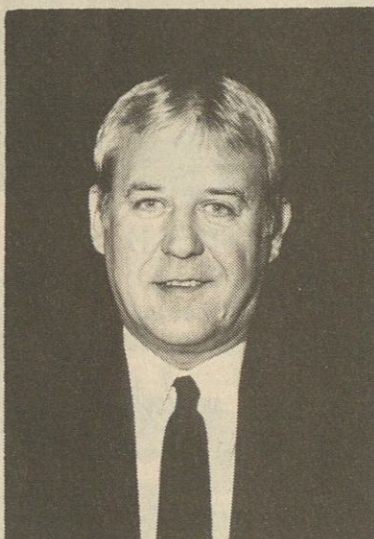

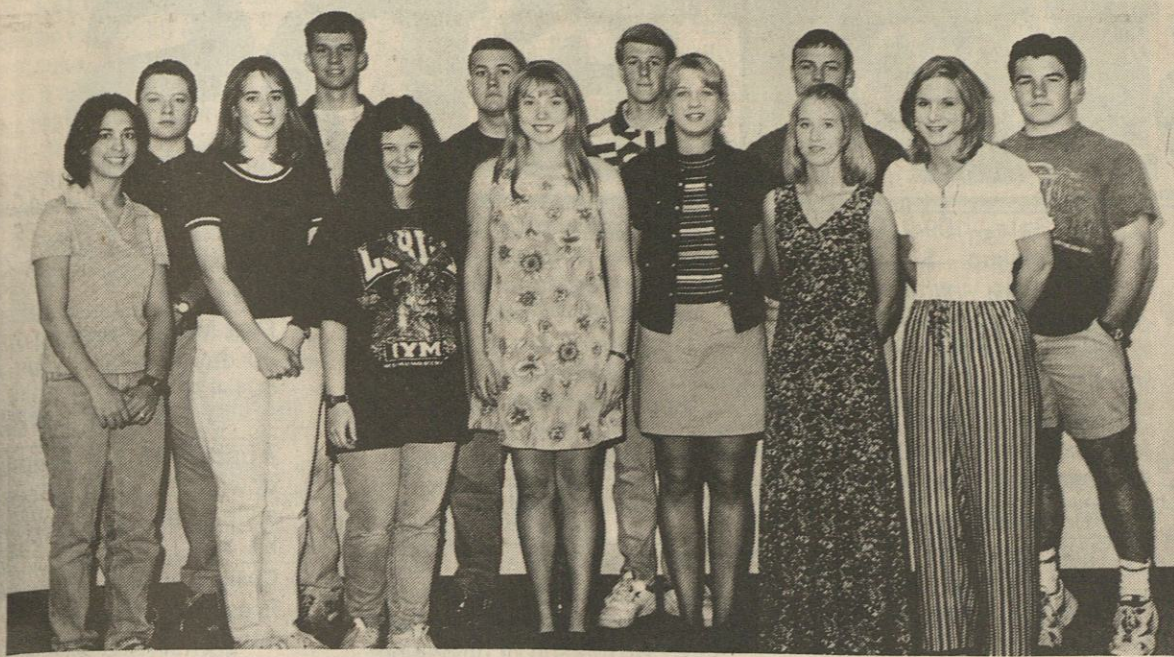

Striking Out Stroke

May Is Stroke Prevention Awareness Month

Iuka Hospital has joined the Foundation for Medical Care, peer review organization for the state, in emphasizing National Stroke Prevention Awareness Month activities during May. The campaign is part of a national effort to focus attention on stroke prevention and to promote recognition of stroke symptoms.

Area residents are encouraged to attend stroke screenings and to learn to recognize the five main signs and symptoms. "Everyone needs to learn these signs," said Dr. David Lee Gordon, who serves as chair of the Mississippi Stroke Education Consortium and is director of the University of Mississippi Medical Center Acute

Stroke Unit. "Anyone with any of these symptoms should call 911 immediately and get to a hospital emergency room as soon as possible. A stroke is a brain attack and demands the same immediate attention as a heart attack. The sooner treatment begins, the better the chances for recovery of the stroke victim."

Dr. Gordon noted that prompt recognition and treatment of stroke improves the quality of life for the victim, decreases disability and decreases health care costs throughout the nation. Stroke is the third leading cause of death and the leading cause of long-term disability in the United States.

The signs and symptoms of

stroke include:

- Sudden weakness or numbness of face, arm, or leg on one side of the body;
- Sudden trouble talking or understanding others when they talk;
- Sudden change in eyesight, such as blurred, double, or loss of vision;
- Sudden dizziness, unsteadiness, or falling when associated with another symptom;
- Sudden severe or unusual headache.

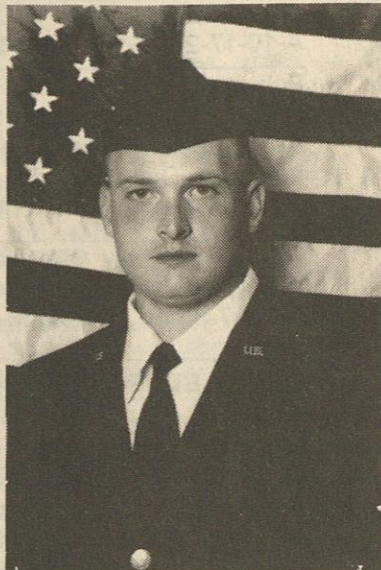
Prevention is based on the knowledge that there are certain risks which cannot be changed, such as advanced age, male gender, African-American heritage, diabetes mellitus, prior stroke history, and family history of stroke.

Risk factors which can be changed by lifestyle and medication include smoking, increased blood cholesterol, obesity, lack of exercise, alcoholism, certain drug addictions, high blood pressure, mini stroke (TIA, or transient ischemic attack), specific blood

disorders (e.g. high red blood cell count), and atrial fibrillation or heart disease.

Studies indicate that appropriate anticoagulation or blood-thinning therapy among Medicare patients with atrial fibrillation reduces the risk of stroke by about two thirds.

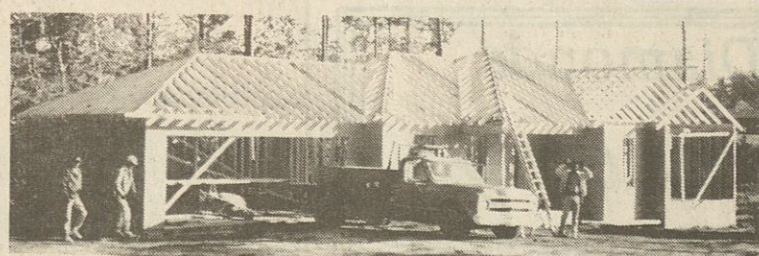

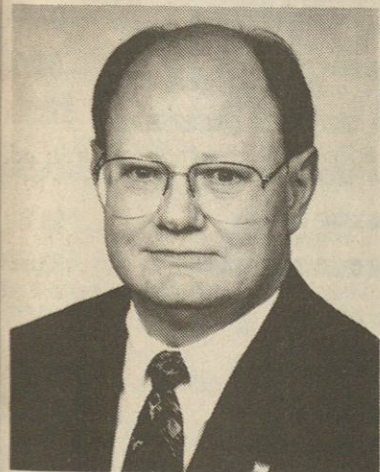

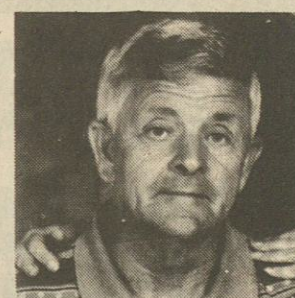

Tax Cuts For Married Couples

Thousands of married couples in Mississippi are due to get a tax break under a bill approved by the Legislature and signed by the Governor, revising state income tax laws to do away with the so-called "Marriage Penalty". The measure raises the standard deduction and annual exemptions for a married couple, making them the same as those for two single taxpayers living together. The changes will be phased in over the next three years, providing tax relief when fully implemented to more than 300,000 married couples. Tax Commission officials estimated the legislation would mean a tax cut of \$145 to \$185 a year for couples whose annual income amounts to \$30,000 or more, with lesser reductions for lower income couples.

The bill boosts the exemption for a married couple from 9,500 to \$10,000 in 1998 to \$11,000 in 1999, and to \$12,000 in 2000 and each year thereafter. The standard deduction for a married couple filing a joint return will be increased from \$3,400 to \$4,200 in 1998 and to \$4,600 in 1999 and succeeding years. The standard

deduction for married individuals filing separately will be raised from \$1,700 to \$2,100 in 1998 and to \$2,300 for each year thereafter. There will be no change in deductions or exemptions for single tax payers, with the deduction remaining at \$2,300 and the exemption at \$6,000. The legislation is expected to cost about \$2.3 million in the fiscal year starting July 1, 1997 with an estimated reduction in state revenues of about \$46.7 million a year when fully implemented.

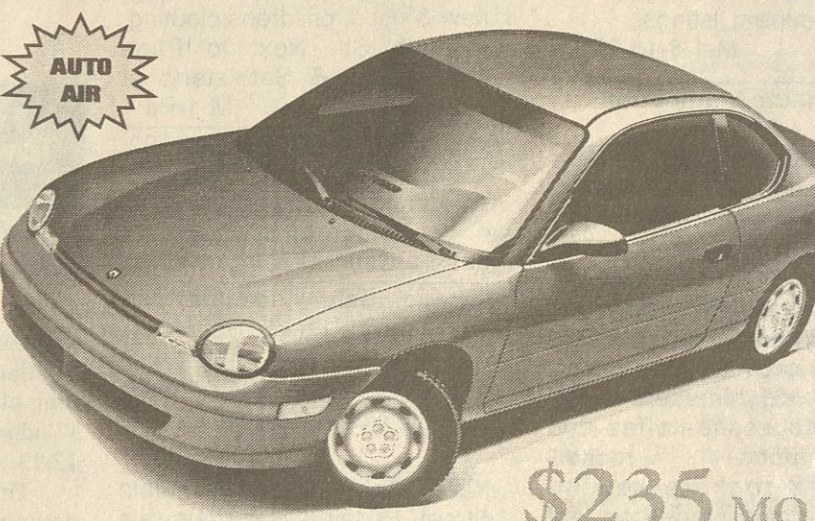

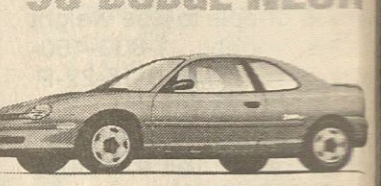
