Investigation **Underway About Money Missing** From City Hall

An investigation is underway regarding approximately \$1,000 missing from the Iuka City Hall since the August 17th fire.

The only official comment was from the Mayor, David Nichols, who said that the matter is under investigation by the Mississippi State Highway Patrol Investigator's office.

Allegedly, about \$1,000 of Iuka City Court money, consisting mostly of fines paid, was left in the court clerk's office. About \$600 of it was cash, and several checks were included in the bag that was apparently not put in the vault. Officials have said it was kept out, rather than deposited, so that there would be change for city court, which was scheduled for August 19th. The money was allegedly still in the clerk's office at the time of the fire, though officials have not said exactly when it was noticed missing.

Some city hall employees have been administered a polygraph test (with no negative results), but higher ranking officials will also be asked to take the supposed "lie detector" test, officials said, on the condition of remaining anonymous.

Very few people allegedly new where the funds were kept,

Numerous people were in and out of the city hall in the time after the Sunday morning fire.

Procedures of depositing such inds have been adopted since the scident, city officials said.

\$150,000 **Grant To Dennis Water Association**

The Appalachian Regional Commission has approved a grant of \$150,000 to the Dennis Water Association in Tishomingo County for water system improvements to residential and commercial customers along the Tennessee-Tombigbee Waterway, federal lawmakers said Thursday.

U.S. Rep. Roger F. Wicker and Sens. Thad Cochran and Trent Lott said the funding will provide improved water service to 1,300 households and potable water to two existing industries which employ 40 people. The work will enable one of the industries to add a second shift and hire eight new employees. The project will also make it possible to expand 250 acres in the area for future commercial development.

The water system presently does not have the well capacity to serve the needs of residential households in the area or to meet Mississippi Health Department standards.

Total project cost is estimated to be \$1,834,310. Matching funds include a \$363,000 grant and \$1.1 million loan from Rural Development; \$100,000 from Tishomingo County; and \$90,310 from the Dennis Water Association.

luka Receives \$800,000 CDBG **Grant for Wild Rose Furniture Site**

Iuka city officials, state officials and economic development professionals were on hand last Friday to witness Jimmy Heidel award an \$800,000 grant to assist in the development of a site for Wild Rose Furniture Manufactur-

Heidel, the executive director of the Mississippi Department of Economic and Community Development in Jackson announced in a short ceremony that the \$800,000 Community Development Block Grant (CDBD) was awarded to bring the furniture manufacturer to the Iuka Indus-

"We are happy to be on the team with Iuka and Tishomingo County in locating Wild Rose Furniture to the area," Heidel said. "We are equally proud that this international company has selected our state to expand its operations and create new job opportunities for the people of this community."

"This check represents not only our dedication to the project but a commitment to the hardworking people of this community," he said.

Wild Rose is based in Calgary, Alberta, and plans to locate a new 110,000-square-foot facility in the industrial park. The Canadian company specializes in contemporary master and youth

bedroom furniture, entertainment units and home office furniture. Initially, the international company will invest \$1.8 million in equipment and inventory, and future projections include an additional 110,000-square foot expan-

This CDBG grant, along with a \$400,000 Appalachian Regional Commission (ARC) grant will fund installation of water, sewer and drainage infrastructure, as well as site development at a site on Seago Road in Iuka. The ARC grant will be finalized at the end of this month, said luka's grant consultant Jack Griffith, of Jack Griffith Associates in Corinth.

Iuka has been granted a waiver to go ahead and consider the ARC grant as money at their disposal for the project, said Griffith, but a contract has not yet been awarded, though a contractor has been identified as a low

The State of Mississippi is also assisting the financing of the location with a \$1.5 million Small Enterprise Development loan through the Mississippi Business Finance Corporation, the finance arm of MDECD, according to the MDECD release.

The Wild Rose project was highest-rated project in the state of those requesting economic development funding, according to Griffith. The rating is based on a number of factors, including the amount of money invested by the industry, and the jobs projected to be created factored in with the present unemployment in the

Two-hundred jobs are estimated to be created over the next three years. Wages should be comparable to those at other local furniture manufacturers, from \$8-\$14 an hour, officials have said.

Remarkable also, is the amount of the CDBG grant, which are typically no more than \$500,000, making the Iuka award 60 percent higher than usual, according to Griffith.

"I am elated about the decision concerning Wild Rose locating in Iuka," said Mayor David Nichols.

"This \$5.5 investment bringing international company to Iuka, and the 200 jobs it will create will ensure that our local economy will continue to grow," the mayor said.

The site and infrastructure improvements are estimated to take about 60 days, after the contract is awarded and a notice to proceed is issued. The low bidder on the site work was Gray Corporation.

Construction on the facility is scheduled to begin after sitework is complete, said officials familiar with the project.

Citizens Gain **Understanding, Voice Concerns at County Tax Increase Hearing**

More than a dozen concerned citizens met with the Tishomingo County Board of Supervisors Monday morning to air concerns about the proposed tax increase of

Citizens voiced general concerns and disappointment with the general perceived increase in taxes for the county in recent years. The meeting served as an educational experience for many, who learned that recent increases in taxes are often not within the power of the Board of Supervisors. Reason for Increase

The reason given by the supervisors for the one mill increased administrative costs, which come under the designation of the "general county" fund. The general fund covers everything not covered by the "road and bridge" fund, or the "education" fund, which are self-explanatory.

In the general fund, the proposed increase is to cover legislature-mandated increases for county offices, like the sheriff, county clerks, tax assessors and collectors, and supervisors. It also is to help with increases in county administrative cost increases, like office equipment and contractual services.

An additional financial concern is some pending litigation against the county.

Explanations Given

Dale Price, president of the board, and Hayden Ables, Chancery Clerk, both spoke for the board as they tried to explain the county budget process to the

Several people at the meeting expressed frustration at, in some cases, a 20 percent increase in taxes from year to year, not including city, state or federal taxes. With a fixed income of a retired person, some said, it is getting very hard to make ends

Price explained that the increases in recent years were not proposed by the county board, but by the school district, which, by law, can request up to a certain amount each year, and if there is not significant public protest, then the schools' requests are granted. The school district is required to advertise their request each year, like the county, and there is a hearing that concerned citizens can go to voice their concerns to the school board, but reportedly only one or two people went to the advertised meeting last June.

This year the school district's requested budget is \$2,521,588, which is a \$462,164 increase over the \$2,059,424 requested last fiscal year.

Some areas are very hard to budget for, explained Price. For instance, it can't be known how many people will be in the jail for the entire year, or how many trials will be held here, requiring in some cases, significant cost to the

Economic Development a Major Concern

Citizens referred several times to the lack of jobs in the county, saying that if there was more industry it would help ends

Ables pointed out that Tishomingo Countians pay significantly less that citizens in surrounding counties. mentioned that compared to Tishomingo County's 70 mills, Alcorn County citizens pay 91-93 mills, and Prentiss County citizens in Booneville pay 120 mills.

Businessman Lambert then said that there is no comparison between Alcorn and Prentiss counties and ours, because "they have industry, they

That began a conversation about what the county board was doing to bring in industry. The board is in the dark as much as anyone else about any possible progress at the Tri-State Commerce Park, Price said.

He mentioned that industry recruitment is mostly handled by Tishomingo Development Foundation, which receives \$55,000 a year from the county, and the Tishomingo County Development Authority.

Recent successes for the development organizations were listed as Bauhaus in Iuka, the incoming Wild Rose Furniture plant, some industries in Belmont, and a couple industries that have since folded.

Requests for Board Supervision Businessman Paul Morris

asked simply that the board continue to take steps to control any costs within their control. As a businessman, he said, he has to pay close attention to his costs and he can't just raise prices every time some of his expenses increase. Sometimes increases just have to be absorbed in his business, he said.

Ables assured everyone that "the men that sit at this table every Monday [the supervisors] give an outstanding effort to control costs in this county."

Eye-Opening Meeting

Generally, citizens went away from the meeting more educated. It is yet to be seen if citizens will make an effort to get involved in some of the areas where they have

Many Critical Cases and Pleas Heard in Busy Circuit Court Week

Last week in Tishomingo County Circuit Court a number of pleas were heard by Judge Tommy Gardner. Circuit Court action continued Monday and Tuesday with a civil trial, several pleas and some hearings under Judge Frank

Tuesday Bond Hearing

Tuesday morning, in what was supposed to be a bond hearing, Merlin Hill, of Tishomingo, was arraigned on three indictments of capital rape, and eight counts of sexual battery with a child.

Hill's attorney, Greg Beard, was initially going to ask for bond to be set for Hill, who has been incarcerated at the county jail since his arrest April 22. His initial bond was \$1 million.

Assistant District Attorney Jim Pounds successfully argued that Hill could not have a bond hearing, since his attorney had previously filed a motion for a psychiatric evaluation

"If the defendant has legitimate psychiatric problems, until that evaluation is completed,

the defendant has to, by law, remain in the county jail," said Pounds. That could take a few months, Pounds said.

Judge Frank Russell ordered Hill be sent to Whitfield Psychiatric Hospital evaluation as soon as a bed is ready, and then to be sent back to the Tishomingo County Sheriff when the evaluation is completed. Pleas Heard

Last week the following pleas were heard:

Randy D. Smith, 34, of Tishomingo, plead guilty to two felony indictments, possession of marijuana and manufacturing marijuana in connection with his October 2, 1996 arrest. Smith received two sentences of 10 years each, to run concurrently. He must serve 5 years in the custody of the Mississippi Department of Corrections, and 5 years on probation. He also had to pay court costs and \$330 to the Tupelo Crime Lab.

Larry Joe West, 35, plead guilty to two counts of aggravated assault and one count of possessing a firearm as a

convicted felon, in connection with an incident in April 1996 in which he was accused of firing a gun several times into an occupied apartment in Belmont, striking three people inside. West received a sentence of 40 years with the MDOC, 20 to be served and 20 years suspended, with five years post-release supervision. Vincent Copeland, plead

guilty to an indictment for possession of marijuana, less than one ounce, with intent to distribute, which was enhanced by the fact that the incident occurred within 1,500 feet of a church. He was sentenced to six years with MDOC, which were suspended, and he was ordered placed in the house arrest program. He was also ordered to pay a \$2,000 fine, lab fees, and Mississippi Bureau of Narcotics fees.

Three Plead Guilty in Marijuana Conspiracy Case

In the December 1996 case involving several people accused of conspiring to sell, transfer or distribute marijuana, two pleas were heard, and one was sentenced by Judge Frank Russell.

Jimmy Grimes, of Burnsville, previously plead guilty to an indictment on conspiracy to sell marijuana, an indictment of possession of marijuana with intent to sell, and an indictment of possession of a firearm by a convicted felon.

He was sentenced Monday to 10 years with the MDOC for the conspiracy charge, two suspended and eight to serve; five years for the possession charge, to run concurrent; and three years for the firearm charge, also to run concurrent.

Under the same conspiracy indictment, Daniel Armadariz, 21, plead guilty both to the conspiracy indictment and a count of possession of marijuana with intent to sell, transfer or distribute. His sentence was deferred until the next circuit court session, in January 1998, and was released on his current

Also in the same conspiracy case, Ronald Montgomery, 21, plead guilty to the conspiracy charge, and to a charge of

Fall Fashions And Labels

The emphasis lately has been on back-to-school shopping, but now with Labor Day signaling the end of Summer, it is time to get serious about Fall clothing for all family members.

Whether you sew your own or buy ready-made, you will be seeing a new look in care labeling this season. Beginning July 1, 1997, the Federal Commission is allowing apparel manufacturers to use symbols instead of written instruction on garment care labels.

According to a recent report from the Soap and Detergent Association, four out of five consumers read care labels before they buy clothing, and follow label instructions when washing garments. Upcoming changes in care labels will affect how we read these labels.

The symbols were developed by the American Society for Testing Materials (ASTM), using a system that is simple and easy to learn. Like any new "language," they may look a bit strange in the beginning, but do have some advantages. For one, they should be a real benefit to non-English speaking people. The new symbols also benefit U.S. apparel manufacturers in that one label for the three NAFTA countries (Canada, Mexico, U.S.) will reduce manufacturing and inventory costs.

As to benefits for the average U.S. consumer, by reducing words to symbols, labels will be smaller, which means they will be more

Household Poisons

A pet that has been poisoned becomes sick very fast...within minutes to hours. In most instances, pets will recover even without medical intervention. But, pets known to have consumed antifreeze, rodenticides (rodent bait), or specific human medications, like heart and blood pressure medication or birth control pills could be in trouble. Don't wait until the pet becomes sick. Call a veterinarian immediately for advice.

Poinsettias and liquid fertilizers applied to grass are among the most common sources of presumed pet poisoning. In fact, they are not. Poinsettias, even if consumed in large quantities (Yes! Dogs will do this) causes little more than mild intestinal upset. Dogs and cats will not become ill after consuming grass that has been sprayed with liquid fertilizers if the liquid has dried. Even if it hasn't, serious injury is not likely.

If a pet has become poisoned and its condition is getting worse, NEVER try to treat it at home. Immediately take the pet to a veterinarian. Administration of specific drugs and supportive treatment are critical and must

be given as soon as possible. Poison Control Centers are available specifically for pets. Centers provide useful information and insights about specific compounds and can tell you if they are poisonous to pets or not. But, if a pet does become poisoned, DON'T call a Poison Control Center. Get medical attention first.

Smoking And Vision

There are a lot of results from smoking - all of them bad. Here's another one to add to the list. If you use tobacco to excess, this can sometimes have an adverse effect on your vision due to circulation problems. In extreme cases, it may even cause "tobacco blindness." this is a form of amblyopia in which central vision becomes impaired resulting in a loss of ability to read or discern detail. In less extreme cases, heavy smoking may cause a blurring of vision along with a numbness or tingling of the fingers.

The nicotine and other chemicals in tobacco are believed to interfere with the normal circulation of the blood throughout the body. This includes the tiny blood vessels in the eyes. This is a much more serious problem for heavy smoker.

Cutting down, preferably stopping the use of tobacco, is also considered important in reducing the likelihood of heart disease and lung cancer as well as vision problems caused by poor circulation.

I was also informed that Chief Bates had moved his office, (before the fire), into the fire departments office. Why would



\$40,000 to Accident Victims in **Civil Suit**

An Iuka couple received a judgment and \$40,000 in a civil suit in Tishomingo County Circuit Court last Friday.

Lessie Sanders and Danny Sanders, of Iuka, sued Robert McAffee, of Florence, for negligence in connection with an accident in 1995 that occurred at the intersection of Highway 172 and Highway 25, near Town and Country Furniture.

Lessie Sanders, driving a Chevrolet Lumina, was hit near the rear wheels by a Mercedes driven by McAffee, said the plaintiff's attorneys. She was hospitalized for eight days and suffered physical and emotional damage.

Danny Sanders was suing for loss of consortium, as well. Plaintiff's co-counsel Mark Segars explained that loss of consortium is essentially the loss of the services of your spouse. domestically and personally.

In the two-day jury trial under Circuit Court Judge Tommy Gardner, McAffee admitted liability in the accident; that he was the cause, said Segars. The jury did find for the plaintiffs.

Plaintiff co-counsel Phillip Whitehead said, "We are very pleased that the jury ruled in our favor."

"In liability cases such as these, the plaintiffs' or their counsel are not allowed to mention that the defendants have liability insurance to cover the damages suffered by the plaintiffs," said Mark Segars. "If the jury had been given this information, we believe that the damage award would have been much higher," he said.

Both parties have ten days to file post-trial motions.

Teamwork & Cooperation Help Area Law Officers Solve Cases

More than fifty law enforcement officers from the tristate area got a chance to enjoy a meal together and compare notes on unsolved cases at a meeting last Tuesday of the Tri-State Law Enforcement Association.

Sheriffs. policemen, investigators, state troopers and officers from Alabama, Tennessee and as far as Monroe and Tippah Counties in Mississippi joined forces with FBI agents, and agents from the Alabama Investigation Bureau, constables, Mississippi state investigators, and other investigative agencies for a few hours and came up with, at the very least a few really good leads on previously unsolved cases. And they enjoyed a good steak dinner at the Tishomingo County High School cafeteria.

Of local interest was some positive information about fourwheeler theft cases, fraudulent check cashing operations, and even new leads on the identity of the bones found some months ago in the Piney Flats. Effectiveness of Teamwork


Formed a little more than a year ago, largely in part due to the efforts of Tishomingo County Sheriff David Smith, and Sheriff Jimmy Taylor of Alcorn County, the association has met a few other times as a group. But the greatest evidence of its effectiveness has demonstrated in several recent cases that were resolved with the hard work and unprecedented cooperation between agencies that has been fostered by the association.

The most recent success of the association has been the arrests made in connection with the July 20th murders of Harold Pugh and his 11-year-old-son Joey Pugh in Colbert County, Alabama, which are presumed linked to a Belmont, Mississippi bank robbery, that happened the next morning, July 21st. The cross-state-line nature of the investigation called into action

many different local, state and federal agencies, and Tuesday night Colbert County Sheriff Buddy Aldridge gave credit to all the different people involved.

"You have never seen a group of people work as hard, for as long as they did," Aldridge told the more than fifty officers present.

Another recent case involved a man hunt for an escaped prisoner from Alcorn County. The prisoner escaped when he wrestled a deputy's gun away as the deputy was driving him to a

dental appointment. The man had been convicted of at least three murders, and fired the gun at the deputy's head. The safety being on was the only thing that saved the deputy, Smith said. Since the fugitive has a sister in Tishomingo County, officers from both counties and several agencies joined in the search, and the man was found just a little more than 24 hours later.

Tishomingo Co. Benefits Most

Sheriff David Smith, who served as host for the dinner, said his county benefits more than any of the others for the ties formed through the association, since Tishomingo County borders not only three Mississippi counties, but also counties in Tennessee and Alabama. He often has to deal with "line jumpers" who go into another jurisdiction committing a crime, so working with other agencies and sheriff departments is a day-to-day operation at the Tishomingo County Sheriff Department.

"We can do so much more for the people when we work in numbers," said Smith."Teamwork is the most effective way to work."

And apparently it was, listening to the conversation between officers as they compared

Just the mention of an unknown body found burned recently in western Alabama, brought recognition from a Monroe County, Mississippi official. Since then, there has been

an arrest made in the case.

The familiarity of each officer with the common law breakers in his own county turned into valuable information that could be used to solve cases.

Jimmy Taylor in Alcorn County had located some guns, and brought up the subject at the meeting, which lead to those guns being identified as ones that were needed in a murder case in Baldwyn. The guns were the physical evidence needed to help prove the case on the subject, from Alcorn County, that is charged with capital murder.

Similar "mode of operations" (MOs) of check fraud suspects, and suspected four-wheeler thieves gave some counties the best leads they had in months. Especially since habitual offenders' photos and records were on file in another office, they could soon access the information that they learned about at the

Tishomingo Cracks Down on Overdue Court Fines, Utility Bills

In its continuing efforts to straighten out the finances of the town, the Tishomingo Board of Aldermen and the city judge adopted new policies on collecting delinquent court fines and utility

Tishomingo Town Board Regarding the more than \$3,000

in uncollected utility bills, the board adopted a collection policy consisting of a reminder letter sent to the delinquent utility customer, followed up by legal action if it is not cost prohibitive, town officials said.

For the approximately \$6,000 in court fines that have not been paid, Tishomingo City Judge Phillip Whitehead made the decision to send names of those who have not paid court fines to the Mississippi Department of Public Safety, Driver License Division. The state will then attach a "failure to appear" or "failure to pay" to their drivers licenses, which will put their licenses on a suspended status until the fines are cleared up in Tishomingo. John B. Strickland, Jr., who has served as a policeman in Tishomingo since 1995, was officially appointed Police Chief by the board Tuesday night. He had been "acting" police chief since

the previous administration. **Budget Approved**

The 1997-98 fiscal year budget for the town was approved Tuesday. The total budgeted expenditures for the year are

\$578,500, according to City Clerk Karen Kennedy. The millage rate of 25.25, the same as in recent years, was

also approved. **Town Looking for Utility Maintenance Operator**

The town is now officially looking for someone to fill a fulltime maintenance position that is either certified, or willing to get certified, in gas, sewer and water system operations and maintenance, said Mayor James Tennyson.

City Hall Work Will Go Through Normal **Bidding Process**

Iuka City Board

Making plans for repairs to the recently fire-damaged city hall topped the list of actions at the regular meeting of the Iuka Board of Aldermen September 2nd.

There had been some consideration given to declaring some damaged parts of the building an "emergency," in an effort to speed along the process of rebuilding the city hall by avoiding the normal procurement process for contracting services. Under the lessrestrictive emergency purchasing statute of the state code, contracts still be

competitively bid, but formal advertisements in newspapers are not required, which would cut down the time required for bidding the

But last Tuesday night, under the advice of the city attorney, the board conservatively voted to proceed with normal state guidelines for bidding design and construction services, even though it will mean much longer than the originally announced optimistic plans for a 30-60 day return to a refurbished city hall, which caught fire August 17th.

'This will delay the project substantially, but the board felt it was best under the circumstances," said Mayor David

Nichols. "This will help us avoid mistakes that could be made if we get in too big of a hurry," said Alderman George Long, who voiced concerns with quality of

materials and quality work that could mean wasted money on the 4,000-square-foot building.

Different construction contracts for separate components of the building will be bid separately, with Public Works Director Don McNeely performing the job of general contractor, explained officials. This will allow the city to avoid the cost of a general contractor.

City employees have been doing all cleanup work to date.

Costs of the renovations are not known, and will depend upon the insurance

> settlement. interior floor plan will essentially same, Nichols has said.

In other business, the board passed a resolution allowing some development of Jay Bird Park.

They also voted to officially change the location of Board meetings to the temporary Iuka City Hall facility on Eastport Street. Also officially changed until the city hall renovations are complete was the location of Iuka City Court, which will be held at the Tishomingo County Court-

Budget Hearing

At a Monday night hearing on the Iuka City Budget for the next fiscal year, only one person showed up, and he had no comment on the budget, said Nichols. The new budget will be formally adopted September 15th, and published afterwards.

Furthermore, this information gathered from contacts with parents and other agencies will be used to help determine present and future program needs as progress is made toward the goal of providing a free appropriate public education to all children with a disability.

Information which could identify an individual child will be maintained by this agency and will be provided to other agencies only in accord with the Family Rights and Privacy Act and EHA-B. As a parent, you are guaranteed the right to inspect any such information about your child and to challenge its accuracy. Access to this information is forbidden to an unauthorized person without informed consent.

Please contact Betty Barnes, Child Find Person for the Tishomingo County Special Municipal Separate School District, if you know of any children who may have a disability by calling 438-7471 or writing to her at the following address: The Education Center, P.O. Box 98, Tishomingo, MS 38873.

The Child Find Person implements child identification, location and evaluation of children birth through twenty-one who have disabilities, regardless of the severity of their disability, and

who are in need of special education and/or related services. The Child Find Person works with the local Head Starts, Human Services, Health and Mental Health agencies, as well as local education agencies, physicians and other individuals to identify and locate children out of school and in school who may be in need of special education services.

Once a referral is made, it is the responsibility of the Child

Find Person to insure that the Referral-to-Placement procedures are followed. She works with Local Survey Committees at each school to implement this procedure. The following activities briefly describe the procedures.

Prior to evaluation, a copy of the Parent Information Pamphlet and Procedural Safeguards are given to parents. District personnel explain the Parent Information Pamphlet to parents and insure that they understand the Procedural Safeguards.

After parental consent for is obtained, nondiscriminatory evaluation is conducted. Students are evaluated in all areas related to the suspected disability by personnel.

Parents are notified when a student is ruled eligible for a special education program. An Individual Educational Plan is developed for the student before the student is placed. Parents must sign permission for placement. Parents, teachers and/or students participate in this process. All students receiving special education services are reassessed at least once and year and reevaluated at least once every

We now have twenty-five special education classes in our district which provide services to students who have a physical, mental, communicative and/or emotional disability. It is the goal of the Tishomingo County School District to provide free appropriate education to all children with disabilities through age twentyone by the year 2000.

Free Electricity/ Refrigeration Training

The Northeast Extension Center is offering quality Electrical/Refrigeration training free to dislocated workers. Students who are currently receiving unemployment benefits can continue to receive this money while in training. The Pell Grant is available to eligible students.

Mississippi Farm Bureau Federation Opposes Term Limits. A term limits initiative proposal has been filed in the office of the Secretary of State. The following is information on this proposal -Initiative Measure #9.

Why Term Limits are BAD

We already have term limits - elections! We need to protect our constitutional right to extend or limit terms at the ballot box.

It limits good officeholders as well as bad. Let the people decide

when turnover is necessary. It shifts power to the bureaucrats. Many times when we have been unable to get a response from a government worker, we have called upon an experienced elected official to get the response. Unresponsive bureaucrats will gain more power if we

automatically terminate elected officials with experience. Its ultimate goal is to limit all officeholders, including city, county,

state, & federal officeholders.

Out-of-state money funds term limits efforts.

It diminishes the benefit of experience.

It creates more "lameducks" earlier.

People are put out of office, regardless of the will of their constituents.

The Mississippi Constitution guarantees that a legislator is chosen by voters in his/her district. The state does not have the

constitutional right to order the district to have term limits. Term limits will not solve problems presented by low voter turnout and lack of voter interest. When you are presented with a statement of how "bad" government is, ask the question: "how would term limits solve it?"

The effect of term limits is that government would have to be started from scratch every eight years.

Patriots have shed blood to preserve the right of American citizens

to vote freely, and not be "handcuffed" by arbitrary limits on elected leadership.

he objective for now is to minimize the number of signatures placed on the initiative petition in our county. The best way to do this is to share information about term limits with the people in our county. The more people know, the less likely they are to promote term

Unemployment Rises In County....

According to Jimmy Rowland, Manager of the Mississippi State Employment Service, unemployment in Tishomingo County rose to 11.5 percent in mid-July. This compares to 8.0 percent in June and 11.5 percent in July one year

The civilian labor force for the county numbered 10,360, 160 less than June, but 100 more than July, 1996. Approximately 9.170 Tishomingo County residents held jobs in July while 1,190 were unemployed.

Manufacturing jobs in the county numbered 3,340, 480 less


than June, but approximately the same as July of last year. Nonmanufacturing jobs numbered 3,3290, approximately the same as June but 40 less than July, 1996.

Wicker District Tour Highlights Issues On The Minds Of First District Residents

"In this era of satellite communications and electronic mail, I still prefer an old-fashioned handshake and person-to-person contact."

Thus went my press release as I set out on my 24 county tour of Mississippi's Congressional District during August.

As it turns out, I didn't realize how right I was or how beneficial - not to mention how much fun - it would be for me as an elected representative to travel the highways and back roads of our

I found that even a lifelong resident of north Mississippi can learn a lot more by listening to the people who live, work, and raise families in our part of the country. In hundreds of conversations I had the chance to discuss how the programs and policies of the federal government affect our people every day.

I talked about farm programs with several area farmers. Many of them said they were optimistic that shifting from government price supports to a market-based farm economy will benefit producers as well as American consumer

Although our Mississippi economy is doing well with an unemployment rate just over five percent, legitimate concerns were expressed about the loss of jobs in the apparel industry. To meet the encouraging aspect of this story is the way local communities and their leaders are swinging into action to seek new employment opportunities manufacturing sectors.

A visit with the school lunch

coordinator at a courthouse resulted in an invitation to share lunch at a nearby elementary school. I saw how effectively the staff stretches their resources to provide well-balanced meals, and I talked with faculty and staff members about discipline and the impact of federal regulations on school operations.

At another location, the principal in a small school district outlined his vision of bringing the internet to every classroom. He has enlisted the enthusiastic support of local volunteers, parents, and area businesses to assist in rewiring the building.

I met with members of the National Guard at several locations and pledge my continued support for maintaining the strong federal role of the Guard as part of the Total Force. I also heard from retired military personnel who expressed concerns about the erosion of benefits and health care options.

I participated in one of the many local festivals which have been so successful in recent years. The hard work of over 200 volunteers, 18 civic clubs, and community leaders has been a key
