

Billie White was hired during the January 12 Board of Education meeting to serve as a carpenter for all of the district schools. According to Dr. Carl Weeden, White's primary task will be to take care of the roofing problems which are plaguing some of

However, controversy has arisen over the hire-in salary White is supposedly getting. While the exact salary has not been confirmed by the administration, it is rumored to be over \$35,000 per year and will include a benefit package enjoyed by other school staff members.

It has been reported that the top paid teachers in the countythose with master's degrees and 20 years or more service— do not match the salary given to White, who reportedly did not need specific certification in order to get

A spokesman for the teachers, Lori Wahlstrom, said that it is more than just the money which concerns the teachers.

"What is the message we are sending our students," she said. "How can we convince them that education and staying in school is important when they see that someone with a skill can make more than someone with years of education and experience."

Wahlstrom addressed the Board on behalf of a group of fellow teachers from Iuka Elementary School and other county schools. The group of 20 or more spilled from the board room into the hallway, according to reports.

"Please don't misunderstand," Wahlstrom said. "I am very supportive of the school system and no matter what the situation, my first and foremost priority is the kids. We just wanted to communicate our concerns and opinions to the Board."

Mastercraft of Booneville To Build Wild Rose Furniture Plant In luka

Building Should Open By August 1 - Expected To Employ 200

The Iuka Industrial Park will soon be home to a new furniture manufacturer.

Wild Rose Furniture Manufacturing hopes to have operations up and running by August 1 of this year at its new location, according to company president Jack Friesen.

This plant, which will manufacture contemporary bedroom furniture, is a branch of the main company located in Calgary, Alberta, Canada which has been in existence for 11 years.

Friesen said their Canadian plant was shipping about 70 percent of their business to the United States, so they felt it would be to their advantage to locate a facility in the states.

The new plant will contain approximately 116,000 sq. ft., with the possibility of two additions which would bring the total space to over 300,000 sq. ft. Mastercraft of Booneville was awarded the contract for this first phase of construction.

At the onset, Wild Rose will

be employing between 30 to 60 people. However, by the end of the year, that number should increase to over 200, Friesen said.

"We will be slower at the start up because our employees will need training," Friesen explained. He went on to explain

that while most of the training will be done at the Iuka site, management hired locally will be sent to the company's Canadian facility for initial training.

Most of the hiring will be done from the local area, including management, Friesen said. At this time, they expect to bring one manager down from Canada.

"We picked Iuka and Tishomingo County for the caliber of people in the area," Friesen

He explained that they will

begin hiring for the plant in the next couple of months.

"We hope to hire as many Tishomingo County people as possible," he remarked.

Friesen said Wild Rose has been very pleased with the way negotiations have gone with officials in the area.

"We are extremely delighted to come to the area," he said.

"The state and local officials have made it extremely easy for us. We appreciate their help." Friesen said he would espe-

cially like to thank Max Walker, associate director of the Mississippi Industrial Development Association and Mack Wadkins, director of the Tishomingo County Development Foundation for introducing him to this area about five years ago. He also extends a thank you to the Tishomingo County Board of Supervisors and to Iuka Mayor David Nichols and the Board of Aldermen, who Friesen said treated him and his company extremely well in the last year in keeping developments moving forward.

Staking And Mulching -**Helpful Disease Control Tips**

Weather officials forecasting milder, wetter-thanusual conditions for this spring, and wet weather gardening can be a real challenge for even the most dedicated vegetable gardener. Diseases are tough to control when it's wet, so every technique available will be needed to protect the harvest. For example, there are several ways to cut down on tomato disease problems such as early blight, Septoria leaf spot, and buckeye fruit rot — all of which are more severe following rainy weather. Several approaches will help with these diseases. The first involves the use of plant stakes or support cages. Gardeners need to "hang'em high" within the first few weeks of setting transplants as the first line of defense for tomato leaf diseases and fruit rots. This control technique is effective since the fungi which cause these diseases live in the soil. Tomato foliage and fruit in contact with the soil surface quickly become disease targets when rain splashes soil particles containing blight and fruit rot fungi onto lower parts of the plant. So, if you stake, trellis, or cage your plants, this will cut down on disease development in the

disease movement up the plant will be slowed. Along with staking of tomato plants, it's a good idea to use mulch to further reduce the amount of soil splash onto fruit. Mulching is a good idea not only for tomato production but for other vegetable crops as well.

Mulching will help with pod rot (anthracnose) of lima beans, belly rot of cucumbers and cantaloupes, and fruit rot of bell peppers. Earlyseason, mulching with plastic, newspaper, pine straw, and similar materials will mean extra work, but the technique works and will allow you to reduce losses from wet weather diseases. Staking and mulching will help, but it's important to realize that other practices such as carrying out a fungicide application program will also need to be carried out to further cut down on vegetable disease losses. Should I Let My Cat Or Dog Have A Litter Before Having Her Spayed?

There are no medical or Psychological advantages to allowing your female pet to have a litter before she is spayed. There are, however, several reasons not to wait.

Breeding your pet and allowing it to become pregnant puts that animal through all the medical risks of pregnancy. While most healthy pets come through a pregnancy in good condition, there is still the risk of complications, uterine infections (which can be fatal), damage to the reproductive system during delivery, and more. Just as a human pregnancy has its risks, so does pregnancy in cats and

dogs. Both cats and dogs may come into heat within their first year of life - but they are not fully grown at this age. Pregnancy in a young animal that has not reached her full size and maturity is even more risky than pregnancy in an adult animal. You would be, in a sense, allowing a young teenager to become pregnant. In addition, young animals may lack the maternal instinct to care for the litter, both during and after pregnancy. The myth that all female animals are natural mothers is, unfortunately, just that: a myth.

Your pet runs a much smaller risk if she is spayed before she ever goes into heat. Spaying a female dog before her first heat also drastically reduces her chances of developing mammary cancer.



Your eyes require adequate light to function properly, but too much bright light and glare can create discomfort. That is where sunglasses, good sunglasses, can be an eye-saver.

In general, plastic sunglasses offer advantage of being lightweight and impact resistant, but many plastic sunglasses are inexpensive and of extremely poor quality. Some polarizing sunglasses, for example, are excellent while others may be just toys. Sunglasses, like regular

eyeglasses, ought to be ground and polished to match the natural curve of the eye surface. No matter how you look through them, there should be no distortion since your eye will always be the same distance from the lens. To produce such curvature, each lens must be ground individually. It cannot be molded or curved by heat.

If you have any questions, be sure to ask your eye specialist. You cannot tell whether a pair of sunglasses is adequate just by looking at them.

My Friend, My Hero,

Mrs. Issac "Sis" Jackson

A Series Of Articles By Christian Evans

A visit with a friend sometimes is not only a pleasure, it is a privilege. I study books and records of local history to learn about the past. If there is one thing have learned is that all the books and papers in the world cannot take the place of a talk with someone who was there and can all you first hand about a time or

One of my most favorite sources of local living history has come from my visits with Mrs. Issac "Sis" Jackson. Our visits are not only educational, I find them to be charming, entertaining and inspiring.

Mrs. Jackson's family moved here in 1918 from Memphis. Her parents, Mr. & Mrs. Jim Doan McRae Sr., were successful in a local business. Their daughter, Aline, was a beautiful young lady. (The faded photographs are proof of that fact!) I should emphasize the word "Lady" because even today, it is the best way to describe the charm, grace and genteel disposition of Mrs. Jackson.

She was born February 9, 1903 and recently celebrated her 95th birthday. She still has a sharp mind and equally sharp witt. Even though now physically weak, her will is strong. Mrs. Jackson's love of life and people is tremendous, heart felt and invariably contagious!

"I have always loved

people!" she exclaimed as she has often done, on my most recent visit. I stopped in to wish her a happy belated birthday. Her older brother, Jim Doan McRae Jr., came to visit the weekend before. "He played his harmonica for me s he came in so I knew who he was before he said a word," she laughed. I knew she liked the mouth harp" as she called it, so I had brought mine along to play her isong or two. I'm not any good at Ols ibut she didn't seem to mind. Brother has played for me since we were little kids. Yes, he'd play and I would dance," she recalled

Mrs. Jackson still calls him "brother" and he always called her "Sis". Throughout the years I think everyone has called her "Sis" rather than Aline. She preferred it.

"I can still recall when Brother was quite popular with the ladies," she chuckles. Back then, she had a number of gentleman suiters herself!

It was about that time one of her suiters, handsome young Issac lackson, fell "head over heels" in love with her. "Ike" as she fondly calls him was nine years older than she. Eighty years later and she still blushes when you speak of the true "love of her life."

He graduated from Iuka High School around 1910. Mr. Jackson attended Mississippi A & M (Now Mississippi State University)

where he lettered in varsity football as a back.

Mr. Jackson graduated from State and worked until war broke out in Europe and volunteers were called for. Issac Jackson was the first man from Tishomingo County to enlist in the summer of 1917. He returned to Iuka in 1919 to see the crop of eligible young ladies had increased considerably, by one in particular!

"I guess it was love at first sight," she once told me. "I just don't remember who looked first!" she chuckled while blushing. It wasn't long before 19 years old Sis became Mrs. Issac M. Jackson. Her engagement picture is my favorite of her. (If I had been around back then I would have given the old running back a run for his money!)

In 1932, Mr. Jackson was elected Tishomingo County's Sherriff/Tax Assessor and Collector. Mrs. Jackson was not at all pleased that he ran for the post. This is still a touchy subject with her. "Ike wanted the job of Assessor and Collector, but the job of Sheriff was included with it then," according to Mrs. Jackson." I didn't sleep a peaceful wink the whole time Ike was in office, "she told me. "One time I told him if he got shot, I'd kill him!" she chuckled.

The Jacksons were blessed with a son, Jim in 1931. Mention Jim and Mrs. Jackson's face will light up in a smile! "He is a good son and a fine boy!" she says proudly, "He calls every Sunday night from Texas and I get a card or letter in the mail every Wednesday." Mae Taylor, one of Mrs. Jackson's caretakers says," Jim always opens with a pet name for his mother, "Dear Fox".

Charles Sweeney recalled how she got the nickname "Fox" from Jim. "Many years ago, the Jacksons all went to a dinner somewhere," he says, "and there was a lady Mrs. Jackson was introduced to - Mrs. Cox. Well, she must have misunderstood the initial introduction and all night she kept referring to the lady as "Mrs. Fox". Mr. Jackson and Jim got a laugh out of it and now he and a few others refer to her as "Fox".

Mr. Issac Jackson was Post Master in Iuka for many years after serving as Sheriff. The Jacksons were active in many community activities, especially in their church.

"I joined the Iuka Methodist Church when my family moved here in 1918," she recalls.

She has been a member for eighty years now. She is most remembered for teaching the young people's Sunday School class in grades 9-12. She began teaching the class in 1925. "I had all boys for many years," she says, "I tell people I have more boy

friends than any woman in Mississippi!"

Not until the last few years she taught did the class go Coed. "It was a right of passage in the Methodist Church to be in Mrs. Jacksons class." Says Ruth Beard Smith," When you reached ninth grade, you had to be in there."

All her students remembered her starting each class by reading the same verse. It was Psalms 19:14, which reads, "Let the words of my mouth and the meditation of my heart, be acceptable in thy sight, O Lord, my strength, and my redeemer."

"She never missed a Sunday that I can recall when I had her," says Donny Brown. He noted her teaching style was unique." She never really went by any book. She would take a topic and bring in newspaper clippings or Guidepost articles and teach her lesson," Brown recalls. "She was a GREAT teacher!"

Donny's father, Cecil Brown was the Sunday school superintendent for the Iuka Methodist Church for several years. "I tried to get her to teach out of the book but she was stubborn and did it her own way," he says. "There was something special about her class."

Many of her students said she made the lessons so interesting that you payed attention and you were drawn to what she said. "She made you feel so loved," says Amy Brown Walker, who was in Jackson's class in her last year of teaching in 1987. Agreeing with her Father and Grandfather, the second generation student sighed saying "Oh, I think she was a wonderful teacher and is still a great person."

Olie Jourdan was a student of Mrs. Jackson in the early 1940's. "She never asked direct questions but she made you think." He commented, "She called us "her boys" but she treated us as adults and expected us to act as such," he says," If you listened to her you were sure gonna learn."

Herbert Thomas says she has "high principles and values." He remembers her talking about alcohol," she said if you never took a drink you would never want one." He says. "For her, that even included eating any rumcake or candy with that stuff in it."

For sixty-two years she

I loved every one of my boys and girls, ALL OF EM! she exclaimes. "They still come by to see me." she says, and they would do anything for me."

"Scott Segars was one of my boys and he is my doctor now," she says affectionately, "He comes by often, he's a good boy." She then laughs, "I call them all boys and girls but they are all grown folks now. I have some former students well in their seventies but

they are still kid's to me."

I have heard that you are only as old as you think you are and I believe Mrs. Jackson literally thinks she is no older than the youngest of her "kid's". She is still loved and cherished by her students and still holds a special place in the collective heart of Iuka Methodist Church.

I was once looking at some old photos with her when we came across some of a ball held at the MacDonnald home on Iuka Day honoring Gov. Fielding Wright. I had a fit over them and asked if I could use them in the county museum, where I was curator at the time.

"You don't want recent stuff like that for the museum," she quipped, "you want old stuff don't you?" I gently reminded her that Iuka Day had been over 40 years ago. She smiled after realizing the time that had passed and said softly. "My, it has been a long while. It still seems like yesterday to me."

Those photos reminded her of the days when she was free to enjoy one of her favorite past times, dancing. She grinned recalling "Ike never liked to dance so he didn't mind if a gentleman took me for a twirl on the floor cause he knew I would be back, sooner or later."

Her love of young people and dancing led to her being asked to chaperone countless proms and dances. "Mrs. Jackson came out to our P.E. Class to show us how to two step and waltz," recalled one former dance student. "She led us around the floor saying "Step-ONE-TWO-STEP-ONE-TWO". he recalled," There's no telling how sore her feet got, especially those poor toes we stepped on!"

I asked her if she remembered the dance lessons. She smiled and said "Ah, yes, it gave me an excuse to kick up my heals with those good looking young men. I danced with everyone who would ask me."

They appreciated her too. The kids, male and female, would wave at her as they came out of the old gym and saw her across the street sitting out on the porch or as they passed her home going to and from school. She was always invited to class activites especially those involving graduation.

"I remember when we had our graduation rehearsal in the Howard Auditorium," says Judy Moore. "After practice was finished, Mrs. Jackson called us to the back row where she was sitting. There was a big box there in the seat beside her. She had a little something there for each of us and there were about thirty in my class."

Another lifelong passion of Sis Jackson is "fishin". " Not

fishing, just fishin" she says. "It sounds more fun to just say "I'm a goin fishin', you wanta come?"

she laughs.

When her brother came for her birthday visit he asked her, "Sis, would you rather be dancin' or a fishin' on your birthday?" She looked up at him and answered," Brother, what kind of question is

that? I want to do BOTH!"

A knock came at the window before daylight one morning. There were no streetlights so when Mr. Jackson opened the window, he couldn't see who was there. A man's voice from the darkenss asked, "Would Sis like to go fishin' this mornin?" "I'll wake her and see," Ike answered. He then woke her and said, "Somebody's outside and wants to know if you want to go fishin?"

"Tell em to wait while I get my clothes on," she told her husband. After dressing and getting her gear she walked outside to where the man was waiting and said to him" before we go, who am I goin' fishin' with?" The man answered, "It's Monk, Monk Dexter now lets get a goin' Sis! It's about sunup now!", and off they went.

She was known for sitting on the pier at Mill Creek for hours with Mrs. John Allen or other friends. When her partner was ready to go, she could always be heard saying, "Just a little bit longer, "I'm about to get a big one! I just know it!"

After Ike passed away, Sis decided to take in boarders for the little apartment off the north corner of home. A newlywed couple rented the place. Billy and Fay McKissick married in 1969. Ruth Beard Smith remembers visiting her in high school and when she came in from college. "Mrs. Jackson, well she says to call her Sis, got me addicted to little Debbie Oatmeal cakes and Pineapple sherbert ice cream," she giggles, "I've told her she is the only reason Nelson's still stocks the pineapple sherbert cause I don't know anyone else who eats the stuff but us!" Mrs. Jackson has

always taken care of "Ruthie" who would come over and take a nap on her couch while skipping her study hall. "I had afterschool horn lessons at Northeast College and I'd visit with my friend, Ladye Love (Long), and we would watch T.V., nap and she would wait on us hand and food," Ruth fondly thinks back. "I visit her whenever I come home now but I wish I could make her feel as loved and taken care of as she made Ladye and me feel." (I feel the same as Ruth).

At the end of our last visit, she noted how wracked with arthritis her feet were. "They're worn out from all that dancin' I did," she says then laughs, "I guess if you dance the dance, you have to pay the fiddler!" she then turned her head to say, "I've had a good life Chris, I really have. God has blessed me far more than I deserve." Mrs. Jackson took my hand then," I had a wonderful husband, I have a good son, lots of friends and lots of laughs. Oh, and no regrets."

I knelt down beside her bed and said a prayer with her, then got up to leave. "You know Chris," she said, "I still go dancing in my dreams." I leaned over close to her ear and asked," Mrs. Jackson could you do me a favor? If Ike won't mind, could you save me a waltz sometime?" She smiled and her eyes twinkled as she giggled "Anytime honey, Ike doesn't mind! Lean over here," she said and gave me a kiss on the cheek as she squeezed my hand again.

"You made me so happy this evening. Do come back to visit me soon!" she said, "Please don't forget me!"

"Forget you?" I asked in surprise, Never! I have to find out how our dance goes! "I'm looking forward to my next visit with a friend and a genteel lady who will always be my "HERO"!





"We were trying to educate the public and the Board to what the job of teaching entails," she said. "At least they were willing to listen. We intend to become much more involved with our Board in the future."

All confirm that the most important thing in all of this is the children.

"We don't want to lose our focus through all of this-the children of the Tishomingo County School District," Weeden

The teachers, who personally touch the lives of these young people every day, are the first to agree with this.

Some Salary Relief On The

Way For Teachers? Dr. Weeden did explain that it was brought to the Board's and his attention during Monday night's meeting that the teachers in the county had not had an increase to the county supplement to teachers' salaries since consolidation. The supplement, a total of \$515 added locally to the salary of a teacher with an "A" certification or \$715 added to the salary of a teacher with an "AA" certification, is by no means the lowest in the state, according to Weeden. However, the teachers are due for an increase, he admitted. He said the Board will be deciding on this in a future meeting.

Weeden also mentioned that the teachers will be getting a 4 percent raise this year mandated by the state of Mississippi as part of its 10 percent in three years raise program.

Notice Of Change In Collections Of Past Due Accounts For TCEPA

Tishomingo Electric's policy has always been to grant, subject to management approval, occasional extensions of time to pay electric bills Unfortunately, a number of individual consumers have abused this privilege and caused additional collection efforts and created chronic past due balances.

This abuse has caused the board of directors to establish a more rigid collection policy for past due balances:

1. Approximately 3 to 4 days after the due date of the bill, a past due notice will be mailed to the customer at the same address as stated on the bill. This past due notice will give a date after which service will be terminated. No additional notice will be given.

2. TCEPA's collector will be required to terminate service if the account has a past due balance when he arrives unless the total past due balance is paid to him.

3. Customers who have not received an extension of time to

pay within the preceding twelve (12) calendar months may be granted an extension subject to management approval. No more than one extension will be granted in any twelve month period.

4. This policy becomes effective April 3, 1998. All past due balances must be paid by this



Income You are legally obligated to pay all of your creditors. When your income drops, however, and you are faced with bills you cannot pay, you must decide how much to pay to which creditors. The debt priority method works by first deciding which debts will have the worst consequences for your family if you do not pay bills. These usually include your mortgage or rent payment, utilities, food, medical insurance and your automobile payment. Pay these high-priority

While it is tempting to let medical insurance slip when money is tight, it is very important to keep up your payments. If anyone in the family should become ill, uninsured medical costs could be devastating.

In determining the next set of debt priorities, ask yourself what you could lose if each bill is not

Old Tishomingo Traces

There has been a tremendous response to Old Tishomingo Traces. It is gratifying to know that so many people are interested in preserving their memories of this area. One such person is Dot (Mrs. Claudis) Gober of Iuka. Thefollowing is her personal memories:

"I was pleased to see the article about Tishomingo Traces. It sure brought back memories. Mr. parents were Bart and Waymon Smith. We moved to Iuka from Rose Trail in Alabama in 1937. First, we lived on Eastport Road just past Ledbetter's Fish Market. Then on to what is now Paul Edmondson's Industrial Park at the west end near the railroad tracks. We attended school in Iuka. We walked on an old log road, and sometimes, we'd get brave and walk the tracks to school. My brother and I were six and seven and far too young to walk that distance by ourselves. We didn't know to be afraid of anything except the trains.

Later we moved across the tracks to what is now Seago Road. We attended Central School and walked on the Harmony Road to the railroad spur where there we rode Bud Dean's bus to school. We enjoyed going there and still have friends from that school.

My dad worked in Memphis leaving mom home with three kids. He was only home on weekends. We lived in an isolated place without another house in sight. We often had visitors from the railroad. They were called hobos. They'd come to our door asking for food. Mom always fed them. We didn't have much, but she shared what we had. Those visitors were mostly young men looking for work and hitching a ride on freight trains. We had no fear of them and no reason to. On this farm we had chickens, hogs, cows and two mules named Emma and Nell. The mules carried us to town, to church and pulled the plow for tilling the fields. They

were so gentle we kids rode them bareback. Dad hired a neighbor boy to do the farming while he

On Saturdays we would go to town in the rubber-tired wagon. Mom and dad had a fancy spring seat on which they sat. We kids had a board across the wagon bed behind them. On west Ash Street (a terrible road back then) we hit a bump. Their seat broke. Not thinking they could have been hurt, we laughed at them. We resented their fancy seat anyway. We still had our plank seat and now they had a floor of the wagon.

In 1942 we moved to Cagle

Road to the first land we had owned. We were about a mile from the school. There were no buses then so we had to walk. Sometimes Mr. Ward Moser came by to give us a lift. Dad worked in the tri-cities and had bought our first car. My brother and I had Miss Lela Graham as our sixth grade teacher. I remember all the teachers but most vivid is my memories of Mrs. Darrell Payne (later Jourdan). She called the roll asking questions. Oh, how we were afraid of her. She was all business but a good teacher. We also had Miss Mamie Culver (Clark). We respected her but she had her bluff on us - no talking or gum chewing. I wouldn't have carried her greens then as I do now. Now she is my special friend whom I love very much. We needed more Ms. Mamies and Mrs. Paynes.

Iuka is far different from the earlier days. On Saturdays everyone and their grandma went to town to do their grocery shopping, and to see their friends. If we had a dime, we would go to the Majestic Theater to see westerns. There was Johnny Mac Brown, Roy Rogers and Gene Autry. I still remember "Deep in the Heart of Texas" from Gene Autry's movie. Prior to the movies there were black and white

Iuka is strickly an old Indian

town. Chief Iuka is supposedly buried under what is now the Bank of Mississippi. Our fields were literally covered with Indian arrow heads, and mini balls from the Civil War. Under power and telephone lines were blue insulators. All these things are worth money today. If only we'd known to have kept them!

Who remembers the old hotels in Iuka? There was the Leatherwood, a huge one, where City Hall and the bank now stands. Also, Mineral Springs Hotel was where Weather's Body Shop is and the Hundley on Eastport Road in front of Iuka Baptist Church. It is still there today. Tourists came by train to drink of the seven mineral springs for health reasons. The old Mineral Springs Hotel also housed the first Vidette office and Health Department. Later this hotel was turned over to apartments.

Iuka had two dime stories -Gallagher and Williams. Mr. Williams collected tax with tokens and was often referred to as "Token Williams." Later, Mr. Williams sold to V.J. Elmore, a chain of dime stores. I started to work there at age fourteen. There

were no child labor laws and no minimum wages then. I only worked on Saturdays and Christmas rush. I started to work at 7:45 a.m. and worked until late at night when the streets folded up for the night. I often worked fourteen hours for \$1.48. We had to be good at math as we figured all the purchases, only using the register for total amount of purchase. After graduating high school and getting married, I went to work full time at Elmore's for \$15 per week. After coming home tired and grippy, my husband had me to quit. He said I was worth more at home. Later I attended Northeast Mississippi Junior College. I waited for Mr. Jourdan's bus at Pan Am. We went through Corinth since Hwy. 30 was not paved.

I remember Claude Curtis' Cafe. There you could buy hamburgers and cokes for five cents each. My friend and I walked from school to Mr. Claude's Cafe. Our lunches were

fifteen cents each. Now, this wouldn't pay the tax. I was in the graduating class of 1950 at Iuka High School. That was the first year a yearbook was published. We named it the Chieftain. We thought this was a good name as Iuka is strickly an Indian town.

Iuka has changed, but so have we. Time must go on.

My mother and sister had to cook for ten people, water had to be carried from the creek and heated in an iron pot on a wood stove, and money was scarce. I apologize to any one who was offended by my portrayal of a situation. I welcome all
