

# Maxwell Found Guilty, Sentenced To Death In Electric Chair In Pugh Case

Michael Craig Maxwell, 26, of Russelville, Ala. was sentenced to death in the electric chair for his part in the murders of Harold Pugh and his 11-year-old son Joey, a jury decided Thursday, May 14.

The jury in Jefferson County Alabama took less than two hours of deliberation Wednesday, May 13, before coming back with a guilty verdict. Then Thursday, the jurors took only an hour and a half to sentence Maxwell to death for the crimes. In Alabama, that means death in the electric chair.

This verdict comes approximately 10 months after the discovery of the bodies of the Pughs were found in the Tennessee River dead from gunshot wounds to the head.

Maxwell was the first of the suspects to be tried for the murder of the Pughs. Thomas Dale Ferguson is scheduled to go to trial in June in Mobile, Ala.

According to a statement by Maxwell, the vehicle of Harold Pugh was needed to use in a bank robbery in Belmont. He said that Mark Moore, one of the other men involved in the bank robbery scheme, had ordered him and Thomas Dale Ferguson, Kino Graham and Donald Ray Risley to get a vehicle to use in the robbery and there should be no witnesses.

The group of men then approached Harold Pugh and his son as they were pulling in their boat in at the Cane Creek boat ramp. The men then allegedly took the Pughs up the river where Maxwell and Ferguson reportedly shot them in the head and dumped their bodies into the water, Maxwell's statement confirmed.

The stolen truck was used as a getaway vehicle during the robbery of Deposit Guaranty Bank in Belmont the next day. It was later found burned in a rural area outside of Belmont.

An appeal will be made in the case, according to Defense Attorney Ben Gardner.

# One Arrested On Drug Charges Following Domestic Disturbance

A disturbance at a home in Iuka Monday night has led to the arrest of one suspect on drug charges and charges of family disturbance.

Floyd Williams, 46, of Gaylon Drive in Iuka, remained in custody at press time and no bond had been set, according to Tishomingo County Sheriff David Smith.

Smith explained that the City of Iuka received a 911 call Monday night and City Police Officers Anita Mitchell and Chuck Dean were dispatched to the home of Williams. The Sheriff went on to explain that the officers called the county for back up because of what appeared to be a volatile domestic situation.

"When we arrived, Williams had a female subject around the neck out in the carport area and we could not determine if maybe he might have a gun in his hand," Smith said. "He pulled her into the kitchen of the house and I went in after him. Once inside, he reached beside the microwave and pulled out what we believe to be 4 to 5 rocks of crank [a form of cocaine].

Smith said he grabbed the suspect and tried to bring him to the ground. When he would not cooperate, Smith was aided by the Iuka officers and Tishomingo County Deputies Rodney Pannell and Bobby Flynt.

Williams was charged with possession of cocaine with intent to distribute—over a gram and family disturbance.

Also arrested at the residence on charges of public drunkenness was Sissy Taylor, 37. Taylor was apparently behind the house at the time of the disturbance, according to Smith.

Confiscated at the time of the arrest was two pistols and a shotgun, Smith said.







# **Notice Of Change In Collections Of Past Due Accounts For TCEPA**

Tishomingo County Electric's policy has always been to grant, subject to management approval, occasional extensions of time to pay electric bills Unfortunately, a number of individual consumers have abused this privilege and caused additional collection efforts and created chronic past due balances.

This abuse has caused the board of directors to establish a more rigid collection policy for past due balances:

1. Approximately 3 to 4 days after the due date of the bill, a past due notice will be mailed to the customer at the same address as stated on the bill. This past due notice will give a date after which service will be terminated. No additional notice will be given.

2. TCEPA's collector will be required to terminate service if the account has a past due balance when he arrives unless the total past due balance is paid to him.

3. Customers who have not received an extension of time to pay within the preceding twelve (12) calendar months may be granted an extension subject to management approval. No more than one extension will be granted in any twelve month period.

4. This policy becomes effective April 3, 1998. All past due balances must be paid by this date.

5. Collections will continue in March under existing policy.

TCEPA provides the following payment options:

1. An automatic draft service for customers who wish to pay electric bills without the worry of missing due dates.

2. Level payment plan for customers with approved credit history

3. Due date change to the 5th of the month for customers on Social Security or once-a-month retirement benefits with approved credit history.

4. Drop box payment receptacles at the Iuka office and Belmont City Hall.



For Thursday, May 28th....

Farmers and others in Tishomingo County who have waste pesticides on hand are urged to take part in a waste pesticide disposal program on Thursday, May 28.

The one-time program offers farmers, chemical dealers, and others a no-cost, environmentally safe way to dispose of these products through a licensed contractor, according to Tishomingo County Agent Danny owen who is coordinating the program locally.

To take part, those with waste pesticides should bring their products directly to the collection site from 8 a.m. to 2 p.m. The program will be held on Thursday, May 28, only and will not be repeated in the immediate area, Mr. Owen said.





My great-grandfather William Henry Bullard and his wife Rebecca Billings were the parents of thirteen children. Their ninth child was Thomas Henry Bullard born 15 December 1864 in Tishomingo County. Uncle Tom married his first wife Susie Tackett (born 16 April 1868) on 21 March 1889. They had twelve children: Julia, Thomas W., Dewey, Alva Lee, Birdie, Bertha, Florence, Walter, Ed, Owen, Mattie and Luther

One of Tom's brothers was John B. "Dock" Bullard. First, Uncle Dock married Wheeler Ann Walker and they had four children: Laura, Jenny, Floyd Austin, and Doskie. Aunt Wheeler Ann died in 1898, and Uncle Dock married secondly Bette Tigner. Uncle Dock and Aunt Bette had six children: Pony, Charlie, Bill, Wesley, George and Gola. Aunt Susie Tackett Bullard and Uncle Dock Bullard both died in April 1916. These untimely deaths left Tom with approximately ten motherless children as two had died in childhood, and Bette with ten fatherless children, four step-children and six of her own.

Six months later in October 1916, Uncle Tom and Aunt Bette decided to marry so their twenty children would have a complete set of parents. Tom and Bette had one daughter Lessie. Lessie married Doug Mansel. They always attended the Bullard Family Reunions. Lessie would jokingly say that she had more brothers and sisters than anyone else in Tishomingo County. All of the 21 children got along well and loved each other as full brothers and sisters. The lone survivor of this large family is Owen Bullard, age 94, who lives near Iuka in the Pleasant Hill Community. As with most large families, kinfolk would come together, sit around large dinner tables and tell jokes and tales about each other. This family was no exception. I composed the following poem about one of the

tales I had heard repeatedly since childhood. I cannot swear to the truthfullness of it, but Owen told me he also had heard something about this incident. I entitled the poem, "Haint in the Tater Patch." (My apologies to the real poets of the world.)

There's a story about Uncle Tom and Aunt Bette,

As fine a couple as could be found, yet

They lived before indoor plumbing. was even a wish. For privacy they had to "go" behind

a bush. Tom was a good man, but afraid of the

dark.

- So he kept a dog that would bark At all strangers, sinners or saints,
- Because, like most Bullards, Tom was afraid of haints.

It was a dark, still night to help set the scene

All day Bette had peeled apples, some were green.

Their farmhouse was shrouded in a dense fog,

Off in the distance the grunt of a hog. They had gone to bed for the night. Bette was dressed in a flannel gown of white.

In her stomach she got a severe cramp

She said, "Tom, git up and light the lamp!

Tom reached for his overalls and took out a match.

And struck it on the headboard with a scratch.

Bette jumped out of bed telling Tom to

Some of our members attended the well planned Health Fair at Tishomingo County High School on Sunday and helped serve refreshments provided by the hospital.




National Honor Society.





the basis of academic excellence. American College Test scores and scholastic averages are considered in designation of the school's STAR Student, explained Bob Pittman of Jackson, MEC president.



Belmont Senior Kamiya Thorne has been selected to play in the Mississippi High School All-Star Basketball Girls Tournament game for the North Squad.







Applicants should submit a \$20 deposit with registration form.


