### Five Plead Guilty During First Week Of Circuit Court

Five pleas were entered Monday, the first day of the May session of Circuit Court in Tishomingo County.

Defendants pleading guilty to felony charges, according to Assistant District Attorney Arch Bullard, were as follows:

Steve Cook pleaded guilty to DUI—third offense. He was sentenced to five years, all of which were suspended. He received five years probation, was ordered to pay a \$5,000 fine and court costs.

Darrin Clark pleaded guilty to conspiracy to procure an indictment. He was sentenced to five years, all of which were suspended. He received three years probation, was ordered to pay a \$500 fine and court costs.

Larry Higginbottom pleaded guilty to the sale of marijuana—less than an ounce. He was sentenced to three years, was given credit for time already

served and the rest was suspended. He received three years probation, was ordered to pay a \$3,000 fine, court costs and \$90 to the Tishomingo County Sheriff's Department.

Randy Tigner pleaded guilty to three burglaries of commercial buildings. The Judge chose not to follow the recommendation made by the District Attorney which would have put him on house arrest for seven years. Tigner instead received three years probation. If the probation is successfully completed, the charges will be expunged (removed) from his record.

James Voyles pleaded guilty to possession of marijuana. He was sentenced to three years, all of which were suspended. He received two years probation, was ordered to pay a \$500 fine, court costs and \$25 to the Tishomingo County Sheriff's Department.

Circuit Court will continue beginning Monday, June 14.

### Shooting/Beating Leaves Two Hospitalized

A shooting incident in Iuka Saturday evening has left two in critical condition in Memphis, TN hospitals.

A 911 call at around 12:20 early Sunday morning, June 6, 1999, reported a shooting at the former Doncrest Apartments on North Pearl Street in Iuka. Iuka Police officers responded to the call. When they arrived on the scene they found a young female, Machele White of Iuka, shot in the arm, apparently by a sawed-off shotgun. They also found a male, Danny James, severely beaten. Both victims were outside the apartment which was rented by James.

The two were transported to the Iuka Hospital and air lifted to Memphis, Tennessee hospitals. Both were in critical condition.

According to a spokesman for the Police Department, at this time no charges have been made pending the condition of the patients. No other details are being released at this time.

### Three Family Members And Friend Charged In Murder Of Iuka Man

Four suspects have been charged in connection with the shooting death of an Iuka man which occurred Friday.

Edward L. "Eddie" Byrom, 56, was found dead at about 4:30 p.m. Friday, June 4, at his home, located at 762 County Road 172, Iuka, from numerous gunshot wounds, according to Tishomingo County Sheriff David Smith.

Suspects arrested and charged in the incident are Byrom's wife, Michelle Byrom, 42, of 762 County Road 172, charged with capital murder; his son, Edward Byrom, 19, same address, charged with capital murder; a friend of the family, Joey Dale Gillis, 20, of 77 County Road 176, Tishomingo, charged with capital murder and Byrom's nephew, Eric Byrom, 24, of 762 County Road 172, charged with accessory after the fact of murder.

Smith said after his department received the call Friday afternoon, they arrived at Byrom's residence and found him lying on the floor between the couch and the coffee table. The Sheriff confirmed that Byrom had been shot numerous times with a 9mm German Luger handgun.

"After finding the victim, we immediately secured the crime scene and started the investigation," Smith said.

He said they made pictures of everything at the scene. At that time, the law officers began questioning Byrom's son, Edward, who had called authorities and reported that his father had been shot, Smith explained.

"Soon after we had started the investigation, we realized that we had a murder scene," Smith said. "We began to try and find out who all had been at the residence."

Smith said they then began to compile statements and physical evidence. Since that time, the Sheriff and his entire staff have worked tirelessly to gather information and evidence in the case.

As part of this investigation, a gun, believed to be the murder weapon, has been found in the Burgess Creek area, Smith reported. He said that in addition to the gun, other physical evidence has been found and will

be taken to the Mississippi Crime Lab for analysis.

Sheriff Smith also brought in Investigator Ricky Marlar of the Mississippi Highway Patrol Criminal Investigation Bureau to aid in the gathering of evidence.

"We are not giving out a lot of details at this time since we are still in the process of interviewing people and gathering additional information," Smith said. "We also are not giving out information on a possible motive at this time since this is an ongoing investigation. I will say that additional charges could be made."

The Sheriff said he discussed the case with Assistant District Attorney Arch Bullard, and Ralph Dance, an investigator with the DA's office, was brought in on Monday to follow up on the questioning done by the Sheriff's Department.

Only hours after the victim's graveside service Monday, an arraignment was held for the suspects involved in the case. At that time, bond for Michelle and Edward Byrom, as well as Joey Dale Gillis, was set by Tishomingo County Justice Court Judge J.R. Blakney at \$1 million each. Bond for Eric Byrom was set at \$250,000.

### Authorities Investigate Break-In At Burnsville Business

Tishomingo County authorities are searching for suspects who broke into a Burnsville business last week.

According to Tishomingo County Sheriff David Smith, Officers Bobby Flynt and Donald Thomas were dispatched to Raceway service station, located on Hwy. 72 in Burnsville, around 2 a.m. Wednesday, June 2, when the business' owner Larry Martin called to report that there had been a break-in.

Martin had apparently come by his business and found that

someone had entered a small hole made in the roof of the metal building and had taken various items from the store. These items included all the Marlboro cigarettes, some watches, an undetermined amount of cash and the video tape from the business' surveillance system.

The Sheriff said this break-in and several other burglaries in Iuka businesses may be the work of the same person or persons. He is asking that anyone with any information on the Burnsville burglary call the Tishomingo County Sheriff's Department.

### Iuka Police Department Seeks Information In Area Burglaries

The Iuka Police Department is offering a substantial reward for information leading to the arrest and conviction of the person or persons responsible for break-ins at four Iuka businesses recently.

The burglaries, which have occurred within the last week, have all taken place in the late night/early morning hours, according to Iuka Assistant Police Chief Randy Stringer.

The Iuka PD is not releasing the names of the specific

businesses which were burglarized at this time. However, assorted items taken included money, name-brand clothes, meat and Marlboro cigarettes.

"We need the public's help in solving these burglaries," Stringer said. "We are asking anyone with information to call us."

## Home Economics Tips

### Water: An Essential Nutrient

Although it is often overlooked, water is one of the most important nutrients. It is vital to health and is ranked second only to oxygen as essential for life. A person can live for a few weeks without food, but can only survive a few days without water. On average, an adult body weight is 55 to 75 percent water, which equals to about ten to twelve gallons.

### WATER IN YOUR BODY

The primary role of water in the body is to transport nutrients to the body cells and carry waste product away. Water supplies the universal medium in which various chemical changes of the body occur, aiding in digestion, absorption, and circulation. It is the main part of every body fluid including blood, gastric juices, and saliva. It also helps to cushion joints, form body cells, and protect body organs and tissues. By softening stool, it also helps to prevent constipation. Water supplies small amounts of many minerals vital for life, such as sodium, potassium, calcium, copper and magnesium.

### How Much Water Do You Need?

The average adult loses about 2 1/2 quarts of water daily through perspiration, even when they are just sitting. During hot, humid weather or strenuous physical activity, fluid loss becomes much higher. Water replenishes the body's cooling system, enabling it to survive sweltering heat or elevated body temperatures due to exercise.

Sweating cools the body by evaporating water on the surface

of the skin and dispensing excess heat.

Water is also removed during bodily functions including urination, bowel movements, and breathing. To avoid dehydration and to keep your body working normally, it is important to replace lost fluids. This is imperative because unlike other nutrients, the human body does not store an extra supply of water that can be used when there is a time of need.

Most people need eight to twelve cups of water daily. This includes water that is found in milk, juices, and some solid fluids. Milk is about 87% water, meat ranges from 40 to 75% water; and vegetables are as much as 95% water. Even foods normally considered "dry" such as cereal and bread contain about 8 to 35%

water.

### To Increase Your Water Intake And Prevent Dehydration

1. Take water breaks during the day instead of coffee breaks.
2. Complement food with water, milk, or juice.
3. Drink water before, during, and after any physical activity, especially in hot weather.
4. Consume 4 to 8 ounces of water every 15 to 20 minutes while you exercise.
5. Travel with a supply of bottled water.
6. Decrease your intake of caffeine and alcoholic beverages. Caffeine and alcohol act as diuretics, causing the body to lose water through increased urination.

### Drug Store Glasses

I am often asked for my opinion on the cheap eyeglasses on display at drug stores. Here it is:

These glasses are simply magnifying lenses mounted in frames. They may seem fine when worn for a couple of minutes in the store but, when used for an hour or more to concentrate on reading or sewing, they may prove unsatisfactory.

They can cause headaches, tired eyes and other eyestrain symptoms. The reason for this is that they do not contain your exact lens prescription or because the lenses' optical centers may not be centered with your pupils.

The real risk with these glasses, however, is that you may substitute them for a thorough vision examination. Your optometrist needs to see you every year to make certain your eyes are healthy and determine the exact cause of any vision difficulties. Then the proper lenses can be prescribed for your eyes.

### Dental Implants Grow More Popular

Dental implants - replacements for missing teeth - are proving to be one of the most exciting areas in the dental profession today.

Dental implants attach replacement teeth directly into the jawbone. For some people, they may be a viable alternative to conventional bridges and dentures.

Dental implants are not suitable for everyone. An evaluation is necessary to determine if an individual is a good candidate for an implant. Such an appraisal includes, a dental and medical history, oral exam, X-rays and other diagnostic tests.

Factors such as diabetes, loss of bone under the gums and factors in the patient's medical history and psychological profile also contribute to the success of the implant procedure.

A candidate for an implant must have a jawbone that is high enough, wide enough and dense enough to accommodate the implant. Good general health, healthy gums and a commitment to oral hygiene also are important requirements.

Because several steps are involved, the implant process can take from three to nine months, depending on the type of implant.

### Tacky, Tacky Ticks

Ticks are perhaps the most annoying external parasites known to attack small animals. These small, ugly parasites firmly attach themselves to your pet and gorge themselves on the animal's blood. Animals are likely to acquire ticks anytime they get in shrubbery, undergrowth or high grass.

While ticks are more likely to be found on dogs, they are often found on cats as well. Both cats and dogs should be examined frequently for ticks. Most often, ticks are found in the neck area, between toes, in the ears and in the folds of the body between legs and torso. They may appear to be a small wart or seed.

Other than discomfort, ticks pose two basic threats to your pet's health. First of all, frequent scratching to get rid of a tick may break the skin and lead to a serious bacterial infection. Secondly, ticks, because of their blood sucking, lower an animal's resistance to disease and transmit infections from animal to animal.

In addition, ticks pose a threat to human health. They are known to transmit Rocky Mountain Spotted Fever, a frequently fatal disease to humans.

Many of the programs currently available for tick control are designed to help control ticks as well. Remember, however, that the program must be on-going in order to be effective. Not all products used to prevent ticks are safe for all animals. The best person to advise you concerning safe products for your pet is your veterinarian.

Like many other external parasites that threaten small animals, ticks are experts at survival. They can go without food for as long as two years.

The female lays her eggs as many as 3,000 of them virtually anywhere.

Therefore, your pet has only a room outside the protective environment of your home to pick up new ticks.

Be on the alert. Protect your pet. Guard against ticks. Ask your veterinarian about the new products available.

She discussed the changes of shoes in the 18th and 19th centuries and the social emphasis of shoes. Wealthy women wore more stylish, expensive, and elaborate shoes than the wives of the common men. Shoes were generally considered a mark of rank of prestige. Throughout the 1800s, stylish shoes were made of rich

silks and velvets decorated with embroidery and silver trim. Shoe materials and style depended on climate, custom, or other factors. The practice of using ribbons and cross-over laces was popular. Buckles became larger and more elaborate with the passage of time. shiny buckles were a sign of wealth. Shoe makers began putting labels in shoes around the middle of the century for advertising. During the 18th century ladies wanted to order their shoes from London.

Shoes with buckles were worn for outdoor use. A style of shoe without backs, created in France, was worn indoors. This style of shoe is called a mule. These are the popular shoes of today worn everywhere.

Ladies of gentry in the 18th Century did little outdoor walking but rode in carriages. Their expensive and elegant shoes needed to be protected from the elements.

Around 1820, rounded toes and practical heels, sandal shoes and slides like the Greek and Roman slippers were worn.

Boots began being fashionable early in the 19th century because people were walking more.

Throughout history, shoes have been worn for protection. Shoes have always been a fashion statement and worn for looks as well. Today, many people buy shoes for comfort because of their busy life style.

### Justice Court Held At Old Tishomingo County Courthouse

The Justice Court recently held a session at the old Tishomingo County Courthouse. Customarily, the justice court hears cases on the first and third Tuesdays of each month at the "new" courthouse on Highway 25 South. Several years ago, Justice Court Judges Willie Joe Sparks and James R. Blakney and County Prosecuting Attorney Nick Phillips decided to have court occasionally at the old courthouse. "Originally, we thought it would just be for one time," Judge Blakney said, "but it worked so well that we try to do it every two to three years, especially when we know the new courthouse will be crowded because of another court being held."

In order to plan a session in the historic facility, the judges have to give notice a couple of months in advance, and bail bonds are made returnable to that building rather than the regular courthouse. "It does require some

planning and parking is, of course, a problem at the old courthouse" Judge Sparks said, "but we have had a number of positive comments about having court there."

The old courthouse was built in 1886 at a cost of \$7,784.36 after

the previous courthouse had burned. It served the county until 1971 when the present courthouse was completed. County Prosecutor Nick Phillips recalls first seeing a trial in the upstairs courtroom: "Mrs. Mamie Clark, my sixth grade teacher, encouraged us to attend court when we could, so the first trial I ever watched was in that courtroom before Circuit Judge "Soggy" Sweat. The building was not air-conditioned at that time, so the windows were open. Between the noise from traffic on Highway 72 and trains coming through town, it was sometimes hard to hear what was going on in the courtroom." Both Judges Sparks and Blakney and prosecutor Phillips hastened to add that while they enjoy the historic atmosphere of the old edifice, they prefer the better accommodations of the present courthouse.

The old courthouse is today the headquarters of the Tishomingo County Development Foundation and contains a public museum on county history. In addition to occasional justice court sessions, the courtroom is a popular space for public meetings.

## \$190,000 Settlement Reached In Six-Year-Old Case Against The County

After six years of litigation and negotiations, the County of Tishomingo ended a civil case last week brought against them by an Iuka resident.

According to information obtained from the minutes of the May 24 Tishomingo County Board of Supervisors meeting, a check for \$190,000 was to be issued in the names of Iuka businessman Carrol Ed Sanders and his attorney Mike Cooke as settlement in a 1993 case brought against the County by Sanders. County records show that a check for that amount was written to the two parties on June 1.

The original judgement against the County in the amount of \$500,000 was reduced in November of 1998 to \$100,000 by U.S. Northern District Court Judge Glen H. Davidson. Sanders

had the option of accepting that amount or refusing it. In the event he refused it, the County would be granted a new trial for the issue of damages, according to the court reports.

The County had the option of appealing the judgement or paying the plaintiff if he agreed to the amount. Sources reported that the County decided not to go to the expense of an appeal, and instead, negotiated with Sanders for the \$190,000 settlement. An agreement in conjunction with the settlement stipulates that this case cannot be brought against the county again.

The original suit charged that a former Tishomingo County Sheriff and two former Sheriff's Department Deputies planted drugs in Sanders' home and shot into his Hwy. 172 business in Iuka.

## Alabama Man Fails To Appear In Court To Face Tour Bus Scam Charges

An Alabama man did not appear for his trial date during this week's Tishomingo County Circuit Court and will now be held in jail until the next session of court in September.

According to Assistant District Attorney Jim Pounds, the defendant, Earl Douglas Smith of Russellville, Ala., is charged with seven counts of false pretense involving the alleged embezzlement of \$40,000 from investors in a tour bus scam.

The charges state that Smith got seven different individuals, two of which were Tishomingo County residents, to invest several thousand dollars each on the assumption that he was purchasing a bus to be used for conducting tours. The individuals

who invested in the proposed tour company reported that no bus was purchased with the money they invested and that Smith was merely running a scam.

Pounds said the State had witnesses in other states who were waiting to fly in and testify in Smith's trial. When Smith did not appear Monday in court, Pounds filed a motion with Circuit Court Judge Thomas J. Gardner III to have him held, without bond, in the Tishomingo County jail until the next session of circuit court in September. He also asked that his \$50,000 bond be revoked.

Smith was found later Monday and was turned in by his bonding company, Pounds said. He was then placed in the county jail.

The critical components identified through this process either have been or will be remediated in time for the new millennium. In addition, we have also requested certification of readiness from our vendors to determine the status of critical systems and we are requiring that current and future purchases be compliant. TVA as our power supplier has and continues to implement a comprehensive Y2K review and remediation plan. Finally, TVA and Tishomingo County Electric Power Association are in the process of developing a contingency plan so that we can resume normal operations in the event of a system failure.

We believe our distribution facilities will be capable of operating without significant interruption caused by the transition into the next century.

## Anti-Spit Tobacco Poster Contest

The Tobacco Intervention and Prevention Program of Tishomingo County recently held an anti-spot tobacco poster contest sponsored by the First American National Banks. The middle school students illustrated the dangers of spit tobacco in a colorful and straightforward manner. These posters can be seen in several of the local businesses in your area. Each proclaiming a simple message to users of smokeless tobacco, "Spit it out!"

Although the use of smokeless tobacco ("chewing tobacco", snuff) has enjoyed a long history in the U.S., recently years have witnessed a rapid increase in the use of these products. A national survey indicated that over twelve million Americans use some form of smokeless tobacco, and nearly half of these persons used it at least once per week. Twelve percent of Mississippi males in grades 9 to 12 use smokeless tobacco. Smokeless tobacco use starts early. In fact, a quarter of all users say they tried smokeless tobacco by 6th grade. In recent years, total sales of moist snuff products in the United States has increased approximately 55%. This dramatic increase can be attributed in part to a push in

recent years to eliminate smoking in public places and the mistaken belief that smokeless tobacco is a

safe alternative to cigarettes. The United States Surgeon General reports that only 40% of kids think that smokeless tobacco is harmful. It may be smokeless, but it is not harmless.

A single cigarette delivers up to 3 milligrams (mg) of nicotine directly to the smoker's bloodstream. Smokeless tobacco products pack an even more powerful punch, providing up to 4.5 mg. of nicotine in a single pinch. Nicotine is a highly addictive drug, whether it is delivered to the body via spit or smoke. The effects of nicotine in smokeless tobacco fade within 20-30 minutes of use; therefore, frequent use is necessary just to feel normal. Besides addiction, smokeless tobacco can contribute to serious health problems, including, tooth abrasion and decay; gum problems; bad breath; high blood pressure; cancer of the mouth, voice box, throat, and esophagus; stomach ulcers and heart disease. If you use smokeless tobacco, you should be on the lookout for some of the early signs of oral cancer: a sore that does not heal, a lump or white patch, a

prolonged sore throat, difficulty in chewing, restricted movement of the tongue or jaws, or a feeling of something in the throat. Pain is rarely an early symptom. For this reason, all tobacco users need regular dental check-ups.

## Old Tishomingo Traces

Last week I failed to get an article ready. Guess you could say I'm suffering from old age since I was 62 on Sunday, June 6. I don't mind telling my age; just don't ask me how much I weigh.

Irene Barnes sent in an interesting historical sketch of the Goode Family. Irene is a very knowledgeable lady regarding the history of Tishomingo County and I appreciate her very much. Sometimes we talk for hours and have found that we have a lot in common. As Anne of Green Gables would say, "I guess we are kindred spirits." I hope everyone will enjoy Irene's following sketch of "The Goode Family" as much as I did:

Nathan Goode, the son of Charles B. and Elizabeth (Halbert) Goode, married an Indian woman named Mahulda Ladd. They had seven children all born in Lauderdale County, Alabama. In 1854 they bought land in Tishomingo County described as the SW 1/4 of Section 28, Township 3, Range 11 from John J. Blythe, administrator of the Shelby Ussery estate through the court.

Mahulda, or Hulda, as she was called, was an Indian doctor treating anyone who needed her services. She had a lean-to on the house where her herbs and concoctions were kept. She and Nathan often took in orphaned children and cared for them.

On the day of Nathan's death in 1862, he and a sickly, crippled Negro boy went out toward Bear Creek to hunt some cows. During this time there were bushwhackers and outlaws. A man named Clark and his gang overtook Nathan and the boy. Clark demanded that Nathan give him his money. Nathan told him he had no money. They seemed to think he was Major S.S. Hogue, a nearby wealthy landowner. He told them again he had no money. They shot Nathan, searched his body and found nothing. The Negro boy hurried home to tell Hulda what had happened. All she had was a bull yearling to pull things. Indian trained, she kept a forked tree top to use as a slide. After dark, she went through the woods, found Nathan, tied him on her tree top slide and pulled him home. Then she, the boy and an old one-eyed man dug a shallow hole in the garden that night and buried Nathan Goode. They took rough ceiling out of the house loft to make a coffin. They had no nails, so they tore up their bed and got the bed cords to tie the planks around his body for a coffin. The Goode place is located about one mile southeast of Snowdown Methodist Church Cemetery.

On January 1, 1867, their land was sold to Joseph P. Wilson and his wife Margaret Caldonia (Goode) Wilson (Hulda's daughter and son-in-law). Hulda died July 5, 1880 at the age of about 102 years. She was living with a family named Crews. She is buried beside her son-in-law Mark Lewis Daniel in Old Smyrna

Cemetery four miles southeast of Cherokee, Alabama.

Among Nathan and Hulda's children was a son James H. Goode, born September 3, 1834 in Lauderdale County, Alabama. James fought in Co. E, 2nd Tennessee Regiment of the Civil War. He married Sallie Wood. Their children were sons, George Shelton, J.H. and Willie M. Goode and daughters Emma Bell, Mary Ida and Lillie Lee Goode.

James' wife Sallie is not known to have Indian blood like Hulda but she did many amusing things. She often went to Snowdown Methodist Church and rang the church bell. No one could persuade her to stop. She claimed to be calling up her dead family members to talk with them. Will Mars once wrapped himself in sheets to look like a ghost during one of her bell-ringing episodes. She chased him and almost caught him.

Once there was a big snow and several young men, Andrew Daily, Jim J. Mars and others went down on the steep hills near the Goode home to slide down the hills on boards. Sallie came out with her dough bread tray to ride with him and crashed into a barbed wire fence. She would sometimes cut a wagon load of wood off some one's land and take to town to sell. Once she was traveling on Snowdown Road with a load of pine kindling. Newton Jackson was traveling behind her. She jumped up in her wagon and yelled, "Shut your eyes, Newton Jackson. There's a lizard on me," and turned her dress over her head. Evidently, he didn't shut his eyes.

James H. Goode's grave is marked by a Civil War marker at Snowdown but Sallie and most of their children are buried in unmarked graves. According to the family Bible record, George Shelton Goode was born January 24, 1865; J.H. Goode was born March 29, 1875; Emma Bell Goode was born August 23, 1869 and died October 19, 1944; Mary Ida Goode was born November 27, 1872; Willie M. not on Bible record but 1880 Census lists the age as 3 years

old; Lillie Lee was born August 23, 1879. Sallie died November 28, 1921.

Emma Bell Goode had three sons: William Henry Goode born May 16, 1894 and died November 16, 1948. He was a World War I veteran and married Mary Lou Brown; Silas Ray Goode was born May 2, 1900 and died October 26, 1937. He married Bessie Dexter on January 4, 1921; Mack Goode was born December 21, 1913 and died April 8, 1988. He married 1st Alma Pinch and 2nd Helen Null. He

divorced both. He was a veteran of World War II.

Lillie Goode and Charles Edwards alias Charles Clark married in the summer of 1909. They lived together for a month and he deserted her. Mary Ida Goode married John W. Wimbish and had one daughter Ethel

who married Carl Booker.

Irene, thank you for your interesting article. While reading an issue of the Vidette dated August 22, 1928 (on microfilm at the Iuka Library), I found the following notice: No. 1861 - In matter of Estate of James H. Goode, deceased. Letters of administration having been issued to the undersigned by the Chancery Court of Tishomingo County, Miss., notice is hereby given to all persons

having claim against the estate of said decedent to have same probated and registered by the clerk of said court within six months from this date, or the same will be forever barred. Signed: Belle Goode, Administratrix, August 13, 1928.

And, from the Vidette dated July 12, 1928, I found this article:

Little son of Luther Rice struck by car: A very serious accident occurred late Sunday afternoon when the three year old son of Luther Rice was struck by a car driven by Silas Goode. The accident occurred near Mr. Rice's home here. It seems that the little fellow was crossing the street and a car had stopped for fear of running over him but the other car in which were several young men and

driven by Goode, dashed across car which had stopped and struck little fellow dragging him about hundred feet before the car stopped. Goode was arrested and jailed. The little boy, it is hoped, recover, though he is very seriously injured.
