Fumes From Propane Buffer Send Six Dollar General Employees To Hospital

Carbon monoxide fumes created by a propane powered floor buffer sent six employees at Luka's Dollar General Store to the hospital Monday afternoon.

According to Luka Firefighter/EMR Lee Shields, a man who was hired to buff the floors at Dollar General Store in Luka used a propane buffer inside the building. Apparently the building did not have sufficient ventilation and the doors were closed resulting in a high concentration of carbon monoxide collecting inside. Since this gas is odorless and colorless, employees in the store were not aware that it was in the air.

Luka Firefighter/EMR Brandon Grissom said the employees reported that the man started buffing around 9 a.m. and left around 4 p.m. so the employees were exposed to the toxic fumes for most of the day.

"We suspected that it was carbon monoxide from the symptoms the victims reported," Shields said.

Some symptoms associated with carbon monoxide poisoning include burning eyes and nose, dizziness, nausea, headache and lips that turn cherry red in color.

Apparently the victims began passing out inside the store. Grissom said when IFD

firefighters took their CO (carbon monoxide) detectors within five feet of the store's doors, the level of carbon monoxide in the air was at 170 parts per million. In the back corner of the store it registered at 172 ppm.

Shields said the normal carbon dioxide levels are between 0 and 25. Anything over 25 is considered to be in the danger level.

Both Grissom and Shields agreed that the victims of the carbon monoxide poisoning were lucky to be alive.

"With levels this high, and the prolonged exposure, they could have died," Grissom said.

He said one of the victims, who was seven months pregnant, was taken to Tupelo's North Mississippi Medical Center's Women's Center and was kept overnight for observation. The others were taken to Luka Hospital. Shields reported that at least two victims remained in the hospital overnight.

The Luka Fire Department responded to the call at approximately 4:35 p.m. After the building was vacated, they spent over an hour setting up and running large positive pressure ventilators to get the fumes out as quickly as possible, according to the firefighters.

One-Vehicle Accident Claims Life Of Tennessee Man

A one-vehicle wreck just south of Savannah, Tenn., has claimed the life of a 22-year-old Tennessee man.

William Jason Hoover, of Mt. Vinson Road, Stantonville, Tenn., died Wednesday, June 16, at the Hardin County (Tenn.) General Hospital.

According to a report from the Tennessee Highway Patrol, Hoover was traveling west on Tennessee Hwy. 57, near Leath Road, at approximately 12:15 a.m. in his 1990 Chevrolet AstroVan when he apparently lost

control of the vehicle and hit a tree.

William Jason Hoover is survived by his wife, Stephanie Tuberville Hoover of Stantonville, Tenn.; his mother, Linda Hoover of Luka; his father, William Roy Hoover of Baldwin; one brother, Mark Hoover of Corinth and his grandmother, Vida Nichols of Tishomingo.

Services were at 4 p.m. Friday at Ludlam's Funeral Home with Bro. Howard Stanford and Bro. Johnny Nunley officiating. Burial was in Providence Cemetery.

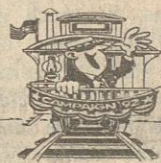

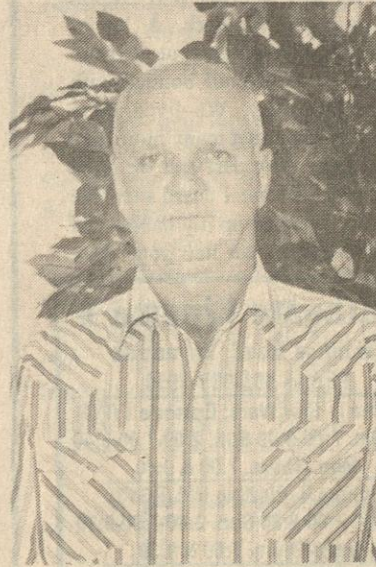
Leslie Blaylock Announces Candidacy For County Sheriff

Sign-Up For Daily Call-Up Service For The County's Elderly Set For Thursday Night

Tishomingo County Sheriff David Smith urges all the elderly or those who have loved ones who are older or disabled to come to the courtroom in the Tishomingo County Courthouse on Thursday, June 24, at 7 p.m. to sign up for the Sheriff's Department's "Are You O.K.?" daily call-up service.

"Are You O.K.?" is a free program which will soon be available through the Tishomingo County Sheriff's Department designed for older adults, disabled persons, shut-ins who live alone or anyone in the community who needs to be checked on daily.

This program is a computerized telephone calling system which will call each enrolled caller (known as a subscriber) at the same time each day.

If the subscriber answers the phone, he or she will hear a voice saying, "Good morning, are you okay?" If the subscriber does not answer, the computer will try again. The computer will notify a police dispatcher if there is no answer or if there is a busy signal several times in a row.

If a subscriber plans to be away from their residence during a holiday, vacation or any other time, he or she may call and have

the service stopped for that time period.

Each subscriber will be asked to choose a time they prefer in the morning between 7:30 and 10:30. The calls will be made in the same order each day.

Everyone who signs up for this service will be asked to fill out a short form with medical and other information needed in case of an emergency. Smith explained. This information will be kept totally confidential and would only be used by Sheriff's Department personnel in case of emergency.

Anyone who thinks he or she might be interested in signing up for the call-up program should come to the Courthouse Thursday night beginning at 7 p.m.

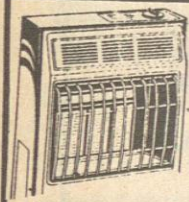

Old Tishomingo Traces

Thanks to Jewel McCoy Choate for her continuing story of "The Other Side of the Coin" as follows:

Memories Surrounding Our Days at Cross Roads.

In 1941 Wilson and the two older girls and I were still living in the little house next to Yellow Creek. Uncle John Curtis had Mr. Charlie Levin come over and rework the house and make it liveable for us. We spent many happy hours fishing, boating, swimming and just wading in the canal.

The saw mill crew was still in Kentucky. Aunt Ethel Curtis and Sis would help me with my children Barbara Sue and Martha Lou, now almost 4 and 2. They loved Sis so much.

The mill crew was made up of the Cutshall Brothers - Otis, Preacher, Tidy, Hafford and Clayton Earl, Wilson Choate, Charlie Carson, Vardaman Robinson, if I remember correctly. Also Mr. Otis' brother-in-law Mr. Loyd would help out. Mr. Loyd is all I heard him called. Mr. Otis was a fine man and an idol to many folks. One morning, according to Wilson, Hafford showed up late. Mr. Otis asked him if he had been drinking. "Not a drop, Otis," replied Hafford but Mr. Otis told him to go on home. Families and crew all lived together in a big rented house. They were short handed. Mr. Otis was not only boss of the whole crew, he was shepherd of the flock. Mr. Otis had quit his wild, wooly ways and was going to see that his brothers did also. Atlas Carson was chief cook and bottle washer. He not only cooked the food but kept the time clock. He would go to everyone in the morning singing a tune, "Rise and shine and get your 4 o'clock coffee. I know you are tired and sleepy too. I hate to call you but you got it to do." I have heard that story and also the cute little tune many times over the years.

When the crew got home for dinner one day, Mr. Carson's beans rattled in the cooker. Mr. Otis asked Atlas if Hafford had divided his drink. "No, Otis, not a drop," replied Mr. Carson. I don't know if Hafford divided or not. Anyway Mr. Otis didn't raise his voice and told the crew to wait patiently until he could go into town and bring back lunch.

It was getting pretty hard for me to stay by myself so much with Wilson staying away from home while working at the mill. I was also expecting my third child Anna Jean. Uncle John had lots of friends including TVA men since he bought and sold land. My children were improving with their singing. Uncle John would call me to bring them and let his TVA men hear them sing. God

gave each of them talent in music and song which later led them into broadcasting, concerts, and singing in revivals, churches, funerals and weddings. People would give them change. Each one had their own cup

and would save their money for what they wanted.

We had never got to be near Wilson's own family. We had visited and they visited. Mr. Ed Hubbard one of their friends promised Wilson a good job taking care of a filling station and fixing cars. Also, a nice little place to live. We decided to move near his people half way between Tyroneza and Marked Tree, Arkansas. Mr. Ed ate many meals and fellow shipped with us. Wilson was a very good mechanic and did quite well. We looked forward to our third baby girl who was 25 months and 5 days younger than the second one. She seemed to be a healthy baby for about 9 months and then she was over come with illness, one thing after another. Pear Harbor was bombed and war declared while we were in Arkansas. So much going on we decided we would be better off coming back to Mississippi. Wilson went to work in defense plant at Reynolds in Muscle Shoals, Alabama. So we came back to Uncle John's and had our first little house made over. Paul Reece was a good decorator and he painted and papered the house. We had some pretty new furniture. People were making new mattresses and we joined in. The Cutshalls moved to Florida.

Elton "Sis" Curtis had now grown up and married and Berlon Curtis was off to work. A lot of changes had taken place but we were still close, and they all bonded with our precious baby. We lived there quite a while and met many more nice people. Some time past and we lived near Scruggs Bridge. I heard a terrible explosion. I picked up my babies and went to check. A car had gone right

through the rails on the old bridge and come to rest by the canal. No one was near as it was Saturday afternoon and everyone gone to town. The first to arrive was Andrew and Mentia Bullard in a black pickup. I soon made friends with them which was to last for a lifetime. Others began stopping and soon help arrived. One young man had lost his life. One survived. It was a tragedy that still stands out in my memory.

We lived down there while Wilson was working in defense plant. One late Sunday afternoon it came a terrible storm. I had supper ready but we had to hurry and go down to Uncle John's house before it hit. It came a terrible storm and beat our house top into rubble and ruined most of our furniture. The saddest part was Aunt Ethel had two lady friends as company. The storm hit one side of their house and knocked all the windows out on that side. It made leaks that had never been in that tin top house. Their family, company and our family all survived in one big room and hall. People came in and helped us clean up the next day. Reynolds made up money for new roof. Our car had to be replaced and

transportation was hard. We decided once more to move back south of town and that was our last time to live at Cross Roads. We still keep close in touch with our friends there.

Wilson shared his memories of Bullard Cut Off School as he had grown up in that area. He had so many friends there. The Osborns, Gardners, Hudsons, Walkers, Bullards and many more. They had an older man for teacher and he would take naps after lunch and told kids not to bother him. One day he slept all afternoon until time to go home. They would check and he still slept on. They had a young lady teacher and she went out with one of the students Bilbo Bullard who happened to be Wilson's cousin. They forgot to come home in time for school one morning. Sad thing was his dad Uncle Jeff Bullard was on the school board. So it was decided she had to move on. They got Mrs. Mentia Bullard to finish out the term. Wilson was jumping for joy probably hoping she would help keep him out of trouble. He and a friend the late Bert Hudson had been fighting on way home and Bert always won. Wilson decided he would get his big sister to help him. Wilson and Lillie jumped on Bert with their dinner buckets and won the fight. From then on they were great friends. He also went to school with Gola Bullard (Dean) and his

Two Types Of Glaucoma

In glaucoma, pressure created by fluid within the eye becomes abnormally high. In people over 40, glaucoma is the leading cause of blindness. There are two broad categories of glaucoma:

The most common is the open angle or chronic simple glaucoma. There is no way for you to recognize it until it's too late. One third of people with open angle glaucoma first seek help from a doctor when they are blind. The increased pressure does not cause any pain. It affects your side vision first and therefore you think you are still seeing well. That's why a regular eye examination is so important.

The second type of glaucoma is called narrow angle (or closed angle) glaucoma. This occurs primarily in adults who are farsighted. It comes on suddenly when the pressure in the eye goes to extremely high levels. These patients lose their vision and have significant pain, perhaps with nausea and vomiting. They usually end up in a doctor's office or hospital within 24 hours of an attack.

Speech Therapy Opens Opportunity For Corinth Boy

A series of recurring ear infections left Nicholas Knipp with less than half of his ability to hear by the time he was only 13 months old.

"His physician said Nicholas could only barely hear us. When we talked to him, it was like he was under water and heard only muffled noises," said his mother, Polly Knipp of Corinth.

Because Nicholas' hearing was impaired, his speech and language development was also lagging. "By age 2, all he could say was 'mama,'" Knipp said. Margaret Glynn, M.D., a pediatrician with The Segars Clinic, P.A., recommended that he start speech therapy to catch up.

"When Nicholas first started talking, he would often leave off the beginning or ending of words, and we had to listen very closely to understand what he was saying. Many times we had to ask him to repeat what he had said," Knipp said.

Angie Manahan, speech-language pathologist with Iuka Hospital, works with Nicholas three days a week to build his language and articulation skills. Manahan makes learning fun by incorporating various games into each session. "We use games which encourage Nicholas to identify pictures of objects. By doing so, he learns to vocalize different sounds and how to use new words in a sentence format," Manahan said. "His mother has also worked very diligently with him on at-home activities I developed for him."

At age 4, Nicholas had three ear surgeries and two years of therapy behind him. Since

Manahan began working with Nicholas two months ago, he has reached his age-equivalent goals for language and is doing well with articulation. His mother says speech therapy at Iuka Hospital has definitely helped Nicholas prepare to start pre-kindergarten this fall.

Manahan says parents may wish to consult a speech-language

pathologist if:

- Your child is not talking at all by age 2.
- You have a difficult time understanding him after age 3.
- He is leaving off many beginning consonants after age 3.
- He is still not using two-to three-word sentences by age 3.
- His word endings are usually missing after age 5.
- He is embarrassed or bothered by his speech at any age.
- He is making errors in speech sounds after age 7.
- His voice is monotone, too loud or too soft, or is of a poor quality.
- He sounds as if he is talking through his nose or as if he has a cold.

Iuka Hospital offers speech therapy for all ages by physician referral between 8 a.m. and 4:30 p.m. Monday through Friday. Manahan holds a bachelor's degree in communicative disorders and a master's degree in speech-language pathology, both from the University of Mississippi. We believe our distribution facilities will be capable of operating without significant interruption caused by the transition into the next century.

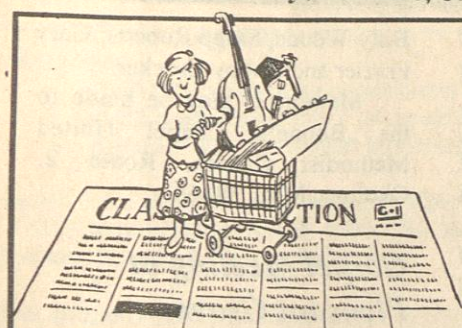

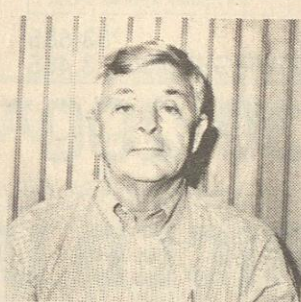

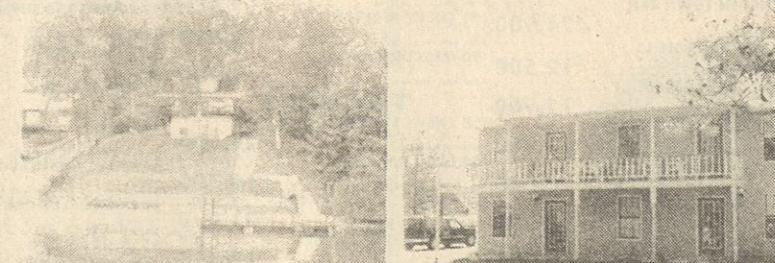

Y2K? Y 2 Care: Protecting Your Finances from Year 2000 Scam Artists

"I got a call from a man who said he represented my bank. He said they're having trouble preparing for the Year 2000 and that I need to transfer my money to a special account until the bank can comply with the Year 2000 requirements. I hung up when he asked me for personal information. Did I do the right thing?"

"I got a call from a woman who said she needed my credit card number to verify that the card would work after January 1, 2000. Is this a scam?"

Yes! The confusion surrounding Y2K provides one more opportunity for scam artists to take advantage of consumers.

Protect Yourself. Never give out personal information - including your bank account or credit card numbers - over the phone or online unless you're familiar with the business and have initiated the contact. Scam artists have a way with words. Don't fall for lines from strangers telling you how to "verify" their identity. Scam artists can use your personal information to commit fraud against you.

Be on the alert for unauthorized charges to your credit card. If you haven't authorized a change, don't pay it dispute it. Follow your credit card issuer's procedures for disputing a charge. If you notice unauthorized debits to your checking or savings account, contact your financial institution immediately.

immediately.

The Y2K problem... the Y2K glitch... the millennium bug. Whatever you call it, it's the inability of some computers and computerized systems to correctly recognize dates after 1999. Many products have microchips that have been programmed to process only the last two digits of a year on the assumption that the first two would be 1 and 9. As a result 98 is read as 1998, and 00 could be read as 1900 instead of 2000. Financial institutions are

taking steps to ensure their computer systems are ready to process transactions properly as of January 1, 2000. In fact, they are required to be Y2K compliant before the century date change. Federal regulators have a comprehensive Y2K program underway that include examination of federally insured depository institutions, including banks, thrifts and credit unions. And the Federal Reserve has arranged for printing additional currency in 1999 so that extra cash is available to bank customers.

Have questions? Call your financial institution. Ask your financial service provider about its plans to deal with Y2K. If you're not comfortable with the response, consider doing business elsewhere.

Ask your provider about contingency plans for system failures. If you don't normally

maintain financial records, you may want to consider doing so in preparation for the Year 2000. That way you'll have proof if something happens to the computerized records. At a minimum, keep a six-month paper trail - three months before and after the date change - on significant transactions, such as mortgages, stocks and insurance.

Make sure your deposit receipts and periodic statements are accurate. Report discrepancies to your institution. Keep canceled checks, bank statements and check registers as proof of payment for at least several months before and after the date change. If you bank by computer, download your transaction records and store them on a backup disk. You also may want to print out downloaded records in case backup disks are contaminated with Y2K problems.

Keep credit card receipts for

purchases and cash advances made on or around January 1, 2000. Compare them against your billing statements. Report discrepancies to your card issuer.

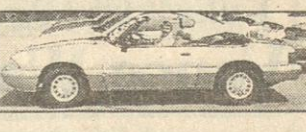
