"I am James Skinner, native and life long resident of Tishomingo County. First, I would like to express my sincere appreciation for your vote and the support you gave me four years ago.

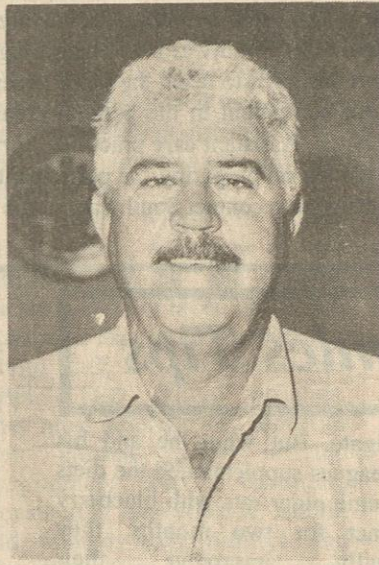
The office of Sheriff is a very important office. The Sheriff is charged with the responsibility of keeping the peace and protecting ALL citizens of our county.

Burnsville Manufactured Housing Facility To Reopen This Summer

Dr. Bob Robinson, Executive Director of the Tishomingo County Development Foundation announced today that the manufactured housing facility, formerly owned by Housing Resource, LLC, at 28 Industrial Drive, Burnsville, Miss., will reopen for production in August, 1999.

At full production, it is anticipated that the facility will employ approximately 125-150 employees.

The facility, which has been idle for two years, was acquired on June 8, 1999 by Spiral Industry, Inc. of Russellville, Ala. Since that time, Spiral has commenced pre-production activities and has begun to accept applications for employment.

Weldon Watson, President of Spiral stated today: "We are extremely appreciative of the efforts made by Dr. Robinson and the other members of TCDF. Their cooperation greatly facilitated this acquisition. It is our intention to staff this plant, to the maximum possible extent with citizens of Tishomingo County. Spiral has been engaged, continuously in the production of manufactured housing since 1984, and we anticipate a very long-term and expanding presence in Burnsville."

Dr. Robinson stated: "The work of the TCDF is to create good paying jobs for the citizens of Tishomingo County. Spiral's wage rates and employee benefits

will add significantly to our county's economy. This project would not have been possible without the help of the Board of Supervisors, the TCDF Board, DECD, NMIDA and others."

In May 1999, Spiral announced the construction of a new manufacturing facility in Russellville, Ala., and during the first half of 1999 has acquired Dencraft Furniture of Hartselle, Ala. and Owen-Benton Furniture of Haleyville, Ala., also, on June 17, Industries, Inc. of Haleyville and Bear Creek, Ala. and five of its affiliates.

Chairman Leonard James stated that: "The Spiral acquisition was done completely with private funds and demonstrates

Spiral's commitment to Tishomingo County. Throughout the time that the plant has been idle, the Board of Supervisors has made sure that the lease remained current. The investment in this building should now produce the long-term dividends that we have anticipated."

Watson, part of a new management team recruited to Spiral by its Chairman, Leonard James, further noted: "If the Spiral product, targeted to an upscale market, to be produced at Burnsville meets with the acceptance that our research indicates, we believe that an expansion of the plant will ultimately be in order."

Two Mississippi Dept. Of Corrections Escapees Captured At Hilltop Apts.

Tishomingo County Authorities brought two Mississippi Department of Corrections escapees back into custody Sunday night after they were found in an apartment in Burnsville.

Brian Mock, 27, formerly of Burnsville, and Willie Tubby, 22, address unknown, escaped from the MDC satellite facility in Rosedale, Miss., according to Tishomingo County Sheriff David Smith.

Apparently, the two, after breaking out of jail Friday, went to Rosedale Port where they took a vehicle and headed toward Tishomingo County, Smith said. When they arrived in the county, they dumped the vehicle on Hwy. 350 and were picked up by another man, Robert W. Hudson,

42, of Corinth.

Smith said Mock and Tubby were found in a closet at an apartment in Hilltop Apartments in Burnsville and were taken into custody just after 7:30 p.m. Sunday.

Mock was in the custody of the MDC after being convicted of embezzlement. Tubby's charges are unknown at this time. Both men will be picked up by representatives being sent from MDC's Parchman facility.

Hudson, who was charged with aiding and abetting a felony escape, has been released from Tishomingo County Jail on \$5,000 bond.

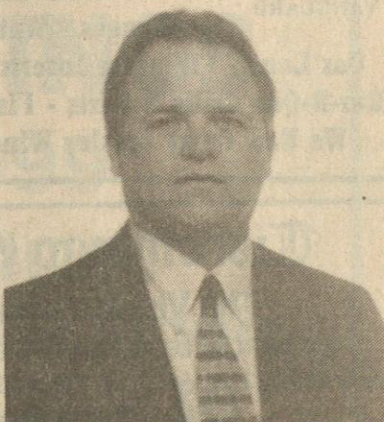
Sheriff Smith said a special thank you goes out to Burnsville Police Department and the Mississippi Highway Patrol for their assistance in this case.

The Tax Assessor is a very critical position in local government. He must keep

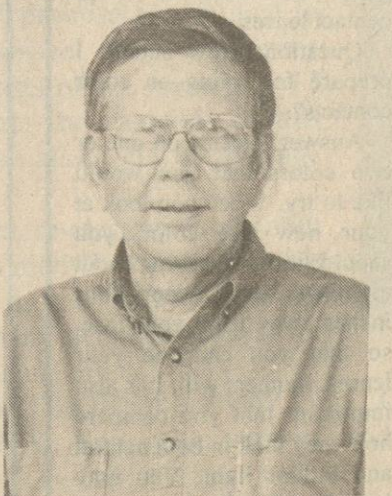

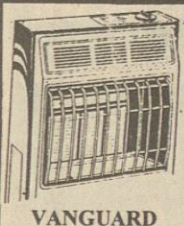

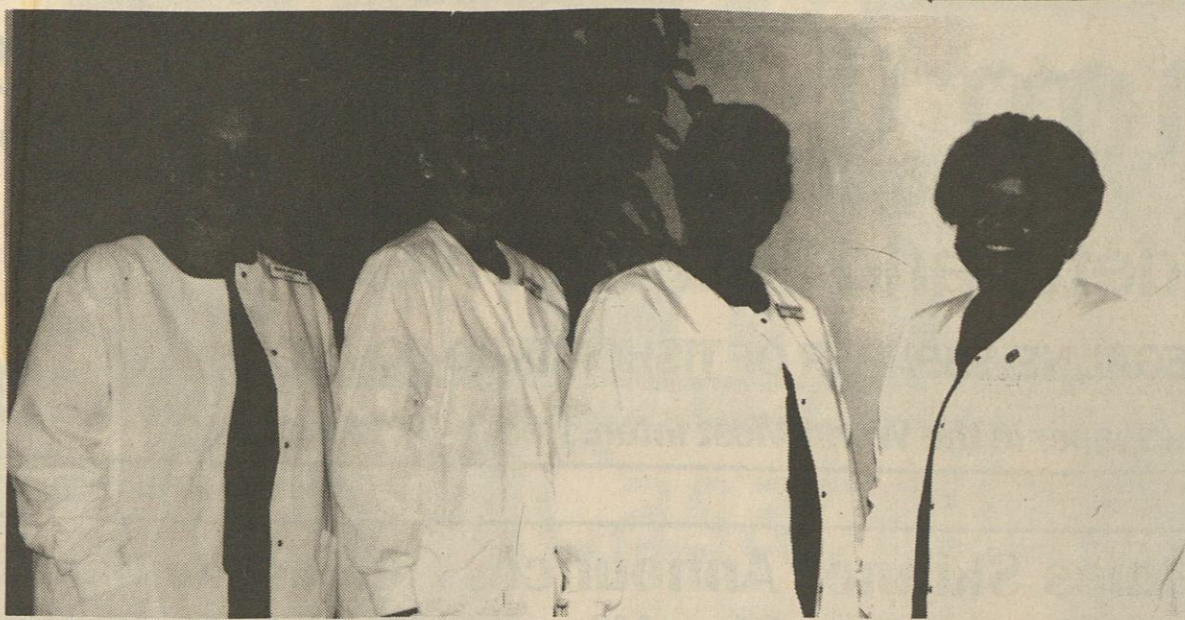

Miracle Berry
Want To Stop Aging. Live Longer, and Keep Your Mind Sharp?
Make Blueberries A Habit!

If you add one food to your diet this year, make it blueberries. Calorie for calorie, luscious blueberries have recently emerged as the single most ferocious food in the supermarket at halting the forces that age you. Even the scientists who study blueberries are excited.

Radical Resistance

Every second of your life, your cells are bombarded by dangerous particles called free radicals. In a split second, they can alter your DNA in ways that cause cancer. Or change LDL cholesterol (the bad cholesterol) so it sticks to artery walls. Or damage collagen and make skin wrinkle prone. Over time, changes such as these accelerate your aging.

Fortunately, you can fight back. The trick is to load your diet with antioxidants - the natural zappers of free radicals - by eating lots of fruits and vegetables.

Dr. Joseph, Ph.D., a USDA scientist at Tufts, explains that as rats age, they forget how to find their way through mazes that they previously had learned to

navigate. But when he and his colleagues supplemented the diets of some older rats with blueberry extract for two months, they actually improved their navigational skills in the same mazes. The rats' balance, coordination, and running speed also improved.

Though these results are still very preliminary, Dr. Joseph calls them "very exciting". The next step to identify the compounds responsible for this effect and eventually test them in humans. Meantime, Dr. Joseph and his wife have begun eating blueberries regularly.

4th Annual Clean Up, Pick Up, Fix Up At Bear Creek Area

Another successful clean up detail was organized at Bear Creek on June 19th. This cleanup marks the fourth in what has become an annual event of shoreline cleanup. Eighty-three people and 20 boats took part in this year's clean up. Vincent Ralph of the development "Hills of the Bear" headed the cleanup, which lasted from nine a.m. until noon. The west shoreline of Bear Creek from Pearson Point past Fred's Hollow on the Tennessee River was picked up. This year Eastport Road was included in the cleanup by the Tishomingo County Sheriff David Smith's crew.

Once again Danny Johnson of TVA supported this cleanup with garbage bags and pickup equipment, as well as participating during the cleanup with a crew on the TVA boat. Each boat received a brochure on safe boating from the TVA police boat that joined in by patrolling Bear Creek during the cleanup.

Judy Schaper, of Eastport Marina, supplied all attendees with hot dogs, chips, and a cold

drink. Employees of Eastport Marina took part in supplying the refreshments, and later removal of truckloads of garbage collected by the volunteers. T-shirts were provided to all participants.

This year's clean up was well supported by the Bear Creek community. It has become an annual event looked forward to by the participants and respected by other Pickwick Lake residents as leadership in shoreline management.

What is the Best Method of Protecting My Horse?

The virus that produces EEE in horses is widespread in wild bird populations and professional vaccination is the only method available to protect horses from the disease. Mistakes in vaccination protocol, or the use of improperly cared for vaccine, can result in ineffective protection in an animal that was thought to be risk free.

Properly administered vaccinations are effective for only one year, thus, booster shots are required on an annual basis. Newly vaccinated animals require a two-shot series administered 2-4 weeks apart before protection can be guaranteed. Foals should be re-vaccinated during summer to ensure protection during the first year of life. It is recommended in the face of a fall epidemic, horses vaccinated in March should be boosted later in the season.

What is the Best Method of Protecting My Family If My Horse Contracts EEE?

Although human cases have been associated with equine EEE, a sick horse is an indication that the virus is present in local mosquitoes. There is no human vaccine available for routine usage.

Thus mosquito avoidance is the best protection in an area where EEE is known to be present. Homeowners should contact their county mosquito control agency and make them aware of the situation.

Mosquito control personnel are familiar with the EEE cycle and have the expertise to reduce the mosquitoes that function in the cycle. Have your family and employees avoid mosquito-infested areas and use insect repellents when exposure is unavoidable.

Eliminating water-holding containers from your property (buckets, tires and other receptacles) will reduce mosquito breeding in the immediate vicinity. Horse troughs provide excellent mosquito breeding habitat and should be flushed out at least once a week to reduce mosquitoes near the paddock area. Work with your county mosquito control agency and point out any wetland habitats that may have produced the mosquito responsible for the infective bite.

What Should I Do If My Horse Develops Symptoms?

Suspect horse cases should be reported to your veterinarian as soon as possible. Your veterinarian will diagnose the infection and take blood or tissue samples for confirmation. Euthanasia may be necessary because the disease is fatal in unvaccinated animals. There is no quarantine for EEE and non-reporting only postpones the mosquito control activities that could protect other horses on your farm and the immediate vicinity. The cycle of EEE is not yet completely understood. Quick reporting of a suspect case could provide valuable information for the future.

Q. What does toothbrushing accomplish?

A. Toothbrushing removes plaque from the chewing surfaces, the tongue side, and the cheek side of the teeth. If not regularly removed, plaque - the invisible, sticky substance that forms continuously on the teeth - can lead to the formation of cavities anywhere on the tooth surface. It also can accumulate below the gum line and lead to gum disease, which is why regular brushing, flossing, and special plaque removal procedures performed by your dentist, or hygienist are important.

Colored Contacts

Question: I don't need prescription glasses. Can I still change my eye color with colored contact lenses?

Answer: Yes, Most colored contacts are available in noncorrective lenses for those not requiring vision correction. You will need an eye exam, however. This is both to ensure proper fit, and to make certain that you are a good candidate to wear contact lenses.

Question: How should I prepare for trying on color contacts?

Answer: Decide on one or two colors that you would like to try. When you look at your new eye color, you should hold the mirror about eighteen to twenty-four inches away from your face, so that you can see your lenses as others will. It is also important that you compare how they look in both natural and indoor light. You may want to ask a friend - or one of the optical assistants at your eye care professional's office - to help you select the color that looks best on you.

Letter To The Editor

Things have changed in our schools since the 50's and 60's when I attended. Progress in every area of our lives has brought with it a society that is increasingly stressful and excessively tolerant of many things that would just not have been accepted a few years ago. Our school systems are at the forefront of change that, unless altered, will usher in practices and philosophies that are completely contrary to the moral structure and Christian values that have always been a major part of our community and society.

The problems are many and parents with children in every school in Tishomingo and adjoining counties are finding that it is virtually impossible to receive proper, just, fair and equal attention to almost any complaint. I am concerned they may have regarding issues with their child's education and educational environment. The truth is that unless we join together to bring about change, it will get much worse.

It is not by mere accident that our school officials are rapidly making major decisions regarding our schools, teachers, and children, which will drastically affect their education, rights and freedom, and everything about their future educational environment. The apparent intent and direction of our own county school system is no doubt, to foster and support a school system much like or in actuality, the "school-to-work" and "Goals 2000" Educate America Act, signed by President Clinton in

1994. (Element's of which are already being implemented in schools here in our state). Please notice the following (5) Specific Mechanisms of Control to restructure our public schools:

(1) Bypass all elected officials on school boards and in state legislatures by making federal funds flow either (a) to the Governor and his appointees on workforce development boards (as projected in the Careers/Workforce Development bill), or (b) to a new entity called a "consortium" of several district superintendents.

(2) Use a computer database, a.k.a. "labor market information system," into which school personnel will scan all information about every school child and his family, identified by the child's social security number: academic, medical, mental, psychological, behavioral, and interrogations by counselors. The computerized data will be available to the school, the government, and future employers.

(3) Use the new slogan "high standards" to cement national control of tests, assessments, school honors and rewards, financial aid, and the Certificate of Initial Mastery (CIM), which is designed to replace the high school diploma.

(4) Control the vocabulary of education, so that many words have double meanings. Thus, when parents hear the words "outcome-based" or "performance-based," they think the outcomes must be skills such

as reading and the multiplication tables, but the educators mean "accepting diversity" or "being environmentally sensitive."

(5) Coopt the Governors and the CEO's of large corporations to front for these "reforms" by promising the former some control over the flow of federal funds and the latter some free teenage labor. Once a Governor or CEO signs on, all decisions are actually made by the same education bureaucrats who gave us the problems in the first place.

School-to-Work is a plan designed on the German system by Marc Tucker, a Clinton insider, who boasts that he has written the "restructuring" plans for more than 50% of public school children. It is a plan to train children in specific jobs to serve the workforce and the global economy instead of educating them so they can make their own choices.

As individual parents we do not have any control of these and the many and varied problems our children experience such as: The manner and length of their lunch break, recess, and store break (recess may be eliminated completely); What they wear (uniforms are currently planned for Tishomingo County schools); How they are disciplined (punishing an entire class for the misbehavior of only a few); The negative and discouraging manner of speech that has been used by some teachers with our children; and a host of other issues and concerns that are very real for our children as well as for some of our teachers.

Collectively, as a group, we can have a voice in our children's educational future and effect the very course and direction of their educational system, safety, curriculum, treatment, discipline, and practically every aspect of their schooling. As parents we have access to a program whose absolute motive is to give parents their rightful voice in the structure and direction of our children's educational environment. It is called STOP (Student Teacher Observation Program) and was created to give parents a tool with

strength enough to gain the attention of teachers, school staff, and school officials sufficient to bring about change. Our motto: When it's wrong STOP it; When it's not fair STOP it; When it's not safe STOP it; When there's a problem STOP it, clearly bespeaks the sentiment and frustration of almost every parent with a child in our county schools. By joining together we can effectively exercise our rights to have a voice in the structure and direction of our children's schooling.

I challenge every parent with school age children to attend our next STOP meeting, Thursday evening, 7 p.m. the 29th of July at the Southern Style Restaurant in Midway. Please join in this effort that will give us the necessary information, tools, and leverage we must have to bring about changes that will be in the best interest of our children, teachers, and schools. If we don't STOP it now, others will continue to force upon our children and us a system and practices that infringe upon the very sovereignty of the individual and the family.

We have, within our county school system, a number of well educated, devoted, and capable teachers who are faced daily with challenges from problem students, school staff, and our elected and APPOINTED school officials. They must defend every aspect of their chosen career in an environment that is becoming increasingly questionable, unfair, and tainted with politics and favoritism. They and our children should be treated fairly with consistent guidelines and practices that are totally unbiased and fair. We must support our teachers as well as our children in our motives and goals. It is they who have the task to instill in our children a sound academic foundation. We must encourage, if not demand, that they also support the practice of Christian values and a moral lifestyle.

Over 2 million dollars per year is collected from the taxpayers in Tishomingo County (over half of all taxes) for the county schools and a further tax increase has been proposed. How and where is this money being spent and should not the taxpayers have a right to see and decide for themselves regarding the stewardship of this treasury? The

law says that we do.

I am very proud and grateful for those teachers, school officials, children and parents who perform, represent, and conduct themselves in a respectable and morally conscious manner. For those who do not, it is time to join together and exercise our right and duty to STOP it. The longer we wait to do something the more difficult it will be to effect a change. Again, I challenge every parent who values you child's future to attend the next STOP meeting on

Thursday evening, 7 p.m. the 29th of July at the Southern Style Restaurant in Midway.

Unemployment in Tishomingo County

According to Jimmy Rowland, Manager of the Mississippi State Employment Service, unemployment in Tishomingo county rose to 7.6 percent in mid-May. This compares to 6.9 percent in April and 11.5 percent in May, 1998.

The civilian labor force numbered 8,900, 160 more than April but 850 less than May of last year. Approximately 8,220 Tishomingo county residents held jobs while 680 were unemployed.

Manufacturing jobs in the county numbered 2,810 and nonmanufacturing jobs numbered 3,380.

Day July 25th

July 25th was a date John Marshall Stone probably remembered. On this day in 1865, he was released from Johnson's Island. Colonel Stone was captured at Salisbury, NC and was a prisoner of the War Between the States.

The events of his life are intertwined with the history of our country, state and Tishomingo County. He and the men of Iuka formed Company K of the 2nd MS Regiment. Together these brave men fought in many battles before many were wounded, killed or captured.

Colonel Stone served as a Senator and Governor. He was an outstanding leader and was much loved and appreciated by the residents of Mississippi. As United Daughters of the Confederacy, we were proud and honored to

reactivate the John Marshall Stone Chapter #394 on July 25, 1997. Mrs. Marquita Mathis was the organizing president for the reactivated chapter. She and Mrs. Vicky Durham, Registrar, and the Corinth UDC spent many hours assisting members with their applications, making phone calls and meeting with prospective members.

The United Daughters of the Confederacy was founded September 10, 1894 in Nashville, TN. The founder was Mrs. Caroline Meriwether Goodlett; co-founder was Mrs. L.H. Raines of Savannah, GA. Any woman is eligible for membership who is sixteen years old and can prove lineal, blood line descent from an ancestor who served in the Confederacy or aided the cause.

Sheriff David Smith can carry this title because he does these things. My name is Neil Edmondson and I worked

alongside David for six and one-half years. I've seen him do these things.

In extreme cases I've seen David go days with very little sleep. Sometimes that little sleep was on the couch at the jail. During December '97 and January '98 a drug case was worked by David and his department that made Mississippi's #1 drug case for '98. The Mississippi Bureau of Narcotics helped with some equipment and little man power. Some nights we swapped watch sitting in unmarked cars and apartments while doing surveillance. During a recent murder case few went home until all suspects were in custody.

In one case an individual was set up. The individual was arrested before David knew of the set up. Upon finding out, the charges were dropped on that individual and charges were brought against the individuals that were responsible for the set up.

I have witnessed, on numerous occasions, David share the Gospel of Jesus Christ. Christian officers have a special ministry because some we encounter may never darken the doors of a church or be visited by an outreach ministry.

Dear Editor:
Place our Trust Fund into a TRUST!

Social Security is a pay-as-you-go program funded by taxpayers to pay benefits to people receiving benefits. The defect in the structure of Social Security requires that the ratio of taxpayers to people receiving benefits remain large to prevent the program from failing. All this hoop-la about saving Social Security is the result of the retirement bulge that will start

forming in 2008 when the first of the boomers become 62. The good thing about the boomer bulge is that they are in the prime of their careers when their income is highest allowing a buildup of money in the Trust Fund to create the current \$650 billion surplus.

Unfortunately, many believe that the Trust Fund which is the intended recipient of the taxes is believed to be as impregnable as Fort Knox. Not so. Since the founding of Social Security during the Great Depression, politicians have used Trust Fund surpluses to fund pork-barrel projects to gain re-election. This occurs because Congress co-mingles the Trust Fund contributions with income and other taxes in formulating the federal budget. For example, the 1998 \$70 billion budget surplus existed only because Congress included the 1998 \$99 billion Social Security surplus when the actual budget showed a deficit.

In order to prevent these Congressional shenanigans from occurring over and over again it is mandatory that the Trust Fund be removed from control of the politicians and be made into an autonomous agency like the Federal Reserve having a charter to collect, invest and distribute the trust money in a prudent manner. Allow me to propose that the new agency be called the United States Social Security Trust.

University Changes Telephone Prefix

The University of Mississippi will change its telephone prefix from 232 to 915 effective Aug. 1. The change coincides with

BellSouth's switching the area code from 601 to 662 for a large part of north central Mississippi, including the University. The new area code became optional in April, with a mandatory usage date of May 1, 2000.

The tentative date for the University's new campus prefix 915 to become mandatory for residence halls is Jan. 1; May 1 for personal extensions, modems, etc.; and Aug. 1 for all other University numbers.

Until the corresponding mandatory dates, callers can reach their parties dialing either the old or new prefix. However, after the new prefix becomes mandatory, callers dialing the old prefix will have their calls intercepted with a message that gives the new number and instructs the caller to hang up and redial. If the call is long distance, the caller will not be charged for the intercepted call.

"The University has almost exhausted the available phone numbers in the 232 prefix, and with the new construction and renovation taking place, the demand for new numbers continues to increase making it necessary to change the campus prefix," said Buster Clark, director of the Ole Miss Telecommunications Center. "The University will reserve 10,000 numbers in the new 915 prefix, which should be sufficient for years to come."

Rather than keep the 232 prefix (and a few numbers with 281), Clark said the decision was made to switch the campus to the 915 prefix with the last four digits remaining the same as they are now. He emphasized that Oxford telephone numbers with a 232 prefix will not be affected.

Two Local Students Are Among Those Who Qualify For Critical Needs Teacher Loan/Scholarships For Fall

Two Tishomingo County students are among the 788 recipients statewide who will receive Critical Needs Teacher Loan/Scholarships for teacher education training for Fall 1999. Iuka residents April Bostick and Angela Long are recipients of this funding and will both be attending Northeast Mississippi Community College in Booneville beginning this fall. This year, scholarships totaled more than \$4.3 million. In response to an unprecedented number of applications and in keeping teacher preparation a priority in the state of Mississippi, Commissioner of Higher Education Dr. Thomas D. Layzell in late June authorized the Office of State Student Financial Aid to award the Critical Needs Teacher Loan/Scholarship Program to an additional 451 eligible applicants so that they could prepare for college. Dr. Layzell authorized Spring 2000 funds to be used for Fall 1999. Legislative leaders support the plan and have pledged

to find a way to fund a \$2.4 million budget deficit appropriation in January. Scholarship applications rose from 323 last year to 788 this year. The undergraduate scholarship covers the cost of public university tuition, student housing, meals, books and fees. Recipients must major in education and agree to teach in a district that the Mississippi Department of Education has designated as having a teacher shortage. Students who receive four years of assistance are required to spend three years teaching in a shortage area, while students receiving less than four years of assistance are expected to commit one year for each year of assistance received. Recipients who do not successfully complete a Mississippi teacher education program and secure teacher certification will be required to repay the loan with interest. Teacher education program graduates who fail to teach in a

shortage area are required to do the same. To qualify, students with less than 12 hours of college-level work must have an ACT score of 18 or higher and a high school grade point average (GPA) of 2.5 or higher on a 4.0 scale. Students with 12 or more hours of college credit must have a college GPA of 2.5 or higher on a 4.0 scale. 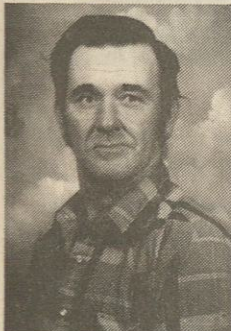

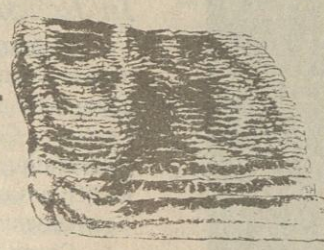

Tishomingo Class Of 1944 Reunion

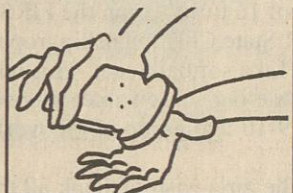

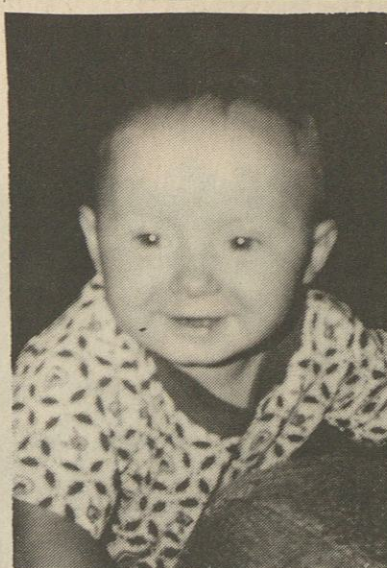

Department of Agriculture, Rural Development has been requested to administer an ARD grant for financial assistance from the Short-Coleman Park Water Association located in Tishomingo County, Mississippi. The specific elements of this proposed action includes the extension of the water system to give water service to 15 new users in the Pine Flat Community and renovation of its surface water treatment plant to serve the Yellow Creek Industrial Park. There is no feasible alternative to upgrading the current system and providing service to additional users.

Rural Development will administer the project for ARD. Rural Development has assessed the potential environmental impacts of this proposed action and determined that this project would not have a direct or indirect impact on the identified 100-year floodplain area or wetland areas within the water association's service area.

The proposed project conforms to state and local floodplain protection standards.

The Mississippi Department of Economic Development and the Tishomingo County Board of Supervisors are also providing financial assistance for this project.

Rural Development has further determined that this proposed action will not significantly affect the quality of the human environment. Therefore, Rural Development will not prepare an environmental impact statement for this proposed action.

Any written comments regarding this determination should be provided within fifteen (15) days of the publication to the Rural Development District Office, P.O. Box 237, Booneville, Mississippi 38829. Rural Development will make no further decisions regarding this proposed action during this 15-day period. Requests to receive a copy of or to review the Rural Development Environmental Assessment upon which this determination is based should be directed to the above address.

Micah Ginn Will Film Story of Ole Miss Company In Dennis

Who better to tell a Mississippi Civil War story to the movie industry than a Mississippian working for that industry?

Micah Ginn, 25, a native of Tishomingo County, is doing exactly that through a film he is making in North Mississippi focusing on the true life events of a young soldier in a company formed at the University of Mississippi at the beginning of the Civil War.

Micah will be filming scenes for his short film, tentatively titled, "July 3, 1863," in Dennis, Miss. beginning next Wednesday, July 28, and continuing through Saturday, July 31. According to Micah, most of the filming will be done on his grandfather's farm located just off Hwy. 25.

An alumnus of Northeast Mississippi Community College and Ole Miss, Micah moved to California two and a half years ago to follow his dream of working in the movie industry. He is presently working for a Los Angeles production company which he hopes will like what they see in this project and agree

to fund a feature-length film based on the story.

According to Micah, the true story centers on Civil War soldier Jeremiah Gage, a student who has just received his law degree from Ole Miss at the beginning of the Civil War, who joins with a group of about 80 other students from the University who form their own company. The film follows the events of this young man's life and his zealous company, the 11th Mississippi, also known as the "University Grays," as they fight in the major battles of the war. The story culminates with the Battle of Gettysburg where all the remaining members of the company, including Gage, fall.

More than 60 Civil War reenactors from the Mississippi, Tennessee and Alabama areas will be a part of the production.

Micah, who is the son of Jerry and Rae Ginn, the grandson of Willie Deaton and the nephew of Carlos Ginn, will direct, act in and produce this film.

out. This problem occurs because the float is set too high of the ball cock is leaking.

The water level in the tank should always be at least one-half to one inch below the overflow tube to avoid leakage. If the ball cock is leaking, water may run directly into the overflow through the refill tube. Lowering the float or repairing the leak in the ball cock will prevent these losses.

Another reason for water running out of the tank continually is a defective float. If the float leaks, it will not raise high enough to shut the water off after the tank refills and water will overflow into the bowl.

Test the float by taking it off and shaking it. If you hear water inside, replace it.

After the faucets and toilets have been checked for leaks, there is one more thing that can be done to be positive there are no leaks. The water meter should be read both before and after a period of several hours when no water is being used in the home.

An ideal time would be overnight particularly if the family is warned in advance not to run water during the night. If the meter reads exactly the same in the morning as it did the night before, there is no leak.

Child Support Collections/Tax Refund Interceptions Increasing In State

The Mississippi Department of Human Services, Division of Child Support Enforcement, announced that total collections for SFY 1999, ended June 30,

1999, totaled \$145,191,818.03 with \$16,758,451.36 attributed to state and federal tax refund interceptions from past 'due non-custodial parents.

Comparatively, total collections represent a 13 percent increase and a 297 percent improvement since SFY 1992.

The Federal and State Tax Refund Offset Program collects past due payments of child support from the tax refunds of noncustodial parents (NCPs) who have been ordered to pay child support and is a cooperative effort among the Internal Revenue Service (IRS), U.S. Department of Treasury, Federal Office of Child Support Enforcement (OCSE), Mississippi Tax Commission and DCSE.

According to Richard Harris, Director, DCSE, many families benefit from this service, and he urged families not receiving Temporary Assistance to Needy Families (TANF) to contact their County Child Support Enforcement Offices for information.

The tax offset is free to all families who are receiving TANF or Medicaid-Only as administered through MDHS, while other families may receive DCSE services by completing a child support application and paying a one-time fee of \$25.

Marijuana Plants Found During County Fly-Over

Tishomingo County Sheriff David Smith said that 305 marijuana plants were discovered during a sweep of the county Thursday, July 15, by a helicopter from the Mississippi Bureau of Narcotics.

The Bureau's helicopter scanned the county for about six hours Thursday looking for the illegal plants.

Smith and his deputies, along with the narcotic agents, pulled the plants, transported them to the sheriff's department property and destroyed them.

The plants ranged in height from 3 to 7 feet, according to Smith. He said most of them were found northwest of the Burnsville area.

Smith said that the number of plants found in the county has steadily decreased over the last few years.

"Thousands of plants used to be found each season," Smith said. "But in the last few years, that number has dwindled down to only a few hundred. We believe this is a very positive indicator that our war on drugs in Tishomingo County is working."

Home Economics Tips

How To Stop Water Leaks

Water leaks account for about 5 to 10 percent of all residential water consumption. Most of the leakage is due to worn out faucet washers and faulty toilet tank valves.

A leaking faucet of one drop per second can waste seven gallons per day. A steady drop will waste 20 gallons per day.

A more serious type of leak that occurs in toilet tanks can waste up to 200 gallons of water a day. A simple way to check for a toilet leak is to remove the tank cover and place food coloring in the tank. This should be done when the toilet will not be used for several hours.

If the color seeps into the bowl, the flush ball needs to be replaced. The average life of a

flush ball is seven years. As it becomes older the possibility of a leak increases greatly.

If the toilet tank continues to make noise after the flush and fill cycle is completed; the flush ball not fitting properly into its valve seat usually causes the problem. The problem may be a bent or corroded guide wire. A replacement for the flush ball is available that uses a flapper assembly eliminating the need for the guide wires.

Two other common causes for loss of water are easily detected. If the water level in the

flush tank is above the overflow tube, water will continually run

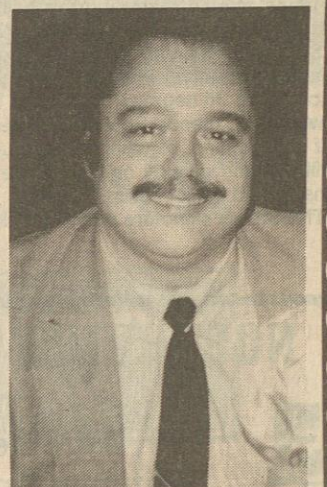

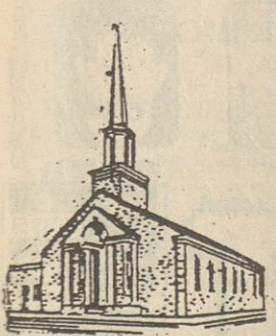

Old Tishomingo Traces

Since there was so much interest shown in the article on the Goode Family by Irene Barnes, I asked her if she had any more of their history to share. She responded with the following:

In the Confederate P.O.W. records of those who died in Federal Prisons and military hospitals in the north, there are only five soldiers buried at Mt. Olive Cemetery, Frederick, Maryland. The picture I have of my ancestor William F. Biggs' marker is in a long line of markers. Those marked are:

Biggs, Wm. F., Pvt. K, 2nd Miss. Inf. d. 10/13/1862, Grave 118 Cottingham, M.M., Pvt. A., 2nd Miss. Inf. d. 11/18/1862 Grave 169

GOODE, Wm. T., Pvt. K, 2nd Miss. Inf. d. 1/15/1863 Grave 187 Harris, Robert, Sgt. C, 2nd Miss. Inf. d. 10/9/1862 Grave 96 Tegin, S., Pvt. D. 4th Ala. d. 10/06/1862. Not located.

Notice four from the 2nd Miss. Inf. with Biggs and Goode

both of Company K, which was that of Capt. John M. Stone's Regiment. John M. Stone was from Iuka and later became governor of Miss. He was wounded. This is after the Battle of Antietam. In checking the 1850, 1860 Federal Census of Tishomingo Co., Nathan Goode had a son William. He was 17 years of age in 1860. This is probably the one buried in Mt. Olive Cemetery. If family members are interested, a copy of his Civil War record would probably prove it. Wm. F. Biggs' war record shows he was shot in the hip and lung, carried to a hospital and died a month later. He had not received any pay in several months and had money due him.

The following letter was written by Mahulda Ladd Goode, living in Iuka, to her daughter Martha Goode Parsons and family, in Crane, Stone Co., Missouri, on November 20, 1867: Mr. Hiram Parsons and Martha Parsons and Children -

Dear Son and Daughter and Children we now embrace the present opportunity of writing you a few lines to inform you of our present welfare, we are well at

present hoping when these few lines come to hand may find you all in the best of health. We have not sold our land yet we have had several offers and I have felt two hundred Dollars on it we can sell it but I can not get all of it cash and I will not sell on a time. I offer it at fourteen hundred Dollars I am in hopes I will get the opportunity to sell before spring if can sell out I will be certain to come to that country and we will do our best to sell as soon as we can - I am now alone by myself only one little orphan girl I have raise from 5 years old and when I come to that country I will bring her with me and James is coming to that country with me but he is not living with me at present. We can inform you that the health of our country is very good here - though every thing is high here corn is worth from 50 cts to six bits per bushel bacon is 25 cts a pound every thing is proportion to it - the election is in favor of no convention and I could sell my stock and furniture in the house and get money enough to bring me to that country but if I can not sell the land I could not buy me a home. Caldona is living in Hamburg, Tennessee. We got a letter from her a few weeks since her and family were all well and doing well - if want to write to her write to Hamburg Tennessee back your letter Joseph Wilson - Mary Daniel has made two fine bails of cotton to her part and good crop of corn Daniel and family is all well - my little boy is named Lewis Stark and my girl is Mary William, she is 9 months old (her grandchildren) and I want you to write to me where Mary Shannon is - Hiram I want you to write to me what you think is best for me to do whether to leave the land and come or stay till I can sell it write to me what you think is best and the connection all sends their best respects to you all. So I must bring my letter to a close for the present write to me as soon as you receive this letter and let us know all the times of your country - so nothing more at present - but my best love to you all.

Remembering Aunt Coe

Read my Vidette last night and enjoyed the article and picture of the new lodge at J.P. Coleman State Park. It reminded me of when a facility was built at Tishomingo Park. There was, at one time, a swinging bridge we crossed to get there afoot from my Aunt Corine Gray's place. She lived close to Mingo, MS. then moved to Tishomingo. My favorite visits to the park was with her. My dear Aunt Coe was my mother, Myrtle Hargett Sprouse's sister. She was one of the best when it came to crocheting, knitting, embroidery and crafts. Always a room full of goodies for flea markets, garage sales, etc.

A memorable day was when I drove over from Tupelo to spend the weekend with Aunt Coe. Sometimes she rode a senior bus over to Tishomingo Park for a little R and R so I'd go over there and pick her up. Her face would light up when I walked in and she was ready to go.

We would get up early next morning and load the car for a sale at the park. This particular day, she had made 15 sun hats, as she called them, to take with us. I put one on and walked through the crowd while Aunt Coe set up her booth. After the judge passed her stand, even though she won a nice prize on her quilt, I thought they missed the best item - the sun hats.

I told the lady how Aunt Coe would go to her neighbor's field and pick up a sackcloth full of corn nubbins to get shucks. Then clip both ends, put in a plastic bag with a wet bath cloth overnight to moisten them. Next day they were real flexible, she would tear them into strips about 1/3 inch wide.

Next, she would make a 4-strip plait adding a new strip when it got too short to fold down, rolling the plait up as she went until it was 22 yards long.

Then, she sat at sewing machine beginning at the crown, cupped the crown about 12 inches. It was unreal how she could do this. When finished, she would add a dime store scarf and put a \$3 price tag on it. It took her about 4 days to make one hat. She said it beat holding her hands.

After I talked to the judge, she went back and bought one and gave her a prize. Shortly, they were gone. I wonder how many people in Tishomingo County have worn Aunt Coe's shuck hats? She married again late in life. Ted Wilson would go with us sometimes, taking a sack of gourds, a bucket of potatoes and sometimes hickory nuts to make a little money and just have some fun.

Aunt Coe, a daughter of Dexter and Janie (Taylor) Hargett was born September 10, 1907 in Cherokee, Alabama and died April 19, 1998 in Tishomingo County.

Conservation Corner

By James L. Cummins, Jr.

I have been fly fishing for over 15 years and I can attest to the increase in the number of people fly fishing, especially when I fished for trout while in school in Virginia. But if you are interested in fly fishing, but don't care for traveling long distances, the answer lies right in your backyard.

Mississippi is blessed with thousands of acres of waters which hold enough bluegill to make any angler dance a jig. Bluegill can provide the same kind of fun that trout do and can provide valuable practice in the many finer points of fly fishing.

Fly fishing for bluegill is not just a fun and exciting way to fish, it can be extremely effective. During the spawn, males are usually around beds and are extremely aggressive. They will hit almost any fly or popping bug that comes close to them. A fish every cast is not unusual.

Equipment should be kept simple. If bluegill are to be the main focus of your fly fishing efforts, a 7 to 7.5 foot, fiberglass rod designed to cast 4 to 5 weight lines will be sufficient and will aid in casting accuracy, especially in close quarters. If you think you might try trout with the same gear, you may want to consider an 8 to 9 foot graphite or composite rod, designed to cast 5 to 7 weight line. In a fly fishing reel, a lightweight, singleaction reel with some type of drag system is all you need.

As is the case with monofilament line, there are many

different types of fly lines on the market and it can be quite confusing trying to pick what is right for you. The manufacturer will suggest a line size best suited for the particular fly rod. I would advise using light weight line. For example, if you have a rod designed for 5 to 7 weight line, try 5 weight. A double taper or weight forward taper in a floating line will give you the most versatility and will also simplify casting.

Manufactured leaders come in various lengths and sizes and are a matter of personal preference. For bluegill, match the length of your leader to the length of your rod. The leader should be tapered and the tippet should be somewhere in the 3 to 6 pound test size. Because of the expense of manufactured leaders, it would be wise to purchase tippet material in the same test size as your leader. This way when your leader gets down to the heavier test, you can simply tie on a piece of the tippet material to make your leader, it's original length, rather than replacing the leader.

Effective flies for bluegill include popping bugs, wet flies and nymphs, in various insect patterns, and a few dry flies. Remember that bluegill have small mouths, so flies in 12 to 20 hook sizes work best. The best colors are black, olive-green and brown.

Now that you are fully equipped, locate some fish. And take a young person with you!

Help For Gambling Problems Offered At University of Memphis

The University of Memphis is offering a new program aimed at helping families and individuals deal with problems related to gambling.

The Gambling Clinic, a center for self-change, is offered by the Department of Psychology at the University of Memphis, said Dr. Andy Meyers, department chairman and co-director of the program.

"The growth of gambling opportunities in nearby Tunica, Miss., and the steady increase in gambling-related problems in the Mid-South show the need for such a program," said Dr. James Whelan, director of the U of M Psychological Services Center and the project's co-director.

A recent survey indicated that six percent of Mississippi's population can be classified as problem gamblers, Whelan said.

"A national survey revealed that people with serious gambling problems had higher rates of job

loss, bankruptcy, divorce, physical and mental health problems, arrests and incarceration than people with no gambling problems," Meyers said.

The U of M program, funded by a grant from the Memphis-based Assisi Foundation, is based on a brief, outpatient approach to the treatment of problem gambling. Trained counselors will help gamblers develop the skills necessary to abstain from or control their high-risk behavior. Family members may be involved to support the therapy.

Although the program is aimed at any gambler

experiencing difficulties, funding from Assisi will enable *low-income gamblers and their families* to participate in the program, which will involve nine sessions, at a total cost of \$30.
