Local Man Chased Through Russellville School After Routine Traffic Stop

According to an article in the Times Daily by Tom Smith, a Mississippi man was arrested Thursday morning, January 31, 2002, after he ran through an elementary school in Russellville. AL, and commandeered an occupied vehicle following a traffic stop.

Police Chief Donnie McGuire of Russellville said Eldridge Taron Johnson, 22, of Tishomingo, MS, is charged with disorderly conduct, driving without insurance, driving without a license, and not using a seat belt while driving.

It was determined that Johnson was also wanted on three third-degree burglary charges by the Franklin County Sheriff's Department and on numerous traffic violations by the Florence and Red Bay police departments.

The ordeal began about 7:42 Thursday morning when Police Officer Ivie stopped Johnson on Clay Avenue in the parking lot of Russellville Elementary School. Chief McGuire said Johnson did not have a driver's license or any other kind of identification. When Officer Ivie did a criminal check on the suspect, he found out there were several outstanding warrants on Johnson. As Officer Ivie was talking to Johnson, Johnson took off running and went behind the elementary school. He then ran into a back door of the school, through the building, and out the front door. As soon as Johnson left the school, he got into the back seat of a vehicle occupied by a woman and her daughter, and he told the woman to "drive!" Officers were able to stop the car at the intersection of School Drive and Clay Avenue, where Johnson was arrested without incident. He is being held in the Russellville City Jail without bail, and more charges are possible.

Jerry is nationally trained and is very interested in setting up disaster shelters in the Tishomingo County area. Anyone who needs Red Cross assistance, which is totally free, should contact Jane Johnson, at the 438-7061 num-Since the beginning of ber. 2002, the Red Cross has already provided assistance to three Tishomingo County fami-

lies. They have also helped the local fire departments by providing coffee, water, Gatorade, and food to firemen fighting to save the property of citizens.

"Lazy Eye" Must Be Caught Early

"LAZY EYE", also known as AMBLYOPIA, is a vision condition in which there is a loss of near and distance visual acuity (sharpness of vision) usually in only one eye. Normally, the images sent from both eyes to the brain are the same. In the case of lazy eye, one of the two eyes is sending out an image which is significantly less sharp. Eventually, the brain will begin to ignore this "inferior" picture. Because of disuse, the lazy eye will be further weakened, until it is all but useless.

Since the better eye "takes over" seeing for both, persons with lazy eye are often unaware that they have the condition. Periodic optometric examinations - beginning at the age of three or even before - are an excellent means of diagnosing lazy eye. It is a condition in which early diagnosis and treatment can usually make an important difference. This is a condition that is almost impossible for parents to notice on their own



Before you call to report an outage, make sure you haven't a fuse or tripped a circuit. Also look outside to see if your neighbors' light ea off. Be prepared to tell if you heard any unusual sounds or can see downe lines in the neighborhood.







KEEP ATV'S FUN BY BEING SAFE

Many children don't want to wait until they are older to join in the fun to be had on off-road vehicles, but safety experts urge them to be cautious when they do. With the proper training and protective gear, youth can be safer on properly sized vehicles such as fourwheelers. However, there are still many unsafe riders.

All terrain vehicle manufacturers recommend beginning drivers take a safety course before riding and discourage riders from driving after consuming alcohol or drugs. ATV's were not designed for passengers or driving on pavement and should not be used on public roads. Riders should wear protective gear such as a helmet, goggles, boots, gloves and sturdy pants. Young people should be encouraged to follow the safety practices. Often the safety rules are not enforced or the needed gear is not available. Parents need to make sure their children have a

Riders age 12 to 16 can drive ATV's with 70 to 90 cc engines, while those larger than 90 cc should only be driven by riders age 16 and older. Riding a too-large or too-powerful ATV can result in accidents that can be fatal. Larger fourwheelers are more powerful and, thus, harder to control.

The ATV Safety Institute recommends young riders be able to sit comfortably and have both feet firmly on the footrests. Foot controls should be easily reached, and fingers should reach around the handlebars and brake levers, even with the wheel turned.

Young riders should be strong enough to squeeze hand controls and press the brake lever. They should also be familiar enough with shifting and operating the choke and fuel valve to be able to use them without looking. These riders need to have good endurance, coordination and visual perception.

Other things to avoid are passengers, stunts and riding on public roads and pavement.



Tishomingo County Special Municipal Separate School District CHILD FIND PUBLICITY CAMPAIGN AND **DISTRICT CONFIDENTIALITY LETTER**

The Tishomingo County Special Municipal Separate School District is participating in an ongoing statewide effort to identify, locate and evaluate children, birth through the age of twenty-one, who have a physical, mental, communicative and/or emotional disability. Early identification of children in need of special education experiences is most important to each child. Furthermore, this information gathered from contacts with parents and other agencies will be used to help determine present and future program needs as progress is made toward the goal of providing a free appropriate public education to all children with a disability.

Information which could identify an individual child will be maintaind by this agency and will be provided to other agencies only in accord with the Family Rights and Privacy Act and EHA-B. As a parent, you are guaranteed the right to inspect any such information about your child and to challenge its accuracy. Access to this information is forbidden to any unauthorized person without informed consent.

Please contact Betty Barnes, Child Find Contact Person for the Tishomingo County Special Municipal Separate School District, if you know any children who may have a disability by calling 423-3206 or writing her at the following address: Tishomingo County Schools, 1620 Paul Edmondson Drive, Iuka, MS

38852.

The Child Find Person implements child identification, location, and evaluation of children birth through twenty-one who have disabilities, regardless of the severity of their disability, and who are in need of special education and/or related services. The Child Find person works with the local Head Starts, Human Services, Health Department, and Mental Health Agencies, as well as local education agencies, physicians, and other individuals to identify and locate children out of school and in school who may be in need of special education services.

Once a referral is made, it is the responsibility of the Child Find Contact person to insure that the Referral-to Placement Procedures are followed. She works with the Local Survey Committee at each school to implement these procedures. The following activities briefly describe the procedures.

As a part of Child Study, parents are invited to attend a Local Survey Committee Meeting to review a child's educational record and performance and determine a need for an evaluation. Prior to an evaluation, copies of the Parent Information Pamphlet and Procedural Safeguards are

given to the parents. District personnel explain these copies to the parents and insure that they understand the Procedural

Safeguards. This process will be reviewed at each parent meeting.

After parental consent for testing is obtained, a nondiscriminatory evaluation is conducted. Students are evaluated in all areas related to the suspected disability by qualified personnel.

Parents are invited to the attend . Eligibility Determination Conference by Multidisciplinary the Evaluation/Eligibility Team to determine if a disability exists. If the child meets eligibility criteria for special education services and/or related services, an Individualized Education Program is developed and the parents are invited to attend the meeting. Parents must sign permission for placement before a child can receive services. Parents, teachers and students participate in the process. All students receiving special education services are reassessed at least once a year and reevaluated at least once every three years.

We now have twentyseven special education classes in our district which provide services to students who have a physical, mental, developmental, communicative, and/or emotional disability. It is the goal of the Tishomingo County School District to provide a free appropriate public education to all children with disabilities through age twentyone.

February is "Strengthening **Family Ties**" **Month At FFRC**

Tishomingo County Families First Resource Center has designated February as "Strengthening Family Ties" month. The "Family Ties" program is dedicated to the memory of Jay Darwin, who used the symbol of a heart to communicate his feeling of love for his family and those close to him. If you received a heart from Jay, you knew that you were special to him and that he was thinking about you. At the time of Jay's death, many of his organs, including his heart, were donated so that others might live. In a strange coincidence, the young lady who received Jay's heart also liked to use the heart symbol to express love and concern for others. Jay's mother Teresa Darwin is the volunteer coordinator for the school-based programs that are taking place this month throughout the entire county. Each child in grades K-3 has been asked to draw and/or color a picture that illustrates positive things that they do as a family, keeping in mind that all families are different and that every family member is important. The children in grade 4 have been asked to write a radio spot to promote the family for FUN 91 radio station. The winners will record their spots to be used on FUN

month. In grades 5-8, students may enter an original poem concerning the positive aspects of a family. Students in grades 9-12 have been asked to write an original essay concerning fathers. The essay may be about his/her own father or father figure or a true story about an experience with a father, grandfather or foster father. Young men may also wish to write about what kind of father they want to be when the time comes. Volunteers will be going to each of the Head Starts in Tishomingo County during February to read "Love is a Family" by Roma Downey.

We ask that the minister of each church mention that February is "Strengthening Family Ties" month from the pulpit each Sunday in order to make everyone aware of the importance of strong families.

Please help us "strengthen family ties" by working in your own family. During the month of February, spent time with your children and so something together as a family. TISHOMINGO COUNTY HAS BEEN AWARDED FEDERAL FUNDS UNDER THE EMERGENCY FOOD AND SHELTER NATIONAL BOARD PROGRAM

Tishomingo County has been chosen to receive \$17,546.00 to supplement emergency food and shelter programs in the county.

The selection was made by a National Board that is chaired by the Federal Emergency Management Agency (FEMA) and consists of representatives from The Salvation Army; American Red Cross; United Jewish Communities; Catholic Charities, USA; National Council of the Churches of Christ in the USA; and, United Way of America which will provide the administrative staff and function as fiscal agent. The Board was charged to distribute funds appropriated by Congress to help expand the capacity of food and shelter programs in high need areas around the country.

A Local Board will determine how the funds awarded to Tishomingo County are to be distributed among the emergency food and shelter programs run by local service organizations in the area. The Local Board is responsible for recommending agencies to receive these funds and any additional funds available under this phase of the program.

Under the terms of the grant form the National Board, local organization chosen to receive funds must: 1) be private voluntary non-profits or units of government, 2) have an accounting system, 3) practice nondiscrimination, 4) have demonstrated the capability to deliver emergency food and/or shelter programs, and 5) if they are a private voluntary organization, they must have a voluntary board. Qualifying organizations urged to apply.

Public or private voluntary organizations interested in applying for Emergency Food and Shelter Program funds must contact Steve Gaines at 423-7013 for an application. The deadline for applications is Tuesday, February 19, 2002 at which time a Tishomingo County emergency Food and Shelter meeting will be held at the offices of Northeast Mississippi Community Services in the Tishomingo County courthouse.
