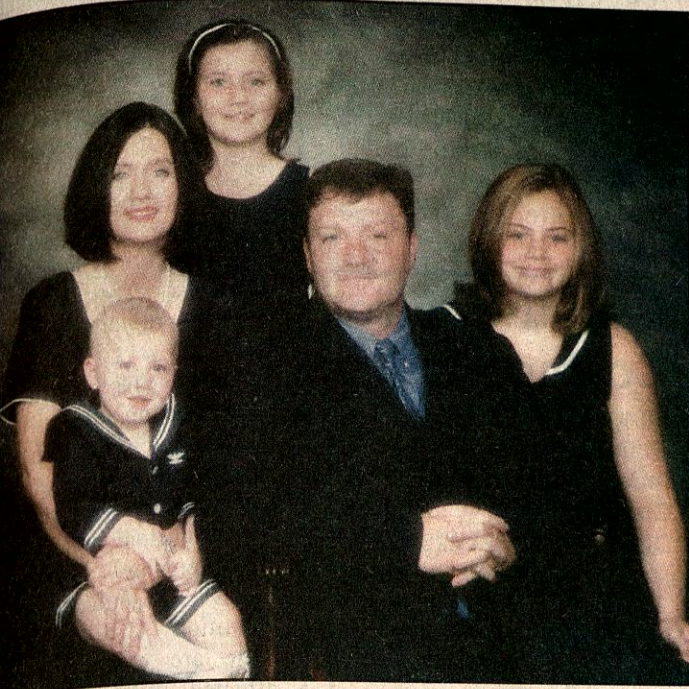

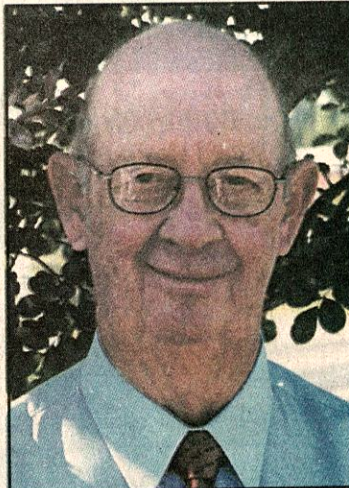
employed in the trucking business for the last eight years.

mechanical fabrication group, where I was promoted to Manager of Hydroelectric Maintenance supervising and

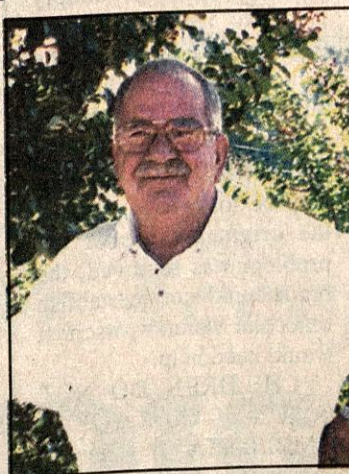

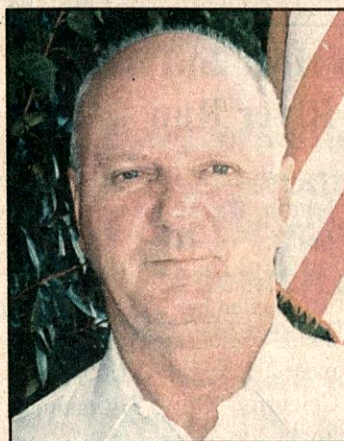
Leslie Blaylock Announces Candidacy For Sheriff

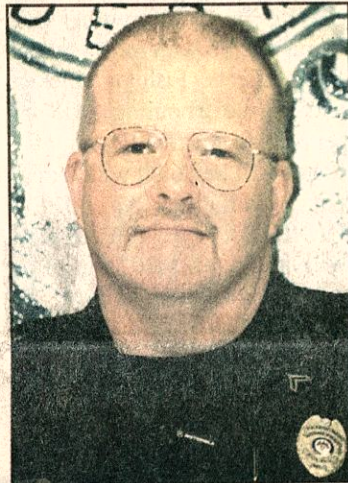
in our county. I will uphold the rights of each citizen in a fair and impartial manner regardless of social or economic status.

A Constable is not just a process server, but a fully

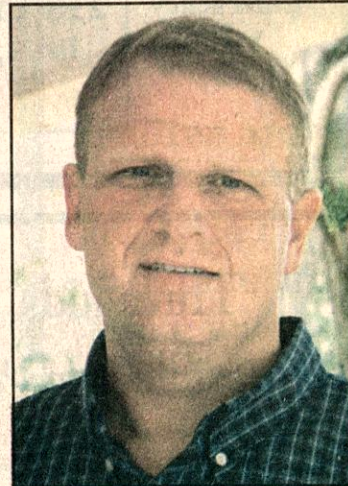

Iuka Eight Year Old Mauled By Dogs

Matthew Wilson, 8, son of David and Pam Wilson, of 1639 Pleasant Hill Road, Iuka, MS, was out riding his dirt-bike on Wednesday afternoon, July 9, when he was viciously attacked by two pit bulldogs that belonged to neighbors.

Matthew suffered serious injuries in the attack. Over his entire body, he received more than 30 bites, lacerations, and injuries to his face, arms, and legs.

Matthew received extensive injuries to his face that required plastic surgery and grafts. Skin was taken from behind his ears and grafted to his forehead, and he will require more plastic surgery at a later time. Matthew also received serious injuries to his right arm when muscle tissue was literally pulled from the arm. The arm may have permanent muscle and nerve damage. The left leg also received numerous cuts and bruises.

Eight-year-old Matthew and a 13-year-old friend were riding a dirt-bike and a go-cart, respectively, on a trail in the Wilson's back yard when two pit bulldogs, one 8 years old and one 8 months old, attacked young Matthew.

The dogs belonged to a neighbor and were not penned. According to neighbors, several complaints concerning the dogs had previously been registered with the city.

The older dog, with the younger dog right behind him, jumped on Matthew's back and pulled him off his dirt-bike. Matthew got up off the ground and tried to run from the dogs. When his helmet got in his way of seeing, he stopped and tried to adjust it, and the dogs attacked again. The dogs man-

gled Matthew's face.

The young friend began yelling for help; and, luckily Matthew's father, David, was outside, working in the yard. When David saw the dogs, he ran to help his son. As David ran toward the scene, he searched his pockets for any kind of object to use to help contain the dogs. He had a Leatherman in his pocket and in the Leatherman was a small knife. David grabbed the older dog by the nape of the neck and used the knife on its throat. He was able to cut the dog, stunning it so he could pull the dog off; but, he still had to fight the younger dog to get it off of Matthew. The younger dog turned on David as he picked Matthew up and ran toward his truck. The younger dog bit at David's legs all the way to the truck.

Young Matthew was taken to the Emergency Room at the Iuka Hospital where he was stabilized. He was later transferred to North Mississippi Medical Center in Tupelo.

Matthew came home from the hospital on Friday, and he is feeling better; however, he is facing additional surgeries this summer. According to Pam, his mother and real-life nurse, Matthew is "one tough little boy."

Pam and David Wilson, both say they don't want anybody else to suffer such a tragic happening like this one. They want people to realize how violent some dogs can be, and they want people to realize the responsibilities of owning such dogs.

According to Iuka officials, both of the pit bulls have been destroyed, and the investigation into the serious happening is continuing.

Children Don't Outgrow Lazy Eye

The word "amblyopia" comes from Greek, meaning dull vision. In common usage, it refers to a particular condition in which the two eyes are feeding different information to the brain. Since the sense of vision is so vital and since the brain is so dependent on it, the two different inputs will not be tolerated. The brain will gladly sacrifice the benefits of stereoscopic vision to avoid the confusion of double vision. It simply learns to ignore the input from one eye-hence the name "lazy eye". Over a period of time, the pattern becomes so ingrained that a normal binocular pattern may be lost. Then, even if the original cause of the problem was removed, the brain could not reestablish binocular vision by itself. It would need help.

CHILDREN DO NOT OUTGROW AMBLYOPIA. It generally entails long-term treatment. This will probably involve correction of the sight problem with glasses or contact lenses, straightening the eye if it is turned, and a great deal of visual therapy.

Arthritis

Arthritis is a complex condition involving inflammation of joints. There are many causes of arthritis in pets. In many cases, the degree of arthritis is related to the age of the animal.

What causes arthritis?

The most common type of arthritis is osteoarthritis (OA) which is also known as degenerative joint disease (DJD). This can be primary, the cause of which is unknown and secondarily, the cause of which is known. Following conditions involving joint instability leading to damage of the subchondral bone that line the joints. Some common causes of DJD include hip dysplasia, cranial cruciate ligament rupture, and trauma.

Other causes include joint infection, often as a result of bites or injuries or it may follow joint trauma and damage.

Rheumatoid arthritis is an immune mediated erosive, inflammatory condition. Cartilage and bone are eroded within affected joints and the condition can progress to complete joint fixation (ankylosis). It may affect single joints or multiple joints may be involved (polyarthritis). In certain dog breeds Rheumatoid Arthritis (RA) factors can be detected with blood tests.

Other types of immune mediated arthritis can be non-erosive, such as arthritis that is associated with Systemic Lupus Erythematosus (SLE). SLE is often accompanied by other clinical signs in addition to the arthritis.

Infective or septic arthritis can be caused by a variety of microorganisms such as bacteria, virus and fungi. Septic arthritis normally only affects a single joint and the condition results in swelling, fever, heat and pain in the joint. Before long your pet is likely to stop eating and become depressed.

How do we treat arthritis?

Treatment will depend on the cause of arthritis. Immune mediated and rheumatoid arthritis are usually treated with high doses of corticosteroids which often lead to a dramatic response. The maintenance of these conditions often involves the long-term use of corticosteroids and other drugs such as immunosuppressive or cytotoxic agents.

The treatment of septic arthritis involves determining the type of microorganism involved and its antibiotic sensitivity. Antibiotics are usually administered for a minimum of a month and analgesics are also necessary to combat pain and inflammation.

Analgesics are the most common form of treatment for osteoarthritis. It is important to select these medications with care since some dogs are more sensitive than others to the potential side-effects of analgesics. The most common side-effects of analgesics include decreased appetite, vomiting and diarrhea. Most pets will have pre-medication blood tests to make sure that they can safely metabolize and excrete the medication and then periodic blood tests to ensure continued safe usage. If you have any concerns following the administration of any medication we have prescribed, please discontinue them and contact us immediately.

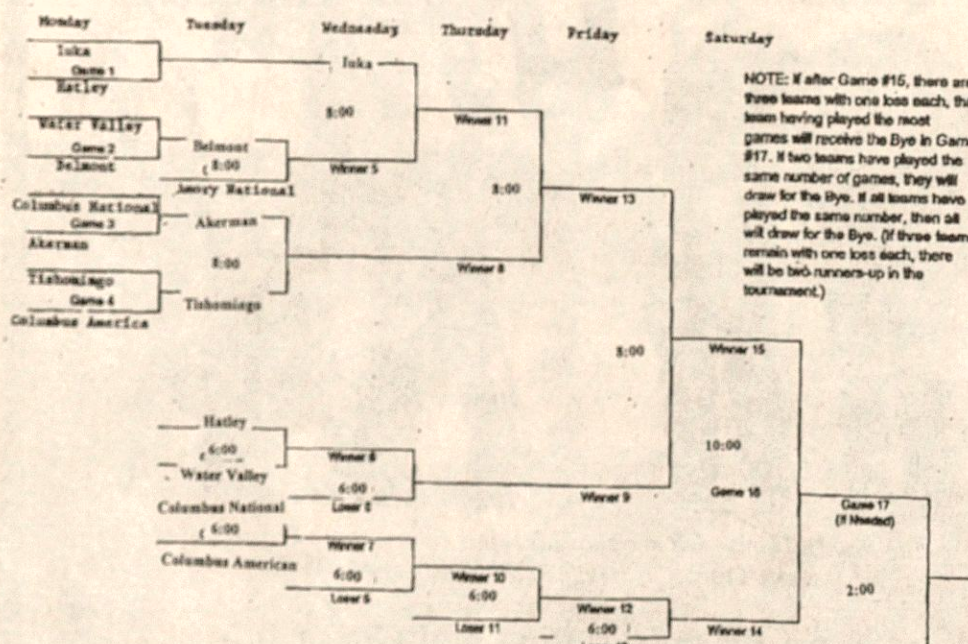

Ask the Doctor?

Q: I am a 60 years old woman and was recently diagnosed with osteoporosis. I have been taking calcium supplements for years. Why hasn't that kept my bones strong? I stopped having periods at age 50 and have never took hormones.

A: Osteoporosis means the bones have become thin and brittle. Women begin losing bone mass in their 30's and this increases even more after menopause or when the ovaries have been removed by surgery. The female hormones especially estrogen, are the body's chief means of getting calcium into the bones. Some women never get thinning bones as long as they get adequate calcium, but many do.

If you are beginning to have symptoms of menopause such as hot flashes, you should request a bone density test with your doctor or nurse practitioner. There are now medications besides hormones that can help protect you from osteoporosis. All women should get adequate calcium and vitamin D. If you are past menopause, you should also take a supplement containing 600mg of calcium plus vitamin D twice daily. And remember, osteoporosis is not the same as osteoarthritis, which is deterioration of the joints due to age, and wear and tear.
