## Saturday Night House Fire Claims The Life Of Elderly Iuka Man

Jack Ignatius Charbauskis, 68, of 243 CR 915, Iuka, tragically died as the result of a house fire at his residence Saturday night, July 24. Two others, Charbauskis's son, Jack, Jr., and his girlfriend, Jennie Hall, were also in the house but escaped with some injuries and burns. Both of them were transported to the Iuka Hospital. She was treated and released, but Jack, Jr. was sent to the Med in Memphis, for further treatment of his injuries. He was expected to be released on Tuesday or Wednesday.

A passerby reported the fire to 911 at approximately 11:40

p.m. on Saturday night, July 24; and within minutes firemen from the Eastport/Mill Creek Volunteer Fire Department, the Iuka Fire Department, and Snowdown/Pleasant Hill Volunteer Fire Departments were on the scene.

Fire Chief Brian Grissom of the Iuka Fire Department reported that the front part of the house was fully involved when they arrived to backup the Eastport/Mill Creek Department. Firemen from Snowdown/Pleasant Hill also assisted at the scene.

Witnesses on the scene reported to the firemen that the elder Jack Charbauskis was still

inside. Reportedly, the elder Mr. Charbauskis, who had trouble walking, had been seen at the front door, but had returned inside to get his faithful companion, his dog. A neighbor, who also suffered some burns to his body, tried to get Charbauskis out of the house but was unsuccessful.

Apparently Mr. Charbauskis, the son and his girlfriend were all inside the dwelling asleep when the fire began. According to witnesses, the fire is believed to have started when a cigarette fell on a mattress and set it on fire.

## Iuka Man Killed In Accident At Shiloh Falls Golf Club

Iuka resident, Harold Fulton, 57, was killed in a Monday morning, July 26, accident at Shiloh Falls Golf Club where he was an employee.

Fulton, along with the Head Greenskeeper at Shiloh Falls, were preparing for the day's work about 10:30 a.m. They were transporting needed equipment down a steep 200 foot embankment near the 15th hole at the golf course where two trams, one for people and one for equipment, are located.

According to the Hardin County Sheriff, Sammy Davidson, Mr. Fulton was attempting to drive a greensmower up and onto the platform on the equipment tram when it lurched forward through a metal gate and plunged down some 40 feet before becoming entrapped in the track. Fulton was thrown from the mower and landed some 40 feet away.

Emergency personnel from Hardin County District III-Counce, TN, quickly arrived after the 911 call and medical assistance was administered on the scene. Mr. Fulton was taken to the Savannah, TN, hospital, by ambulance where he died. Hardin County authorities are continuing the investigation of this tragic accident.

Harold had worked at Shiloh Falls after his retirement as co-owner of Piggly Wiggly in Iuka.

William Harold Fulton, 57, of Iuka, died Monday as a result of an accident at Shiloh Falls Golf Club, where he was currently employed.

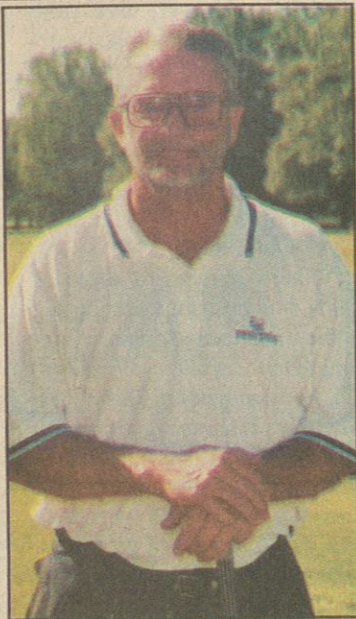
A native of Clarksdale, he was the son of the late Mr. and Mrs. T.O. Fulton. He graduated from Clarksdale Coahoma High School. He attended Mississippi State University and graduated from Delta State University where he played on the tennis team.

Harold married Janet Gann of Iuka. They first lived in Clarksdale, where he managed the Five-County Farmer's Association, a co-op founded by his father.

He and Janet and their young son, Alex, moved to Iuka in 1977. He was an employee of Piggly Wiggly and was later co-owner.

Harold was an avid sportsman throughout his life. He enjoyed tennis, golf, and snow skiing, as well as dove and duck hunting with his son and friends. But for the past thirty years, his love of the game of golf took precedence.

Survivors include his wife of thirty-one years, Janet Gann Fulton of Iuka and his son, Alexander Dean Fulton of Nashville; a brother, T.O. Fulton Jr. and wife Joyce of Lyon; a sister, Francis Fulton Jacobs and husband, Jim of Brandon, FL.

## Two County Teens Killed in One Vehicle Accident on AL Hwy. 247, Thursday, July 22

Two young Belmont men, Marvin Carlton, II, and Dustin Smith Pharr, were killed on Highway 247 in Franklin County, AL, Thursday night, July 22, 2004, in a tragic one-vehicle accident.

The four occupants of the vehicle had been to the drag races and were apparently returning home when the late-night (approximately 10:25 p.m.) accident occurred.

The four teens involved in the accident included passengers, Marvin Carlton, II, 15, Dennis; Dustin Smith Pharr, 15, Dennis; driver, Justin Seth Higginbottom, 18, of Sallito; and passenger, Emily Holcomb, 15, Belmont. Both Carlton and Pharr, who were ejected from the T-top 1997 Camaro, were pronounced dead at the scene by the Franklin County, AL, Coroner. According to Tishomingo County Deputy, Donald Thomas, the accident happened just across the Mississippi line, and allegedly may have been caused as the result of a blown-out tire and/or excessive speed.

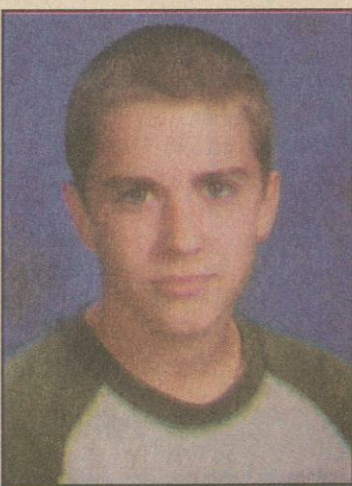
The other occupants, Higginbottom and Holcomb, received multiple minor injuries in the accident that occurred about 10 miles north of Red Bay. Both Higginbottom and Holcomb (who was wearing her seatbelt) were transported to area medical facilities, treated for multiple minor injuries, and later released.

Alabama Highway Patrol Trooper Knight contacted Tishomingo County authorities when the victims were identified as Tishomingo County residents so that family members could be contacted.

According to Deputy Thomas, an investigation into the accident continues.

## Miki McCarty Finishes 2nd In The Southern National Doubles Championship In Memphis

Iuka's own Miki McCarty and partner, Lori Maxwell held off Juliana Korver, five time World Champion, and her partner Addie Isbell through the final six into a sudden death playoff before dropping a putt to finish second in the 2004 Southern National Doubles Championships in Memphis this past weekend.

There were 74 doubles teams, in 9 divisions competing in the first ever Southern National Doubles Championships.

As you may have read in a previous Tishomingo County Vidette, Miki is on her way to the PDGA (Professional Disc Golf Association) Pro/Am Worlds the first week in August in Des Moines, IA.

Juliana and Addie had the lead by one stroke going into the final six "worst shot" round of the Championships. Miki and Lori swapped the lead three times in the final six with Juliana and Addie trying it up on the final hole. This resulted in a "sudden death" playoff!

Juliana drove first to within 30 foot of the pin, with Addie parking her drive at around eight feet. Being a "worst shot" round, they had to use the "away" shot.

Lori's drive fell short and to the left of the basket, around fifty feet from the pin. Miki crushed a drive that went 80 feet past the basket to the right, which ended up being the shot they had to use.

Lori's approach was 25 foot from the pin, with Miki's landing within four feet. Neither Addie nor Juliana made their putts from thirty feet, and took a par three on the hole.

Lori sank her putt, putting all the pressure on Miki to do the same, as they BOTH have to make the putt to carry on to the next hole. Miki lined up, with the wind picking up a bit, and sent her putter flying...into the side of the basket, for a miss, and a score of four. This ended the sudden death playoff for first, with Juliana and Addie as the new Southern National Pro Women Champions.

Miki will face Juliana again next month, in singles competition, at the 2004 PDGA World Championships, along with current champion Des Redding and 22 confirmed Pro Women entrants.

The top 1/3 will be cashing for over \$4,000 in entry fees alone, not counting the added cash from sponsors. It will be one of the biggest Pro Women's events ever!

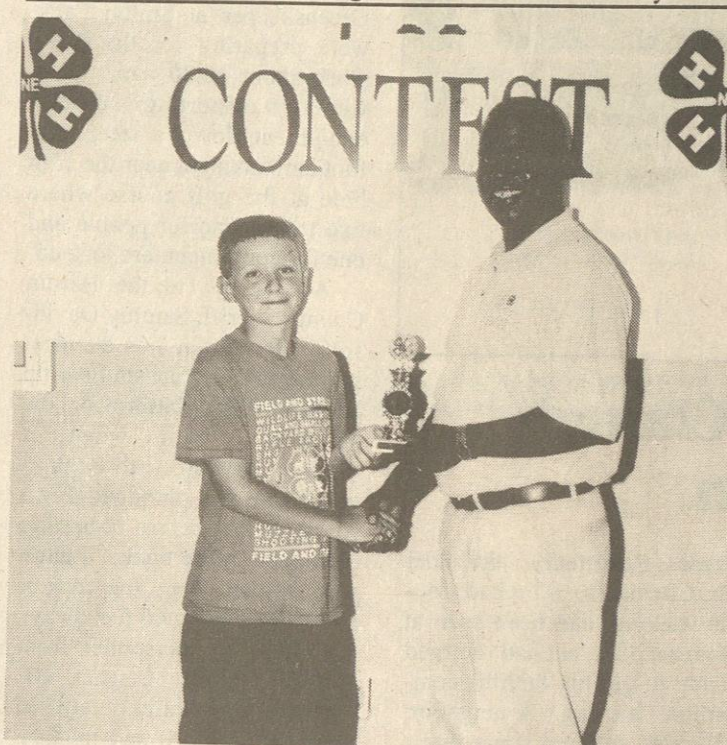

**CLASS ACTS**  
When there are so many plaintiffs involved in a single lawsuit that it would be impractical to conduct a like number of individual civil legal actions, the court may decide to treat them as a group. This type of lawsuit, known as a "class action," may be called for when many hundreds or thousands of people are involved in the same injurious event or are exposed to the same risk. Aggregating smaller claims in a class action serves to ensure that all those injured by the wrongful conduct are compensated. It is also designed to remove any unfairness that would result from different outcomes over the same issue in different cases.

**Why Nearsightedness?**  
It is estimated that 25% of our population is nearsighted, and no one knows why. This has changed now.

Researchers have discovered that myopia (nearsightedness) in monkeys is strikingly similar to that of humans. Their results so far indicate that myopia may be caused by abnormal influences on the nervous system on the developing eye.

**RESOLUTION DECLARING THE NECESSITY FOR AND THE INTENTION OF THE TISHOMINGO COUNTY SPECIAL MUNICIPAL SEPARATE SCHOOL DISTRICT TO BORROW THE PRINCIPAL AMOUNT OF TWO MILLION, SIX HUNDRED THOUSAND DOLLARS (\$2,600,000) FOR THE USE OF THE SCHOOL DISTRICT**

WHEREAS, the School Board of the Tishomingo County Special Municipal Separate School District of Tishomingo County, Mississippi, (the "Board" of the "District"), hereby finds, determines, adjudicates and declares as follows:

(a) It is necessary, advisable, and in the best interest of the District to erect school buildings and other buildings used for school purposes and to make repairs, alterations and additions to school buildings of the District, at an approximate cost of two million, six hundred thousand dollars (\$2,600,000).

(b) There are no funds available in the school funds of the District or from any other source with which to make such erections, repairs, alterations and additions; and the District needs and requires an additional sum of two million, six hundred thousand dollars (\$2,600,000) in order to properly do and perform such work.

(c) The Board is authorized and empowered to borrow money for such purposes under the provisions of Section 37-59-101, et seq., Miss. Code of 1972, as amended, and related statutes.

Early identification of children in need of special education experiences is most important to each child. Furthermore, this information gathered from contacts with parents and other agencies will be used to help determine present and future program needs as progress is made toward the goal of providing a free appropriate public education to all children with a disability.

Information which could identify an individual child will be maintained by this agency and will be provided to other agencies only in accord with the Family Rights and Privacy Act and EHA-B. As a parent, you are guaranteed the right to inspect any such information about your child and to challenge its accuracy. Access to this information is forbidden to any unauthorized person without informed consent.

Please contact Betty Barnes, Child Find Contact Person for the Tishomingo County Special Municipal Separate School District, if you know any children who may have a disability by calling 423-3206 or writing her at the following address: Tishomingo County Schools, 1620 Paul

The Child Find Person implements child identification, location, and evaluation of children birth through twenty-one who have disabilities, regardless of the severity of their disability, and who are in need of special education and/or related services. The Child Find person works with the local Head Starts, Human Services, Health Department, and Mental

need of special education services.

Once a referral is made, it is the responsibility of the Child Find Contact person to insure that the Referral-to-Placement Procedures are followed. She works with the Local Survey Committee at each school to implement these procedures. The following activities briefly describe the procedures.

As a part of Child Study, parents are invited to attend a Local Survey Committee Meeting to review a child's educational record and performance and determine a need for an evaluation. Prior to an evaluation, copies of the Parent Information Pamphlet and Procedural Safeguards are given to the parents. District personnel explain these copies to the parents and insure that

they understand the Procedural Safeguards. This process will be reviewed at each parent meeting.

After parental consent for testing is obtained, a non-discriminatory evaluation is conducted. Students are evaluated in all areas related to the suspected disability by qualified personnel.

Parents are invited to attend the Eligibility Determination Conference by the Multidisciplinary Evaluation/Eligibility Team to determine if a disability exists. If the child meets eligibility criteria for special education services and/or related services, an Individualized Education Program is developed and the parents are invited to attend the

meeting. Parents must permission for placement before a child can receive services. Parents, teachers, students participate in the process. All students receive special education services reassessed at least once and reevaluated at least every three years.

We now have seven special education in our district which services to students who physical, developmental, communicative, emotional disability. goal of the Tishomingo School District to provide free appropriate education to all children disabilities through age 21.
