



Sip Code - Why You Should Pucker Up And Use A Straw?

It's bad enough that sodas, fruit juices, and those newfangled canned and bottled goods known as flavored teas contain high doses of sugar. They're chock full of enameleroding acids, too. So one way or another, they contribute mightily to tooth decay. If you're a devotee, your best option is to cut down on soft drinks. Second best? "Sip them with a straw," advises Anne Murray, DDS, with a practice in Cupertino, California. "That way, both the acid and the sugar bypass the mouth and teeth and go right into the throat."

What's more, "drinking straws satisfy the suckling impulse and may exercise the muscles of mastication around the mouth," says H.B. Garrison, DDS, of Lauderdale Lakes, Florida. "Being the subconsciously pleasurable experience that it is, sipping out of a straw means you'l drink more," adds Norma Olvera, DDS, assistant professor of prosthodontics at the University of Texas Health Science Center in Houston. That's of benefit to those who have dry mouth.

Plus, straws, in their individual wrappers are a lot more sanitary than drinking glasses, adds Dr. Olvera. And as anyone who's ever devoured an ice cream soda is fully aware, a straw is the only way to drink it without getting foam all over your face. (Be sure to brush your teeth as soon as possible afterwards.)



I may not be able to see all add a couple additional personof you but I am honored and proud to represent you, the people of the second District of Tishomingo County. For you that may not know me, I am the husband of Sandy Watson White; father of three, Derenda, Jana, and Jenny; and grandfather of three, Ethan, Trenton, and Alexia. I am the youngest son of Rev. Talmadge and Mildred White.

Please let me dispel some rumors I have heard. Your school tax base is at 39 mils, this comes out of the county tax base. This has not changed during my term and I will assure you that I will fight to keep school taxes at this level if reelected. The tax level (39 mils) is among the lowest in the state and if you check our adjoining counties you will see that they are at 50 + mils. this should prove that we can manage your money wisely. I believe that everyone has a voice in the schools because you the tax payers make these fine schools as great as they are. Let me focus on the positive accomplishments in our district. I am very proud to be a part of a school district that is second to none. I, too, have a child in this school system and have had two graduates from TCHS. We are one of the top ranked schools in the state, academically, out of 150 + school district state wide. Thanks to the faculty, staff, parents, and our children, we have achieved a level 5 accreditation throughout the county, to get a comparison please check the counties next to us. We have to show progress to maintain this academic level. When I was first elected to the board we had a drop out rate of 25%, I have fought to reduce it. Today it is at about 5% to 7%, thanks to the efforts of our school staff and our children we are putting a diploma in 93% of our children's hands. We were able to reemployed all of our staff and nel. This means that our classroom size will stay at about 18 children per classroom. This was due to managing your money wisely. We have a new field house at the high school campus, adding bleachers to the gym, new carpet in the classrooms, and security cameras on the parking lot (parking lot cameras are being looked at for all campuses). Please check at the surrounding school districts to compare the things that I have shared with you. You will find that we truly are in great shape. My platform has been proven and continues as follows; to keep classroom size low in numbers to have more individual attention for the student, keep your taxes low, reduce or completely do away with classroom fees, and continue upgrades of existing buildings. All of this affects you and most importantly our children.

#### Let me tell you about a few things we did to improve your schools:

1. For the last three years we have been putting back money because the state has been threatening to cut our budget. They did not do this until this year and over \$600,000.00 was cut from our budget. We are ready with some extra money; I think you the tax payer should be proud of the fact that we were able to absorb this cut. The teacher's had \$300.00 cut from there classroom fund, we were able to replace that and add \$50.00.

2. We have purchased 25 + buses during my term of office and installed 2 way radios on all buses county wide for emergencies all of these communicate to all school and cen-

red blood cells. Because red blood cells live for 90-120 days, this test tells how wellcontrolled blood sugar has been for the past 3-4 months. A finger stick blood sample is taken and measured, and

within a few minutes the re-

sults are available.

"One of the most important services I can offer my patients is a simple test to screen for diabetes," said Steve Barnett, Pharmacist. "Our pharmacy wants to identify those at risk for diabetes and encourage them to visit their physician. We want to teach consumers that nearly half the time, diabetes can be prevented through simple changes in diet and exer-

A patient's glucose level is determined by putting one drop of blood on to a test strip using a simple finger stick. A glucometer then reads the test strip and issues results immediately. Any patient tested that has a fasting glucose level over 200 will receive a second test to obtain his or her homoglobin A1c levels. Another drop of blood is required for the HbA1c test. This drop of blood is put into an HbA1c test cassette and placed into the analyzer. The analyzer will run for 6 minutes. Will the screening tell me if I have diabetes?

No, the screening will not diagnose diabetes. It will help to indicate whether your blood levels indicate you may be at risk for diabetes. We encourage our patients to take their results to their local healthcare provider.



### "Remembering a Real Superman" by Christian Evans

"Superman Dies" was printed in large black letters heading a section of the The morning paper. "Superman" in the piece was actor Christopher Reeves. He will forever be remembered not only for playing the role of the man of steel on screen but for showing the world that within a paralyzed body lived the soul of a true "Man of Steel".

He started acting in theatre. The dashing young man worked his way to Broadway. Reeves' charm and charisma was recognized as he tried to break into the big time on the silver screen. His breakthrough portrayal as mild-mannered Clark Kent hid the secret identity of Superman. Reeves had other roles, winning awards and critical acclaim. Yet, this breakthrough in the Superman films would mirror his life.

Reeves' was an adventurous spirit with many hobbies. From mountain climbing to flying jet planes, sports and varied interests filled the free time of the busy actor. He loved horses and competed in equestrian events. In 1995 at one of these events, Christopher Reeves was thrown from his horse. The fall paralyzed his body below the neck. The previous mildmannered man, like his onscreen Clark Kent character, took on a new role as Christopher Reeves, crusader for the physically challenged.

Struggling to life in the days shortly after the accident, Reeves' breathing was aided with a machine to help him breath more normally. He

endured rigorous physical therapy daily. Reeves contemplated suicide but was guided through his faith to set goals. He wanted to breath on his own again, work as an actor, director and other projects but above all, he wanted to walk under his own power again.

Reeves took to the airwaves to give a face and voice to disabilities. Reeves focused on his "abilities". He was able to work with world-renowned specialists in spinal cord injury and worked on every lead and every option in reaching his goals.

We watched as Reeves rolled on stage at the 1996 Democratic National Convention. That night we heard the voice of an admired and respected actor challenge us to help in supporting research funding and government involvement in finding cures through modern technology and science.

Reeves stayed in the limelight pushing his cause from talk shows like Larry King to Oprah. He won awards for his portrait of a man who witnessed a crime in the remake of "Rear Window." He directed a number of projects. All this while working tirelessly with doctors and therapists daily.

progress with experimental treatments was followed closely by the media. Reeves' smile and labored voice was seen and heard around the world. In the Halls of Congress to the far corners of the world, this man became a constant figure pushing for

stem cell research which is still a controversial issue in our country today. Though controversial, Reeves fought his battles in private and in public to find a cure. He was an icon who represented 50 million disabled Americans. He not only worked tirelessly for

To me, this gentle spirit showed us how the frailty of man, one who had it all, fame, wealth, talent, a charmed life, can still seemingly loose everything. He never lost his faith, hope and optimism. For this Christopher Reeves will always be my hero. A real SUPERMAN.
