Emergency personnel responded to the 9-1-1 call just after noon.

## Luka Man Injured In Tractor Accident

Dale Williams, 164 CR 255, Luka, was injured in a serious tractor accident before noon last Friday, Oct. 29. According to emergency volunteers on the scene, Williams was hauling a woodburning furnace used to heat water and provide heat on a trailer behind a tractor when the burner apparently slipped off.

According to Williams, the weight on the trailer shifted causing the burner to slip off. He got off the tractor, and when he did, the tractor flipped over on him, pinning him be-

neath the tractor. Williams was pinned to the ground with the weight of the tractor (about 2 tons) resting on his leg.

Williams was found between 12:00 noon and 12:30 when a man at Williams' house heard Williams yelling. Williams had been out of the house on the tractor since about 9:00 a.m. Friday morning. He was unsure about the actual time the accident happened. He did state that he knew he had been outside for at least an hour. He was uncertain of the time he had been pinned be-

cause he was "in and out" of consciousness.

The call to 9-1-1 came in at 12:20, and units from the Luka Fire Department, Showdown-Pleasant Hill VFD, Midway VFD, Burnsville VFD and North Crossroads VFD, and Air Evac responded to the call. The Jaws of Life had to be used to lift the tractor off Williams. He was transported to North Mississippi Medical Center in Tupelo by Air Evac where he was treated for a broken leg. According to a family member, Dale was released from the hospital on Monday, Nov. 1.

## Bush Projected as US President

In a record-turnout election, many voters across the country stood in line for hours to cast their votes. Rain and other bad weather hindered some voters, but most were determined to mark their ballots, and the voters have apparently chosen incumbent George W. Bush as the next President of the United States. TV media reported that Bush received more votes than any other man has ever received in a Presidential election. Voters in the state of Mississippi and Tishomingo County cast the majority of their votes for the Bush/Cheney ticket.

Both Republican George Walker Bush and John Kerry have spent record-breaking amounts of time and money on the 2004 Presidential election. On Wednesday morning, media still was reluctant to call the election for Bush.

Candidates from seven different political parties (Republican, Democratic, Libertarian, Green, Independent, Reform and Constitution) were listed on the ballots.

In the other national race in Mississippi, Republican Roger F. Wicker was pitted against Reform Party candidate Barbara Dale Washer for the position of First District Congressman. Wicker won this race by 80% and will again represent North Mississippi in the First Congressional District seat. Tishomingo County Elections

In Tishomingo County voters elected Election Commissioners in all five Supervisory Districts and a School Board member in the Second District. Tishomingo Countians also voted for a District 3 (Northern Position No. 3) Supreme Court Justice. William L. Bambach

and Incumbent George Carlson were in this race. Carlson won this race with 56% of the votes. In the races for Election Commissioners, the following were elected.

**First District**—Ind. Arthur W. Bonds was elected with 1442 votes. He was unopposed.

**Second District**—Jeffrey W. Wilemon (Dem) was elected with 1283 votes. He, too, was unopposed.

**Third District**—Democratic Raymond E. Gist, Jr. ran against Independent Sherry Gwatney. Gwatney won with 841 votes over Gist's 733 votes.

**Fourth District**—Four candidates ran for this position. Hafford G. Luttrell (Dem), Josh McNatt (Rep), David P. Rushing (Ind), and Bob Russell (Dem) were on the ballot. Luttrell received 372 votes, McNatt received 534, Rushing received 598, and Russell received 315. A run off between Josh McNatt and David Rushing is scheduled on Tuesday, Nov. 16.

**Fifth District**—Ronald Deaton (Ind.) ran unopposed for this position. He received 1238 votes.

**Second District School Board**—Four candidates were listed on the ballot. Bobby H. Johnson had 338 votes, Steve McGee had 428 votes, Anthony L. Whirley had 553 votes and Gary White had 368 votes. Anthony Whirley won this race with no run-off over incumbent White.

**Constitutional Amendment**—Mississippians in all counties also voted yes to the amendment banning marriage between same sex people and recognition of such marriages.

## IUKA WOMAN MISSING INFORMATION BEING SOUGHT FROM THE PUBLIC

According to Luka Police Chief Randy Stringer, local resident, Donna Teresa Cupido, is missing and he is asking the public for any information they might have concerning her or her whereabouts.

Donna Cupido is a 44-year-old white female, 5 foot 9 inches in height, 135 lbs., with blonde hair and green eyes. She has a butterfly tattoo on her right shoulder. She was last seen on Thursday, Oct. 21, 2004, wearing a flannel shirt and slacks. Her vehicle, a silver Kia Sportage, was found, parked behind the Luka Apostolic Church on Hwy. 72 E.

Chief Stringer stated that a search of the area in and around the church was conducted by members of his department, along with members of the Luka Fire Department, Tishomingo County Sheriff's Department, and other volunteers; however, no sign of Mrs. Cupido was found.

The department has been pursuing numerous leads into her whereabouts, however nothing has led them to her at this time. All officers of the Luka Police Department have been working almost around the clock, many on their off days, to pursue leads, in order to locate this woman, according to Chief Stringer. Also, the Federal Bureau of Investigation (FBI) has been contacted to assist with the investigation into Mrs. Cupido's disappearance.

"We would like to ask anyone who knows Donna

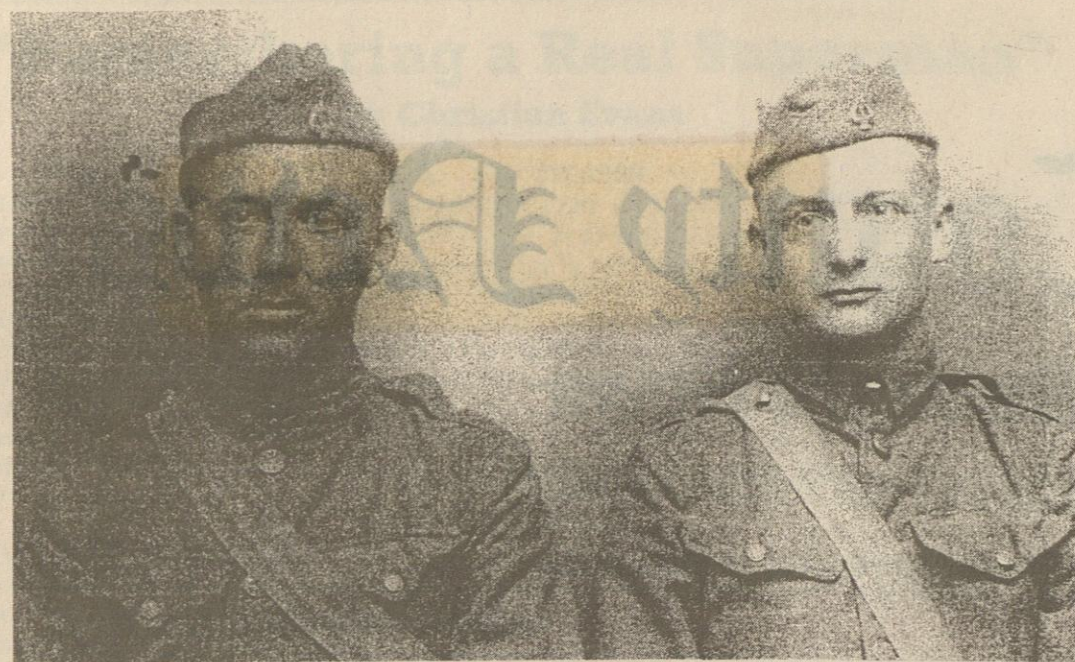

### Dental Devices Can Help You Get A Full Night Of ZZZ's

Are you a snorer? Do you emit delicate, husky bleeps, or do you roar like a diesel engine? Not sure? Chances are your significant other will know. An estimated 20 percent of the adult population snores, and while mild snoring causes no harm (beyond not being romantic), labored breathing may indicate obstructive sleep apnea - a disorder whose effects can be dangerous. With sleep apnea, breathing is interrupted for a minimum of 10 seconds hundreds of times per night - causing sleepers to awaken many times and severely limiting the amount of rest they receive. The problem is that they awaken so slightly, they rarely remember these brief arousals.

If sleep apnea is suspected, your doctor or dentist may refer you to a sleep clinic for a full diagnosis. Surgery is an option for those with anatomical problems. A more common solution is a CPAP machine (short for Continuous Positive Airway Pressure). This device is essentially a mask worn on the nose that's connected to a bedside machine that blows air into the nostrils all night long. Compliance? Not great. Many patients prefer something less obtrusive.

This is where your dentist can help. More than 35 different oral appliances are currently available for treating mild to moderate sleep apnea. A dentist familiar with these devices can help you choose the one that's best suited to your mouth - though first, he or she will take soft plaster or wax impressions of your teeth. These are sent to a lab where an appliance is constructed that fits your teeth precisely.

There are two categories of sleep appliances.

- Tongue advancers pull the tongue away from the back of the throat via a small suction cup that's braced against the teeth. This prevents the tongue from falling backwards against the soft palate and enables air to pass freely.
- Mandibular advancers work by moving the lower jaw forward. As it does, the tongue and uvula (that little piece of flesh that hangs down from the rear portion of the soft palate) move away from the back of the throat, allowing for more regular breathing.

handled; can't touch me stage" to the "Gee your not such a bad guy I think I'll let you on my back stage." That's a big step for a young horse, for any horse. And if you've ever handled horses, you can appreciate the importance of learning this

technique.

The technique's he'll demonstrate can also help with already trained horses that may have developed bad habits, such as, "You can't catch me!" or "I don't want to go in that trailer."

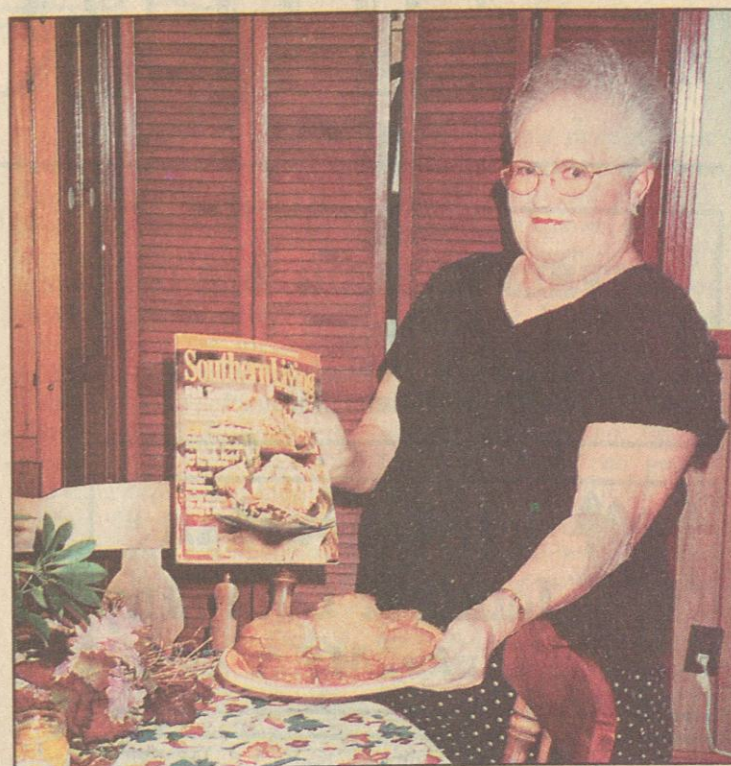

Additionally, if the stream is successfully nominated, Mississippi income tax credit of up to ten thousand dollars will be available to landowners creating conservation easements on adjacent to Bear Creek. 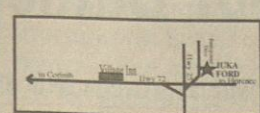

## Iuka Police Dept. Obtains Grant To Place Computer Software In Middle School And Library To Protect Kids From Internet Predators

Are your children at risk of being lured away by an Internet predator?

If they have Internet access, there is always a possibility.

Iuka Police Department will be introducing a new program in the local school system and Iuka Library to teach area kids, parents and educators about this increasing threat and how your child can avoid being a victim.

According to a national study, middle school age children from rural areas, and those from both rural and urban areas from lower income families are most vulnerable to these predators who often offer them money, gifts or vacations. Most often these predators pretend to be someone they are not. They claim to understand the problems the kids are going through and use the personal information given by the children to locate them or to entice them to meet them somewhere.

In a recent survey of young people, approximately one in five middle school age children admitted being approached through the Internet by someone making promises of this type; however, the survey also reported that of these kids, 75 percent did not report it to their parents for fear of losing their Internet privileges. In our local area, law enforcement have had to deal with several cases of luring through the Internet.

Iuka Police Chief Randy Stringer and the members of the

Iuka Police Department know that with the high numbers of our area youngsters using the Internet on a daily basis, the threat against the kids in our city is very real. With this in mind, the Iuka police Department has obtained a grant of computer software - a game for youngsters ages 11-14 - to be placed in Iuka Middle School and the Iuka Library to help educate them about the dangers of these strangers who approach them on the Internet.

The game is called "MISSING" is based on a real case of Internet luring. It puts the young people in the role of police and detectives. They try and locate a missing boy who was lured away from his home to a big city where the person he has been chatting with and e-mailing on the Internet promises him a cool job making good money. However, when the boy gets there, he finds he has been deceived and is held captive by the predator.

Those playing this challenging game must use any clue they find to locate the missing boy so he can be returned safely home. At the conclusion of the game, each child will be asked to create a personal Internet safety plan to put into practice each time they go on-line.

"We will be placing copies of this game in Iuka Middle School and at the Iuka Library

so it can be installed on their computers and played by the students," Chief Stringer stated. "Along with the game and in-

formation for students, there is information for parents and teachers. We believe that by having the children playing this challenging, but fun game, it will make them more aware of the danger they may be putting themselves in by talking to people they don't know on the Internet and hopefully prevent them from falling prey to one of these people."

Local school officials and regional and local library officials have given their approval to the installation of the "Missing" game for use by local students. Superintendent John B. Moore and Board of Education members, along with Iuka Middle School Principal Jimmy Smith have stated that they believe the game will be a great asset to the middle school children by giving them insight into the dangers they could encounter on the Internet and give them the skills they need in order to avoid becoming a victim. Library officials agree and want the game to be available at their local facility so that those children who may be home schooled can also have access to it, as well as making it available to any other children who may not attend Iuka Middle School.

"We have officers who will be implementing this program in the very near future at these locations," Chief Stringer said. "We look forward to working with them so that we can educate our children about these potential dangers and make their Internet use much safer."
