## Burnsville Volunteer Fire Dept. Purchases New Fire Truck

The Burnsville Volunteer Fire Department and the Town of Burnsville recently purchased a new fire truck.

This new addition to the Fire Department was partially funded with a \$70,000 grant

from the State of Mississippi. This new truck is to replace the current Class A pumper which is 15 years old. The new truck was tested and certified at the Fire Academy in Pearl, Miss.

With this new truck, the

Fire Department can maintain its current class 8 fire rating and give the Fire Department and the Town an opportunity to work toward an even lower fire rating to ensure the lowest insurance rates for local residents as possible.

## Firefighter Grants Go To Four Mississippi VFDs

The Department of Homeland Security has approved fire safety grants for four north Mississippi volunteer fire departments, federal lawmakers said Wednesday.

U.S. Rep. Roger Wicker and Sens. Thad Cochran and Trent Lott said the funding will be used to improve firefighter safety and purchase new vehicles.

The Myrtle Volunteer Fire Department will receive \$52,250 to acquire a new vehicle. Funding to boost safety procedures and enhance operations will go to Holka VFD in for \$80,138; Midway VFD in Tishomingo County, totaling \$47,595; and the Smithville VFD will get \$12,208.

The awards come from the Assistance to Firefighters

Program approved by Congress to directly assist the nation's firefighters and the services they deliver.

The program provides funds to increase the effectiveness of firefighting operations, health and safety programs, purchase of new firefighting equipment, and improve emergency medical service response capabilities.

## 2006 Unofficial Election Results Run-Offs To Be Held In Circuit And Chancery Judge Races

In Tuesday's election, there was a heavier than usual turnout of voters throughout the county and across the nation, according to reports.

In Tishomingo County, there will be a run-off election between John Hatcher and Phil Hinton for the position of Chancery Court Judge.

There will also be a run-off between Jim Pounds and John White for Circuit Court Judge. The run-off election will be held on November 21, 2006.

In local school board races, there will be no run-off, making Tommy Dean the winner in District 3. The District 4 candidate was unopposed.

## Missing Iuka Man And Girlfriend Being Sought

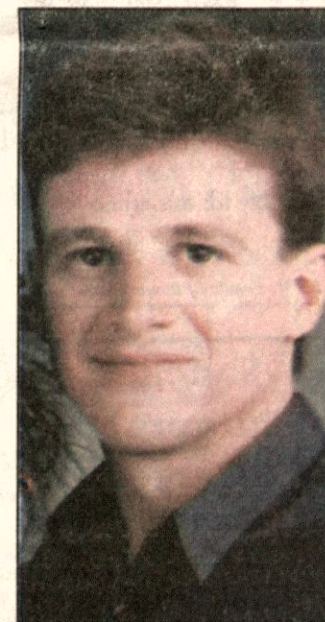
The family of Kevin Reece Monroe, along with local law enforcement, are seeking any information on the whereabouts of Kevin Reece Monroe, 42, who has been missing from his mother's home at 105 County Road 247, near Iuka.

According to the family, Kevin was last heard from on Monday, Oct. 30, 2006, and may be with his girlfriend, Lynette Barnes Garland. No one has seen or heard from either of them since that date.

Kevin is approximately 6 ft. tall, around 170 lbs. with brown hair and brown eyes.

The couple may be traveling in a 1996 purplish, black Mazda 4-door sedan with Tishomingo County license plate 644TSR.

The family knows of no reason that Kevin would have left so mysteriously and not have let someone know where he was going. Apparently, all the couples clothes and other belongings remained at the County Road 247 residence.



Nothing seemed to be missing and there did not appear to be any signs of foul play at the scene.

## Mississippi Author Paige Cothren Sets Latest Novel In Tishomingo County

Mississippi author Paige Cothren has written his latest novel "At the End of the Swinging Bridge," and has placed his characters in a setting which includes mainly Tishomingo County sites.

This novel is one in a series of five with settings in Tishomingo County by the author.

Cothren, who lives in Houston, Miss., said he is not from Tishomingo County, nor does he have relatives here. He just visited the area in past years and found the landscape of rocks, hills and trees—to be so beautiful and unique out of all the other counties of the state in which he had visited.

"Tishomingo County is truly unique and one of the best kept secrets—as far as beauty—in the entire state," Cothren. "This makes it a perfect setting for my novels."

Cothren was born in Natchez, MS in 1935, a member of the famed Poole family, 16 of whom have played football for Ole Miss. He graduated from Ole Miss, and Dallas Theological Seminary and at-

tended Mid-South Bible College in Memphis for two and a half years and Mid-America Baptist Theological Seminary for one year. He has taught in two Bible colleges, serving as Dean of Students at one of them.

Cothren also played professional football for Los An-

geles Rams and Philadelphia Eagles. Paige formed and led Directiv Counseling Center in Memphis for more than 20 years, where about 1,500 people were

seen each year. During those years, he spoke and taught an average of 300 times yearly.

## On Two-Year Anniversary Of Her Disappearance, Family Of Donna Cupido Asks "Was She Murdered?"



The following press release was submitted by the family of Donna Cupido:

Was Donna Cupido murdered?

The family and investigators familiar with this file are confident that she was. They believe the person responsible for this crime is a local area resident. For that reason it is imperative that the community step up to help with the final details in solving this case.

On October 21, 2004, Donna Cupido dropped her youngest child off at school and has not been heard from since. Her silver Kia Sportage was found a few days later at the Apostolic Church on Hwy. 72, just outside of Iuka.

It is critical for the community that this crime be

solved. For nearly two years a private investigator has worked this case and is nearing a conclusion. The investigators just need a little information from the community.

### Safety Glasses

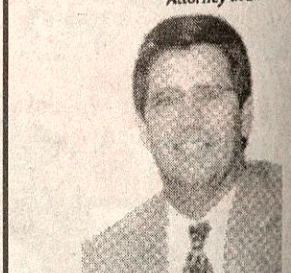

Criminal cases move slowly through crowded courts. A plea bargain, on the other hand, is both fast and provides the prosecution and defense with some control over the outcome without the need to go to trial. Generally, a plea bargain enables a defendant to receive a lighter sentence for a less-severe charge than might otherwise result from taking the case to trial and losing. It also saves time and money. There is, of course, no requirement that a defendant enter into plea negotiations or accept a plea agreement offer. Defendants sometimes decline plea bargains, hoping they will be acquitted at trial. In all legal matters, the counsel of an attorney helps defendants make decisions that are in their best interests.

### Congregations For Children

St. Mary's Catholic Church recently hosted Sister Donna Gunn, Director of Parish Social Ministry for the Catholic Diocese of Jackson. Sister Donna traveled from the Catholic Charities' central office to Iuka to initiate a program called Congregations for Children which challenges faith based communities to address why so many children in Mississippi consistently rank 50th in the nation in almost every indicator of child well being.

This faith based effort was originally initiated by the Catholic, Episcopal and United Methodist bishops, but it is now extending beyond those three denominations to any and all interested faith based groups.

Sister Donna combined the efforts of Congregations for Children with the efforts of the Coalition for Children's Welfare which has basically the same goals. This Coalition is composed of long time child advocates who see the need to begin a grass root effort to lift our children off the bottom. This Coalition hopes to engage the business community and others in seeking solutions to long term problems.

Sister Donna reviewed with the group some of the alarming statistics and showed an audio visual presentation.

According to St. Mary's Parishioner, Mary Vella, "We learned that though the statistics are as bleak as they were back in the early 80's, the difference between now

and then is that back then there was a massive grass root response. In 1982, folks from across the state began to partner together and were on the way to making significant, positive changes for our children.

For a variety of reasons, that progress stopped more than a decade ago. In many cases, the plight of our children has worsened," she said. "But instead of feeling paralyzed, I left energized. I am personally hopeful this state wide effort will point us in the right direction for Mississippi's children. As Sister Donna pointed out, if we don't care for our children now, who will care for us in the future?"

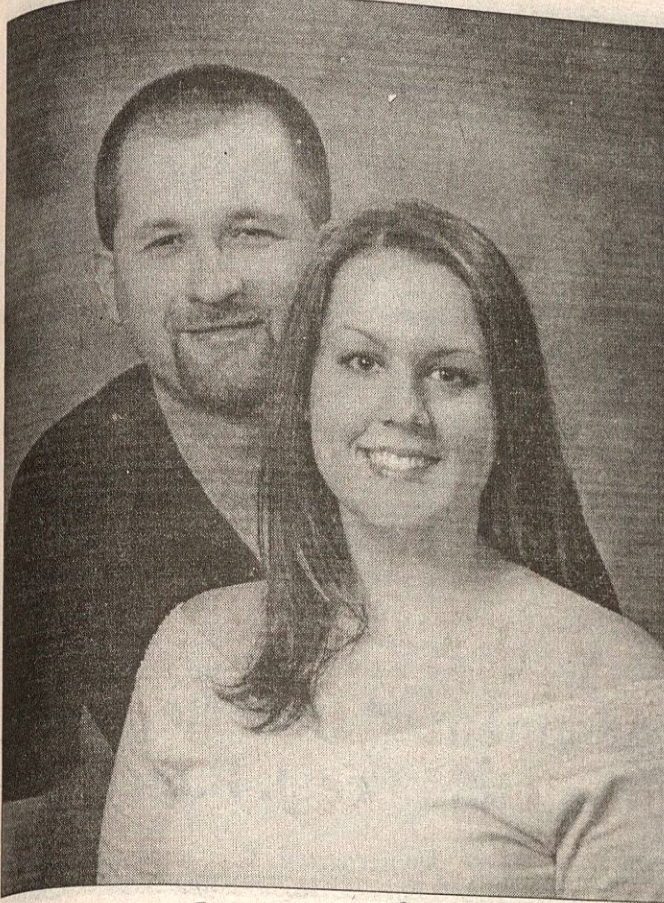

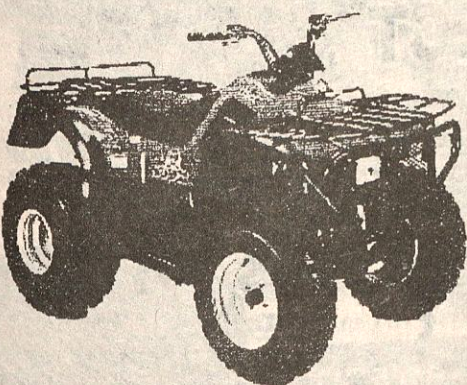

or more of the following characteristics and adversely affects the student's educational performance over a long period of time and to a marked degree:

- an inability to learn that cannot be explained by intellectual, sensory, or health factors;
- an inability to build or maintain satisfactory interpersonal relationships with peers and/or teachers;
- inappropriate types of behavior or feelings under normal circumstances;
- a general pervasive mood of unhappiness or depression; and/or
- a tendency to develop physical symptoms or fears associated with personal or school problems.

Children who are initially suspected of having an emotional disability must be seen by a clinical psychologist, a psychiatrist, or MDE licensed school psychologist who has reviewed all assessment data to obtain a statement which indicates whether the child has an emotional disability.

It is the goal of the Tishomingo County School District to increase the number of students identified as having an emotional disability. Tishomingo County Schools EmD Child Find

The Mississippi Department of Education has established a goal to increase the percentage of students identified as Emotionally Disabled (EmD) to .55% of the school population by 2007-08. This goal represents 75% of the 0.74% of the school population (the national average as indicated in the Twenty-third Annual Report to Congress). The .55% represents the state goal; actual identification percentages of individual districts will vary.

EmD is an educational

definition that:

- is included in the Individuals with Disabilities Education Act (IDEA);
- indicates as disability and the need for special education and related services;
- does not include temporary conditions or children at risk;
- does not include children who are only socially mal-adjusted, unless it is determined that they have emotional disturbance.

An Emotional Disability involves the presence of one

Code Ann. (1972). In addition, the Board of Supervisors is responsible for purchasing in accordance with the bid requirements of Section 31-7-13, Miss. Code Ann. (1972). The Board of Supervisors of Tishomingo County, Mississippi, has established centralized purchasing for all funds of the county and has established an inventory control system. The objective of the central purchasing system is to provide reasonable, but not absolute, assurance that purchases are executed in accordance with state law.

Because of inherent limitations in any central purchasing system and inventory control system, errors or irregularities may occur and not be detected. Also, projection of any evaluation of the system to future periods is subject to the risk that procedures may become inadequate because of changes in conditions or that the degree of compliance with the procedures may deteriorate.

In our opinion, Tishomingo County, Mississippi, complied in all material respects, with state laws governing central purchasing, inventory and bid requirements.
