Iuka Airport Gets New Fence . . .

Thanks to grant money from the Federal Aviation Administration (FAA), a new game-control fence is being erected around Iuka Airport.

The grant was applied for through the Tishomingo County Board of Supervisors on behalf of the Airport Board of Directors, and covers the \$90,000 cost of the fence.

The fence is 8 feet tall and encompasses the approximately 13,000 ft. or 2.5 mile perimeter of the airport. The prime contractor of the project is Buddy Ayers.

According to reports, the fence is designed to keep out wildlife which could be dangerous to planes using the airfield. Completion of the fence is planned for next week.

Rewards Offered For Arson Information

The Mississippi State Fire Marshal's Office is offering up to \$1,000 cash rewards for information on arsons in our area or anywhere in the state.

The rewards are for information leading to the arrest and arson conviction of any person responsible for the willful destruction by fire or explosion of any real or personal property within the state of Mississippi (Section 83-1-35 - MS Code).

Local Man Arrested For Possession Of Moonshine

An Iuka man was arrested recently by Tishomingo County Authorities for the possession of a large amount of illegal untaxed alcohol, beer and also a small amount of marijuana.

According to Tishomingo County Sheriff Glenn Whitlock, the suspect, Hoyt Michael Howard, age 49, of 88 County Road 346, Iuka, has been arrested and charged with possession of 60 gallons of untaxed whiskey, possession of beer and possession of marijuana, less than an ounce.

Sheriff Whitlock said that Howard had been buying what is known as "white lightning"

and was then aging it in an oak barrel. He was then taking the aged, untaxed alcohol and bottling it, possibly for resale.

Howard was also in possession of quite a large amount of beer and a small amount of marijuana, the Sheriff confirmed.

Tishomingo County Deputy Christina Shipman was alerted by some citizens' information that someone in the Goat Island area was selling untaxed "moonshine" liquor. She and other deputies went out to talk to the suspect—Howard—and while there, asked for consent

to search the premises. He agreed. The illegal substances were discovered by the deputies while searching.

At press time, Howard had been released from custody on a \$3,000 bond awaiting his day in court.

Assisting the Tishomingo County Sheriff's Department in the arrest were members of Mississippi's Alcoholic Beverage Control (ABC) Department.

One Arrested In Connection With Ramsey House Fire

An Iuka man has been arrested and charged with arson in connection with the burning of a residence in Iuka.

Archie "A.J." Hauck, 31, of Iuka was jailed after being charged with setting the February 27, 2007 fire that burned the residence of Corrie Ruth Ramsey-Parsons, located at 601 W. Third Street in Iuka.

According to Tishomingo County Fire Investigator Brian Grissom, a tip from an anonymous person led to the arrest of Hauck on Friday, March 16.

At press time, Hauck had been released on bond awaiting his day in court.

Grissom said that apparently Hauck had been in

to a dispute with the homeowner and had come to the house while she was at a neighbor's house. Hauck told Grissom that he knew Ramsey-Parsons was not at home when he set a cardboard box on fire in the living room and then left the house. The residence was completely destroyed by the fire, which took place around 9:35 p.m.

Investigator Grissom would like to thank Iuka Police Department for their assistance in this arrest.

Investigation Leads To Arrest Of Iuka Man On Arson Charges

An Iuka man, being held in the Tishomingo County Jail on drug charges, confessed to the Tishomingo County Arson Investigator that he set fire to a home located on Old Hwy. 72, in Bishop Bottom, on February 19, 2007.

According to Tishomingo County Fire Investigator Brian Grissom, the suspect, Shane Woodruff, 26, of Iuka, was questioned about the February 19th fire at the old Skinner home, (owned by Steve and Bonita Nicholson) located across from Esparanza Restaurant on Old Hwy. 72, near Burnsville. He confessed that he had set the fire by lighting the contents of the garbage can on fire with a cigarette lighter.

The suspect stated that he had no motive, but was under

the influence of drugs at the time, according to his confession statement.

Woodruff was a guest in the home at the time of the incident. All who were in the home escaped the residence without injury when the early morning fire started around 4 a.m. on Feb. 19.

Woodruff was charged with arson on February 22 while in jail after being arrested by Burnsville Police Department on an unrelated drug charge. At press time, he remained in custody.

Investigator Grissom said he would like to thank members of the Tishomingo County Sheriff's Department and the Mississippi State Fire Marshal's office for their help in this case.

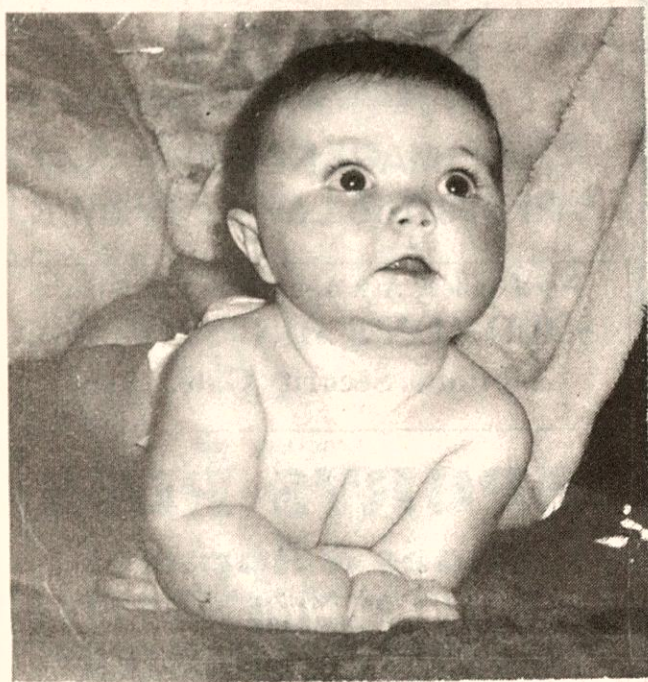
Isabella's Birthday Gift "Baby Brother"

The event will benefit Boys & Girls Club units in

Because there is no charge to be a member of Boys & Girls Clubs of Northeast Mississippi, the organization depends on funding generated at these events and allocations received each year from the United Way of Corinth and Alcorn County to carry out its programs.

Boys & Girls Clubs of Northeast Mississippi served over 3,000 youth ages 6-18, through both in-house and outreach programs in 2006. The Corinth unit has been active since 1954, and units opened in Iuka and Booneville in 2003.

The mission of the Boys & Girls Club is "to inspire and enable all young people, especially those who need us most, to reach their full potential as productive, caring, responsible citizens."

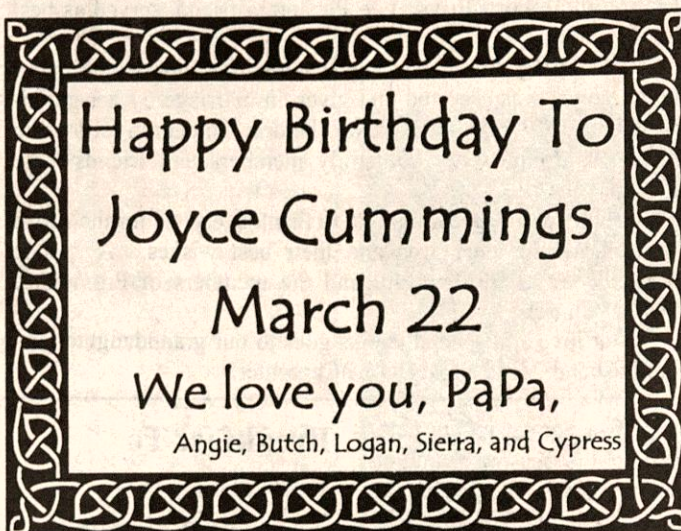

On March 6th, 2007, the Mayor and Board of Alderman voted to eliminate all commercial use of the Iuka Youth Center. Effective April 6th, 2007 this decision will prevent four groups of people from renting the Youth Center on a weekly basis. This cost to you, the taxpayers will be approximately \$500.00 to \$600.00 per month.

After numerous discussions with people inside the city limits, inside the county and outside the county there seems to be only five people that agree with the decision that was made. They are: Buddy James, Johnny Southward, Martha Biggs, Alderman Grisham and Mayor Jackie Bryant. If you have not read the plaque that is on the outside of the Youth Center, please do so. It states that the building was donated to the City of Iuka for the

good of all people. How can it be used for the good of all people? If a group of people, that consists of mostly elderly can not get together to listen to music, laugh, talk, dance and eat together as friends and family. In the two years that "Just Plain Country" has been playing at the Iuka Youth Center there have been no incidents where law enforcement have been involved, no complaints from the neighbors and the cleanliness of the facility was left in better condition when we left for the night than it was when we arrived.

There is a water bill, telephone bill and electric bill that still has to be paid regardless of whether the Youth Center is rented or not. The amount of money that was lost due to their decision would certainly go a long way on paying these bills.

comic strip to their walls when murdering the boss is not an acceptable option!

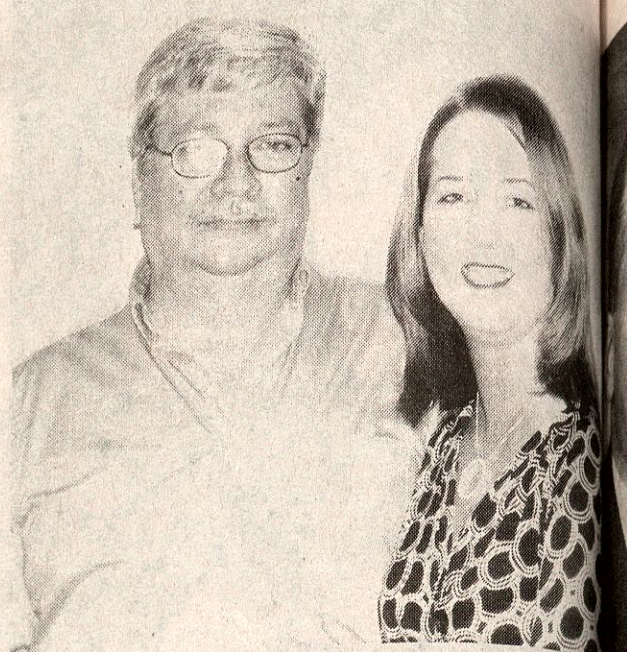
"Pirates of the Caribbean, Dead Mans Chest", DVD, starring Johnny Depp as Capt. Jack Sparrow.

The FAX machine at the library is working once more.



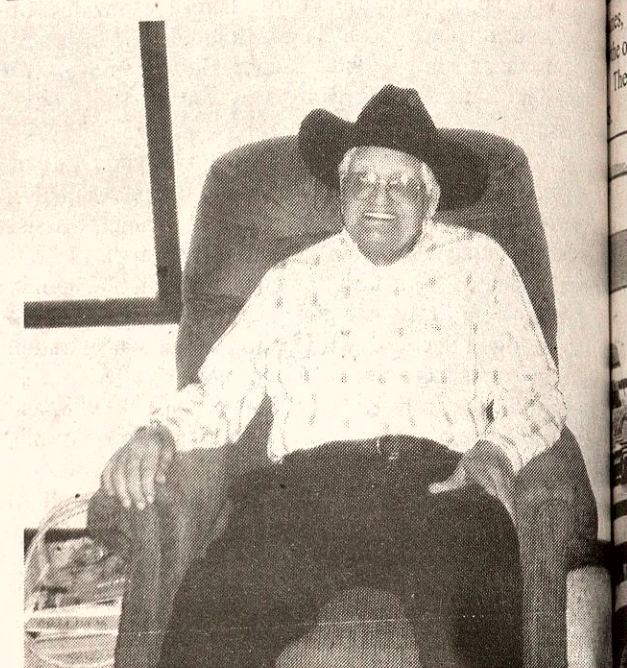
Miller-Holmes To Wed March 31st, 2007

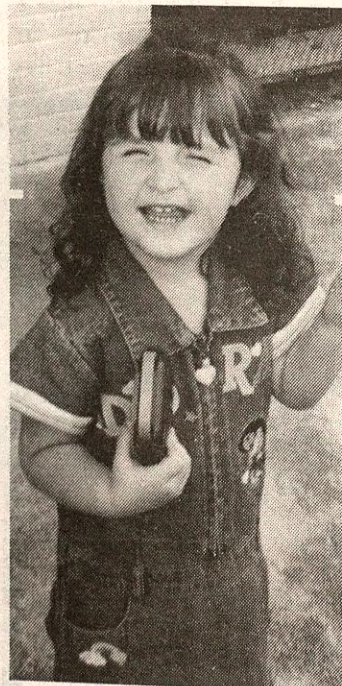

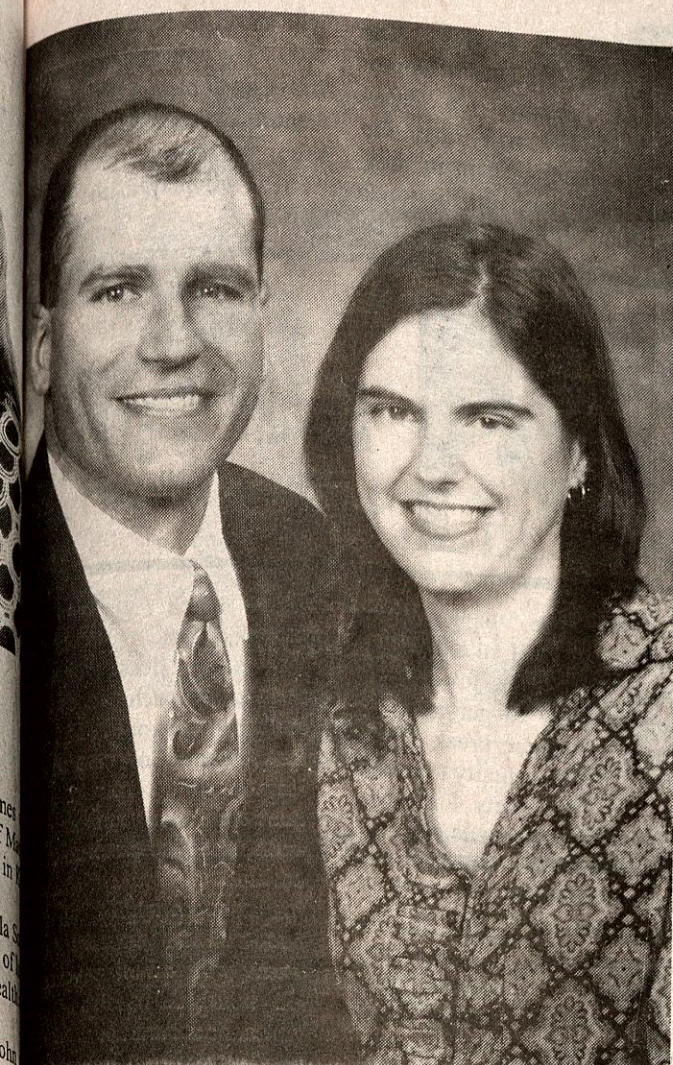
The annual Easter Egg Hunt and Hay Ride at the Thorne Farm in the Snowdown Community will be held Saturday, March 31st.

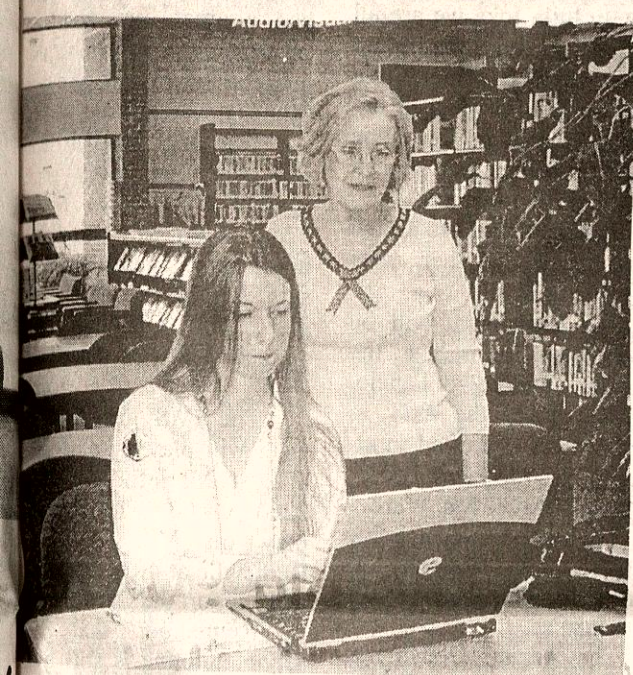

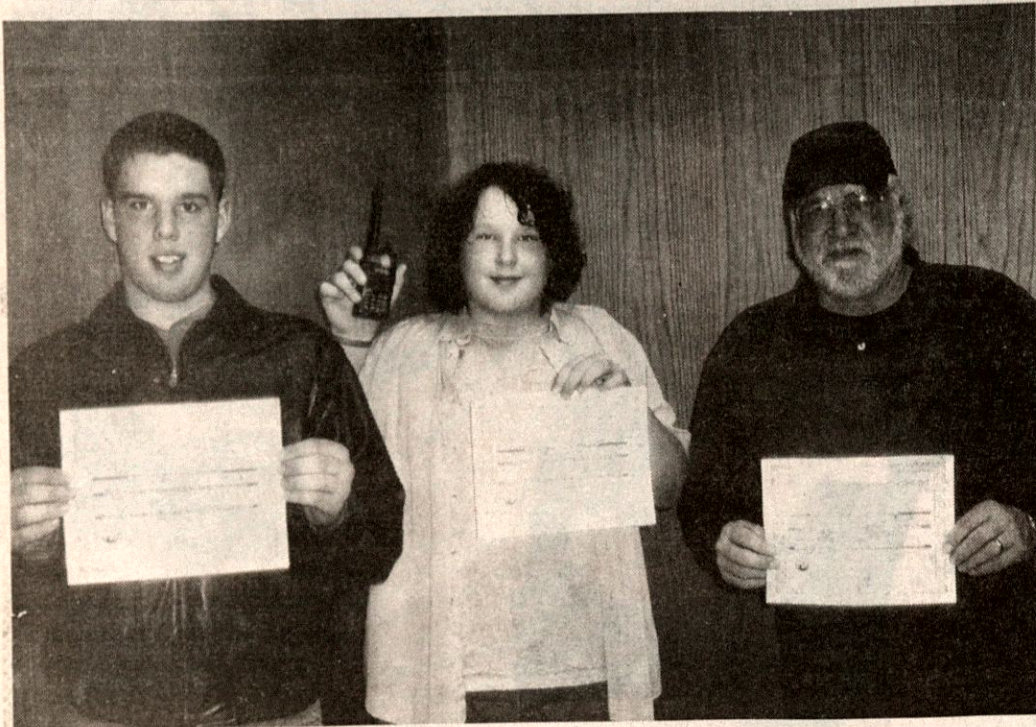

Tishomingo County Amateur Radio Club To Hold Test Sessions Every Three Months

The Tishomingo County Amateur Radio Club holds test sessions every three months on the second Thursday at 6:00 p.m. in the Tishomingo County Courthouse. The Club is affiliated with Homeland Security and the Amateur Radio Emergency Service.

Amateurs (HAMS) are trained to handle communication during emergencies (for example, Hurricanes Katrina and Rita). HAM radio operators can receive and relay messages when all other modes of communication fail.

The Federal Communication Commission regulates the HAM bands. FCC-approved tests are administered by voluntary examiners. There are three classes of Amateurs: Technician, General, and Extra. (Entry level is the Technician, with Extra being the highest. The higher levels have more privileges.)

Anyone passing a test is issued a Certificate of Successful Completion of Examination (CSCE). Test information is then sent to the FCC which will issue a call sign to the individual. (Morse Code is no longer a requirement.)

The Benefits Of Marriage

Although the concept of traditional marriage is under assault and the number of traditional two-parent families is declining in America, the scientific evidence of the benefits of marriage to all family members is increasing.

Social science data are definitive in stating that the intact family best ensures the welfare of children and society. As alternative family forms have become more prevalent since the 1960s, social science research and government surveys have indicated an accompanying rise in a number of serious social problems.

Government is interested in marriage because of its interest in the welfare of the next generation. Marriage has a special place in our legal traditions because it is the foundation of the intact family, and no other family structure provides a better level of social stability.

In other forms of family

and household structure, risk of negative outcomes, family disintegration is greater, increasing the risk dependence on state services. A free society requires a critical mass of individuals in stable households who are dependent on the state. The most stable and secure household, the available research shows, is the intact family. Therefore, everybody has interest in protecting the intact family. The Booneville School District Healthy Marriage Initiative collaborates with many local, regional, state agencies to strengthen marriage and families through education and media.

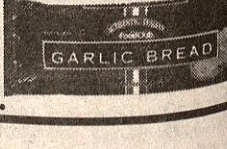
