## Storms Hit County Twice in One Week

Severe thunderstorms and possible tornadoes caused damage in several areas of the county last Thursday morning and Saturday night.

Mid-morning Thursday, May 8th, a possible tornado touched down near County Road 86 and 37, 12 miles south of Belmont. Fifth District Supervisor James McDowell on Monday. Some damage was done to a garage and fence on the property of Joe Ewing, he reported. But it went back up in the air over Belmont, said McDowell.

Later the storm damaged trees and lifted a house from its foundation on County Road 55 (Bethlehem Road). Ms. severe Cornelius took cover on the floor of the trailer behind her former home, and prayed for protection "if it is Your will."

As she huddled in safety in her manufactured home, large trees fell all around her and the house where she raised her children, about 50 feet from her trailer, was shifted off its foundations several feet and its roof suffered considerable damage. Her children are now helping her clear up all the damage, and this humble lady is giving

## New Boys Basketball Coach for Belmont

Move causes coaching changes for Iuka Middle School

Monday night, the Tishomingo County School Board approved Shannon Edmondson as new head basketball coach for the Belmont Cardinals.

"We are excited to have Coach Edmondson come on board, and to give him this head coaching opportunity," said Belmont High School principal Mark Hood. "His winning record proves itself and we know he will be an asset to both our basketball and academic program."

Hood said they are looking forward to Edmondson carrying on the momentum started under retiring coach Glen Elmore.

"In the past two years, I think he has turned this program around, and showed the community just what a Belmont boys basketball team can be," said Hood. Last year's team had a record of 16-7, and performed well, often in overtime, against great teams in district and north half play.

"We are looking forward to implementing Shannon's plans for team camps at Delta State and UNA, if funding can be found at this date," said Hood.

Edmondson is a Tishomingo High School and Mississippi State graduate who has been coaching boys basketball and football at Iuka Middle School for the last nine years. His overall record is 210 wins and 84

losses, and his teams have won seven 7th grade county championships and five 8th grade county championships.

Edmondson said he is thrilled and honored with the new challenge. He will coach the first full season in Belmont's new gym, which was opened last winter.

Edmondson is married to the former Heather Nelson, and they have a daughter at Belmont Elementary and a three-year old son.

**IMS Coaching Switches**

Edmondson's departure leaves the boys basketball and football coaching positions open, and principal Jimmy Smith said that Jeff Horn will become basketball coach, and that they are talking to football coach candidates and hope to have an announcement soon.

Jeff Horn came to IMS last year from Belmont, and he teaches English and

coaches softball.

He has coached basketball at Belmont and Pontotoc.

"If the kids will work and the parents get behind him, the players will learn a lot of basketball from him," said Smith.

"Coach Horn has high expectations from the students in his classroom, and I feel he will have the same expectations for excellence on the basketball court," said Smith.

"I'm excited about the opportunity," said Horn. "We have got great kids, and they have been working hard with Coach Edmondson, and we will keep working to be the best."

Horn grew up in the Midway area and graduated from Tishomingo High School. He is married to Kari, and has two daughters, one at Iuka Elementary and one at IMS.

## Finally, We Have a Congressman!

Childers wins 19 of 24 counties, 54 percent

Travis Childers won 54 percent of the vote in the special election for First District Interim Congressman Tuesday, after a runoff campaign that may go down in history as one of the nastiest for political advertising.

Turnout was high across the district, and in Tishomingo County there was a 16 percent increase in total turnout from the April 22nd special election. Republicans increased the turnout for their candidate—Greg Davis received 36 percent more votes than

in April. But Childers prevailed with 52 percent of county votes, to Davis' 47 percent.

This is the fourth time voters have voted for these two candidates, but neither ever received a majority until now.

Voters across the district will breathe a sigh of relief after being inundated with negative advertising by both political parties.

Childers is set to be sworn in at the convenience of the Speaker of the House, who returns to the country next week from the Middle East.

Nathan Oneal Owen has been selected as Belmont High School's salutatorian for 2008.

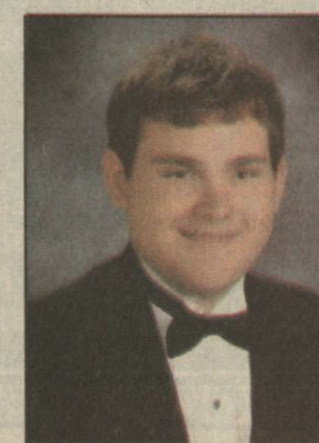

There was some damage to other locations in the fourth district, but it was mostly caused by high winds and fallen limbs and trees, said fourth district supervisor Steve Thorne.

### Second Wave Saturday Night

Saturday night around ten, thunderstorms, high winds, and possible tornadoes pounded the area again, and approximately 1,000 households over several parts of the county

were without power for some time. Tishomingo County Electric crews worked about 14 hours starting at 11 p.m. Saturday to restore power. Only a few residences with severe damage were still being repaired Monday, said Pe-Joe Arnold with TCEPA.

On Highway 25, north of Iuka, a high winds did considerable damage to at least four homes, and caused a tree to fall on a car.

No injuries were reported as a result of the storms, said Tishomingo Emergency Management Agency Official Bill Strickland.

Storms were forecast for the coming week, too.

Strickland urges citizens to take cover, respond to warnings, and act responsibly should threatening weather occur.

The City of Iuka wants to remind citizens of the city and surrounding areas to heed the tornado sirens if you hear them.

A three-minute wailing signal means that a tornado has been spotted in our area. A three minute steady signal means that a severe thunderstorm is approaching our area.

If you hear either of these signals, officials ask that you take cover, and tune into your local weather service to find out what is going on in your area.

If you should hear a (3) three-minute "Wailing Signal", this means that a **TORNADO** has been spotted in our area.

If you should hear a (3) three-minute "Steady Signal", this means that a **SEVERE THUNDER STORM** is approaching our area.

Again, this is an outside warning system if you should hear these signals, seek shelter and tune in to your local weather service for further information.

We will continue to test the system the first Saturday of each month at noon with a (1) one-minute steady signal.

The use of turquoise has been traced back to the beginnings of civilization. When the tomb of Egyptian Queen Zer (5500 BC) was excavated in 1900 Archaeologists discovered a *Turquoise* and gold bracelet on Her wrist. These are the world's oldest known examples of surviving jewelry.

The Bible in the book of Exodus contains an important reference to *Turquoise*. The Breastplate of the High Priest contained twelve stones set in four rows. *Turquoise* was the first stone on the second row.

## They Gave Their Lives

May 20th Friends of Library program honors WWII veterans

Former Iuka resident Duane Bullard will speak at the Iuka Public Library on Tuesday, May 20 at 12 noon. The Friends of the Iuka Library have chosen this special program from Mississippi Humanities Council's Speakers Bureau. The program honors our WWII Veterans.

Duane will share experiences that were told to him by 53 living veterans of WWII. He documented these experiences in 34 hours of interviews that he recorded and videoed. The veterans' experiences provide a detailed look at how young men and women and their families gave of their lives to preserve our country and the cherished freedoms we sometimes take for granted.

Working as a nationally certified community developer in Ripley, Mississippi, Duane Bullard has been a prominent figure in both historic preservation and economic development and for the past 5 years has been employed as the President and CEO of the Tippah County

Development Foundation. Duane has a list of accomplishments too numerous to detail, but it's worth noting here that it is as part of his work as a preservationist that he researched and recorded the stories of these 53 WWII veterans.

As the son of Bonnie Bullard and the late Herman Bullard of Iuka, Duane developed his interest and pride in the lives of war veterans because of an amazing scrapbook his mother, an artist, and father, a wounded veteran, produced to share their experiences as a young married couple during WWII. It tells how Herman went off to war and struggled through fierce battles in Italy and through the rehabilitation from wounds he received. It displays how war touches the lives of families and friends. Henry Wadsworth Longfellow once wrote, "If we could read the secret history of our enemies, we should find in each man's life, sorrow and suffering, enough to disarm all

hostility." It is important to record these stories of patriotism by our countrymen for future generations, and perhaps of even greater importance to share the sorrow and suffering of war with our enemies. These are endeavors that change the world.

Join your Friends at the Iuka Public Library at noon on Tuesday to see and hear Duane Bullard's presentation about people who gave their lives for our freedom.

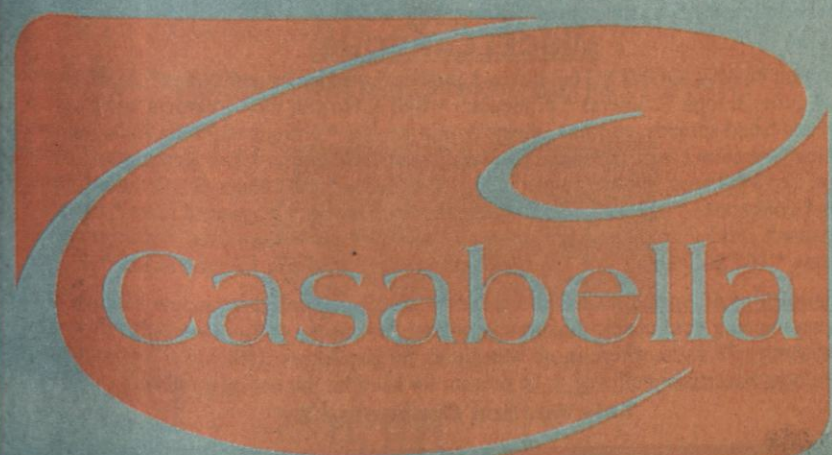

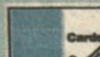

## Desire To Help People Runs In The Family

For Anna Louise Southward, RN, nursing is a family tradition. Southward started as a high school candy stripper at the Luka Hospital (now North Mississippi Medical Center-Luka) more than 30 years ago. For her daughter, Cherri Cox, RN, the desire to be like her mother and great-grandmother led her to want to become a nurse, also. "I never really had an idea to be anything else," Cox, a nurse at the NMMC Bariatric Clinic in Tupelo, said. "My mother is an awesome nurse and has really inspired me to follow in her footsteps, but never pushed me too hard to be a nurse. I'm an only child, and I've always been very close to my mother. She is an amazing nurse and I wanted to do anything to be like her. She encouraged me to do whatever would make me happy, and that happens to be nursing."

Cox grew up in Tishomingo, and her mother worked the night shift as a nursing aide so she could take Cox to and from school

each day. Eventually, Southward decided to go back to nursing school at Itawamba Community College to become an RN. The day after Cox graduated from Tishomingo High School, Southward graduated from ICC. Southward's inspiration came from her grandmother, Henrietta Martin, who was a nurse for the only physician in the area back in the 1930's and '40's. "The doctor she worked for worked out of his home," said Southward, who is now a night shift supervisor at NMMC-Luka. "They'd deliver babies and even perform minor surgeries at his house. Some days she would take me to work with her, and I'd get to watch them work. I knew from a very young age that I wanted to help patients like my grandmother did." Both mother and daughter say that best part of being a nurse is helping their patients become healthier.

"I love the fact that I am able to help people live longer and improve their

health," Cox said. "It's so rewarding when a patient comes in smiling because they've been able to go off of their blood pressure medicine after having a bariatric procedure, or they realize they're not going to have to have that knee replacement after all."

Cox lives in Aberdeen with her husband, Darrius, and two boys, Latherio, 13, and Myles, 3. Southward says Myles might be the next nurse in the family.

"Several years ago my brother had a stroke, which left him needing a feeding tube and other help, so he moved in with me so I could help care for him," Southward said. "Myles loves to watch us take care of my brother and watch us do some of the medical things that most 3-year-olds would be scared of. Maybe he'll follow the family tradition!"

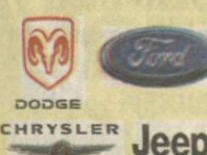
