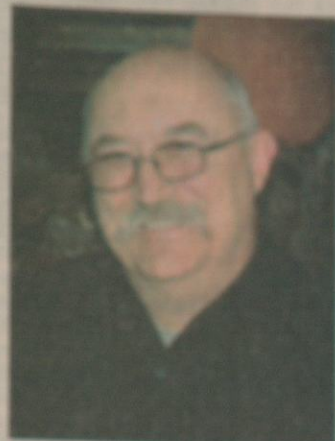

Belmont Man Killed Motorcycle-Car Collision Last Week

Belmont man was killed when a car struck him Saturday night as he headed on Highway 25.

Ricky Holt, 53, died as a result of a collision with a Nissan that apparently pulled in front of him from County 9, said Tishomingo County Sheriff Mack Wilmon. He was driving his 1995 Honda Shadow motorcycle south on Highway 25, heading home from a meeting.

The car was driven by Kenneth Holt, 20, and neither the driver nor passenger was injured, Wilmon said. The crash occurred at the intersection of Highway 25 and Highway 9.

Ricky Holt, 53, died Thursday night at the Belmont Hospital. He was born July 18th, 1956 in Red Bluff, Alabama to Thelton and Timbs Holt. He was a member of the Muehler Copper Church and a member of the Belmont Baptist Church.

Funeral services were on Sunday at Belmont Baptist Church with his dear friend Bro. Crane officiating. Burial was at Belmont Memory Gardens.

Ricky is survived by his wife, Linda McAnally Holt; a son, Andy Holt and his wife Amanda; a daughter, Carrie Holt; and her fiancé Marcus Robinson; his father, Thelton Holt; one brother, Doug Holt; a sister-in-law Sarah Pogue and husband Les, of Columbus, Mississippi; a brother-in-law, Mac McAnally of Nashville, and special children Johnny, Jr., Noah and Heather.

He was preceded in death by his mother.

Tishomingo County students stood out among other schools recently at the Northeast Mississippi Math & Science Competition. The team placed second overall, and two students placed in the top ten individually.

The competition included about 20 high schools, all those in the district served by Northeast Mississippi Community College,

which sponsored the annual competition, explained science teacher Malcolm Brown.

The students completed a multiple choice math test that included algebra,

trigonometry, pre-calculus, and geometry. Additionally they took a science test that included biology, chemistry and physics.

The top ten individual scores from each team are considered, and the TC team placed second.

In individual scores, senior Alex Hampton scored second overall in the competition, and junior Hunter Lambert scored in the top ten.

Absentee Voting Now for June 1st Republican Primary

Donna Henry Dill, Circuit Clerk, announces that absentee ballots are now available for the June 1st Republican Primary for United States House of Representatives, 1st Congressional District. You may come to the Circuit Clerk's Office to vote by absentee Monday-Friday, 8 a.m. to 5 p.m. The clerk's office will also be open on Saturday, May 22 and 29th, 8 a.m. to 12 noon, for absentee voting.

We encourage those who need to vote by mail to call our office as soon as possible so they will have ample time to go through the absentee process. When an absentee ballot is requested, an application for an absentee ballot will first be mailed to the voter. This application shall be completed by the absentee voter and mailed back to the circuit clerk's office. When the application is received, the ballot will be mailed to the voter. No absentee ballots may be hand delivered to anyone.

Any registered voter is eligible to vote by absentee in the clerk's office, but only five groups are allowed to vote absentee by mail. These five groups are:

1. A registered voter who is 65 years of age or older;
2. A registered voter who is temporarily residing outside the county;
3. A registered voter who is temporarily or permanently physically disabled, and/or
4. A registered voter who is the parent, spouse or dependent of a temporarily or permanently physically disabled person who is hospitalized outside the county or more than 50 miles away

from his/her residence and will be with that person on Election Day.

5. All voters who are members of the Armed Services, or other voters that fall within the Armed Services Absentee Voting Law.

All absentee applications and ballot envelopes must be submitted except for a registered voter who is physically disabled, either permanently or temporarily. The disabled voter's application and ballot envelope must be witnessed and signed by a person 18 years of age or older. This witness does not have to be a registered voter.

No absentee ballots may be hand delivered.

May 29th will be the last day to vote an absentee ballot in the clerk's office for the June 1st Republican Primary.

All mailed absentee ballots must be received by 5 p.m. on Friday, May 28th, in order to be eligible to be counted for the June 1st Republican Primary.

Club members ready to serve were Sue Kerby, Zenobia Oaks, Jo Russell, and Terrie Whitehurst.

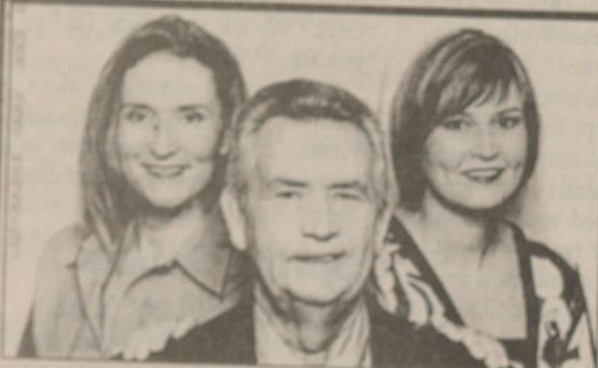

Insight Into Eyesight

Dr. Phillip Gray Dry Eyes

While most of us think of tears as symbols of sadness, they also play an important role in keeping our eyes healthy. Tears are a natural mixture of salt, water, and microbial enzymes that kill bacteria and a thick layer of lubricating fluid that slows evaporation.

Dry eyes occur when the ocular surface of the eye lacks an adequate protective tear layer. This leaves the eye exposed to common irritating elements, such as dust, smoke and pollen.

Symptoms of dry eyes include burning, redness and sensations of having a foreign object in the eye. Doctors usually recommend the use of tear replacement eyedrops which contain many of the major components of natural tears.

Decreased tear production and abnormal tear composition are associated causes of dry eye. Aging, menopause, arthritis and infection are probable causes for either decreased tear production or abnormal tear composition.

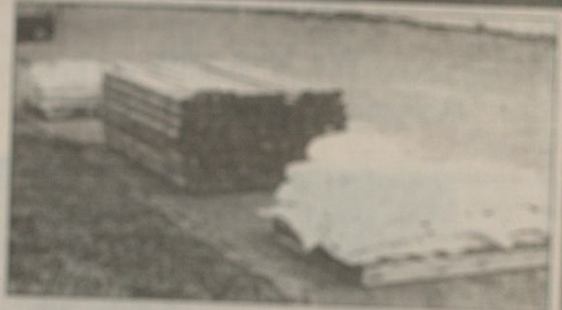

Northeast Women's Basketball Schedules Summer Camps

BOONEVILLE, Miss. — Northeast Mississippi Community College women's basketball coach Ricky Ford has scheduled a trio of camps for the 2010 summer.

Ford, who enters his 30th season at the helm of the Lady Tigers, will start his camps with a junior high girls camp on June 7-9 and follow that three-day camp with another three-day event one month later when the veteran Lady Tiger mentor holds individual and team camps on July 7-9.

Northeast's junior high camp is open to grades 5-8 while the senior high individual and team camps are open to grades 9-12.

According to Ford, the purpose of the camps is to teach skills in fundamentally sound basketball and to improve the abilities in the finer points of the game.

During the camp, athletes will be striving to not only improve their game but also develop character that will help them later in life in such areas as leadership, sportsmanship and citizenship.

Campers need to bring basketball shoes, athletic socks, T-shirts and shorts for camp as well as swim wear

for free time at the college's Gaye Roden Carr Aquatic Center.

If a camper is staying overnight at the camp, campers also need to bring one set of single sheets, a pillow and case, laundry bag, towels and toiletries.

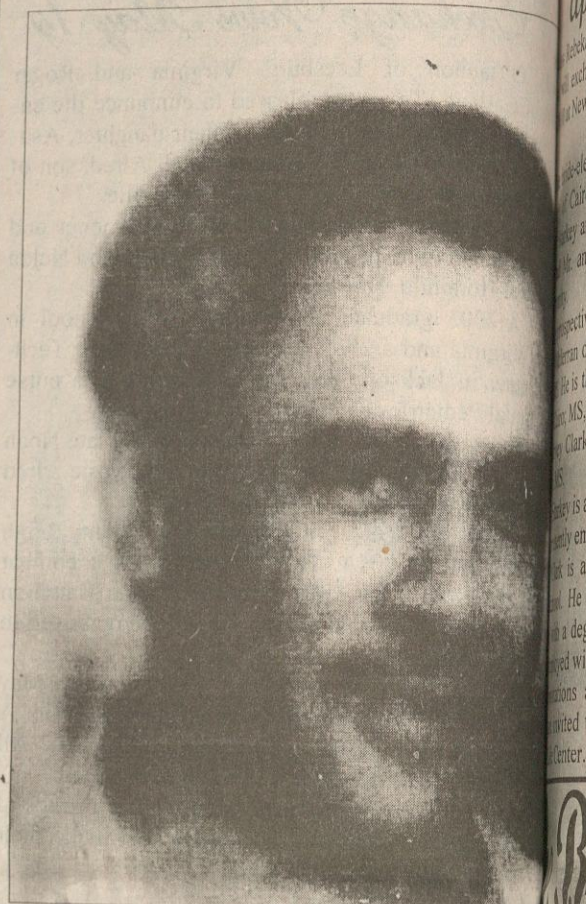

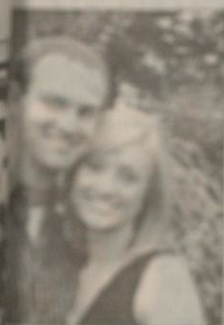

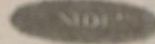
