## Airport Needs More Hangars, Policy Revamp

 Representatives of Segars Airport near Iuka met with county board of supervisors regarding hangar rental policies issues at the air field. The Tishomingo County Board of Supervisors met Monday for its regular first Monday meeting and spoke with Dr. Kelly Segars and John Horner, Airport Authority board members. The airport, which is owned by the First, Second and Third Districts, has several hangars for airplane storage at the airport, and a waiting list of 18 airplanes for the limited space.

An ongoing problem at the airport is that some of the hangars are being rented... but not for airplanes. "Some people have rented hangars and are looking to use them but haven't found one yet," said Dr. Kelly Segars. Also, some people are using them for storage units, for items other than airplanes - taking up space that airplane owners would like to use.

The supervisors have discussed increasing the fees for the hangars, since they are about the same as some other comparable facilities. Additionally, the Iuka Airport provides electricity. Segars said that interest rates are now as favorable as they are going to be for a while, and that the county should consider building at least 12 more hangars.

Board President James McWell appointed Danny Ryan, Brandon Grissom, and Nicky Rae to meet to further discuss the airport hangar issue and suggest action to the board when they meet for their next work session, this Friday, April 9th.

Segars also urged the board to continue to discuss extending the airport runway to one mile, so that corporate jets can use it. "Iuka has economic development advantages," explained Segars, "and it will become more important as we anticipate economic development projects. Congressional representatives have promised to look for funding, but there's been no progress there," said Segars.

## Dulcimer Day April 7th

Like the blooming dogwoods, one of the surest signs of spring in Tishomingo is the "Dulcimer Day" at Tishomingo State Park, and it is scheduled for this weekend. Tishomingo State Park will be hosting the 32nd Annual Long Memorial Dulcimer Festival on Saturday, April 17, from 10 a.m. to 4 p.m. at the Loochapola Lodge. The program will begin at 10 a.m. and last throughout the afternoon.

The festival is sponsored by the Ala-Sippi Dulcimer Association. Musicians from the local area and surrounding states will be creating those sweet dulcet tones. Musicians will be available to answer questions and demonstrate the dulcimer.

## Battleground Plaza Fire Ruled Arson - Reward Offered

 The March 12th fire at Battleground Plaza has been ruled "incendiary" by the Mississippi State Fire Marshal, and there is a reward being offered for information that may lead to an arrest and conviction of those responsible.

On March 12th, Iuka firefighters responded to an alarm in the unit occupied by Money Matters, where smoke was pouring through the ventilation system. No fire was found there, so firefighters ended up forcing entry into an adjoining empty unit. There, they found and extinguished a fire in a back room near some shelving, said Iuka Fire Chief Brian Grissom.

The cause of the fire was immediately under investigation, and Tuesday morning the State Fire Marshal issued a notice of a reward up to \$1,000 for information leading to the arrest and arson conviction of those responsible. # Shiloh Living History Events Mark 148th Anniversary

The roaring noise of cannon and rifles echoing through the woods, the sun glistening off of bayonets, the view of cavalrymen raising sabers, and the sight of gray uniforms marching across the battlefield will be just some of the Civil War interpretive experiences available for public enjoyment on April 10th, and April 11th, 2010, at Shiloh National Military Park.

"The Civil War will be revisited as volunteer reenactors present interpretive programs that demonstrate 1860's military tactics and historic small arms and artillery weapons firings in observance of the 148th anniversary of the Battle of Shiloh," Park Superintendent Woody Harrell announced today.

"The Battle of Shiloh was the first major land battle of the western theater of the Civil War, and landmarks such as the Hornet's Nest, Peach Orchard, Bloody Pond, and Shiloh Church, would be remembered by those who fought at Shiloh Hill and by later generations. Not only did three out of every four Confederate or Union soldiers experience combat for the first time, or "see the elephant" to use a common phrase of the period, but the divided citizens of the nation sadly discovered how destructive the war was going to be for both sides. Confederate and Union units fought gallantly and suffered severe casualties, such as the Bloody Sixth Mississippi Infantry Regiment who entered the battle with 425 men and after their first charges, left 300 of their comrades dead, or wounded on the field of battle. At the end of this

bloody and ferocious battle, 23,746 Americans lay upon the once quiet and peaceful Shiloh battlefield. For the first time, death, carnage, and destruction impacted tens of thousands of homes, and families of the North and the South alike," stated Harrell.

A full schedule of demonstrations and special activities are being presented throughout the day on Saturday and Sunday. From 8 a.m. to 5 p.m. on Saturday and 8 a.m. to 3 p.m. on Sunday, a Confederate encampment, located between tour stop #3 and tour stop #4, will be open to the public. Park visitors are invited to visit the encampment and learn more about the common soldier's experience during the War Between the States from the reenactors who portray actual units. "We expect approximately 150 participants representing infantry, artillery, and cavalry service branches for this year's program," stated Harrell.

Instead of depicting two opposing lines of fire, choreographed tactical scenarios will demonstrate authentic field maneuvers interpreting how each combat branch of army service would have operated separately and combined.

"These living history military demonstrations will assist park visitors to better understand Civil War era troop deployment, maneuver, and battle tactics as experienced by 109,784 soldiers engaged in the two-day Shiloh battle," commented Harrell, lawn adjacent to the Shiloh battlefield Visitor Center.

During the course of the weekend, the 52nd Reg-

imental Band will be performing Civil War music in conjunction with demonstration activities. This soldier's band will perform a variety of music which would have been popular during the war period. Also available to the public will be medical programs which will discuss diseases during the Civil War, and the treatment of battlefield wounds.

Superintendent Harrell invites the public to take part in any or all of the special anniversary activities scheduled on the park. Daily admission to Shiloh National Military Park is \$3 per person or \$5 per family. The entrance fee permits daily admission to the park for seven days from date of purchase, and is collected at the Shiloh visitor center. Included with a paid admis-

sion to the park, visitors receive a printed entrance permit which further provides free admission to the Tennessee River Museum located in Savannah, Tennessee.

Both the Shiloh visitor center and bookstore will be open Saturday from 8 a.m. to 6 p.m., and again on Sunday from 8 a.m. to 5 p.m. Located within the visitor center are exhibits of period artifacts from the momentous battle and an orientation video, which is shown every forty minutes. The bookstore carries a wide selection of literature on the Civil War, historical art prints, maps, and videos.
