

New TAP Alliance Starts Business Promoting Regional Development

Monday, Tishomingo County finalized its participation in the new TAP Alliance, when the board authorized the county's contribution of \$5,000 into a fund for the new industrial development entity.

The TAP Alliance, including Tishomingo, Alcorn and Prentiss counties, is modeled after the PUL Alliance, a cooperative agreement between Pontotoc, Union and Lee counties, which managed to successfully lure Toyota to build a plant in Blue Springs. The goal of the TAP Alliance is to assist in the future development of a regional industrial park and other projects that will provide economic benefits, including but not limited to industry, distribution, commerce, tourism, health care and other purposes in which the public purpose and interest of the people of the State of Mississippi are served.

The new board of the TAP alliance was recently elected, with Tishomingo County Supervisor Brandon Grissom in the president's position. The vice president is mayor Joe Eaton of Booneville, and David "Bubba"


Pounds, Prentiss County Chancery Clerk is secretary.

Each county board, and each county seat city in the TAP Alliance area are represented on the TAP board, Tishomingo including County Fifth District Supervisor James McDowell, and Iuka Mayor Jackie Bryant.

Each county and city said they would contribute \$5,000, which gives the Alliance \$30,000 to start marketing the area, and to help pay for the development of a regional economic strategic plan. This plan would identify strengths of the area, and possibilities for what would be the best industry for the area. One of the

main sites they are on is the 900-acre N Mississippi Water dustrial Park in Bu owned by the Yellon Port Authority, Said som Monday.

Warning Here's some news for

people who wear contact lenses. The combination of contact lenses and waterproof makeup can damage both your lenses and your eyes.

The problem is that makeup, waterproof particularly mascara, tends to flake off and get caught between the eye and the contact lenses. Unlike water-soluble makeup, waterproof mascara does not break down and wash away in tear fluid (the eye's natural cleanser). Trapped particles can cause extreme pain and scratch the eye.

Mineral-oil-based makeup removers also are a problem. They can leave a residue in or around the eye. Traces of the oil can remain in the eye and cloud the contact lenses when reinserted.

If you wear contacts, to water-soluble and oil-free makeup Insert lenses before applying cosmetics to cut the risk of carrying makeup into your eyes and causing irritation or - in the case of soft lenses - an unnecessary refit.
