


# **Pilot Club Installs New Officers**





# Retinopathy

Diabetic retinopathy is a disorder of the blood vessels in the retina stemming from diabetes. Visual impairment can result from swelling of the retina, from leaky blood vessels, bleeding from abnormal retinal blood vessels into the vitreous (the clear, jelly-like substance which fills the center of the eye), formation of scar tissue and detachment of the retina. The incidence and severity of retinopathy are generally proportionate to the duration of diabetes.

Photo coagulation, the use of strong, finely focused laser beams to seal off the abnormal vessels or destroy diseased retinal tissue can be effective in preventing or forestalling blindness in certain stages of the disease. Vitrectomy, surgical removal of the vitreous, may restore sight in some eyes already blind from diabetic retinopathy.

If you have been diagnosed as having diabetes, it is extremely important that you have regular optometric checkups in order to catch such a disease in its early stages.
