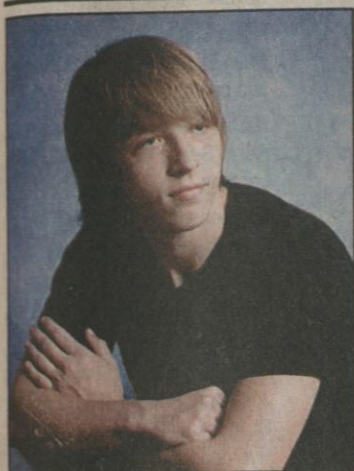

Young Iuka Man Killed in One-Vehicle Accident

The Iuka community is mourning the death of a young man killed early Sunday morning in a one-vehicle wreck on Highway 364.

Cameron L. Bernal, 19, of Iuka, was traveling west bound on MS Hwy 364 a little before 5 a.m. October 2nd, when he apparently lost control of the 1998 Chevrolet S-10 he was driving, according to the Mississippi Highway Patrol.

The vehicle left the road and overturned several times, said the highway patrol report. Bernal was ejected from the vehicle.

In addition to being a beloved son and brother, Cameron was a well-loved member of the Iuka soccer community. At Monday night's Iuka Youth Soccer games, league coaches and former teammates were devastated. In addition to being a star player on the Tishomingo County High School soccer team, he excelled during his years in the Iuka Soccer league, inspiring many with his skill, grace and athletic ability. He later worked as a referee for the league.

The cause of the accident remains under investigation, said Trooper Ronny Hall, of the Mississippi Highway Patrol.

Sheriff Department Leads Monday Round Up of More than Three Dozen

Monday was a busy day for area law enforcement personnel as they cooperatively brought in dozens of subjects with Tishomingo County Grand Jury indictments. Notable among the many drug cases was that of a Burnsville alderman, and that of a suspect in dozens of local burglaries who had eluded authorities for many months.

Officers with the Tishomingo County Sheriff's Department led teams that included deputies from all the surrounding counties, as well as Iuka Police and Red Bay, Alabama Police.

The U. S. Marshals Gulf Coast Regional Fugitive Task Force assisted in the arrest of Dennis Christian Martin, for whom Iuka Police have been searching for about a year in connection with several Iuka area burglaries.

Martin's arrest hopefully brings resolution to many burglary cases in the county including several in the Snowdown area and lake properties in Alabama at the end of Snowdown Road. Martin is also

a suspect in a series of robberies of businesses in Iuka, and the Iuka Police requested the assistance of the Marshals months ago to search for Martin, when he seemed to have left the area.

But Monday, as officers were serving a warrant on Clayton Clingan, on Snowdown Road, they observed a man fleeing the yard upon their approach. According to Tishomingo County Sheriff Department Drug Investigator Jeff Palmer, who coordinated Monday's operation, the fleeing man was identified as Martin, and officers chased him into the woods. Throughout the day, sightings were reported by officers in the woods, and authorities were on the lookout for vehicles he may have left the area in, but he remained on the loose, causing much concern for residents in the community.

However, he was not a federal fugitive, since the Marshals' warrant for him was at the Iuka Police's request. Martin was also not an escaped convict, as some rumors suggested.

Board Boots Rescue Squad from County Building

The board of Supervisors is pulling the plug on the Tishomingo County Rescue Squad, because it has been unable to fulfill insurance and personnel certification requirements.

The Tishomingo County Rescue Squad was chartered by the state more than ten years ago, but, despite the name, is not connected with the County, explained First District Supervisor Brandon Grissom. Grissom has been dealing with the rescue squad about some of their recent activities, and their inability to acquire the required \$2 million liability insurance that would allow them to be called out on emergency calls.

Currently, the rescue squad occupies a county-owned building between the jail and the county courthouse. They pay no rent, but the county, and its taxpayers, pick up the bill for utilities - which can be as much as \$800-\$900 a month in colder weather, according to the Board of Supervisors.

They can not respond to wrecks, or 911 or other emergency calls, because they do not have emergency medical responder (EMR) or other necessary certifications, and they lack essential training, explained Grissom.

Grissom reported Monday that he had informed the squad members last week that he would be making a motion to the Board to evict the organization from the county-owned building, and he did, but it failed to get a second.

Alternately, Second District Supervisor Nicky McRae made a motion to give the organization 30 days to get the required insurance and certifications, and then turn them out if they did not do so.

The rescue squad holds fundraisers and dances occasionally in the building, which they have said are to raise funds for the needs of the department. Rescue squad members have come to the county board several times in recent years, asking the county to step in to establish and maintain order, but the Board said the county has no business getting involved in the private affairs of a non-profit organization.

Then Grissom said that they have known for the past four years that they need the insurance, and they have failed to get it.

In other Board business:

Donathan Enlow addressed the board requesting them to make phone calls of support regarding the renewal hearing scheduled for the next day of the gaming license for Tishomingo Bingo.

Enlow, who owns the building on Highway 25 South, reported that it would be a shame to have the bingo operation closed down and its 20 employees put out of a job as a result of the hearing.

Enlow said the gaming commission said that the profit numbers were not what it expected, and Enlow indicated that with, now, three bingo halls in the Iuka area, everyone's profit numbers are down.

Enlow said that nearly all the people who come to the bingo hall come from Alabama or Tennessee, but it's nearly all local employees who work there.

Tishomingo Bingo has operated with no problems for 15 years, and they donate to many causes in the area, in addition to it's charity, Bell's Educare in

Martin apparently stole a white 2002 Hyundai Santa Fe from the Datsis home (next door to a highway patrolman's home), and the car was sighted at a residence familiar to Martin near Kossuth in Alcorn County early in the day Tuesday.

U.S. Marshals surrounded the location, and apprehended Martin around noon. He was processed in Alcorn County, and later brought in to the Tishomingo County Jail.

While the search for Martin was carried out Monday, other authorities searched the barn where Martin had apparently been residing, and found many, many items that had been stolen from area residences. The stolen items were transferred to the Iuka Police Department, and burglary

victims were contacted to identify belongings. The items varied greatly, and it looked like a poorly-organized yard sale as victims sifted through the stuff to find their GPS units, backpacks, fishing equipment, coolers, piggy banks, jewelry, and countless other things that Martin apparently stashed away after the burglaries.

Martin stole the car Monday night using keys left in the vehicle, and in many of the burglaries, he gained access by using car keys or garage door openers left in vehicles. Authorities encourage more security vigilance by all residents, just as a preventive measure.

Burnsville Alderman Arrested

Burnsville Alderman James Randy Walker,

54, was charged with attempted sale of controlled substance, child endangerment, and possession of a controlled substance with intent to distribute.

According to Investigator Palmer, Walker had been under investigation for some time for selling prescription medicine. Undercover investigators gave Walker's sister, Sara Dotson, money to purchase hydrocodone pain pills, and observed her taking the cash to Walker, who then gave her the controlled substances. Authorities arrested both of them at the scene of the illegal activity, and Dotson had her young grandchild with her at the time.

Walker was one of two aldermen elected in 2009 to fill two vacancies in the Burnsville Board of Aldermen. Ironically, one of the

vacancies had been caused by the conviction of the previous alderman for prescription fraud.

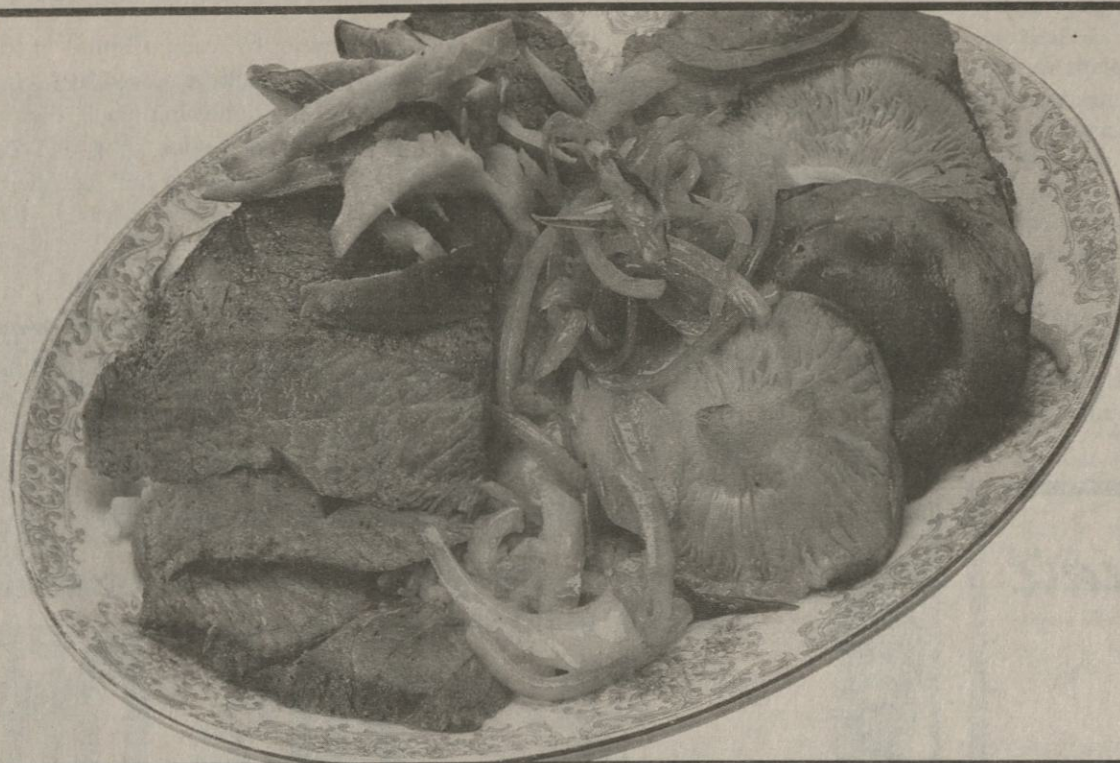

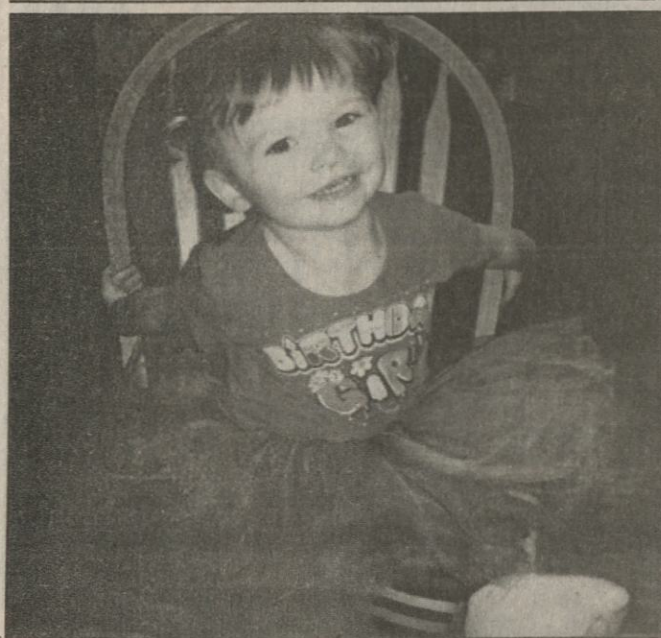

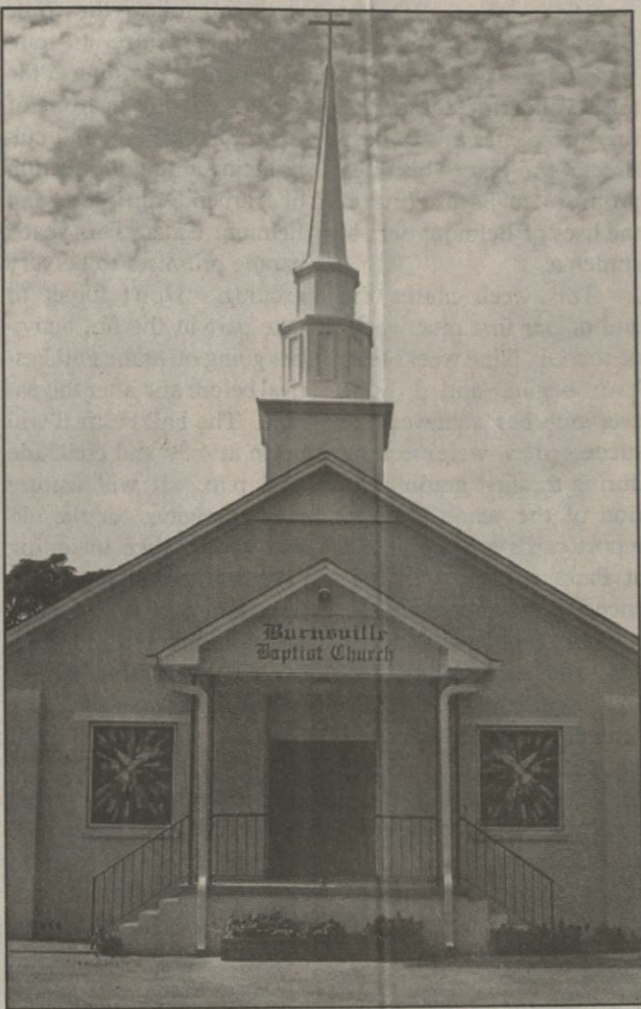

The Burnsville church was organized in 1836 under the name of the Yellow Creek Baptist Church (Yellow Creek was just east of Burnsville in an area now covered by the Tennessee-Tombigbee Waterway). The church was first located one-half mile north of Burnsville near where Antioch Freewill Baptist Church now stands. It began with 9 charter members, William S. Smith, Richard Nance, William B. Fielder, Margaret Smith, Elizabeth Brunson, Mary McCoy, Lucinda Mosier, Charlotte Nance and Lucinda Moody. The Presbtery consisted of Elders J.M. Griffin and J. Vanhoos. In 1958 this area became known as the town of Burnsville. The church group built a new church building that year and apparently that is when the name was changed to Burnsville First Baptist Church. The Tishomingo County Baptist Association was organized in 1860 in the Burnsville church. Later that year the church property was destroyed in the Civil War.

In 1861 a lot was donated by H.M. and Emily B. Cobb, and after the war ended a new church building was built. According to records, this building was torn down in 1906 and a new one was built. This was on part of the present church property. That church building was damaged



some in 1926 when most of the Burnsville business district was destroyed by fire. In the late 1940's, the church building was destroyed by fire when a house next to it burned causing the church to also burn. In 1949 Dr. and Mrs. A.H. Montgomery donated additional land to the church and the present church building was built. The church building that burned in the late 1940's was a white wooden structure that faced north. With the additional land, a new larger building (the present building) was built and it faces east. A Dedication Service for this building was held October 30, 1955.

In the late 1880's a report given to the Tishomingo Baptist Association showed that the membership of the church had gone up in numbers from the original 9 charter members to 220 and back down again to 47. The highest number of members on record was 271 in 1957

with the highest number of baptisms in a year being 45 in 1951. At the present time we have 31 members. We have a heart for missions and have received several certificates in recent years for our per capita giving. We give God all the praise and glory for what our church is able to give to our local, state, and international missions.

Biblical Hell

In the King James translation the Hebrew word sheol is translated hell 31 times, while the corresponding Greek word hades is translated hell 10 times and grave 1 time. (Hades corresponds with sheol. This is plain from the fact that the Apostles used hades for sheol, when quoting from the OT compare Acts 2: 27 with Psa. 16: 10 and 1Cor. 15: 55 with Hos. 13: 14.) Thus it is not possible to get a clear understanding of the meaning of these words from the King James Version Bible. Anyone can see that if it was proper to translate the word sheol 31 times "graves" it would not have been improper to so translate it the same in every other instance.

Nor have the translators of the ARV and RSV given any more help in understanding the meaning of sheol and hades. They evaded the issue. Instead of giving a translation, they have in almost every case left sheol and hades untranslated, and have used them as proper nouns. They were evidently afraid to tell the truth, and ashamed to tell the lie; and so gave us sheol and hades untranslated, and permitted the inference that these words mean the same as the word "hell" has become perverted to mean. Their course, dishonors God and the Bible, which many of the common people are thus led to suppose teaches a hell of torment in the words sheol and hades.

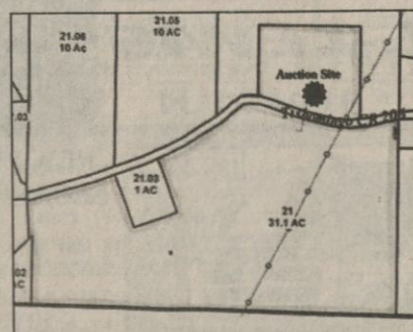

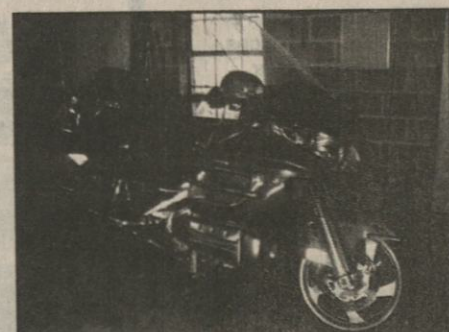
