## 8-Year-Old Iuka Girl Drowns in Pickwick Lake

An Iuka family is mourning the drowning of an 8-year-old girl after a weekend dad-daughter camping trip ended in tragedy.

According to Tishomingo County Chief Deputy Mike Kemp, young Cheyenne Walters went camping with her father this past weekend between Coleman Park and Steel Bridge area on Pickwick Lake. They parked on the road that goes to the Steel Bridge area, and then went on a four-wheeler trail to a camp spot at the head of Poppy Hollow, explained by Cornelison, of Mississippi Parks, Wildlife Fisheries.

Early Monday morning, around 6:30 a.m., as they were preparing to head home, explained Kemp, Cheyenne wanted to go after some ducks they had previously were out. They hiked around an inlet, where skipping rocks in the lake, explained Kemp.

Her father moved away from the child, and when he turned back he could not find her struggling in the water. According to Kemp, Walters leaned out over the edge of the shelf, and when he didn't reach her, he dove. By that time, Cheyenne had apparently gone down, and he struggled to find her. When he finally did, he managed to bring her to the shore, and then carried her a long, long way" trying to help her.

"He'd carry her a little ways, stop and try to give CPR, and then carry her further," said Chief Deputy Kemp. "The terrain is extremely rough, I can't

begin to imagine what he went through, carrying his little girl all that way."

He apparently got turned around and rescuers finally found him near Johnson Cemetery; he may have carried her as much as 3/4 of a mile, as explained by investigators and emergency responders, who searched for the pair after a 911 call came in around 6:44 a.m. She was taken by ambulance to Iuka Hospital, but life-saving attempts were unsuccessful.

Kemp said investigators went out to the site with Chad Walters later Monday morning and verified that the lake dropped off to at least six feet of water immediately below the rocky bank where Cheyenne had been standing.

"Everything was exactly as he described it, it just looks like a terrible, tragic accident," said chief deputy Kemp.

Cheyenne just finished second grade at Iuka Elementary, where she was in GEMS class, and participated in Girl Scouts. She played softball for the Friendly Florist softball team and enjoyed playing outside and chasing

butterflies.

Visitation will be at 5 p.m. until 9 p.m. Thursday at Cutshall Funeral Home and the funeral will be at 11 a.m. Friday, June 15th, also at Cutshall's. She will be buried at Oak Grove Cemetery.

Survivors include her father and stepmother, Chad and Kimberly Walters of Iuka, and her mother, Crystal Brown of Corinth; her grandparents, Donna and Lester Walters, and James Richard "Dickie" Brown and Janet Cummings; her great-grandparents, Alice Barrett and Ann Walters; and one sister, Cashlynn Walters of Iuka.

Pallbearers include Jake Walters, Shon Waldrep, Michael Wayne Barrett, Tony Maxwell, Daryl Lambert, and Brandon Lambert.

## Iuka Man Killed in Wreck Early Tuesday

An Iuka man was killed in a one-vehicle wreck late Monday or early Tuesday morning off Pike Street in Iuka.

Billy Gene Stewart, 51, of Iuka, was killed when he apparently lost control of the 1982 Dodge Rampage he was driving toward town on Pike Street, according to Tishomingo County Coroner Mack Wilemon.

Apparently there were no witnesses to the wreck, said Wilemon. A passerby reported seeing the wrecked car around 1:15 a.m. Tuesday.

The cause of the wreck is still under investigation. Cause of death was preliminarily announced as trauma due to the accident, said Wilemon.



## Lost Cause Confederate String Band to Help Kick Off Battle of Iuka 150th Anniversary Celebration

Organizers announced this week that The Lost Cause Confederate String Band will help kick off the big Sesquicentennial and Heritage Day festivities Labor Day weekend in Iuka.

September 19th, 1862 the Battle of Iuka was one of the bloodiest of the Civil War, and this Labor Day weekend, the Iuka Battle-ground Commission and the Heritage Day Committee are teaming up to observe the 150th anniversary of that day with a festival, living history demonstrations, a reenactment of the battle itself, and much more.

### The Lost Cause

The Lost Cause Band bills themselves as a Confederate string band preserving history through interpretations of antebellum and War Between the States songs performed on stringed instruments in Confederate costume. Their repertoire includes more than 100 authentic Southern arrangements promoting heritage, not hate. They perform routinely for events like the Battle of Iuka/Heritage Day festival, honoring the Southern roots of what later became blues, country, folk, bluegrass, Southern gospel,

rock-a-billy and rock and roll music. They revel in preserving this unique period of American history for future generations to enjoy.

The band will play in Jay Bird Park in historic Downtown Iuka, and will also be playing some on Saturday morning, and Sunday prior to Battle Reenactment. They will set up in sutlers' (re-enactor's campsite) area to sell their CDs.

### Weekend Kicks Off Friday

Friday, August 31st, reenactors will move into a campsite across from Mineral Springs Park, and there will be school demonstrations behind the Old Courthouse Museum.

Beginning at 4 p.m., the Lost Cause band will play in Jaybird Park. Also at 4 p.m. "General Henry Little," who was killed in the Battle of Iuka, will be portrayed by his great-great-great nephew, Fielding Tyler, who is coming in from Virginia Beach. That will be at Twin Magnolias, where Little made his headquarters during the Battle.

There will be another living history event at the Old Courthouse beginning at 5 p.m., when Governor

John Stone, leader of the Iuka Rifles, Co. K, and one of Mississippi's post-war governors (as portrayed by Dr. Phil Bozeman, Stone's great-great-grandson) will greet festival attendees.

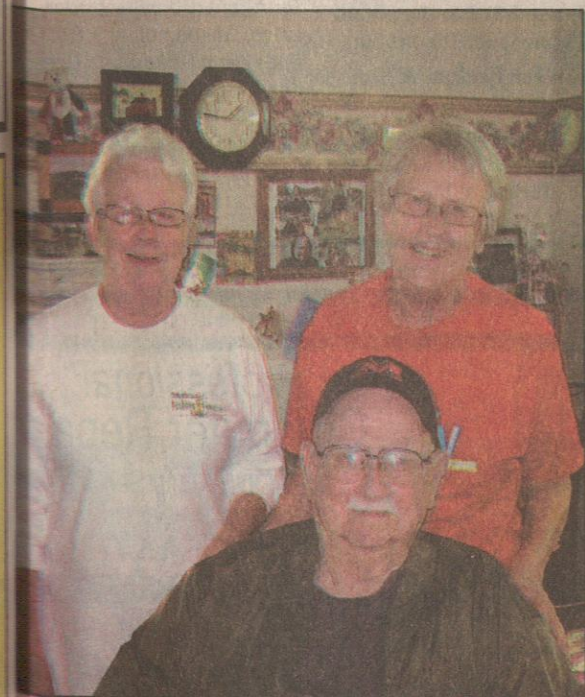
At 6 p.m. that night, there will be a military escort of General Little's "body" down historic Quitman Street. And then at dusk, Iuka will be illuminated by more than 2,000 luminaries, honoring those who gave their life in the historic battle.

### Saturday and Sunday

Saturday events include the popular Heritage Festival-all day; military drills, living histories, descendants' reunion & banquet, mass grave roll call at Shady Grove Cemetery, antique car show, buggy rides, self-guided historic homes tour, grand ball, and much more!

Sunday events start when the battle site opens at 9 a.m. and will include church services, mail call, and the 2 p.m. Battle reenactment.

## Another Week, Another Storm

## Belmont Suffers in Monday Pop-Up Thunderstorm

Monday evening, Tishomingo County was again hit by severe thunderstorms, and Belmont suffered significant damage from high winds and heavy rain.

The storm hit the county, from the north end all the way to the south, from about 5:30 to 6:30, and came on quite suddenly. Sunny conditions around 4:45 had people doubting the severe thunderstorm warnings that started being issued around 4:30.

According to Belmont Police Chief Donald Reno trees were down and blocking roads on Main, 4th, Monroe, Washington, Anthony Streets, Old Highway 25, Redbud Road, and Bethel Road, and roofs were

blown off at the NAPA Auto Parts store, Belmont Café and the old Rainbow store. First Baptist Belmont and the Belmont school also sustained damage from high winds. There were some homes that reported trees down, and a couple with trees actually causing damage to structures, said officials.

Tishomingo County EMA director Bill Strickland said that he had reports of structure damage in 50 locations, and that power was out to as many as 5,000 customers. He said there were also trees down on Snowdown Road in Iuka.

There was also 6 inches of water in the Belmont Library, but investigation indicated it had blown in the back door, said Strickland.

There are tarps available through the EMA office, said Strickland, who had already distributed several by Tuesday morning.

Chief Reno issued thanks to all the agencies and people who pitched in to help with the clean up.

"It's times when we all pull together for the common good, serving the public. I really see how good it is to live in the place we live in. Thank you, everyone who helped with the cleanup."

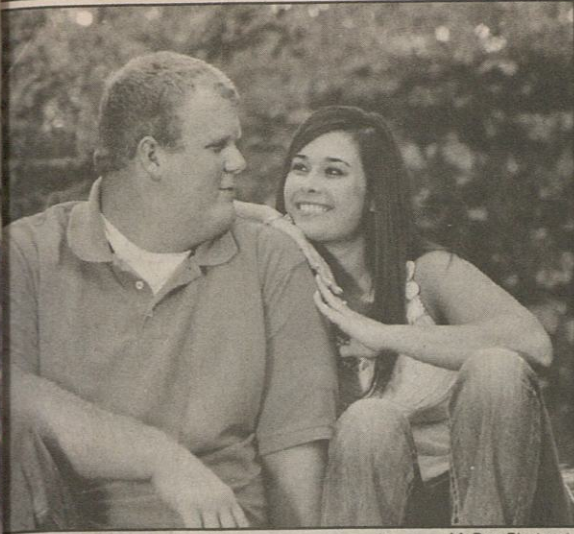

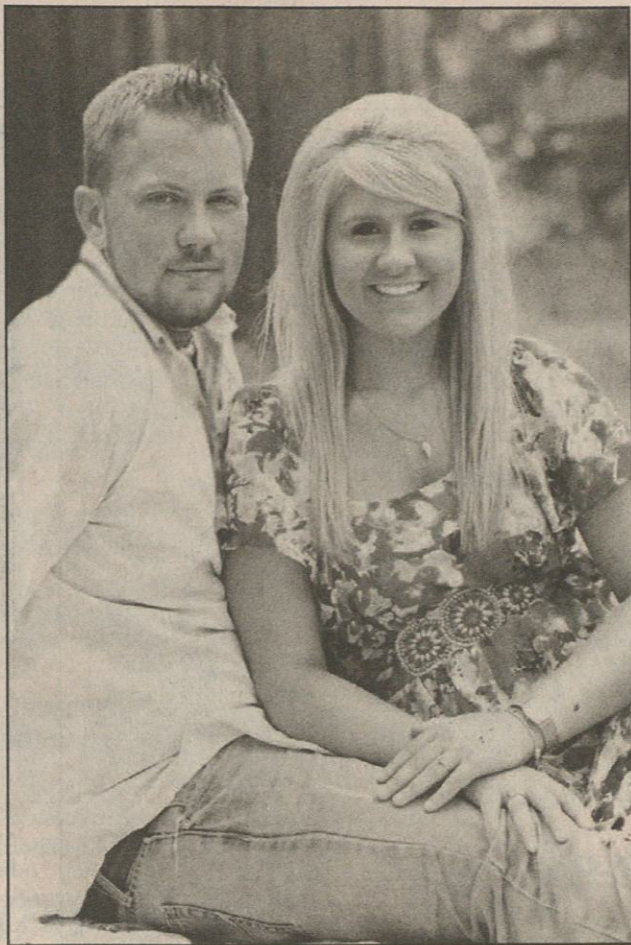

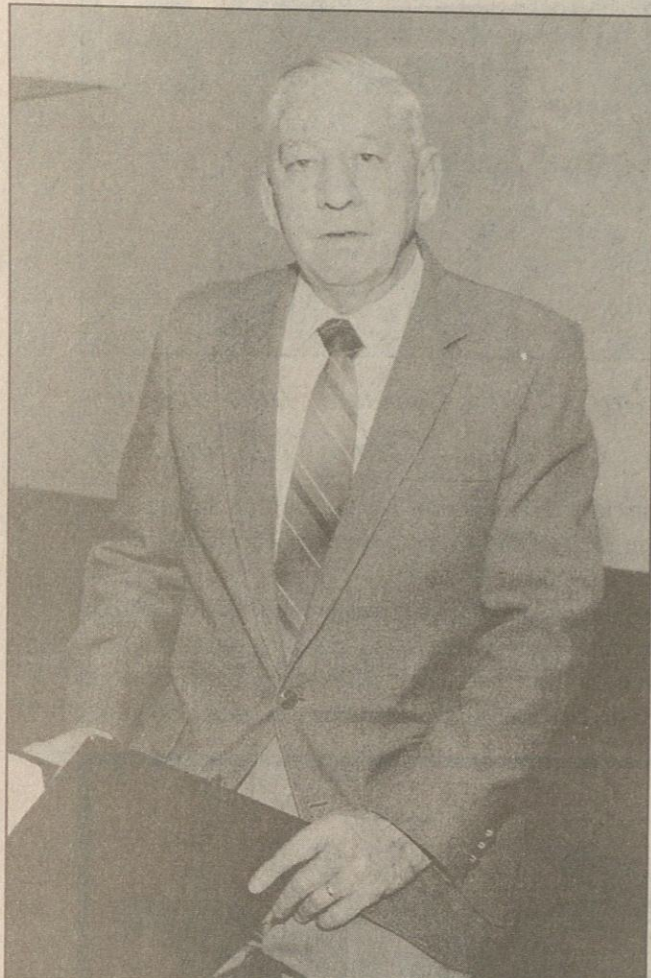

I have never not known Cecil Phifer. He called me "Blossum". He has been a part of my life forever. And Brenda, she was in the room with me when my mother died and I was with her when Lillian died. And I have lots of memories of spending time with a lot of you, Phifers. He taught me how to drive, ride a horse, and eat turnip greens and cornbread. He spanked me one day for sitting down in a mud puddle with my good dress on and made me so mad I begged my Daddy to fire him. Cecil never let me forget that story.

I walked home with him from work many nights to spend the night with Brenda and mostly to eat supper with them. As a child, I remember how his foot hurt and had to be soaked every day, the dark days and nights of his mother's death, Lillian's sickness and death, and I don't remember him ever complaining. On a lighter note, I'm sure he wished I wasn't always around when he had to sit with the phones and he brought his new girlfriend, Rosie. I watched them like a hawk. And then, we had a bigger Phifer family: Rosie, Johnny, Billy Ray and Noonan.

Cecil was the kind of man you could get an education from. He knew lots of "stuff". There was a right way and a wrong way about everything. He might not have had a lot of formal schooling, but he was wise to the world. He was what you would call "old school", maybe local color in our town. Cecil did a lot of hauling. He went on long ambulance hauls, many hearse hauls, a lot of flower wagon hauls, and a lot of Everett Cutshall hauls, then had to haul me around town. Later he did the same for my children, taking them to school in the hearse. He loved my children like they were his.

Cecil and George taught me how to work funerals. We didn't direct them, we worked them. Many times I looked around and Cecil and I would be looking at each other with tears in our eyes. We were the "softies". Cecil had a lot of compassion for everyone.

I'm proud to have been a student of Cecil Phifer's. This world needs more like him.

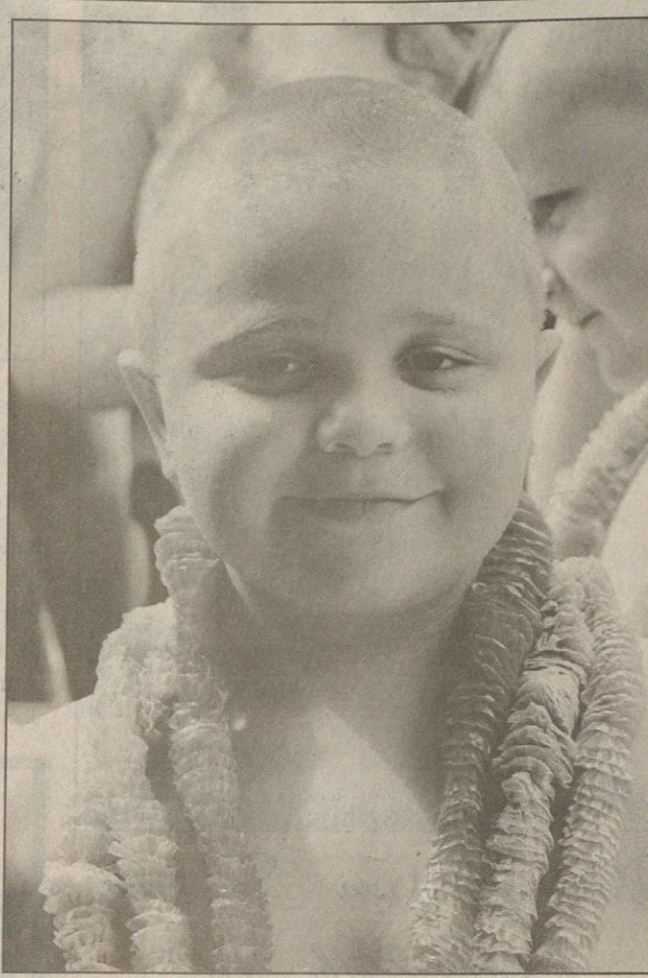

### Iuka Middle School Uses Grant To Improve Nutrition, New Equipment Will Make IMS Meals Healthier For Students

As part of a comprehensive effort to improve student health, Iuka Middle School plans to install new kitchen equipment. Using a Nutrition Integrity grant from the Mississippi Department of Education Office of Child Nutrition, funded by The Bower Foundation, the school will replace its existing deep fat fryer with oven steamers. This healthy change is made possible by the Nutrition Integrity grant that Tishomingo County School district received in May, 2012.

"A combination oven steam uses super-heated steam to cook foods with less fat, saturated fat, and trans fats," says Food Service Director Teresa Stanford. "Since school meals are such an important way to insure that our children are fit, healthy, and ready to succeed, we want the foods we serve to be as nutritious and appealing as possible. "The new equipment will help the foodservice staff improve the 7500 breakfast and lunches served every month to students and staff in the Iuka Middle School cafeteria.

Installing new kitchen equipment and lower-fat cooking methods are two of the many ways that Iuka Middle School is focusing on the health of students. More fresh fruit and vegetable choices are also available to students and staff in our efforts to improve school nutrition. "We recognize the critical connection between good health and success in the classroom," says Principal Christie Holly. "In addition to replacing our fryer with this new oven steamer, our local wellness policy includes that we will eliminate fried foods for a period of five years.

"The funds received from this grant will complete our goal of placing two combination oven steamers in every school in the district while improving school nutrition for all Tishomingo County students" says Superintendent Malcolm Kuykendall.

## Boys' and Girls' Club Gets Another Computer for Lab Update

With the donation of four computers so far, and purchase of several more, the Boys' and Girls' Club of Iuka is making progress on its goal to upgrade the technology in its mobile computer lab.

Monday, Barbara Sweeney, of Iuka, donated the fourth Compaq laptop that will be added to the eleven others already purchased by the Board of Directors of the Boys' and Girls' Club of Iuka.

Their goal is to get twenty computers to replace their old computer lab equipment, which included desktop computers from 2004, explained Kevin Lovelace. The mobile technical center will be located at Iuka Elementary during the summer, where some 85-90 kids attend the club daily. In the fall, the mobile lab will allow use of the equipment at

the Youth Center in Mineral Springs Park, where junior high club kids attend an after-school program.

The Boys' and Girls' Club board bought some of the computers, and others have stepped up to donate to the program, including Ben Burns, of Rushing Drugs. Barbara Sweeney is also on the board of directors, so she sees the value of the program.

"This is such a worthwhile program, and I really feel like it makes a difference in the lives of these children and their parents," said Mrs. Sweeney of the technical education opportunities provided by the program.

The students will use education modules through a national Boys' and Girls' Club program at [www.myclubmylife.com](http://www.myclubmylife.com). They will learn many aspects of computer usage, from word

processing and graphic design, to presentation and web design software, said Lovelace.

The Boys' and Girls' Club of Iuka registered its 1000th member last week, and already have about a dozen more kids signed up since then, said Lovelace, making a total of about 240 currently enrolled in the free program. There are eight employees and several part-time volunteers that help at the club.

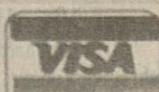

## Old Tishomingo Traces by June Bullard

### Wright Bonds Gravesite Located

Have you ever searched and searched for something and suddenly it's there staring you in the face? It had been right there under your nose all the time! This happened to me last Wednesday in searching notes of my paternal second greatgrandfather Wright BONDS. I read the obituary of my greatgrandfather Lemuel Bonds who died 5 June 1909, Wright's youngest son. In the obituary it stated that "Lemuel would be buried in the Bonds Family Cemetery." Wait a minute! I had always believed that he was the first buried there but evidently he wasn't because it said the Bonds Family Cemetery, not Lemuel's private

burial ground. The first time I visited the site I noticed 3 or 4 large mounds indicating graves of adults and several small mounds for children. I supposed that Lemuel was the first interred there because he was the only one to have a monument, a Civil War marker provided by the United Daughters of the Confederacy. Then, my mind started racing back, when I first visited the cemetery, I wondered why it was located across the road from Lemuel's homeplace. Seems like they would have built the cemetery behind the house not right in the front.

As I continued to try to sort things out, I started looking through copies of old deeds I had found in the Iuka and Corinth Court Houses. I found where Lemuel Bonds'

wife Sarah (Scruggs) daughter of William A. and Elizabeth Scruggs (my second greatgrandparents) had inherited 1/7 of William's estate and Lemuel bought the other six parts. So, the Lemuel Bonds' homeplace had originally been the Scruggs homesite! I knew by looking at the 1850 Census of Tishomingo County that Wright's widow, Priscilla, Lemuel and Sarah Bonds (Sarah & Lemuel married in 1849) were living next to William and Elizabeth Scruggs. The late Grace Coker told me that Kate Moser told her that Elizabeth Scruggs was buried behind the Lemuel Bonds' home around 1886. At the time, I wondered why she wasn't buried in the Bonds Cemetery. Now, I realize since William was buried behind their house, she wanted to be

buried beside her husband. The Wright Bonds homesite is across the road from the William Scruggs homeplace. In those early times families used their own property for burial grounds. Now, I think, I can safely say, the Bonds cemetery did not start with the burial of Lemuel, it started with the burial of Wright Bonds who died on 10th of February 1843. (This is the actual death date of Wright from his pension of War of 1812 found in Fold3. Every Bonds researcher is using his estate settlement date as his death date).

Since this is the 200th anniversary of the War of 1812, it would be great if Wright Bonds' descendants could get together and get a monument erected for him in the Bonds Cemetery. Wright was a great man dedi-

cated to serving Tishomingo County in its infancy. He was one of the first grocery store owners in Tishomingo County and his store ledger can be found at the Corinth Museum. He owned a store in Alabama near the county line of Lawrence and Franklin Counties before moving to Tishomingo County. The names of the people in the ledger match some of the names of people who owed him money in his estate settlement. Wright Bonds Jr. was the executor of his father's estate and he was a county official who worked out of the courthouse so it would be logical that he left the ledger there. Beside his business and political interests, Wright was also a minister of the gospel and solemnized marriages throughout old Tishomingo

County. In Wright's record from War of 1812, he was a sergeant in the Volunteers, 1st Regiment (Perkins) Infantry, December 1813 and at Fayetteville, Tennessee, 25 February 1814. He was \$11 per day, 40¢ per horse and .25 per day for sleeping. Wright Bonds was buried in the Tishomingo County Cemetery about six years before he died, but his spirit lives on in his efforts to make Tishomingo County a wonderful place and through his descendants who can be found to coast. It is wonderful to have heroes especially ancestors.

### When God Says "No"

Forgiveness does not necessarily put everything back just like it was before! We are hearing a theology in our day that makes it sound like sin doesn't really cost us anything, as long as we seek forgiveness and receive it.

This just is not what the Bible teaches about sin! I am thinking about one of the greatest men in the Bible, Moses. Numbers 12:3 says, Now the man Moses was very meek, above all the men which were upon the face of the earth." Numbers 12:7 shows God as saying that Moses was faithful in all His house. Deuteronomy 34:10 says, And there arose not a prophet since in Israel like unto Moses, whom the LORD knew face to face." With all of the great things that God's word says about Moses, we have a problem recorded in Numbers 20:12 that barred Moses from entering the promised land. Our verse says, And the LORD spake unto Moses and Aaron, Because ye believed Me not, to sanctify Me in the eyes of the children of Israel, therefore ye shall not bring this congregation into the land which I have given them."

As great as Moses was, he was still barred from entering the blessed promised land, because he failed to sanctify God at the waters of Meribah. God had told Moses to speak to the rock, but he struck the rock twice with his rod. Deuteronomy 3:24-25 shows Moses praising God and asking Him to allow him to enter the promised land. God gives His answer to Moses request in Deuteronomy 3:26-27: "But the LORD was wroth with me for your sakes, and would not hear me: and the LORD said unto me, Let it suffice thee; speak no more unto Me of this matter. Get thee up into the top of Pisgah, and lift up thine eyes westward, and northward, and southward, and eastward, and behold it with thine eyes: for thou shalt not go over this Jordan." Some things just cannot be recovered after some sins! Moses loved God; he was a great leader and He wrote five books of the Bible, but he was not allowed to enter the promised land. Those who think that everything can be restored after sin need to realize that some things can never be as they were before. Such is often the case with divorce, especially when children are involved. God will forgive, but that does not make everything right with the children. People need to count the cost before they walk away from the plain and simple truths of God's Word!
