Renasant Bank Robbed

A lone white male suspect robbed the Renasant Bank branch on Constitution Avenue in Iuka about 4:20 last Thursday, in what is believed to be the first bank robbery in Iuka.

According to Iuka Police Chief Randy Stringer, the suspect gave a teller a note demanding money and stating he was armed. Police say he did not show a weapon. The teller gave him an undisclosed amount of money and he left.

There were about half a dozen staff members, and one customer at each of three windows, said eyewitnesses. No one was hurt, and no one knew it had happened until the suspect drove away, having warned the teller not to say anything.

"She was calm, and got him in and back out, away from all of us, as fast as she could," said Kristi Deaton, who was in the teller window just to the right of the robber, and never knew anything was happening. Her young

daughter's hand reaching up for a piece of candy on the counter was visible in surveillance video stills that were distributed within an hour of the event via the Sheriff's Department Facebook page.

"When I think of what could have happened, if someone could have been hurt, I was so thankful that she [the teller] handled it calmly," said Deaton.

Authorities are still on the lookout for a white male last seen wearing a baseball cap, khaki shorts, white t-shirt and sneakers.

He's about 6 feet tall with a medium to slight build.

Immediately after the event, authorities were looking out for a light colored SUV, but no one reported actually seeing him drive away or approach any vehicle. People in the bank said they thought they remembered seeing one outside before the robbery.

Anyone with information that could lead to the arrest of this individual is asked to call the Iuka Police, 423-6340.

First Bank Robbery

Long time associates at First American National Bank, and the former Iuka Guarantee Bank in Iuka say that neither of those institutions in Iuka have been robbed in their memories, which unofficially makes this the first bank robbery in Iuka. First American has had robberies at other branches, but not Iuka.

The suspect faces initial charges of armed robbery.

County Gets \$163,000 from MDOT for Jet Fuel Facility at Iuka Airport

Northern District Transportation Commissioner Mike Tagert presented Tishomingo County with a \$163,000 grant that will allow jet fuel to be available for purchase at Segars Field.

The grant is from the Mississippi Department of Transportation from the Multi-Modal fund and provides 99 percent of the funding. The county matches it with one percent.

"We've talked for years how to increase the viability of the airport here,"

said Tagert of conversations with Dr. Kelly Segars, board member and promoter of the small airstrip in the north part of Tishomingo County.

"In the cut-throat atmosphere of industrial recruitment, you need every possible tool to attract industry, and one of the first things executives of larger companies ask about is the availability of an airport within an hour of the site," explained Tagert to the board of supervisors as he was presenting them a symbolic large check.

It will take approximately three months for the bid process, and then to fabricate and install the 6,000-tank, said Tommy Dean, of Dean McRae Engineers of Iuka, the long-time engineer for the Iuka airport. Advertisement was scheduled to begin this week.

"This will have a long-term effect on industrial recruitment," said Dr. Kelly Segars, who was present for the event. "The time has come to do this, and to extend to a one-mile runway if we want our area to grow industrially."

The Tishomingo County Board of Supervisors will hold a public hearing on its proposed budget for fiscal year 2012-13 Friday August 31st 2012 at 10:00 AM at the Tishomingo County Board of Supervisors Office. At this meeting, a proposed ad valorem tax revenue increase in the proposed budget will be considered.

The Tishomingo County Board of Supervisors is operating with projected total revenue of \$11,813,676 and \$3,832,726 of such revenue is obtained through ad valorem taxes. For next fiscal year, the proposed budget has total projected revenue of \$12,110,975. Of that amount \$3,850,620 is proposed to be financed through a total ad valorem tax levy.

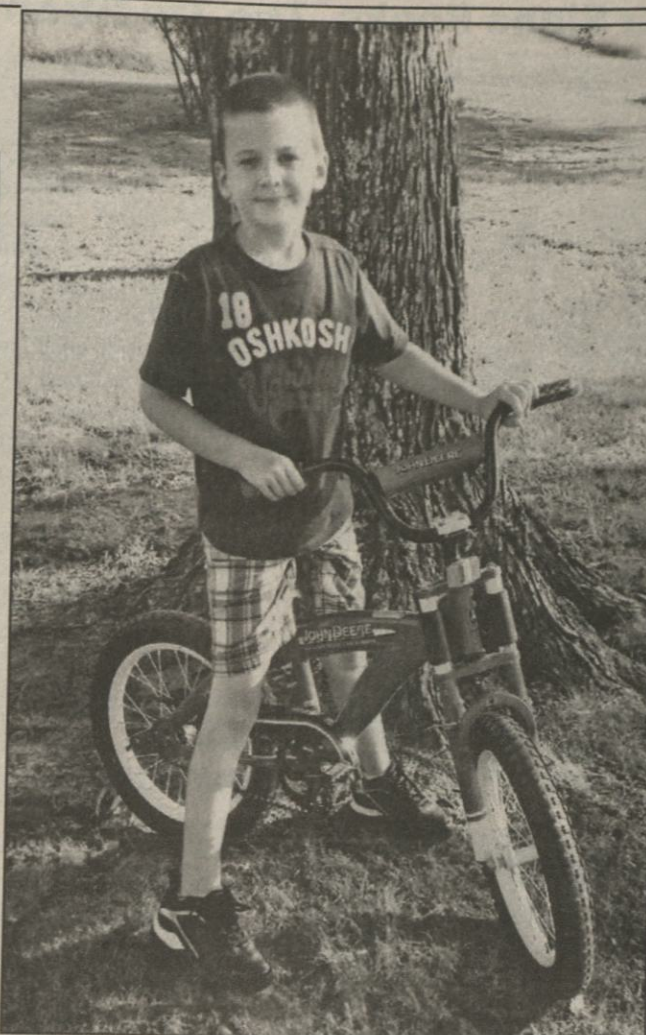

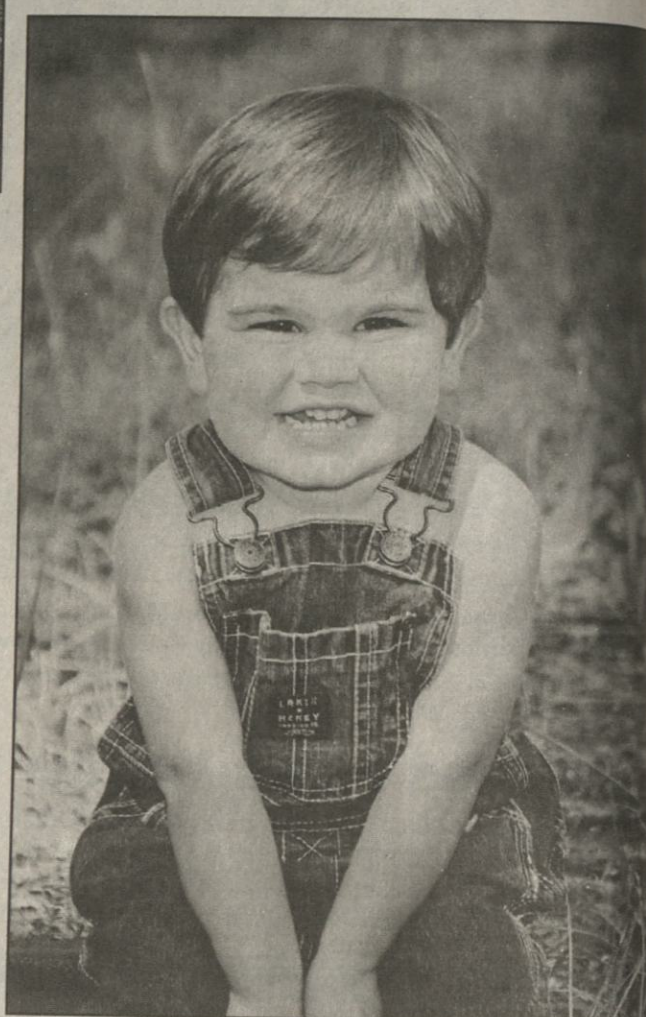

I hope no one takes this article out of proportion or misunderstands it or takes it in the wrong way. If we do not get this on the November election this is what is going to happen. Do you want this petition to cost the tax payers \$20,000? On my last article with the petition on it I stated that this would be the last time that you had a chance to sign the petition to get it on the November election. I must have looked at the wrong date on the calendar because we have one more week to get this done. I thought that this last Thursday was August 23rd, 2012 but it was not, it was August 16th, 2012. This Thursday is August 23rd, 2012. I have until August 31st, 2012 to get these signatures to the circuit clerk's office in the Tishomingo County Courthouse to where they can get them certified and get it on the November ballot. We need 250 more signatures. I have received 42 more from last week's petition that was in the Tishomingo County Newspaper. If all of these are good we only need 208 more signatures. If you sign this petition that does not mean that you are for the sale of alcohol in Tishomingo County. That is only saying that you think that the people of Tishomingo County should have the right to vote on it or if you sign the petition you are saying that you don't want to see \$20,000 of the tax payers money being spent on a special election. I hope this petition drive does not come to this. All I want to see is the people of Tishomingo County have a chance to have a say in this matter. This is what is wrong with this county today. We need to let the whole county speak not just part of this county. You the people of Tishomingo County need to realize that I have spent nearly three years on this petition drive and I am not going to stop until I get my chance to vote on this. How much longer do you think it will take me to get these other few signatures? If it takes me another year or another two years I will eventually get them. Then I will call for a special election and they have got to give me an election within 60 days after I turned the last petition in. If I do not get this on the November ballot I promise you that we will have a special election on this. I am asking you to go ahead and sign this petition. Let's save that \$20,000 that it is going to cost to do a special election. I just want to let you folks know that if something was to happen to me before I get this on the polls to be voted on I already have a person lined up to push this and finish it for me. If something happens to me, which I don't think it will but we never know when that day is coming for us, but I will promise you if it does the petition will not die with me it will continue until it is put on the polls to be voted on. People, you may as well come to acknowledge this. One day you will be going to the polls to vote "yes" or "no" on the sale of alcohol in Tishomingo County. I promise you one day this is going to happen. You the people of Tishomingo County should know that if I have not quit by now that I am not going to quit. Why not just sign the petition and let's get this on the November Ballot. If the majority of the people vote "yes" for it, that's okay, if the majority of the people vote "no", that's okay. If the majority of the people vote "no" and it loses, you will not have to worry about another petition on Tishomingo County for the sale of alcohol for at least five years from that date. It can only be done every five years. Once the people in Jackson get this new alcohol law passed for the cities only then you can do one for the city limits of Iuka only. Iuka is the only city in Tishomingo County that it can be done in. If it loses county-wide it cannot be done again in the county for five years. If you do not believe that it costs \$20,000 to do a special election then you need to call your supervisor's office. The phone number is: 423-7032. That is how much one of the supervisor's told me that it costs to do a special election. I know a lot of people out there do not want their names on the petition. This does not mean you are signing for it or for against it. It is just saying that you think people should have the right to vote on it. I am sure that you do not want to see the county spend \$20,000 dollars on a special election. A lot of people have told me that the reason they will not sign the petition is because they do not believe it will win. I do not know if it will or it will not. I do know this, if we do not get this on the November ballot of 2012 it is going to cost the tax payers of Tishomingo County \$20,000 to hold a special election. After this November election there will not be a general election until the year 2015. I know that it will not take me that long to get 200 and something more signatures. When I get the last signature that I need I am not waiting until the next general election because I will hold a special election. It is left up to the people of Tishomingo County. We can either save \$20,000 dollars in money or waste \$20,000 on a special election. If we do a special election and it goes wet, we still have spent \$20,000. Living Histories Bringing our Past to Life

Living history events are going to bring the past to life during the 150th Anniversary events. General U. S. Grant, Col. Henry Little, and Governor/Colonel John M. Stone will all be portrayed both Friday and Saturday nights in different events.

Grant is portrayed by Dr. E. C. Fields, Jr. of Collierville, Tennessee, in events and reenactments throughout the country. He

is accompanied by his wife, Julia, and they will speak during the living history presentations for school children Friday during the day at the Old Courthouse, and at the Brinkley house/Dunrobin on Saturday September 1st. He will also eulogize the lost Union troops on Friday evening during the Grand Illumination.

Fielding Tyler, is the great-great-grandson of General Henry Little. Little died of injuries received in

the Battle of Iuka, and was temporarily buried in the rose garden at Twin Magnolias, now the home of Neil and Beth Davis in Iuka. He will speak at Twin Magnolias Friday, will eulogize the Confederates killed in Iuka at the Grand Illumination. He will be back at Twin Magnolias Saturday.

Dr. William Bozeman will portray his great-great grandfather, Governor John Marshall Stone, who was a Colonel in the Confeder-

ate army, and after the War, mayor of Iuka, a state senator, and eventually the longest serving Governor of the state of Mississippi. He will address the crowd at 5 p.m. Friday from the steps of the Old Courthouse, and then will thank the people of Iuka for their help with the wounded and dead after the Battle.

Field Hospital

During the Battle of Iuka, Iuka Methodist Church was used as a field hospital, and organizers are planning a recreation of the hospital on Saturday morning, September 2nd. The dramatic presentation will feature local young people as some of the many soldiers treated at the makeshift facility.

Gathering of Descendants

The Tishomingo County Historical & Genealogical Society is planning a "Gathering of Descendants" of the soldiers who fought in the Battle of Iuka on September 19, 1862.

This 150th remembrance ceremony will take place on Saturday, September 1, at 12 noon at the historic Tishomingo County courthouse museum. The commemoration ceremony is being held at the old Tishomingo County courthouse museum located at 203 East Quitman Street in Iuka. Descendants from both the Union and Confederate armies are invited.

The Bread Of Life

In many eastern countries, including Israel, bread is considered the "staff of life". This is because bread is such an important part of the meal in these lands. If one reads the Bible even casually, he will find that bread is mentioned many times in its pages. There was a saying in biblical times concerning those who ate meals together; they would say, "There is bread between us." It is interesting that Jesus took this well-known food and used it to talk about something more important than natural bread. John 6:31-33 says,

Our fathers did eat manna in the desert; as it is written, He gave them bread from heaven to eat. Then Jesus said unto them, Verily, verily, I say unto you, Moses gave you not that bread from heaven; but My Father giveth you the true bread from heaven. For the bread of God is He which cometh down from heaven, and giveth life unto the world." Jesus told the Jews who were "seeking Him" (see John 6:24 -25) that Moses did not really give them the true bread from heaven, namely the manna that God gave in Moses' day. Rather, Jesus said that the Father was giving them the true manna by giving them His Son, Jesus. Jesus also said that He came down from heaven to give life to the world.

It is interesting that Jesus came to give life to all who are willing to receive Him, yet many people are like those Jews who were standing before Jesus; they are unwilling to accept Jesus as the true bread (true life) that God has sent to bring salvation to

the world. John 6:34-36 carries our story farther: "Then said they unto Him, Lord, evermore give us this bread. And Jesus said unto them, I am the bread of life: he that cometh to Me shall never hunger; and he that believeth on Me shall never thirst. But I said unto you, That ye also have seen Me, and believe not." Nobody could make language any more clear than Jesus did here, for He said that He was the very bread of life that could satisfy hunger and quench thirst. The sad note is that these inquirers did not believe Him when He gave them the life-giving message from the heart of the Father! Most people in our world are dying in sin, just as it was with those of Jesus' day, because they are rejecting Jesus, just as these Jews did. Yes, a few people are coming to their senses, by the conviction of the Holy Spirit, and receiving life by faith in Jesus Christ. With which group do you identify yourself today, those who reject Jesus, or those who receive Him?

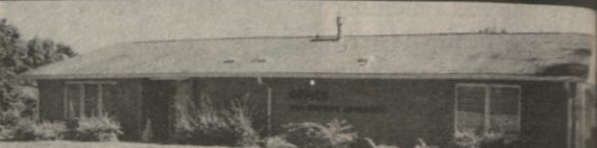
