### Pleas Heard in Circuit Court Last Week

Last week, Judge Jim Pounds presided over some of the pleas in Tishomingo County Circuit Court, including Skyler Bennett, of Iuka, who pled guilty to four cases of burglary of a building in connection with a string of burglaries in Iuka. He was sentenced to 15 years to serve with MDOC, and five years post release supervision, and must pay restitution of \$8,500, in addition to court costs and a \$2,000 fine.

Anthony Collum, 51, of Belmont pled guilty to possession of two or more precursors [to make methamphetamine], and he was sentenced to twenty years with MDOC, all suspended, must successfully complete five years post-release supervision, and pay court costs and fines.

Greg Smith, 36, of

Belmont pled guilty to possession of two or more precursors [to make methamphetamine], and he was sentenced to twenty years with MDOC, all suspended, must successfully complete five years post-release supervision, and pay court costs and fines.

Bethany Lambert, 33, of Iuka, pled guilty to sale of a controlled substance (hydrocodone III), and she was sentenced to twenty years with MDOC, all suspended, must successfully complete five years post-release supervision, and pay court costs and fines.

Jimmy L. Blunt, 46, of Tishomingo, pled guilty to grand larceny, and he was sentenced to ten years with MDOC, five suspended, must successfully complete five years post-release supervision, pay court costs

and fines, and \$1,575 restitution to Johnny Poole.

Randy Wheelington, 43, of Paden, pled guilty to possession of two or more precursors [to make methamphetamine], and he was sentenced to fifteen years with MDOC, all suspended, must successfully complete five years post-release supervision, and pay court costs and fines.

Tracy Knauer, 35, of Burnsville, pled guilty to conspiracy to manufacture methamphetamine, and was sentenced to twenty years with MDOC, all suspended, must successfully complete five years post-release supervision, and pay court costs and fines.

Cassidy Miller Null, 30, of Burnsville, pled guilty to

Saturday, partly cloudy skies dropped a couple showers on the huge crowds that attended living histories throughout the town, and Heritage Day events and vendors in Mineral Springs Park, but overall the weather was wonderful, considering the earlier threat from Hurricane-turned-Tropical Storm Isaac. Many local people, aside from the many reenactors in town, donned period clothing for the day, which brought smiles, and opportunities for snapshots with many a soldier or Southern Belle.

The scene at the Confederate burial trench at Shady Grove was respectful, as names of more than 100 soldiers were read, and honored with a 21-gun salute by a Confederate reenactor honor guard.

The Grand Ball at Dr. Ben and Joy Kitchens' "barn" exceeded all expectations and attracted hundreds to the newly renovated barn Saturday night. The

dance master from the 52nd Regimental String Band lead both polished and completely-amateur dancers in period dances like the Grand March, Virginia Reel, and Patty Cake Polka. Old and young danced together, and despite the extreme heat, everyone praised the event.

The reenactors who played such a big part were mostly pleased with the welcome of Iuka, and organizers say that a good report will go far with these hobbyists who travel all over the country to dozens of events each year.

"They said they had been treated well, and the accommodations, like the water, battlefield and transportation we provided, were good," said Iuka reenactor Ellen Ayers, who hosted a tea at her antebellum home on Saturday for the lady reenactors.

Exact numbers will be difficult to obtain, since all the events were free to the public this year, said Lee-Ann Robertson, but the economic impact was positive, and other than the heat issues the weekend went off with very few problems.

### Braves 23-21 Win Breaks Cardinals Streak!

The moon was Tishomingo County BLUE last Friday night, as the Braves won their first win over cross-county rival Belmont since 2007.

Coming off a school record 72-point score over Alcorn Central last week, the Braves came on the field flying high. They scored on their first possession for the second week in a row, with a touchdown by sophomore quarterback Blake Hawkins. The point-after attempt failed, when senior Gable Butler extra point kick hit the goal post.

Hawkins went on to complete 6 of 13 attempted passes for 166 yards and two touchdowns, compared to Belmont's Colin Harris, who only completed 3 of his 12 attempts.

At halftime, the score was tied, and the teams alternated scores, beginning with a dramatic 64-yard reception and touchdown run by Austin Marlin, followed by Gable Butler getting

back into form for a successful point-after, and later a 38-yard field goal.

Belmont followed their touchdown with successful 2-point conversion.

With 3:30 minutes left in the game, the Braves had a commanding lead of 23-14 when Belmont's Luke Alexander made a reception that allowed Alexander Fancher to punch in Belmont's final touchdown on the next play - a wake up call for the Braves - the Cardinals had narrowed the lead to 23-21! Butler's earlier field goal gave the Braves the two-point lead

that they narrowly managed to keep through some tense moments late in the fourth quarter, when there were issues with the clock that made some people have flashbacks to the 2008 game where tenths-of-seconds allowed Belmont to begin the most recent winning streak.

After the game the students joined the elated team on the field, and both teams prayed together after shaking hands.

# Brinkley Home Still One of Iuka's Treasures



The most impressive of the old homes in Iuka is "Dunrobin" built by Robert Campbell Brinkley for his wife, Elizabeth Mhoon. This colonial home on Eastport Street, faces the Norfolk-Southern Railway and features massive columns imported from Italy on the stately porch, and mantels in the home are of Italian marble.

On this spot the Chief Iuka is supposed to have had his home, and a small Indian mound to the west of the house is still plainly visible. After the arrival of the white man, pioneer David Hubbard built an early home there, fifteen years before the Town of Iuka was

established. This first house, possibly a log structure, was torn away and the present house built in 1847.

Romance played its part in the construction of Dunrobin. When on their honeymoon, Robert Campbell Brinkley and his bride were making a trip on the old stage coach which passed this site - the old coach line ran right in front of where the present house stands. The young bride admired the location and said she wished she had a home built there. One year later Dunrobin (meaning castle) was built.

During the war, when the Federal troops occupied Iuka, General Grant

had his headquarters in this house, and upon vacating it, he wrote the owners that he had taken good care of the property.

During the terrible epidemic of yellow fever of 1878-79 in Memphis, Iuka opened its doors to those fleeing affected areas. The trains bearing the victims barred from entering all other places, brought many suffering from that disease who were nursed back to health in that home, as well as other homes of the town.

Col. Brinkley died in 1878, but not of this disease.

The home remains in the Brinkley family today.

## Stone-Reid-Cutshall House

This house was another that was located in the town of Eastport and torn down then rebuilt in Iuka around 1858. Surviving the war, it was said to be used for soldiers to stay in.

This house is an "L" shaped antebellum cottage that retains its kitchen and dining room structure. Once separated from the house, as were kitchens reported at other houses, this one has been incorporated into the main section. As the lone surviving example of the relationship between kitchen outbuildings and homes.

Earliest available records show that John M. Stone (later Mississippi governor) owned this house in 1869. Then the Reid family bought it and later it was the home of Lawrence and Otha Cutshall.

to submit the following report of the part taken in  
engagement near Iuka, by the 5th Iowa Infantry, the  
19th inst. We left camp six miles from Iuka, at  
early on the morning of the 19th inst. leading the column  
of the 3d Division, and soon came onto the Enemy's  
pickets posted on the road. These companies of my  
infantry were ordered forward as skirmishers, and con-  
cluded in driving them from their position, and con-  
tinued to drive them from one point to another, which  
contested for more than six miles, killing three and  
wounding another, when these companies were re-  
lieved by the 26th Missouri Infantry. Our loss was one severely  
wounded.*

*The Skirmishers soon came on to the  
force of the enemy in a strong position, and re-  
ceived a volley from one or more regiments. My Regt.  
was ordered into line on the right of the 19th.*

## Battlefield Report

The page above is scanned from a copy of the actual battlefield report from the Battle of Iuka, of the Iowa infantry to Lt. Martin, 1st Brigade, 3rd Div. Army of the Mississippi.

It is dated September 21st, 1862, from "camp on the Iuka Road."

Our request for information allowed us to meet John Horrihgs, who has extensively researched the 5th Iowa, who played a prominent role in the Battle of Iuka. Mr. Horrihgs is hoping to write a book about the 5th Iowa, which we will be eagerly anticipating.

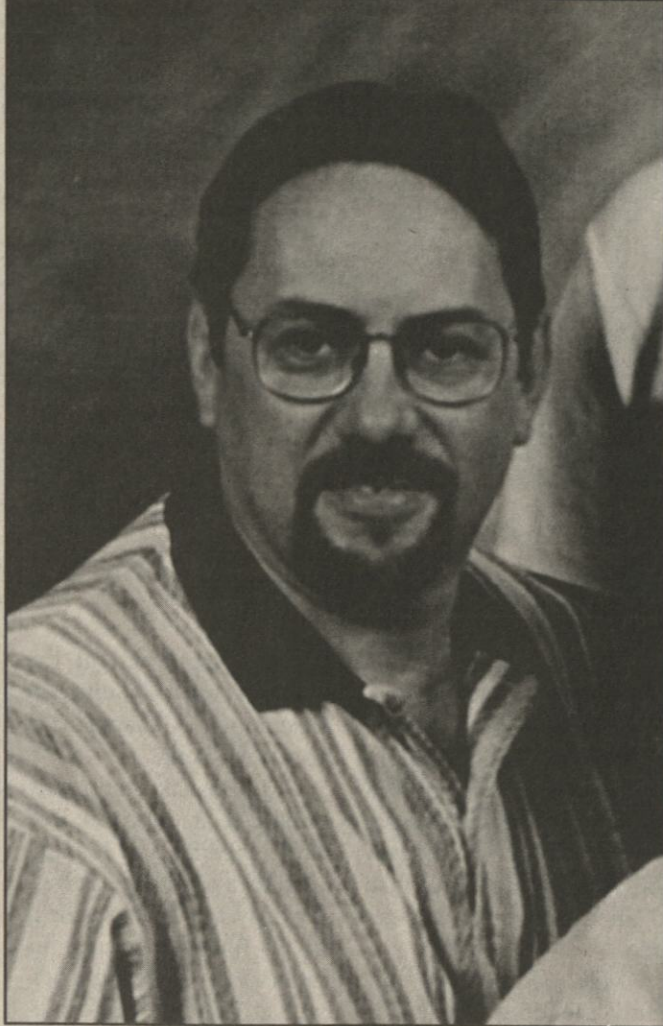

## Southern Cornerstones

**Annie Terry Guards

Anna L. Terry, daughter of Wiley B. and Mary Gooch Terry, was a young lady who entered into the cause of the Confederacy with great zeal. Her father was a wealthy merchant and planter in Eastport, Miss., where Anna was born on April 3, 1839. With generous zeal for the Confederacy and at her own expense, Anna equipped a company of troops commanded by Capt. H. C. Hyneman. This company became a part of the 26th Mississippi and proudly called themselves the "Annie Terry Guards," in honor of their young patroness who lovingly prepared their uniforms. The Annie Terry Guards were sent to Fort Donelson where they entered combat for the first time. They were in the thickest of the battle and many were killed and wounded. Capt. Hyneman was mortally wounded and died a short time afterwards. The remainder of the regiment was captured and sent north, but the soldiers were soon exchanged and sent to join the Virginia Army to fight with Lee and Jackson.

The defeat of the Confederacy and the destruction of property drastically changed circumstances in the lives of Tishomingo County people. The entire readjustment of life demanded courage such as the war itself had required. Annie was a woman of education and a true Southern belle. This petite woman was vivacious, and she never grew old in her courageous zeal for life.

On January 8, 1862, Annie had married Captain Dew M. Wisdom, a gallant younger officer of the 13th Tennessee Regiment. After the war, she went to live in Jackson, Tenn., where her husband held various offices of public honor and trust. From there the family moved to Fort Smith, Ark., where her husband became part owner in a newspaper there. Then, in 1885, the family moved to Muskogee, Okla., when Col. Wisdom accepted the job of chief clerk at the Indian Agency.

Always zealous in her interests, Annie threw herself into Muskogee history and the social events of that era. The three sons of Anna and Dew Wisdom, William D. Wisdom, James Fentress Wisdom, and Wiley Terry Wisdom, became prominent in Muskogee.

Annie was devoted to her church, home, and family. She died January 21, 1907, in Muskogee and was buried in Greenhill Cemetery.

## Conservation Corner

### Baldcypress

For the record, the official state tree of Mississippi is the magnolia but a baldcypress tree, draped with Spanish moss and growing around an old bayou or along one of our many scenic rivers and streams, seems symbolic of the South.

Baldcypress, (*Taxodium distichum*), is a Southern conifer most often found in wet sites, in pure stands or mixed with tupelo gum. The fibrous, scaly bark of baldcypress is reddish brown in color and turns gray near the surface. The leaves of baldcypress are

1/2" to 3/4" long, linear to lanceolate and two-ranked along branchlets that are deciduous along the leaves.

Baldcypress can reach heights of up to 150 feet and diameters of up to 12 feet. Dendrological cross-dating has confirmed baldcypress at up to 1,700 years of age, and there are unconfirmed ages reaching 2,000 years. Baldcypress trees growing in water usually have a fluted trunk. The roots produce cone-like projections above the water or soil surface known as cypress knees.

Baldcypress is best suited to nutrient rich

sediments typical of the soils found around streams and river systems. Baldcypress grows slowly in the less fertile soils of black-water swamps and bayous. Baldcypress seeds will not germinate under water, and on drier sites, competition from more shade tolerant species limits baldcypress numbers.

Baldcypress is widely distributed throughout the Southeastern United States. Along the Atlantic Coast, baldcypress can be found from Delaware to Southern Florida and along the Gulf Coast from Florida to South-eastern Texas. Inland

distribution includes the Lower and Upper Coastal Plains of the Mississippi Valley up into Southeastern Oklahoma, Southern and Eastern Arkansas to the Missouri Bootheel and into Southern Illinois and Indiana.

Baldcypress heartwood is well known for its great durability. Wood duck boxes and other bird houses that are subjected to weather are commonly made from baldcypress because no other wood can withstand such harsh elements.

Baldcypress is a favorite tree used in landscaping and is being introduced into many parts

of the world. In the wild, the seeds of baldcypress are eaten by numerous species of birds, as well as the black bear. Eagles and osprey often use older trees as dens and nest sites.

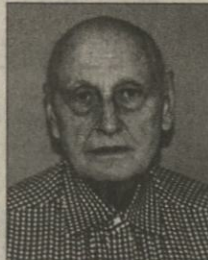

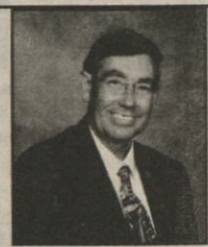

## Four Things That Are Never Satisfied

Our generation seems to have its share of dissatisfaction! It seems that most people want just a little more money; just a little more free time; just a little more information etc. The Bible is the greatest sourcebook in the universe for answers to our major questions, as well as for our minor curiosities! Proverbs 30:15-16 says: "The horseleach hath two daughters, crying, Give, give. There are three things that are never satisfied, yea, four things say not, It is enough; the grave; and the barren womb; the earth that is not filled with water; and the fire that saith not, It is enough." The horseleach is a blood-sucking leach; its two daughters never get enough, picturing the dissatisfaction of people, who are never satisfied, no matter what they can draw out of life!

Next we see four things that illustrate the dissatisfaction of human beings. First, we see the grave that is never satisfied, for its insides are filled with deadness. This pictures the deadness inside the hearts of human beings who have never come to Christ for life! Second, we see the barren womb, which pictures the emptiness of human life without the life of fellowship with God. Most of the world is dead and empty, yet most people are not aware of their real problem or how to solve it! Third, we see the

earth that has such a thirst for water that it never says, "I have had enough water". This pictures the thirst that is never quenched, although great volumes of "water", that is supposed to quench thirst, are consumed. If your name has been denied ask them how you need to sign this petition. Then sign it and fill it out right and mail it back to me. The circuit clerk's office phone number is 423-7026. I want to thank everyone that has signed the petition. This is why we need to legalize the sale of alcohol in Tishomingo County.

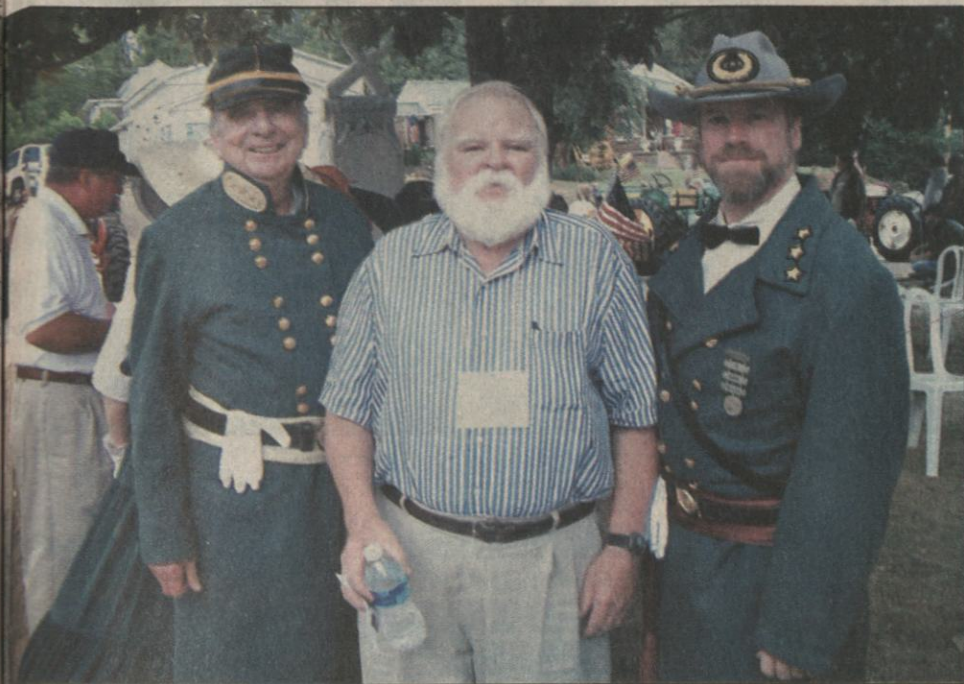
