## Belmont Woman Charged with Murder for Hire

After a week-long investigation, special agents of the Mississippi Bureau of Investigation (MBI) arrested 35-year-old Mary Elizabeth Newman of 12 Old Highway 25, Belmont, Mississippi. She has been charged in connection with a murder-for-hire scheme. Newman hired a hit man as part of a plot to have her husband killed.

"Our agents from the New Albany District developed information about the scheme and arrested Newman about 4:00 p.m. Wednesday, October 17th in Tupelo," MBI Director Colonel Larry Waggoner said.

Newman has been charged with conspiracy to commit murder and is being held in the Lee County Detention Center on \$100,000 bond.

## Development & Tourism Officials Urge Voters to Approve One-cent Restaurant Tax

Development officials are urging county voters to approve a one-cent restaurant tax that will be on the November 6th ballot.

The Tishomingo County Development Foundation requested the county board of supervisors to put the measure on the ballot, and it will only pass if 60 percent of the voters approve the extra penny tax on food sold at restaurants in the county.

"We've been needing this for a long time," explained TCDF Board President Neil Davis at a recent industry ribbon-cutting event. "Compared to other counties, and even cities, we

are not only not doing what we should, we are falling behind."

Development professionals have, for many years, said that tourism is one of Tishomingo County's strongest prospects for industry, and we don't capitalize enough on strengths like two state parks, and hundreds of miles of lake-front property.

Despite efforts at advertising the county with a meager \$16,000 budget, many people still are heard to say, when visiting, "I never even knew this was here!"

Even one ad in a magazine like Southern Living costs thousands, and neigh-

boring states and counties spend thousands, and millions of dollars more enticing tourists to visit. In 2010, Oxford had \$1,925,141 in gross tourism tax revenues to spend; New Albany had \$548,278; and Tishomingo County had \$16,213.

The Mississippi Development Authority reports that tourists spent more than \$12 million in Tishomingo County in 2011, and that tourism accounts for 180 jobs in the county.

The spending and jobs are a tiny fraction of the potential, and they hope with the passage of the penny

restaurant tax to increase both, and bring additional jobs and spending.

Officials initially expected to get approximately \$80,000 annually from a one-percent restaurant tax on all restaurants in the county. But the legislature produced a bill that included only restaurants that can seat more than 25 people, and estimated figures are not available yet on expected income, should the tax pass, said TCDF representatives Wednesday.

The county currently only uses income from a 2 percent lodging tax to promote industry, attract development investors and promote tourism.

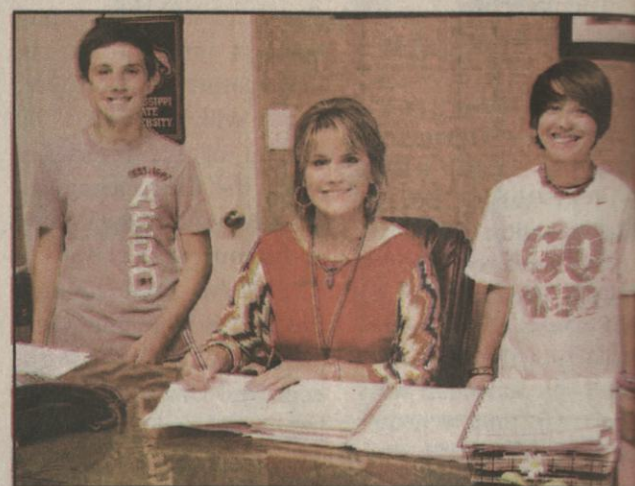
This race is a way for the Food Depot to not only raise money for the holiday season and beyond, but to support healthy living in our area through exercise.

## Bullock-Durham To Wed October 27th, 2012

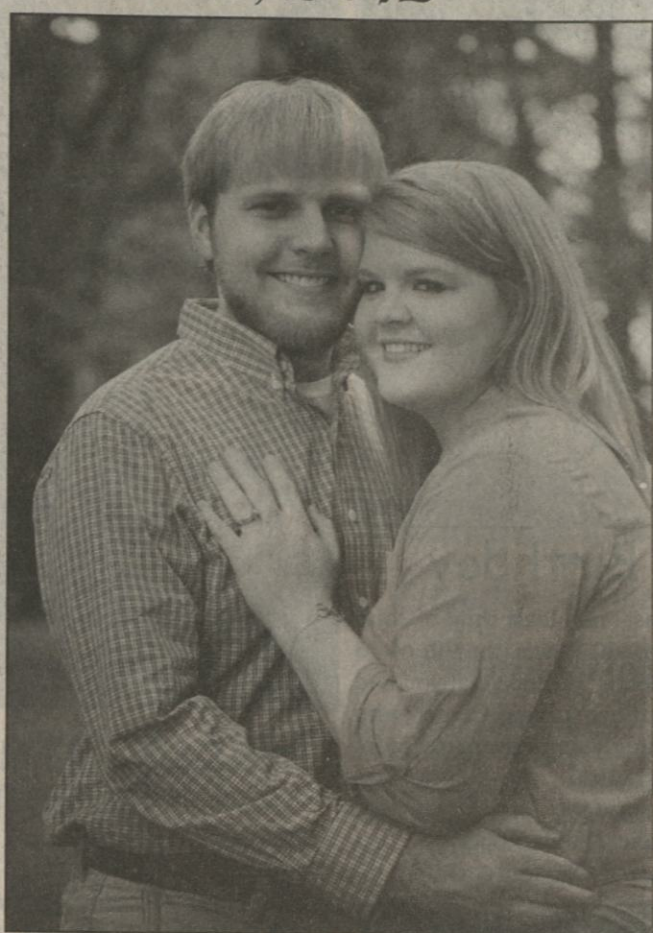

# Little Metal Suitcase Finds Home at National World War I Museum in Kansas City

On August 6, 1932, Gold Star Mother, Julia C. "Carrie" Underwood boarded a train at the Iuka Depot for a once in a lifetime trip to France. Her son, Pvt. Henry A. Underwood was killed in action July 21, 1918, and buried in France. The Government was honoring all the Gold Star Mothers by sending them to France so they could see the final resting place of their sons.

Carrie wanted to remember everything about her trip, so she kept a daily journal so she could tell her family everything she saw and did. She also kept any and everything that pertained to her trip. There were over a hundred items, including menus, shopping receipts, hotel and ship info, a silk bag of French soil, postcards, pictures, dried flowers, and even the party hats and horns from the parties they were given while on the ships. She stored all this in a metal suitcase, along with her passport, gold star pin, gold star metals, all mail & telegrams pertaining to the trip, and letters from home.

It was obvious by Carrie's yard on Mill Street that she loved flowers, so she wrote about all the beautiful flowers along the way to New York. She hated to sleep, wondering what all she would miss. While in New York, the mothers were taken to museums and other points of interest. She said she did not know there were so many different

kinds of people when they went thru Chinatown. She talked about the stairs you step on and they take you to the top, then you step off.

They sailed out of New York on Aug. 10th. In France, the mothers were put on buses that had a big gold star on it. The French people welcomed them warmly, waving their

hats and yelling when they saw the bus coming. The mothers would march by two through some of the churches while music played softly. The French said they would never forget the American boys coming 3000 miles to save their homes. The mothers got to meet a French woman that hid some American sol-

diers. She said they ate all her chickens and drank all her wine. Carrie thought that maybe her son was one of them. The war was won, but the mothers lost the battle, Carrie said in her notes.

While in France, the mothers were taken to many more museums. Carrie saw things she had not even imagined. She was served food she had never eaten. She did not like the hard French bread, and said she had not had a decent biscuit since she left Iuka. And she was shocked that the bread was carried like firewood, unwrapped, by shaggy dirty little boys.

It was a five week trip, and Carrie was homesick and ready to be back in Iuka. "Oh, that sweet word, home," she said. The depot was full of family and friends, welcoming Carrie back home.

Mae Hayes, Carrie's granddaughter, knew the importance of her Grandmother's little metal suitcase and kept it for years, finally giving it to her daughter, Martha Couch.

After her mother's death, Martha went through the suitcase contents several times.

She wondered if anyone else had anything like this and thought that it may be just one of a kind. It should not be sitting in a closet, and should be where it could be viewed by everyone. She contacted the Smithsonian in Washington, D. C. and sent them pictures.

They said if they took

it, it would most likely be stored. And that the best place for it was the National World War I Museum in Kansas City, MO., which was built in 1920.

In September, Martha and her husband Marion took the suitcase and a picture of Henry A. Underwood in his uniform to the museum in Kansas City. All the materials were gladly accepted by Doran Cart, Senior Curator of the museum. He sat down with the Couches and looked at every item. He found things that he did not know existed. He was amazed at the

perfect shape the ribbons were in on the metals. He said the few metals they had, the ribbons were frayed or missing. He laughed when he saw the little note where Carrie was figuring out her US currency to francs. He noted that there was even a vegetarian meal on one of the menus. He said everything would be preserved, including the cedar cutting from the cemetery.

Martha has copied the journal and has shared it with many of the Page and Underwood family.

### How Important Are Good Speeches?

In a day of trained speakers and polished speeches, it is not hard to find those who can deliver well organized speeches and move crowds of people to respond in a favorable way. It is often another thing, however, to find people who are willing to act out in everyday life what they are telling others to do. In Deuteronomy chapter 5 we have the record of God's giving

of the 10 commandments to Israel. When Israel had heard God speak audibly and give the words of the 10 commandments, they said the words of Deuteronomy 5:27 to Moses:

"Go thou near, and hear all that the LORD our God shall say: and speak thou unto us all that the LORD our God shall speak unto thee; and we will hear it, and do it." Now this sounds like the kind of people that every pastor would love to have in his flock, but before we get too excited about the vowed obedience of the nation of Israel, we probably need to read a bit fur-

ther. Moses responds in verse 28: "And the LORD heard the voice of your words, when ye spake unto me; and the LORD said unto me, I have heard the voice of the words of this people, which they have spoken unto thee: they have well spoken all that they have spoken."

Now we have God saying that He has heard all of Israel's words, and they sound good to God, but the story is still not quite finished, for God had something else to say in verse 29: "O that there were such a heart in them, that they would fear Me, and keep all My commandments always, that it might be well with them, and with their children for ever." God has a great desire that people do what they promise! I think I can hear the hurt in the heart of God, when He says that He wishes Israel had

a heart to fear and obey Him in the way they have promised. The big thing here is that God is looking out for the welfare of Israel, for He wants things to go well with them and their children forever. When we disobey God, we do not always think about the affect our disobedience will have on those who follow us. I could cry right now for the careless attitude many Americans have concerning the generation that is to follow us, if indeed we have another one! It seems that many people are living for themselves, for this day, and have little concern about tomorrow, for themselves or anyone else. There is no need to speak of loving God, family or anybody else, if we are so selfish that we do not care what happens to those around us and those who will come after us!

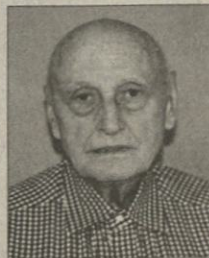

## Time to Observe "Save for Retirement Week"

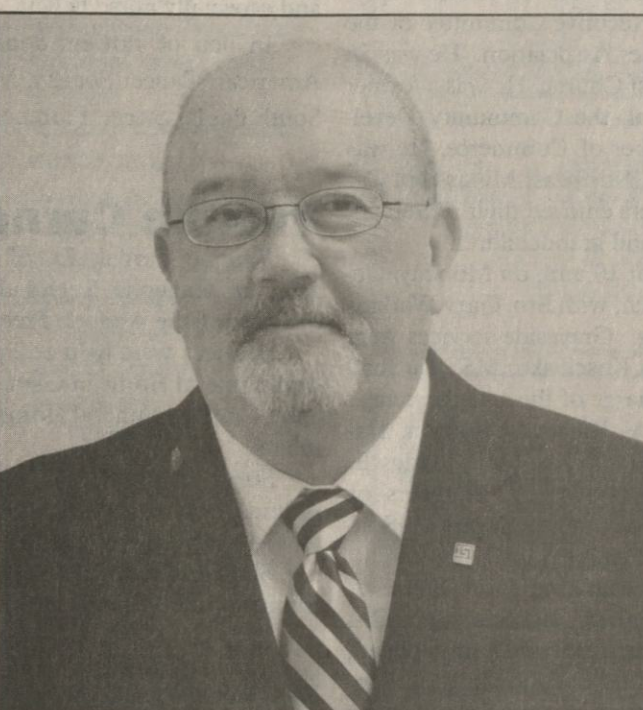

Farmers are baling hay, not the old fashioned way, but with huge equipment.

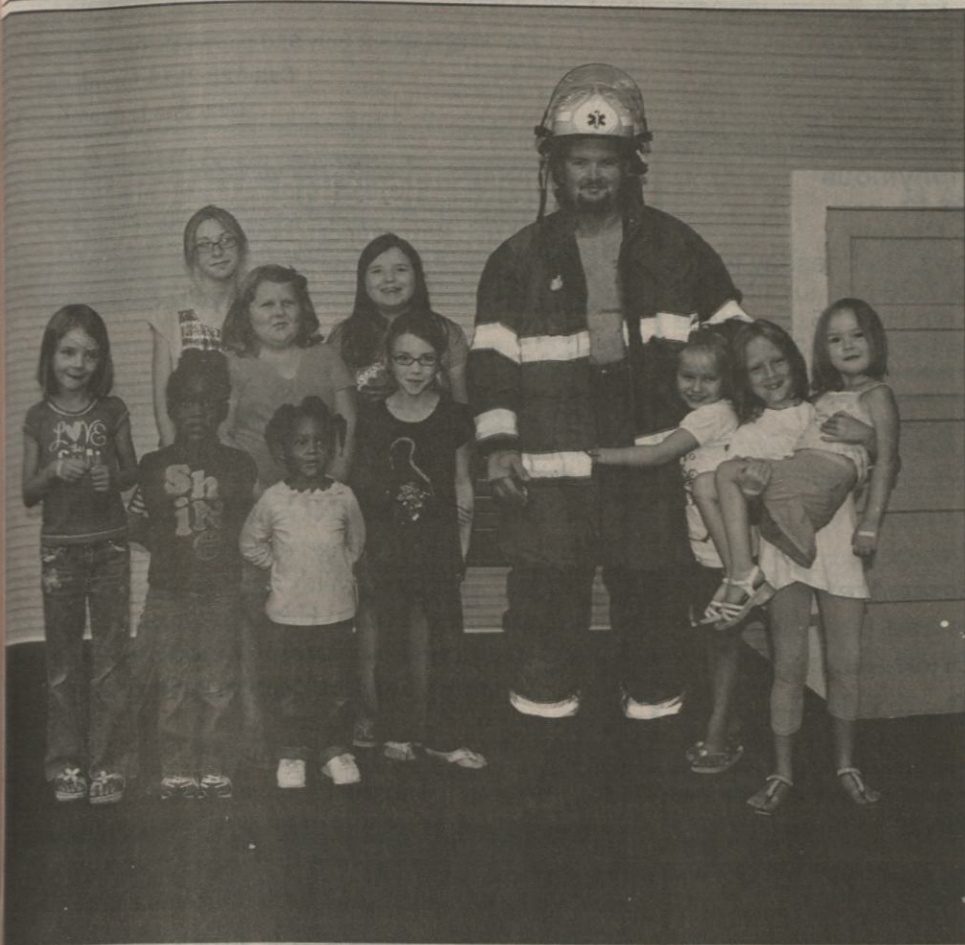

## New Equipment Will Make School Meals Healthier For Students

As part of a comprehensive effort to improve student health, Tishomingo County Schools has installed new kitchen equipment. Using Nutrition Integrity grant from the Mississippi Department of Education Office of Child Nutrition, funded by The Bower Foundation, the schools have replaced existing deep fryers with steamers. This healthy change is made possible by the Nutrition Integrity grant from the Tishomingo County School District received May 2012.

A combination oven steamer uses super-heated steam to cook foods with less saturated fat, and trans-

fat," says Nutrition Director Teresa Stanford. "Since school meals are such an important way to insure that our children are fit, healthy, and ready to succeed, we want the foods we serve to be as nutritious and appealing as possible." For example French fries that are baked instead of fried have 17% less calories, 55% less total fat and 34% less saturated fat than fries that have been deep fried! The new equipment will help the food service staff improve the thousands of breakfasts and lunches served every month to the students and staff in our cafeterias in Tishomingo County Schools.

Installing new kitchen equipment and lower-fat cooking methods are two of the many ways that our school district is focusing on the health of our students. "We recognize the critical connection between good health and success in the classroom," says Teresa Stanford. "In addition to replacing our fryer with this new oven steamer, our school wellness policy includes commitments to nutrition, physical activity, comprehensive health education. Our goal is to institute healthy choices for each member of our student body and staff."

## Look at what Bay Springs Resort is talking about doing.

Dennis, MS (WTVA)- Remember all that talk about a \$300 million resort to be built at Bay Springs Lake?

That development has yet to materialize. Four years after the announcement, spades have yet to hit dirt in Tishomingo County. Scott Eubanks owns a grocery store in Dennis. His close proximity to Bay Springs Lake helps him out. He is among those who hope to one day see the opening of a development there. "There was quite a bit of excitement-kind of like when we had the Yellow Creek come in and the rug was pulled out from under that so, people were a little skeptical to begin with and still are," Eubanks said. They were skeptical that anyone would come in with a development that would include a luxury hotel, golf course; hundreds of luxury cabins and even a place to land sea planes.

Since the development was first announced in 2008, resort status was granted by the Governor's office. It would allow for alcohol on the premises even though Tishomingo County is dry.

In March, 2010 company officials said they were still trying to secure financing-all this during a time when the national economy was in a downturn. Watching all this closely is Lanny Virden-a man who makes his living on outdoor activities. He remains hopeful that a development of some sort will materialize. "It meant a lot to them and there is still hope out there with the public that something will come along; something will break loose and the resort and everything will come in. I know the economy in Northeast Mississippi could really use it," Virden said. Also concerned is Belmont business owner Jim Byram. "It would be a great disappointment for me and I think a majority of the people in and around Belmont," Byram said. Tishomingo County Development Foundation officials are tight-lipped about the status of the project. They have declined to comment on the story. The question remains. Where does the project stand? One source close to this situation tells WTVA the current economic conditions will not support this project at this time. They say funding has dried up. We reached out to developer Doug Martel. He tells WTVA he is considering a news release on the subject to be issued next week.

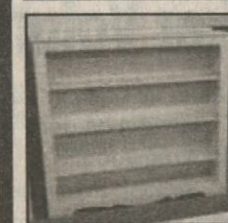

**RESOLUTION OF TISHOMINGO  
COUNTY BOARD OF SUPERVISORS  
TO PLACE 1% TOURISM TAX ON  
NOVEMBER BALLOT**

Be it resolved that the Tishomingo County Board of Supervisors met on the 15th day of June, 2012 and at said meeting considered the request made by the Legislative Delegation representing Tishomingo County, Mississippi in the Mississippi Legislature and the Tishomingo County Economic Development Foundation's request to impose a 1% tax on the gross proceeds from the sales of beverages and prepared food at restaurants pursuant to House Bill No. 1551 with said tax proceeds being used for purpose of promoting tourism with Tishomingo County, Mississippi, Being considered, the Tishomingo County Board of Supervisors do hereby find and resolve as follows:

Be it resolved that the Tishomingo County Economic Development Foundation requested that the Tishomingo County Board of Supervisors seek a Local and Private Bill in the 2012 Legislative session of the Mississippi Legislature authorizing the imposition of a 1% Tourism Tax to be levied upon the gross proceeds derived from prepared food and beverages sold in Tishomingo County, Mississippi with said Tax being used for the purposes of promoting tourism within Tishomingo County, Mississippi. The Board of Supervisors requested and received the same from the Legislative Delegation that represents Tishomingo County, Mississippi and House Bill No. 1551 was passed and signed into law by the Governor for the State of Mississippi authorizing the Tishomingo County Board of Supervisors to provide Notice of Intent to Levy said tourism tax and to provide for the same to be placed on the ballot to be decided by the voters of Tishomingo County, Mississippi.

Be it resolved that the Tishomingo County Board of Supervisors intends to levy a 1% tax upon every person, firm or corporation operating a restaurant in Tishomingo County, Mississippi on the gross proceeds from the sales of beverages and prepared food at restaurants beginning on December 1, 2012, if approved by the voters of Tishomingo County, Mississippi on the November 6, 2012 general election date.

Be it further resolved that the Circuit Clerk for Tishomingo County, Mississippi shall take all action necessary to place the referendum on the November 6, 2012, General Election Ballot to allow the voters of Tishomingo County, Mississippi to approve or deny the implementation of said tax as described in House Bill 1551 as signed into law by the Governor. The Circuit Clerk shall publish said Referendum Election on the Tourism Tax in advance of said election as required by the Statute being once a week for at least three consecutive weeks in a paper published or having general circulation within Tishomingo County, Mississippi with the first publication of the notice to be made not less than twenty-one (21) days before the date fixed in the resolution for the election and the last publication being not more than seven (7) days before the election. Additionally, the referendum on the 1% Tourism Tax to be implemented, if approved by the Voter's, shall be in the form as prescribed by the Statute and shall read, "For the Tax" and "Against the Tax" to allow voters to clearly identify their intentions on the ballot when cast.

Be it further resolved that the Tishomingo County Board Attorney shall submit this resolution of Intent to Impose 1% Tourism Tax and the Referendum Election thereon to the United States Justice Department - Voting Rights Division for pre-approval as provided by the Voting Rights Act of 1965, as annotated and amended.
