Arson Suspected at Two Saturday Morning Fires

An Iuka office and a lake home owned by an Iuka attorney both burned within hours of each other early Saturday morning, and investigators have offered a \$5,000 reward for information leading to the arrest and conviction of the people who caused the fires.

Iuka Fire Chief Brian Grissom said that a neighbor called to report a fire at the law office of Tacey Clark at 311 Eastport Street in Iuka about 4:30 a.m. Saturday morning. Units from Snowdown, Eastport, Burnsville, Midway and Burnsville responded to the fire. The Iuka unit left the scene at 7:48 a.m. Saturday, Eastport, Snowdown and Pleasant Hill responded to the reports of a fire on 3 County Road at Mill Creek. By the time they arrived, the approximate-

ly 3,500-square-foot A-frame home built of cedar and cypress was already burned up beyond saving, said Iuka Fire Chief Grissom. According to Iuka Police Chief Randy Stringer, the Iuka Police are hoping to speak with the owner of both structures, Tacey Clark, but had not been able

to at press time. The fire marshal investigated both scenes on Monday and told Iuka Police that arson is confirmed as the cause at the Eastport Street fire; there were two confirmed points of origin downstairs in the basement and one "area of origin" upstairs. At the lake house fire, the

cause is "undetermined," which may be due to the total destruction of the home by fire. Both structures were unoccupied at the time of the fires. The 311 Eastport Street location has been the Tacey Clark Law office for the past several years. Before that it was the headquarters of Rusty Walker

Programming, and before that, a radio station for many years. It was built in 1948 as the Iuka Church of Christ until that church relocated to the current location on Old Highway 25, Battleground Drive. According to investigation, Ms. Clark bought the lake home in 2012. It was built in 1979.

Iuka Pharmacy Burglarized

Iuka Police are looking for a person or persons who burglarized Barnett Apothecary last Friday. According to Iuka Police Chief Randy Stringer, about 10 p.m. Friday morning, someone broke out the front door of the drugstore on Battleground in Iuka, and managed to steal an undisclosed amount of

many various pharmaceutical items, including narcotics. An alarm went off, and when business owner Steve Barnett arrived, city and county officers were on the scene. The suspects were likely only in the store a few minutes. Barnett said that he has increased his security system substantially since the break-in.

Legislature OKs Borrowing \$250 Million; Including \$300K for Tishomingo County Ag Center

As the legislature closes down the 2016 session, leaders and both houses came to agreement on borrowing money to fund several infrastructure, education and tourism-related projects throughout the state including \$300,000 for a proposed agricultural center in Tishomingo County. According to Representative Lester "Bubba" Carpenter, the money is for an equine/agricultural center similar to that in Prentiss County, which regularly presents horse shows, and other livestock events, to the benefit of the local area. It would be a joint venture between Northeast Mississippi Community Col-

lege and Tishomingo County, said Carpenter, who indicated a movement to have such facilities throughout the state. He said Lowndes County is getting one, too. "It would be a multi-purpose facility that could be used for many events," explained Carpenter. He said that the \$300,000 is a statutory bond that will be forgiven over time, and that a requirement is that the facility be built on land the county already owns - the money can't be spent to buy land. Some reports have come out that the center would be built on county-owned land near Tishomingo. Fourth District Supervi-

sor Jeff Holt said there is indeed a prime location of 47 acres just north of the town, but that the Board of Supervisors has not even discussed that. The land is currently advertised as a potential industrial park location and was the former location of a Bonds Co. plant. With millions of dollars of investments and industries locating in Burnsville, Iuka and Belmont in recent years, it would be a chance for Tishomingo and the Fourth District to get some of the county's development attention.

68 Atlas V, 28 Delta II and 404 Delta IV large composite structures across 104 ULA launches. The 500th structure is a boat tail for a ULA Atlas V launch vehicle that was manufactured with zero defects.

"This is a very special occasion for all of us and a remarkable accomplishment," said Steve Earl, Vice President and General Manager of Orbital ATK's Aerospace Structures Division. "This milestone speaks to the commitment, dedication and diligence of each and

Other local projects that would benefit include improvements to the Ridge Road between Itawamba and Tishomingo County, in Senator J.P. Wilemon's district.

The deal on House Bill 1729, part of a larger negotiation over borrowing, tax credits and tax cuts, includes money for construction projects at universities, community colleges and other tourism

related spending.

Lt. Gov. Tate Reeves had said last week that he was seeking to hold the borrowing total to about \$200 million, but House leaders pushed for more in negotiations.

Food Depot Yard Sale







Corinth Warriors jumped out to an early 2-0 lead in the top of the first.


In the second, the Braves scored on an RBI single by Moss, bringing home Caleb Gardner and getting the Braves on the board.

Pastor's Tidbits

A Glimpse Into Heaven (part II)

It is not hard to get the attention of most people when one speaks about things he has supposedly seen in heaven, but it is quite another story to get people to read the Bible to see what God really says about heaven. It is impossible to check out the stories written in books about those who say they have been to heaven and back, especially when none of them seem to square with the Bible. It is not impossible to learn much about heaven from the Book we know as the inspired Word of God, the Bible! Revelation 4: 7-8 says, "And the first beast was like a lion, and the second beast like a calf, and the third beast had a face like a man, and the fourth beast was like a flying eagle. And the four beasts had each of them six wings about him; and they were full of eyes within: and they rest not day and night, saying, Holy, holy, holy, Lord God Almighty, Which was, and is, and is to come." There are at least two kinds of angels mentioned in the Bible: one group being called cherubim (Ezekiel 10:20), and the other being called seraphim (Isaiah 6:2-3). The seraphim of Isaiah 6:2-3

seem to be the same angelic beings as those of Revelation 4:7-8, for both groups are said to have six wings and both to have continually about groups cry continually about the holiness of God. The cherubim mentioned in the first ten chapters of Ezekiel are also called "living creatures" (see especially Ezekiel 1:5). So, the "beasts" of Revelation 4:8-9 are not beasts as we know them, rather they are living creatures (angels) called seraphim in Isaiah 6:2-3. The faces of the "beasts" of Revelation 4:7-8 seem to represent God's earthly creatures: the lion, calf, man and eagle. In Ezekiel 1:10, we learn that the cherubim (angels) there have the following faces: man, lion, ox and eagle, but Ezekiel 10:14 says they had the following faces: cherub, man, lion and eagle. It may not be likely that this will figure out all that this means, but we can know that God is concerned about both heavenly creatures (cherubim) and earthly creatures, including both domestic and wild animals.

In Revelation 4:8-9 we learn that the angelic creatures in heaven are full of eyes within, evidently indicating their great knowledge of what is around them. We also learn that they do not rest "day or night" (to use our language), since heaven does not have day and night; they are continually in the presence of His being and His is Almighty. All of us can afford to think on this while, for the angelic creatures say that God is completely holy, meaning He is completely set apart from all evil, or sin. The angels also speak about the fact that God is all powerful, nothing that He will do is impossible with Him. These heavenly creatures that God is eternal, "was, and is, and is to come." It is impossible for humans to comprehend eternity; it is not impossible for us to believe the Bible's description of the fact that God is eternal. By the way, the things that are said about God by listening to His angels proclaim the about Who He is, and would be far ahead of any book that men or women have written, or had written about any "trips to heaven and back!"







It is necessary and desirable that a maximum of Two Million Seven Hundred Fifty Thousand and No/100 Dollars (\$2,750,000.00) be borrowed for the purposes of making repairs, alterations and additions to school buildings of the District, for the purpose of erecting school buildings and other buildings used for school purposes, purchasing heating plants, air conditioning, fixtures and equipment for such buildings, purchasing land for school purposes, purchasing school buses and transportation equipment, improving and equipping such lands for school recreational and athletic purposes, refinancing outstanding debt and paying the costs of such borrowing (the "Project");

2. No funds are available in the school funds of the District or from any other source with which to pay the costs of the Project;

3. It would be in the best interests and to the advantage of the District that the funds needed for the Project be obtained by the issuance of notes of the District in the maximum principal amount of Two Million Seven Hundred Fifty Thousand and No/100 Dollars (\$2,750,000.00) (the "Notes") in the manner and form provided by Section 37-59-101, et. seq., of the Mississippi Code of 1972, as amended (the "Act");

4. An annual levy of a special tax which shall not exceed three (3) mills on the dollar of assessed value of taxable property within the District, along with any other funds the District may pledge, shall be sufficient to pay the principal and interest on the Notes to be issued hereunder and all other notes issued and outstanding under the Act, as the same shall respectively mature and accrue.

5. Under the provisions of Section 37-59-115 of the Mississippi Code of 1972, as amended, the limitation of Section 37-59-5 of the Mississippi Code of 1972, as amended, on the indebtedness which may be incurred by school districts is not applicable to the proposed issuance of the Notes;

6. The purposes for which the proposed Notes are to be issued as herein set forth in this resolution are purposes authorized by the laws of the State of Mississippi, and particularly in Section 37-59-101, et. seq., of the Mississippi Code of 1972, as amended, and the Board is authorized and required to declare the necessity and its intention of borrowing money and issuing the Notes of the District as evidence of the same.

7. Pending the completion of the Project plans and specifications and the issuance of the Notes, the District needs to pay certain expenses incurred in connection with the performance of the Project, with such expenditures to be reimbursed from the proceeds of the Notes, when issued.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of the Tishomingo County Special Municipal Separate School District, as follows:

Section 1. The Board does hereby find, determine and adjudicate that the foregoing premises are true and correct.

Section 2. The Board does hereby declare that it is necessary to borrow an amount not exceeding Two Million Seven Hundred Fifty Thousand and No/100 Dollars (\$2,750,000.00) for the purpose of paying the costs of the Project, previously described herein, all at a total cost approximately equal to the principal amount of the Notes to be issued hereunder.

Section 3. The Board does hereby further declare that no funds are available in the school funds of the District or from any other source with which to pay the costs of the Project, and that it is necessary that the costs thereof be borrowed in the manner and form provided by Section 37-59-101, et. seq., of the Mississippi Code of 1972, as amended.

Section 4. The Board hereby declares its intention to borrow such money and to issue the Notes as evidence of the same. The Notes shall bear interest at a rate to be specified by further resolution of the Board, but shall not exceed a greater overall maximum interest rate to maturity than the rates now or hereafter authorized under the provisions of Section 19-9-19 of the Mississippi Code of 1972, as amended. The Notes shall not be sold for less than par and accrued interest. The Notes shall be dated their date of delivery and shall mature over a period not to exceed ten (10) years, with the first installment of principal and/or interest thereon to be made within one year from the date thereof.

Section 5. That unless a petition signed by 20% of the qualified electors of said District, requesting that an election be called on the question of incurring said indebtedness, is filed prior to 6:30 p.m. on May 9, 2016, in the Superintendent's Office of the District located at 1620 Paul Edmondson Drive, Iuka, Mississippi or at the Board meeting at the Tishomingo County High School located at 701 Highway 72, Iuka, Mississippi, final approval of the borrowing of said money and authority for the issuance of said Notes shall be given by the Board at a meeting held on such date and hour at the aforesaid address.

Section 6. The Secretary of the Board be and is hereby authorized and directed to cause this Resolution, as adopted, to be published in the *Tishomingo County News*, a newspaper of general circulation in the District and qualified under the provisions of Section 13-3-31 of the Mississippi Code of 1972, as amended. Said Resolution shall be published once a week for two consecutive weeks, with the first publication thereof to be made not less than 15 days prior to May 9, 2016, on which date the Board will take final action on the question of authorizing the borrowing of said money.

Section 7. The District shall use funds currently available in its District Maintenance Fund to pay certain initial costs of the acquisition and construction of the Project, as subsequently identified by the Board, with such expenditures to be reimbursed from a portion of the proceeds of the Notes, when issued. The allocation of the Note proceeds to reimburse the District Maintenance Fund shall be made in writing not later than 18 months after the later of: (a) the date the original expenditure is paid or (b) the date the Project is placed in service or abandoned, but in no event more than three years after the original expenditure is paid. The expenditures to be reimbursed from the Note proceeds shall be incurred solely to acquire, renovate, construct, or improve property having a reasonably expected economic life of at least one year and to pay the cost of such acquisition, construction and improvements. The Note proceeds shall be used to reimburse these expenditures, and not for the reimbursement of operating costs or similar working capital items. This resolution is the official action of the Board adopted as required by regulations promulgated by the Internal Revenue Service governing the reimbursement of prior expenses from note proceeds.

Section 8. That all orders, resolutions or proceedings of the Board in conflict with the provisions of this Resolution shall be and the same are hereby repealed.

Having received a majority of the affirmative votes of the Board, the Resolution passed on April 11, 2016.
