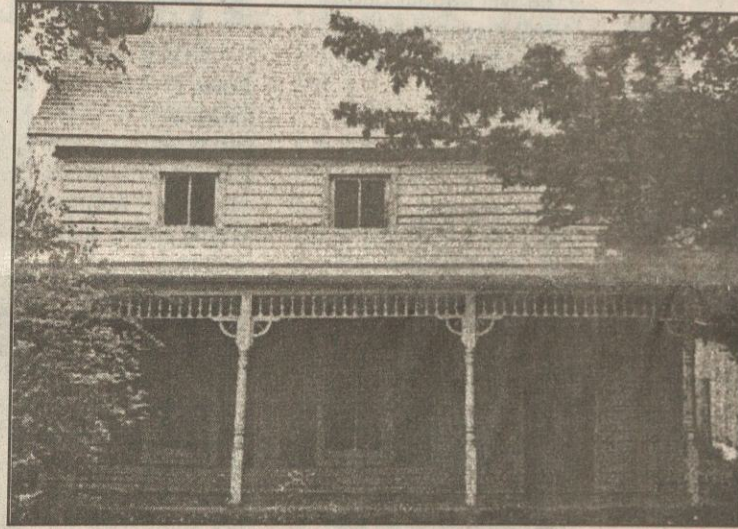
The pre-Civil War structure had been remodeled many times over the years. The old wooden boards had been covered with cedar siding making the outside walls hard to burn.

## Historic Stagecoach House Burns

The historical Stagecoach house in Iuka caught fire around 11:15 a.m. Thursday morning on March 22nd. The pre-civil war house standing at the corner of 11th Street and Main Street, was renovated and vacant at the time of the fire. It has been used as a storage house for many years.

The family living nearest the house was alerted to the fire when their cat started acting strangely, as though it wanted to go outside. When they let the cat out in the early morning hours they noticed the flames and called the authorities.

According to Iuka Fire Chief, Brian R. Grissom, the fire has been ruled as accidental. "The power was connected and had been on for a week or so. Several previous renters had reported smelling something on the house. The maintenance people were never able to locate the source because the smell would come and go. There were also reports that rodents had chewed wires in the attic. No indication of an incendiary was found. The firemen went to great efforts to preserve this historic structure. They did make entry multiple times even after I suggested backing out because of safety



concerns. Due to the fire and the massive amount of water the upstairs floor was so weak it was like trying to walk on a mattress. I am very impressed that we were able to save as much of the structure as we did and not have any damage to the structures in close proximity. In my opinion the lower floor of the two story portion of the structure is salvageable. That is a choice the owner will have to make." Grissom went on to comment, "I'm thankful to live in a community where people are concerned about our historical landmarks."

The Stagecoach House is one of Iuka's oldest residents.

The history of the home is somewhat obscure. The only information about the house available at the time of press was an excerpt from the "Heritage Day" edition of the Tishomingo County News- Vidette from 1988.

"This home was believed to have been moved from Eastport around 1853. It was the first stop on a stage coach route that ran from Eastport to Tupelo. The first recorded deed at the Iuka Courthouse was in 1868 to a Wood's family. Other prominent citizens living in the house were the Millsaps, Harveys, Ligons, Vinsons, Lintons, and Crawfords."

## Former Sheriff Richard Dobbs Dies Unexpectedly

A Former Tishomingo County Sheriff, Richard Dobbs died unexpectedly on Sunday March 25th in Iuka. Funeral services will be held on March 27th at 3 p.m. at Ludlam Funeral Home in Iuka.

Richard Dobbs was visiting his wife at Southern Magnolia Assisted Living which he did for a nurse went in to check on Mrs. Dobbs at 6:40 a.m. and found Mr. Dobbs unresponsive on the floor. He had arrived earlier to feed Becky her breakfast and died of natural causes.

Dobbs served as sheriff of Tishomingo County from January 1988 until 1992.

Richard Oryan Dobbs was 72 years old. He was born July 13, 1945. He was an esteemed United States Navy Veteran, previous Tishomingo County Sheriff, and life member of the United Brotherhood of Carpenters and Joiners of America.

He was a beloved husband, stepfather, grandfather, uncle, and friend. He was preceded in death by his parents.

He is survived by his wife, Becky Dobbs, his two stepsons, Glenn and Keith Adcock, his granddaughter, Abby Adcock, all of Iuka, two sisters, two brothers, and many nieces and nephews. He was a kind

and witty person, a hard worker, and a dedicated and loving husband.

## Fatal Accident Near TN State Line

Terry Ray Fugitt, 36, of the Pickwick Pines community was found dead near his '15 Nissan minivan after being ejected from the vehicle.

It appears he was traveling southbound on Highway 25, about a half of a mile from the state line and ran off the road. The vehicle then fell around 20

feet into a ravine off the side of the road.

Tishomingo County Coroner, Mack Wilemon, stated that it is unclear at this time exactly when the accident occurred but it was reported around 6:55 a.m. Friday morning by a passing driver who noticed the wreck had occurred.

ronment that caused the problem in the first place. We offer a safe and healthful environment away from harmful influences. Bridge House started as a ministry of the Bridge of Burnsville with the vision of connecting Kingdom with Community. We have scheduled an open house on Saturday, April 14, 2018, from 11 AM to 1 PM. We are calling it "The Grand Tour of Hope."

Jason emphasized that "we owe a special thanks to Denise Timbes for remodeling the house and allowing us to use this residence for the Bridge House; Jason Wilkins from Farmhouse Flips and Finds in Mount Hope, Alabama, for donating most of the furniture and decor in the house; Gena Black and Linda Downs for being the originators of this vision and the facilitators of day to day care and activities at Bridge House (We could not do without these two champions!); and to every business, individual, and church that has partnered with us to make this vision a reality.

Gina Black, House Manager and Bridge House Board of Directors, emphasized that "we are open to all women regardless of location although

our focus is on the immediate region. We are a faith based organization that saw a need and we are putting our faith into it."

Alderman Nie Carpenter and Secretary of the Board of Directors of Bridge House, stated "we receive applications from many sources as drug rehab programs, pastors, law enforcement officials, and others. Applicants must meet certain criteria. Women are drug tested, must hold a job and must agree to invest 25% of their earnings into a bed fee and 25% into a savings account. The money is theirs to spend as they desire. Women may stay as little as six months or as long as one year. When they leave, they can take their savings to help them get started in the community."

Mayor David Nixon reported that "Bridge House meets a critical need, especially for the most vulnerable in our society, to help transition women back into a productive life. We thank the board of directors, volunteers, and donors for making this worthwhile project possible."

She was abandoned as a puppy on a roadside. We found her and decided to give her a home. Lily is a very gentle and loving dog. She loves to run and play. Her favorite thing to do is to bark at deer in the fields. We are happy we found a special pet to share life with. The Easter Bunny will be here in just a few days! With all the treats and baskets coming our way, we must remember there are some things that pets cant have. Easter grass for baskets can be dangerous. Consumption of artificial grass can cause minor gastrointestinal problems like constipation or vomiting OR major problems like intestinal blockages that may require surgical intervention. So, either place the Easter basket in a safe place or opt for tissue paper fillers. Also watch out for Easter eggs. Real and plastic eggs can be harmful to your pet. Consumption of real eggs can cause an upset stomach when munched upon and can cause a blockage if swallowed whole. And yes, some dogs gulp without chewing! Eggshells aren't readily digested so the effects of eating hard-boiled eggs can cause several

days of discomfort. Easter lilies are beautiful this time of year, but beware of animals around them. Cats have a tendency to nibble on the flowers and dogs may gobble them up. These flowers are toxic and may cause GI upset (vomiting and diarrhea), lethargy, and kidney failure. Then, there is the candy that has its own dangers to pets. We all cant wait to eat the ears off our chocolate Easter bunnies, but don't share it with your cat or dog. Chocolate contains a chemical called theobromine that can cause vomiting, diarrhea, hyperactivity, elevated heart rate and even seizures when consumed by pets. So, you can see, avoiding a few things will definitely keep your pet safe this Easter. Dr. Perkins and staff would like to wish everyone a safe and happy Easter holiday.

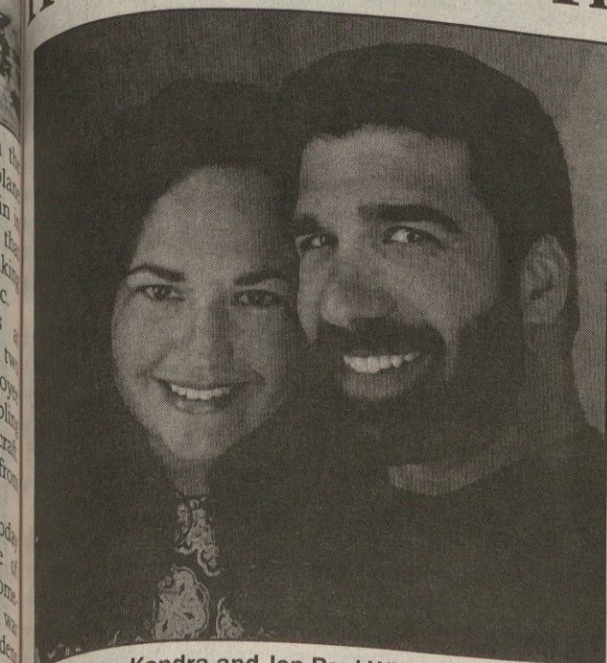

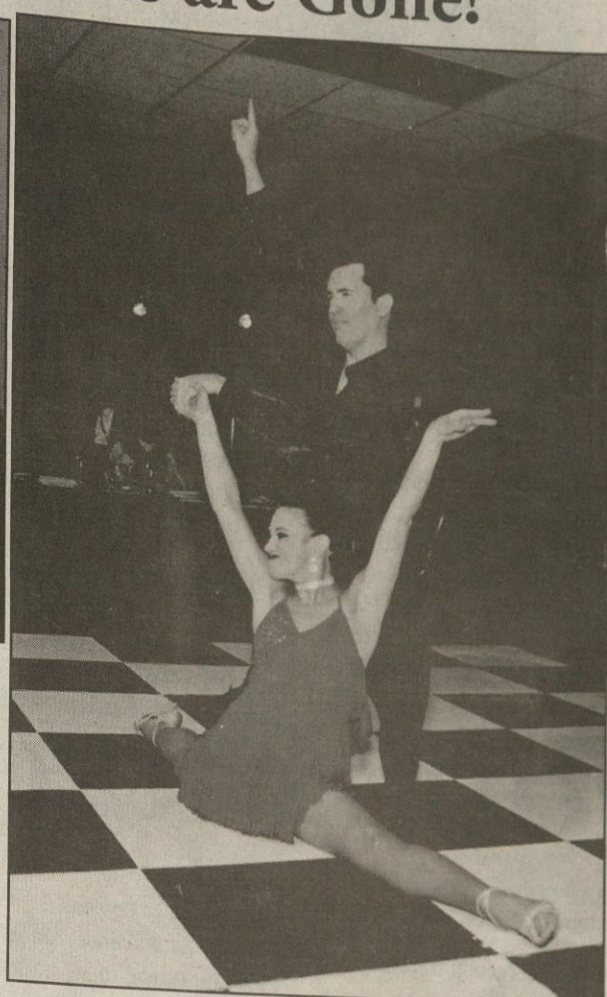

## 156th Anniversary of the Battle of Shiloh April 5th - 8th

SHILOH, Tennessee - Shiloh National Military Park will commemorate the 156th anniversary of the battle by offering a variety of real-time hikes and interpretive programs, from Thursday, April 5, through Sunday, April 8. On Saturday, April 7, the park will host a large scale living history program featuring infantry, cavalry, and artillery demonstrations, an exhibit on navies during the Civil War, a book signing, and lectures on the female Civil War physician.

"The Shiloh battle anniversary activities will be our first signature event since 2018, and we invite everyone to come out to the park and remember the battle and the Americans who fought here in 1862," said Park Superintendent Dale Wilkerson. From April 5 through April 8, volunteers and rangers will lead hikes on all access car caravan routes on a variety of sub-topics, from general battle reviews to actions at specific locations. Some of the tours have limited space, so the park asks interested individuals to register for hikes and tours by calling the Shiloh visitor center at 731-689-1464. A complete schedule of tours is attached to the release, and also posted on the park website at [www.nps.gov/shil](http://www.nps.gov/shil).

wear for the weather and terrain. Visitors attending more than one hike are encouraged to have food and water available. Insect repellent and sunscreen is also recommended.

On Saturday, April 7, we will present large scale living history demonstrations on the battlefield. Living historians will demonstrate the tactics, drill, and firing procedures utilized by the infantry, cavalry, and artillery during the Civil War. This year will mark the largest grouping of cannon on the battlefield for a demonstration. Three batteries of four guns each will be drilling and firing during the event making it the largest concentration of artillery in Duncan Field since 1862. That same day, Dr. Elizabeth Coachman will present a lecture on 19th century physician, writer, feminist, and progressive reformer, Dr. Mary Jane Safford. After 10-years of research, Dr. Coachman published the book "Mary Jane Safford, MD: Indomitable Mite" which presents the fascinating story of this larger than life woman in the 19th century. There will be two programs presented in the park's visitor center auditorium. The first program at 2:00 pm will last 30-minutes. The second program at 5:00 pm will be one-hour in length.

Also on April 7, living historians will display an

exhibit on navies during the Civil War. The display will be open from 9:00 am - 4:00 pm on the front lawn of the visitor center.

## Legislative Report

At this point in the session, a majority of bills have either been sent to the governor to be signed into law or are being discussed in conference.

Conference on a bill occurs when further discussion is needed by members of both the House and Senate to reach the best solution. A conference consists of three representatives and three senators who work together to finalize a bill.

Once a bill is out of conference, it must go to both the House and Senate for a vote before being sent to the governor.

Along with the conferences that were held, the House did meet as a

whole to discuss and pass local and private bills, and honor special guests in the chamber.

Some discussion occurred with the introduction of House Concurrent Resolution 56, which calls for the state to submit an application to request a convention of states under Article V of the U.S. Constitution. In order for this to happen, 34 states must submit an application. Proponents of the bill say this would allow for a few helpful amendments to be made to the constitution. Several members opposed the resolution saying that a meeting to amend the constitution would open the doors for more changes than would be helpful or necessary.

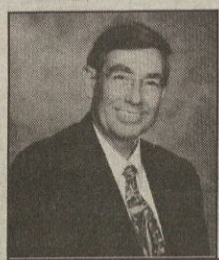


# The Battle Of Armageddon

Perhaps no battle mentioned in the Bible has been the subject of more conversation and conjecture than the battle of Armageddon. It is interesting that we just finished with the Marriage of Christ and the church, and now we are into a "negative subject" that speaks about death and destruction. It may come as a surprise to some people, but those who study the whole Bible will not be surprised, to learn that Scripture probably says much more negative stuff than positive! I just finished reading through several prophetic books of the Bible, as I do on a regular basis, and I noticed in this reading that the prophets had much to say about God's judgment against sin. I wonder why modern preachers and

those who think they are prophets do not major on these themes, since the world today is at least as sinful as the world of the prophets' times. I would much rather write, preach and teach about heaven, but the sad note is that most people will not be in heaven, thus the need of our day, and any day, is to warn the unsaved, as well as to console believers when needed, that the world is headed for judgment. In our present chapter of Revelation, one form of God's judgment is

the battle of Armageddon in Revelation.

Revelation 19:11-13 says, "And I saw heaven opened, and behold a white horse; and He that sat upon him was called Faithful and True, and in righteousness He doth judge and make war. His eyes were as a flame of fire, and on His head were many crowns; and He had a name written that no man knew, but He Himself. And He was clothed with a vesture dipped in blood: and His name is called The Word of God."

John the apostle, who wrote the Book of Revelation, is seeing a vision, and in this vision he sees one sitting upon a white horse. The context here shows clearly that this is Jesus, who once rode into Jerusalem on a donkey, but is here coming back to earth on a white horse. The horse was an animal used in battle; whereas the donkey on which Jesus rode into Jerusalem almost two thousand years ago was an animal symbolizing peace. The Lord Jesus is not coming at this point in time to call for repentance or to heal the sick; He is coming to judge and make war. He is called Faithful and True, because the judgment He is about to execute is in accordance with the plan and will of God. He will make war

in righteousness, whereas most wars started by men are not "righteous wars". Those who think that God is all about love, forgiveness, acceptance etc. need to pay close attention to our passage. Yes, God is a God of all of the things I mention here, but there will be a time when it is too late for any of these, at least for those who have followed their own ways and rejected God and His way!

The eyes of the Lord Jesus, at this point in time, will not be filled with compassion on the unsaved, rather they will be like a flame of fire, symbolizing judgment. (Have you noticed that the "all positive preachers" never cover subjects like the one before us?) There are many crowns on the head of

the Lord Jesus when He comes back to whip the battle of Armageddon. Some of these crowns will evidently be those that are laid at the feet of Jesus the saved who have won them in this life (Revelation 4:10). The name Jesus has here is one that only He knows, perhaps because it is a special name given to Him for this particular battle, but this is conjecture, for no one really knows this name or why it is given, except God. The clothing of Jesus is "dipped in blood" showing that the battle He is about to whip will be a battle of human blood shed. Revelation 14:14-20 gives us a preview of the battle of Armageddon and Revelation 16:16 gives us the name "Armageddon" for this battle.

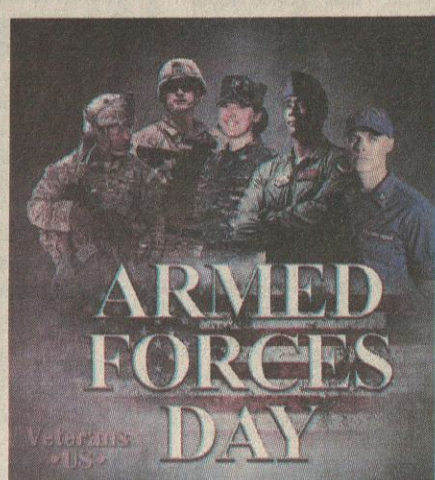

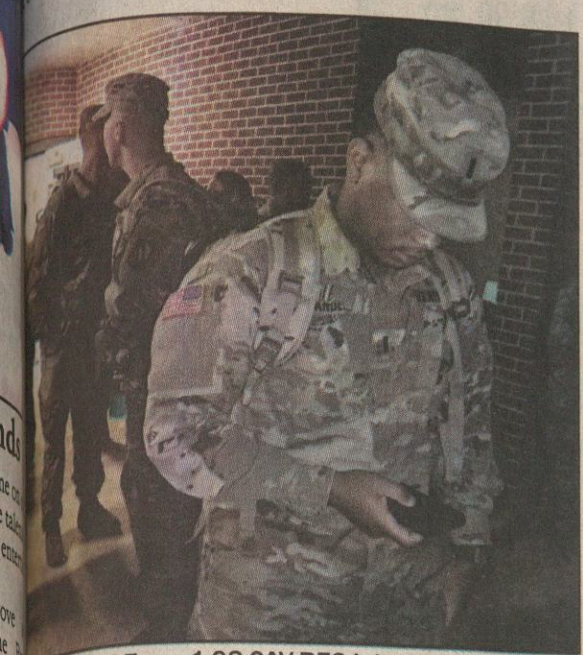
