## Tishomingo County School District Makes the Grade

Tishomingo County School District has received one of the state's highest honors by earning its first-ever "A" rating under Mississippi's Accountability System. Districts and schools receive ratings from A through F each year based upon student performance on Mississippi's state assessment (MAAP) and other factors including graduation rate, ACT performance, and acceleration courses. Iuka Elementary received an "A" ranking as well for its performance. Belmont, Burnsville, Iuka Middle, TCHS, and Tishomingo all received "B" rankings, the second highest level of performance.

## Absentee Ballots Now Available For November 6, 2018 General Election

Donna Henry Dill, Circuit Clerk, announces that absentee ballots are now available for the November 6, 2018 General Election. You may come to the Circuit Clerk's Office to vote by absentee Monday - Friday, 8 a.m. to 5 p.m. The clerk's office will also be open on Saturday, October 27, 2018, 8 a.m. to 12 noon and on Saturday, November 3, 2018, 8 a.m. to 12 noon for absentee voting. I would like to remind all voters who vote by

absentee in the clerk's office that you will be required to show a photo ID. Also, all voters who go to the voting precincts on Election Day will be required to show a photo ID.

We encourage those who need to vote by mail to call our office as soon as possible so they will have ample time to go through the absentee process. When an absentee ballot is requested, an application for an absentee ballot will first be

mailed to the voter. This application shall be completed by the absentee voter and mailed back to the Circuit Clerk's Office. When the application is received, the ballot will be mailed to the voter. No absentee ballots may be hand delivered to anyone.

If your address has changed, you need to call the clerk's office at 423-7026 to update your voter record. A sample ballot is printed in this paper on page.11.



## Drug Investigation Turns up Stolen Vehicle

On October 9th Tishomingo County Sheriff's deputies along with officers from the Iuka Police Department stopped a vehicle on West Quitman Street in Iuka. They believed this vehicle was connected to an investigation of narcotics being transported into Tishomingo County from outside areas. During the traffic stop, law enforcement detained both the driver and the passenger, Aaron L. Hicks and a Lisa R. Shook, because the vehicle had been reported stolen from Lee County.

A search of the vehicle turned up a large amount of alleged methamphetamine, several bags of alleged cocaine and an assortment of pills. Aaron Hicks and Lisa Shook were transported to the Tishomingo County Jail and authorities in Lee County were made aware that the vehicle had been located.

Aaron L. Hicks, 35-year-old, black male of 601 North Parkway Apt 10 Corinth, Mississippi was officially charged with the felony possession of a con-

trolled substance (methamphetamine), and the felony possession of a controlled substance (cocaine). Hicks' remains in the custody of the Tishomingo County Jail awaiting bond to be set by the Justice Court.

Lisa R. Shook, 44-year-old, white female of 2441 McCullough Blvd Belden, Mississippi was also officially charged with the felony possession of a controlled substance (methamphetamine), and the felony possession of a controlled substance (cocaine) and the introduction of contraband into a correctional facility. Shook also remains in the custody of the Tishomingo County Jail awaiting bond to be set by the Justice Court.

It's time to say goodbye to the dog days of summer and hello to a new season. But, as the leaves change colors and the weather starts to get cooler, be aware that there are dangers for pets this time of year. Here are a few things to remember. (1) Watch out for snakes. Fall is the time of year when snakes are prepping for hibernation and they're a little more ill-tempered during this period. Keep your dog on a leash during fall hikes and educate yourself about venomous snakes in your area. (2) Protect pets from mushrooms. Autumn is the season for wild mushrooms.

Although most varieties are harmless, some can be deadly. To be safe, it's best to keep pets away from all mushrooms while outdoors. (3) Consider upping your pet's food intake. When temperatures drop, it takes more energy to stay warm outdoors. Food generates body heat, so if your pet gets a lot of outside activity, you may want to consider a higher daily calorie allowance. (4) Beware of rodents. When temperatures start to cool off, rodents often head indoors to find shelter, causing many people to use rat poison to get rid of unwanted pests. Pet owners should use caution because these products are extremely dangerous to pets if ingested and can be deadly. Keeping these tips in mind are helpful but if you need a veterinarian, Dr. Jim Perkins and staff are here for all of your pet's needs. Call (662) 423-3470 for an appointment. 





# Scenes From The Last Chapter In The Bible (part 4)

Revelation 22:5 says at the end of the verse: ".....and they shall reign for ever and ever." The context shows that these are the people of God in the new Jerusalem. Perhaps it would be interesting for all of us to know in what way we will reign forever and ever, but details are not given in the Bible concerning this. We do know, however, that the Father and Son will reign forever and ever, and we as the saved of this age are the bride of Christ, so we might imagine in what ways a bride takes part in the activities of her husband. After all, Jesus is called the bridegroom in Matthew 9:15 and John 3:29. We as the church are called the bride, the Lamb's wife in Revelation 21:9. The same truth is also taught in Ephesians 5:23-32, where the church is pictured in her relationship with Christ, as an earthly wife is pictured in earthly marriage with her

husband. We will never be God, but we will always be the children of God, yet in our analogy here we are shown as the bride of Christ. In what ways does an earthly husband involve his wife in what he is doing? By the answer to this question we can get some idea of how Christ will involve the church in what He is doing in the new Jerusalem. Since Christ will reign over all things forever, along with the Father, we too will reign by His side and over all things forever. I get excited in thinking about all that God has for us in the future. Earthly marriages are sometimes so weak that we may get a blurred picture of heavenly marriage to Christ for eternity.

There will be many differences in our heavenly marriage from marriage on earth, for it will not be a physical relationship that includes birth of children etc., rather it will be higher than anything in

an earthly marriage. We will be one with Christ, as He prayed in John 17:21: "That they may be one; as Thou, Father, art in Me, and I in Thee, that they also may be one in us: that the world may believe that Thou hast sent Me." A part of this "oneness" is true in the present, but it will be complete in eternity. John 17:23 goes further in this truth: "I in them, and Thou in Me, that they may be made perfect in one; and that the world may know that Thou hast sent Me, and hast loved them, as Thou hast loved Me." Now we see that the Father loves the saved as He loves the Son. This is because the saved are in the Son and are the bride of the Son. It will blow your mind, believer, when you think on what it means for the Father to love us like He loves Jesus. So, we will reign as the bride of Christ forever and ever. It seems that the believers from the

Old Testament period will reign as the wife of the Father. See Isaiah 54:17, but especially 54:5: "For thy Maker is thine husband; the LORD of hosts is His name; and thy Redeemer the Holy One of Israel; The God of the whole earth shall He be called." See also Jeremiah 3:14: "Turn, O backsliding children, saith the LORD; for I am married unto you: and I will take you one of a city, and two of a family, and I will bring you to Zion." The verse, along with dozens of others, teaches the restoration of Israel, the wife of Jehovah! So, dear believer, the future holds much more for the church and redeemed Israel than any of us presently recognize, yet I am excited with what I have seen in the Scriptures that is clearly stated and not too hard to understand!
