

Bridge House for Men Cuts the Ribbon

Friday, May 24, 2019, Burnsville, Mississippi, local officials, board members, and friends gathered to celebrate the opening of Bridge House for Men. Bridge House for Women opened in 2018.

Jason Roberts, President, Board of Directors of Bridge House, reported that "Bridge House is the embodiment of our mission to help men who have successfully gone through a drug rehab program to integrate into society. Judges and law enforcement officials have told us that those who go through drug rehab often go back to an environment that caused the problem in the first place. We offer a safe and healthful environment away from harmful influences. Bridge House started as a min-

istry of the Bridge of Burnsville. We are building a community of recovery."

Jason emphasized that "we owe a special thanks to Harold Lynn Barnes for allowing us to use this residence for the Bridge House and to every business, individual, and church that has partnered with us to make this vision a reality."

Lisa Judd, Vice President, Board of Directors of Bridge House, stated that "we receive applicants from many sources such as drug rehab programs, pastors, law enforcement officials, and others. Applicants must meet certain criteria and follow the house rules. Residents are drug tested, must hold a job, and must agree to invest 25% of their earnings into a

bed fee and 25% into a savings account. The rest is theirs to spend as they desire. Residents may stay as little as six months or as long as one year. When they leave, they can take their savings to help them get started in the community."

Sheriff's K9 Finds Large Amount of Drugs

On June 2nd the Tishomingo County Sheriff's K9 unit conducted a traffic stop on Hwy. 72 in Burnsville for improper equipment. Jonathan Nipper was arrested after he was found to be in possession of drugs and a stolen firearm.

During the traffic stop other deputies from the department assisted in the arrest. The officers could smell an odor of alleged marijuana coming from the vehicle and noticed that the occupants in the vehicle were acting suspicious. The K9 was deployed and alerted on the vehicle and the occupants were removed. A further search by the K9 turned up a large amount of alleged heroin hidden in a

compartment of the passenger door.

A firearm was also recovered from the vehicle that was reported stolen by the Corinth Police Department back in 2014. All three occupants were transported to the Tishomingo County Jail.

Jonathan Nipper, 37-year-old, white, male of Counce, Tennessee was officially charged with the felony possession of a controlled substance (heroin) w/intent to sell. Nipper's bond was set by the Tishomingo County

Justice Court at \$10,000. This case remains under investigation and future arrests are possible.

Golden Woman Charged With Intent to Sell Drugs

On May 31st the Tishomingo County Sheriff's Office officially charged Kimberly Ann Neighbors with the felony possession of a controlled substance (methamphetamine) with the intent to sell.

The Tishomingo County Sheriff's deputies have been working with the Belmont Police Department in this investigation after receiving information about large

amounts of alleged methamphetamine coming into the Belmont area from other counties and states.

Neighbors was arrested after attempting to deliver the large amount of alleged methamphetamine to a location in the Dennis area.

Kimberly Ann Neighbors, 45-year-old, white female, 594 State Line Road Golden, Mississippi was officially charged with felony possession of controlled substance (methamphetamine) w/intent to sell. Neighbors' remains in the custody of the Tishomingo County Jail awaiting bond to be set by the Tishomingo County Justice Court.



ELIGIBILITY:
Growers eligible to sell at the Iuka Farmers Market are those living in Tishomingo County and bordering counties: Alcorn, Prentiss, Itawamba, Hardin (TN), Lauderdale (AL), Colbert (AL), and Franklin (AL). All items offered for sale must be grown by the farmer/grower whose name appears on the "Vendor Permit", with the exception of fruits.

VENDOR PERMIT:
Prior to their first sale, all growers must secure an annual "Vendor Permit" with photo ID at the Tishomingo County Extension Office, located at 238 Kaki Street in Iuka. The application will allow the grower to be a vendor and sell products at the market. There is no charge for the permit. The permit must be displayed in clear view of customers and inspectors.

VENDOR SALE SPOTS:

Vendor sale spots will be available on a first-come first-serve basis. Each vendor using the Farmers Market shall be responsible for maintaining his or her plot in a clean and sanitary manner. Vendors are responsible for set up, display, and packaging of their products. All growers must take with them trash and any unsold products. No permanent structures can be placed on the property. Any awnings,



tents, umbrellas, etc. shall be removed at the close of business each day.

TAXES:
A Mississippi Sales Tax Form will be provided should you need to charge sales tax for your products. Money collected should be turned into the Extension Office at 238 Kaki Street, Iuka. Please contact the Extension Office if you have any questions about taxes at 662-423-7016.

Conduct: Fraudulent, dishonest, or deceptive merchandising or collusion to set prices among growers is prohibited. Camaraderie and cooperation among growers is encouraged.

GENERAL RULES:
The following general

rules will be in effect during the year for all persons using the Farmers Markets.

Only produce (with the exception of fruits), plants, home processed, and/or hand-crafted items grown or made by the certified vendor will be allowed for sale.

Produce should not be sold by weight unless the grower has scales that have been certified by the Mississippi Department of Agriculture and Commerce.

No drinking alcoholic beverages.
No using profanity.
No gambling.
No loitering.

Tourism to Shiloh National Military Park creates \$25.6 Million in Economic Benefits

SHILOH, Tennessee - A new National Park Service (NPS) report shows that 376,100 visitors to Shiloh National Military Park in 2018 spent \$22.2 million in communities near the park. That spending supported 341 jobs in the local areas and had a cumulative benefit to the local economies of \$25.6 million.

"Shiloh National Military Park welcomes visitors from across the country and around the world," said Superintendent Dale Wilkerson. "We are delighted to share the story of the most epic struggle in the Western theater of the Civil War. Both the Shiloh Battlefield, and the Corinth Civil War Interpretive Center, offer unique experiences and provide our visitors the opportunity to experience the culture of West Tennessee and North Mississippi, especially our gateway communities of Savannah and Corinth. Both here, and throughout the nation, tourism is a significant driver in the economies of communities surrounding

the parks, returning \$10 for every \$1 invested in the National Park Service. We appreciate the partnership and support of our neighbors in Tennessee and Mississippi and are glad to be able to give back by helping to sustain the local communities."


Shiloh National Military Park was established on December 27, 1894. Shiloh Battlefield preserves the scene of the two-day battle, April 6 and 7, 1862, involving nearly 110,000 Union and Confederate troops, and resulting in 23,746 casualties, more casualties than the United States had experienced in every war it had fought to that time combined. This decisive Union victory enabled United States forces to advance on and seize control of the strategic Confederate railway junction at Corinth, Mississippi, on May 30, 1862.

From October 3-4, 1862, the fighting for Corinth renewed, with the engagement ending on October 5th at Davis Bridge, near Pochontas, TN. The

Battle of Corinth involved over 250,000 men, and resulted in an additional 12,000 casualties. On September 22, 2000, the Corinth Civil War Interpretive Center and associated properties were made a part of Shiloh National Military Park.

The peer-reviewed visitor spending analysis was conducted by economists Catherine Cullinane Thomas and Egan Cornachione of the U.S. Geological Survey and Lynne Koontz of the National Park Service. The report shows \$20.2 billion of direct spending by more than 318 million park visitors in communities within 60 miles of a national park. This spending supported 329,000 jobs nationally; 268,000 of those jobs are found in these gateway communities. The cumulative benefit to the U.S. economy was \$40.1 billion.

Lodging expenses account for the largest share of visitor spending, about \$6.8 billion in 2018. Food expenses are the second largest spending area and



visitors spent \$4 billion in restaurants and bars and another \$1.4 billion at grocery and convenience stores.

Visitor spending on lodging supported more than 58,000 jobs and more than 61,000 jobs in restaurants. Visitor spending in the recreation industries supported more than 28,000 jobs and spending in retail supported more than 20,000 jobs.

Report authors also produced an interactive tool that enables users to explore visitor spending, jobs, labor income, value added, and output effects



Pastor's Tidbits

Words From The Wisest King Before Jesus (part 16)

King Solomon, writing under the inspiration of the Holy Spirit, tells us much about how to live life in this present world. Often we are concerned about life in the next world, and rightly so, but we must also be concerned about life in the present world. Ecclesiastes 3: 9-10 says, "What profit hath he that worketh in that wherein he laboureth? I have seen the travail, which God hath given to the sons of men to be exercised in it."

The question and the answer that Solomon gives to the world of Bible readers is quite interesting and much needed! Notice that he asks the question concerning what profit man gains from his labors. Most people would likely say, "Oh man gains much profit from his labors, for he can buy nice houses, cars, boats and other things to enhance his 'joy' while on earth." May I ask whether or not "things" really enhance joy? Yes, it is good, and even necessary, for us to work and earn our livelihood, but there are many who cannot do this because of some physical malady, so what do they do? It is right for the nation and the rest of us to help those who are helpless, yet many have made themselves helpless by wrong actions. It is not wise to "throw money" at bad problems if that money only makes the problems worse. Solomon asks what profit man has of his earthly labor, then he gives a partial answer to our dilemma. He says that God also gives travail (meaning employment in our context) to men to be exercised (meaning to abase or humble) therewith. So, God has given labor to humble us, yet most people never seem to realize this truth. There is no room for pride in the lives of human beings, although we see it bursting out in every facet of labor or play.


Ecclesiastes 3:11 says, "He hath made every thing beautiful in His time: also He hath set the world in their heart, so that no man can find out the work that God maketh from the beginning to the end." This verse has more truth in it than most people realize. First we see that God has made everything beautiful for its time, meaning that the creation of God in its original state was more beautiful than anything that men of our day have ever seen. Second, we see that God has set "eternity" in the hearts of men. The word "world" is not the usual word for the world, but the word that means: eternity. The same Hebrew word is translated "eternal" in Isaiah 60:15. So the gist of the meaning is that God has set eternal longings in the hearts of men, even to the point of their searching out as much as they can about the future. Then we hear Solomon saying that no man can really "find out the work that God maketh from the beginning to the end." This means that man cannot exhaust the knowledge that God has displayed in the things that He has created. I do not think it is wrong for men to search after the things of God in examining what He has made, but none will ever know it completely as God does. Now Solomon draws the conclusion in Ecclesiastes 3:12: "I know that there is no good in them, but for a man to rejoice, and to do good in his life." He is saying that better than seeking to know all about what God has made in the universe, men should seek to rejoice in Who God is and what He has made, so that he learns to do good all the days of his life, because he has placed his faith in God the Creator of all things! Verse 13 says that it is a gift from God for man to enjoy the fruits of his labor.

Cochran Was One of Our Nation's Greatest Senators

A dear friend, fellow hunter and angler, and my former boss - Senator Thad Cochran - passed away on May 30. He was also family. Senator Cochran - the tenth longest serving Senator in United States' history - championed the conservation and sportsmen's agenda since he was elected to Congress. Cochran grew up hunting and fishing in Mississippi and valued the important lessons and experiences people gain from being outdoors. He consistently represented the interests of hunters, anglers and gun owners by supporting policies that protect our Second Amendment rights, promote conservation, especially on private lands, minimize burdensome or unnecessary regulations and expand public access to public lands.



Some people go to Washington to make a point. Thad Cochran did not go for that. Leader McConnell said it best: "Thad knows there's a difference between making a fuss and making a difference. Senator Cochran has played a crucial role with many pieces of legislation. We all know that Washington is filled with loud voices, but Senator Cochran's manner served our friend and this institution very well. A few years ago, he reached another important milestone when he cast vote number 12,000 here in the Senate. At that time, I mentioned that *TIME* magazine included Senator Cochran on its list of 'America's Top 10 Senators;' they named him 'The Quiet Persuader.'

Senator Cochran authored a wildlife incentives program-which has restored and enhanced almost 7 million acres with 31,000 landowners. He has championed Wetlands Reserve, which is a voluntary program that has restored 3 million acres with 18,000 landowners. He has helped create programs to restore longleaf pine and native grasslands. He has created the only refuge in the nation named for an African American-Holt Collier. And the list goes on. Add up the list above and Senator Cochran has touched about 12 million acres-the same size as the State of Maryland. There is NO other Senator with the conservation accomplishments of Thad Cochran.

But the greatest thing about Senator Cochran had nothing to do with conservation. It was the respect that people had for him. He earned that by listening more than talking, recognizing the needs of others, being honest, fair, and caring more about what is right than popular. He was a brilliant individual who did a great job by surrounding himself with a staff consisting of the same. I don't have all of the answers, but I do know that the more people serving our great nation with traits like this, the better off our nation will be. We were all fortunate to have benefitted from his lifetime of dedicated service - 45 years - to the greatest nation in the world. I already miss his friendship - his laugh, his fine counsel, and his passion, among other things. While we won't chase trout, or turkeys, or ducks again together, I will constantly be reminded of the legacy this most Southern of gentlemen left each and every sportsman throughout Mississippi and our nation. He was giant.
