# Parent Survey on Re-opening **Schools in County**

The Tishomingo County School District is seeking parent feedback on re-opening school scenarios through an online "Return to School Parent Survey." The survey can be completed online through the link on our district website (www.tcsk12.com). Also, schools will be sending the survey through their class and school Remind accounts. "Our district needs as much feedback from parents as we can get in order to best meet the needs and concerns of our families as we transition back to school in August," stated Superintendent Christie Holly. The district is considering three

possible models for learning in the fall:

Traditional Model -In this model, all students physically return to school in a normal manner with special considerations around transportation, social distancing, movement limitations of students throughout the day, and accommodations for highrisk students.

Hybrid Model -- In this model, students physically attend school on certain days. For example, one set of students would come on Mondays and Wednesdays while another set would attend on Tuesdays and Thursdays. The days students are not physically

at school, they would be required to do distance learning via online or in packets.

Virtual Schedule (Distance Learning) Model - In this model, all learning is online, and students meet with teachers virtually for videos, instruction, and activities.

"At this time, we are preparing for all models. as much as we can. It is very possible that we may have a combination of these models throughout the year if COVID-19 has a resurgence in the fall months. So we want to be prepared," stated Holly.

The end of this week marked the deadline appropriations and revenue bills to be introd passed. Most legislation came from the Appa and Ways and Means Committees, while som bills from the Senate were also introduced.

Although much of the state's budget was last week, several appropriations bills were before the House. House Bill 1746 was one of the bills by the Ways and Means committee. The temporarily reduce the rates of the Oil Severance Tax. HB 1746 passed unanimously of 111-0 and has been sent to the Senate.

The House Education Committee brough Senate bills out of committee and onto the floor this week. Examples of these bills inclusion Bill 2508 would extend the repealer on p of the Mississippi Critical Teacher Shortag 1998; Senate Bill 2283 would revise school provisions related to conflict-of-interest of e and administrators; and Senate Bill 2511 West some licensure requirements for teachers. Each bills passed unanimously when presented.

Committees will continue to meet to discubills. Over the next few weeks, more Senate make their way out of House committees the House floor for discussion. 





Blessed art thou, O land, when thy king is the son of nobles, and thy princes eat in due season, for strength, and not for drunkenness!" Have you ever seen two short verses that say more about the leaders of nations than these two verses say? I did not pick these verses because of the situation in our nation's political arena, because I have been going through Ecclesiastes for a long time and this week's article just hap-

pened to involve these two



verses. The word "woe" is a word that spells out lamentation, or a crying out for something, or because of something. Our writer says that a land, any land or nation, is in trouble when its king (or main leader by whatever title) is a child. This idea is that leaders of nations need to be "seasoned men" who think not about their own welfare, but the welfare of their countries. When the main leader of a nations acts like a child, that nation is in trouble, for children are not mature



gardless of how sweet and good our children may be. The accumulation of years of age seasons one to be fitted for leadership. This is why our nations will not allow a very young man to be its president.

woe second The comes to a nation when it princes, or leaders under the king or president, eat in the morning. This may sound strange, but the idea seems to be that those princes who are most concerned about the "early satisfaction" of their own

appetites do not make good leaders. (I wonder how many of this nation, or any nation, have gotten into public offices for the good of the people, more than the advancement of their own agendas!) On the other hand, a nation is blessed when its king comes from a noble family who has had the good of the country uppermost in mind, more than personal advancement. The princes of the blessed country "eat in due time for strength, and not for drunkenness". Does this fit, or not? Those under the king or president should not think of themselves first, at least not in their leadership roles. The matter of eating in due time speaks of these leaders putting their own needs and pleasures after those of the
