After arriving at the Med, it was confirmed his back was broke in 2 places, there was also bleeding and bruising around his spinal cord. One of the breaks was a critical injury and he underwent surgery. The impact of the wreck also bruised all of his internal organs causing the right side of his abdomen to swell. Within 24 hours of arriving he had surgery to remove the broken vertebras and used rods

and plates to stabilize his spine. Eli is the son of Patry Hudson of Juka.

He is out of ICU, on a regular floor. We hope tomorrow he is moved to the Physical Therapy floor, where he will stay for 7-10 days. Governor Reeves announced his new executive order at his daily press. briefing today, which you can view on our Facebook page here.

In this latest executive order, the Governor lays out strict social distancing guidelines to begin the process of slowly and safely reopening salons, barbershops, and gyms, including:

### SALONS & BARBERSHOPS:

For businesses:

· Before they can reopen. the entire salon or barbershop must be deep-cleaned, disinfected, and sanitized top to bottom. After opening, salons and barbershops must be deep-cleaned daily.

 All salons and barbershops are expected to take every step necessary to implement the regulations, orders, and guidance from the Massissippi State Department of Health and CDC to prevent the spread of COVID-19.

. Hand saminer must be placed at all entrances.

· Minimizing person-to-person contact through nethnology, like mobile or online reservations and contact-less payment, is encouraged. \* Salons and harbershops

must post signage at each entrance stating no customer with a fewer or COVID-19 symptoms are allowed

· Chairs are to be rearranged to ensure at least 6 feet between each customer and be sanitized after each use by a customer.

· Only one customer per employer is allowed in the salon or harbershop at any given time.

For employees:

· All employees will be screened daily at the beginning of their shifts, including asking whether they have been in contact with a con-





been translated: "adversity, affliction, bad, calamity, displeasure, distress, wrong etc." Solomon is not necessarily speaking of a sin, for everything in the context would argue to the contrary. Rather he is saying that some things do not fit well in the equation of earthly life. Notice that our writer said that this "evil" was coming down from the ruler, with no specific position of ruling being given. He is saying that rulers sometimes get



things out of place, so that folly is sometimes set in great dignity. Our word "folly" means: "silliness"; the Hebrew word comes from a word that means: "to do foolishly; to make a fool; play the fool or turn into foolishness." We do not have to look very far to see things that have no merit whatsoever being praised more greatly than the things that are vitally important and essential to life itself. Millions of dollars are being spent to produce things that are not only without value, but are actually detrimental to human society, yet people "buy them up", as if they were more precious than gold!

Now our writer says that this kind of thing is an "error which proceedth from the ruler". I believe in government, especially if we could have a government "of the people, by the people, and for the people", which we have had in times past, and do have now to an extent. I do not believe in rebelling against authority that God has ordained, but I do believe that those in authority are responsible before God to rule justly. Notice that Solomon, who is himself a king, says that the ruler is sometimes the fountainhead of the folly that is being produced. When I say "folly", of course I am not thinking about only one area in which folly is praised as being superior, but I am thinking about various areas of governments, churches and also families in which folly is the "King on the throne". It is not wrong to have clean fun or entertainment, but our idea of what is "clean" has changed drastically in the last few decades! Our writer sees folly in settings of great dignity, while some who are rich, and evidently also wise, sit in places of no honor from the masses. Servants have been elevated to positions of honor, riding in royalty

while princes are walking as if they have no horses to ride. The whole picture here is that of things being turned around and placed out of order. Do I need to say more, or do you get the picture? By J. Briggs King, Evangelist, Rainsville, AL (678) 451-0921



rus has killed one American out 8,554. The average age of a COVID-19 victim is 80 years old - which also happens to be the average age of life expectancy. This is because everyone's immune system declines with age, just like every other part of your body. Older people also die of pneumonia, common colds, the flu and hundreds of other causes. Yet we do not shut down the economy because of this. Just today, CNN reports that 370 workers at the Triumph Foods pork plant in Buthapan County. Missouri tested positive for Covid-19. Not a single one had any symptoms. A virus that causes no symptoms or minor symptoms in 95 percent of the people it infects is not a killer virus. Further, it would be completely impossible to contain a virus such as that. If COVID-19 were a killer virus, grocery store work-

den did not shut down. Yet Sweden is doing just fine and fatalities are dropping sharply like all the other European countries which are two or three weeks ahead of the U.S. The epidemic experts got us into the shutdown game. We believed the experts. But come to find out, the experts have been wildly wrong. They predicted 2.4 million American deaths. That's a big miss. In reality, there is a huge amount we don't know about viruses, epidemics and the immune system. Blind trust in the experts is misguided. Every human body has 500 trillion viruses in it at any given point in time, including 75 percent of the known species that infect humans. We all have four different coronaviruses in us right now - HKU1, NL63, OC43, 229E. Science discovers dozens of new human viruses every decade. Our immune other coronavifrom

ruses already in our bodies. Inaccuracy abounds. Positive infections will continue to increase simply as a function of skyrocketing testing. It is the fatalities that matter, and they are dropping rapidly. Using the CDC's total allcause mortality stats, the total death rate in the U. S. so far this year is about the same as the five-year average. It will take years, to understand what has

really happened. In the meantime, we have lives to live and an economy to rebuild. Never in history have healthy people been quarantined. It massively violates our Bill of Rights and probably won't stand up to judicial review. Before we leave a suffocating debt burden to our children, let's regain our confidence, overcome our hypochondria and get back to living normal lives.

The second event took place while he was assigned to the headquarters segment of the 100 Infantry Division. This Division was in a tough battle with the Germans in France. Move men were mended promin on the front line of battle. A roster of men was quickly listed for immediate transfer to the front. Ershell was on that list. But before the commanding general signed this list he drew a line through Ershell's name. Ershell had been cutting the hair of the General. Ershell learned the barbesing teads by putting the hair of all of he boys plus several neighbors.







Inez Quillen McNutt from Cherokee, AL

attended the annual meetings of the BBB-ie Battling Bastards of Bastogone. Ershell was a mild manneved red headed person with maturity that manifested itself even while he was a senior at Belmont, Mississippi High School. Our mother was a widow and Ershell as a High School boy had to take over the operation of our large farm near Dennis, Miss. After he graduated from High School he attended an extra year in order to take typing and short hand. Our older brothers had left home to seek their living doing. things other than farming. Some wicked men stole our farm and Ershell and my mother traveled all over Tishomingo County trying to find a place for in to leve, Land cwp ers would rather have the plague as to have a widow woman with a house fall

Ershell and wife, Inez Quillen on their wedding day of children. Out of the kindness of his heart, Dr. Joe Wheeler let us move on his large farm across Bear Creek. He had two other families living on this farm but he let us move into a vacant building. Ershell and the rest of us did not think that it was a great sin to work. We paid Dr. Wheeler three bales of comon and over 100 bushels of corn. We also shared hay and peanuts. Our mother had a 4th grade education but had a PhD in determination. She wanted us to get an education. Ershell hauled logs to build us a house on the large farm of our cousin Charlie Byrum near Tishomingo. Dr. Wheeler begged us to stay on his farm. He said, "you have paid me more rent than I have gotten off this farm in five years."

Ershell was a Summa Cum Laude graduate of Miss State University and

I do not think he ever purchased a text book. After the war Cornell University and Miss State offered him a full scholarship leading to a PhD degree but he wanted to get married and settle down. He married Inez Quillen and they had three daughters. Ellen has PhD and was a college professor. Myra was a teacher. Patricia developed a corporation that had offices in eight major cities. 
