

The General Election is Tuesday, November 3rd

Voting at your precinct on election day, what to expect, and steps taken to keep you safe

General Election day is Tuesday, November 3rd, 2020. The Polls will be open from 7a.m. - 7p.m. as normal. A County Wide sample ballot is included in this addition of the paper. I encourage everyone to review the sample ballot, especially the ballot measures for medical marijuana, the state flag referendum, and House Concurrent measure 47. Voters should be prepared to show their photo ID when they go to the polls, and be sure to follow the poll workers instructions.

The election commissioners and myself have implemented a plan to ensure it's safe for you to cast your ballot on election day. To ensure voting at your polling location on Election day is as safe as possible all poll workers will be wearing masks or face shields. At every polling location we have assigned a poll worker, whose sole responsibility is to ensure the location is clean, disinfected, and CDC guidelines are followed to the best of our ability. Voters are strongly encouraged to wear their own mask or face shield when going to cast their ballot, however no voter will be turned away for not wearing a mask or face shield. Mask or no mask, all will be afforded the opportunity to vote. Prior to election day polling locations will be spray disinfected with commercial/professional spray units.

Every voter will be given a stylus pen at the polling locations. This pen allows the voter to sign the poll book without having to share pens. It also allows the voter to use the tip of the stylus pen to make their selections on the voting machine, without having to touch the machine. Using the stylus pen will dramatically reduce the spread of germs. Social distancing signs and markers will be in place along with many other tools to help reduce the risk of exposure to COVID-19 such as; plastic shields at the poll book tables, UV disinfectant tools, plenty of hand sanitizer, extra PPE, many types of disinfectants, and special vinyl wraps on door handles that will not allow the virus to grow on it.

Please be patient with us when voting on election day. Not only are we dealing with the safety measures in place for COVID-19, but we also expect a significant increase in voter turnout. The clerk's office will be open Saturday 10/31/20 from 8a.m. - 5p.m. for Absentee voting. Saturday 10/31/20 is the last day to vote absentee in person. For mail in absentees, they must be post marked by 11/3/20 and received within 5 business days in order to be counted in the 11/3/20 General Election. Medical Marijuana for the State of Mississippi will Appear on the Ballot Tuesday

Voters will be confused by the wording!

During next week's election medical marijuana will appear on the ballot for the state of Mississippi. Voters will be asked to approve either Initiative 65 or Alternative 65A. Both programs amend Mississippi's Constitution to allow for the establishment of a medical marijuana program in the State.

The language used on the ballot is admittedly a bit confusing. The measure appears on the ballot as a two part question, first voters will be asked if they are For or Against the measure; and secondly voters will be asked which initiative they support

should the measure pass. If the majority of voters approve either program the measure which receives the most votes will pass, assuming it receives at least 40% of the overall vote.

The first question to appear on the ballot gives the option of "Vote For Approval Of Either, Or Against Both" Initiative 65 and Alternate 65A. The second portion of the measure states "And Vote For One." Even if a person votes against both in the first portion of the measure, this question allows voters to choose which Initiative they would support regardless of their

response to the first question.

Initiative 65 would allow medical marijuana treatment for more than 20 specified qualifying conditions, and tax marijuana sales at the current state sales tax rate of 7%. The program under initiative 65 has a deadline to be implemented; cards must be available for patients by August 15, 2021.

Alternative 65A would restrict smoking marijuana to terminally ill patients only; and leave tax rates, possession limits, and certain other details to be set by the state's legislature. Alternative 65A has no deadline for im-

plementation and allows pharmaceutical-grade marijuana products to be administered to a registry of approved terminally ill patients.

One aspect of holding a medical marijuana card in any state that citizens should be aware of is that by being a patient receiving medical marijuana it is illegal to own, possess and purchase firearms on a federal level.

A wealth of reliable information about this subject can be found online and personal research into this topic will allow voters to be well informed prior to heading to the polls on Tuesday.

Vote Initiative 65

More than 3.5 million patients are successfully using medical marijuana to treat debilitating conditions in 34 other states. That's right, 34 other states have regulated medical marijuana programs, but the Mississippi Legislature has blocked more than 20 proposed bills to pass medical marijuana legislatively. Qualified patients in Mississippi deserve to have the same access as patients in 34 other states, including Louisiana, Florida, and Arkansas. Initiative 65 gives doctors the ability to certify patients here in Mississippi who suffer from 22 specific listed conditions, including cancer, seizures, chronic pain, and PTSD, to try medical marijuana as an alternative treatment option. Vouchers to be Issued for Basketball Games

The Tishomingo County School District and its schools are preparing for their winter sports seasons. Under Governor Tate Reeves's Executive Order, gymnasiums can only have 25% capacity at this time. Each school has calculated that number and will be issuing vouchers to its students and opponents for entrance into games. Due to this limitation, no district passes will be sold at this time for entry. The only passes allowed for entrance are MHSAA state

passes. Masks must be worn for entry and should be worn when not seated in the stands. Seats will be marked for social distancing. Also, each school has different capacity limits. If community members are interested in the process for entry for a particular school, they should contact the school for information. 

a blessing. There was an urgency to keep reading. I paused and reminisced about my relationship with each of you.

Angie had typed each message and there were several pages of these. I took the school annuals to place many of you since you had a name change.

Saturday, the 17th, Angie came and carried me to the graveside service for Geraldine Rushing. It was so sad but the celebration of her life helped each of us to remember just how special she was. I probably had more memories than most of you since she had been my hairdresser until she retired. We also attended the T.B.C. down through the years we had taken church bus trips. So much fun!

While at the gravesite because of the Coronavirus-Covid 19, I stayed at a distance and did not hug anyone like I wanted to, except Diane and Larry. A must do.

Angie and I said our good-byes and didn't go into the crowd but quickly made our way back to the car almost the length of the cemetery away.

As I got into the car and sat down, I felt for my hearing aid. I had worn only one for a specific reason. I had on shades, ear rings, and a mask. When I felt for it, it was gone.

Angie gave me a shake-down, made me stay in the car, and she retraced our steps the best she could. She came back and no luck. She said, "Mother, I'm going to make that round again. I told her I was going with her and I'd take my walking cane instead of hanging on to her.

All the way down to the grave where they had shaken the green mats, and had looked where I sat. No luck. We turned and started back to the car - the same way as best we could. We thought we were where we were when

Angie had suggested it would be safe to remove our masks.

About the same time we both said, "There it is!" readers, nothing but God's directions, His goodness, and His mercy could have ever let us find this tiny hearing aid without Him. 

Words From The Wisest King Before Jesus (part 85)

We are coming close to the end of Ecclesiastes, so Solomon is giving his final words in chapter twelve. Ecclesiastes 12:11 says, "The words of the wise are as goads, and as nails fastened by the masters of assemblies, which are given from one shepherd." It is interesting that some people seem to have no desire to hear the "words of the wise", but that is "dumb" mistake! I often think of I Corinthians 4:7: "For who maketh thee to differ from another? And what hast thou that thou didst not receive? Now if thou didst receive it, why doth thou glory, as it

thou hast not received it?" I preached a message many decades ago on this verse; I titled it: "Do you have any originals, sir"? It is a given that we all have received whatever we have from some earlier sources. Yes, I know some may say, "I had an original thought". May I ask how we can know if our thoughts are original, since we have not had an opportunity to "pick the brains" of all who have

gone before us? There is no room for any of us to gloat over what we think we know, for somebody, somewhere knows more than we know. So, the wise thing for all of us to do is to listen to the wise people who have lived before us, as well as to those who are living around us now.

Solomon says that the words of the wise are like goads, which was a sharp stick used in Bible times to

prod animals to move in a desired direction. In modern times men use shocking sticks. Solomon says that wise words can "goad" us to move in the right direction, whether mentally, physically or spiritually. Solomon also says that words from the wise are like nails that hold things together. It is amazing to think about how many huge structures are held together by nails. Wise words can also help us keep things in their proper places, or they can help us keep ourselves in the right places. All the wrongdoing in our world begins with improper thinking, when the words of

the wise are not heeded, so that things can be properly put together in our minds and actions. Did you notice that Solomon spoke of builders as "the masters of assembly", or those who have mastered the building trade, yet the real lesson that Solomon is seeking to convey is that those who listen to the words of the wise will be more likely to move in the right direction; they will be more prone to build something worthwhile in their lives and the lives of others. The world we enjoy was created by the Master Creator, God, and He is "all wise" is every-

thing He does. Would it not be fitting that we should inspire a world like Solomon, to go along to others that of the wisdom that has displayed in the great creation? No, we are not going to create a universe, but might help to create some peace, joy and worship in the lives of those around us, if we simply listen to the one who has gone before us and blazed a trail for us to follow.
