

"This group of people are working hard to make Tishomingo County stronger by not only putting in the work, but by open-



**EXHIBIT A - COUNTY GOVERNMENT
RESOLUTION OF INTENTION**

The Board of Supervisors, acting for and on behalf of Tishomingo County, Mississippi (the "County"), took up for consideration the matter of authorizing and approving a loan on behalf of the County from the Mississippi Development Authority (the "MDA") for the purpose of assisting existing industries deploying long term fixed assets that through new technologies will improve productivity and competitiveness and to assist existing industries through the purchase of land, buildings and equipment.

Thereupon Supervisor Brandon Grissom offered and moved the adoption of the following resolution:
RESOLUTION DECLARING THE INTENTION OF THE BOARD OF SUPERVISORS OF TISHOMINGO COUNTY, MISSISSIPPI, TO AUTHORIZE AND APPROVE A LOAN ON BEHALF OF THE COUNTY FROM THE MISSISSIPPI DEVELOPMENT AUTHORITY IN A MAXIMUM PRINCIPAL AMOUNT NOT TO EXCEED THREE MILLION DOLLARS (\$3,000,000) FOR THE PURPOSE OF MODIFICATION OF EXISTING BUILDING TO MEET MANUFACTURING REQUIREMENTS: such as new HVAC, air compressor, fencing, improvements to an existing door, driveway modification, electrical upgrades, crane upgrades, and other building improvements.

WHEREAS, the Board of Supervisors of Tishomingo County, Mississippi (the "Governing Body" of the "County"), does hereby find order and resolve, determine, adjudicate and declare as follows:

- The Mississippi Existing Industry Productivity Loan, constituting Sections 57-93-1 et. seq. Mississippi Code of 1972, as amended (the "Act"), was enacted for the purpose of promoting business and economic development in the state of Mississippi (the "State") through investment by private companies locating in the State.
- Pursuant to Section 57-93-1 of the Act, the MDA is authorized to make interest-bearing loans to state, counties or incorporated municipalities for the purpose of making loans to existing industries to deploy long term fixed assets.
- The County will agree to assist existing industries and will request the MDA to finance a portion of the cost associated with the development of these improvements (the "Project").
- Pursuant to the Act and guidelines adopted by the MDA, the County will file an application with the MDA for a loan to be used for the development of the Project in the amount of Three Million Dollars (\$3,000,000) (the "Loan").
- The County and the Authority will enter into a Loan Agreement (the "Agreement") with the MDA wherein the County agrees to borrow the proceeds of the Loan subject to and upon the terms and conditions of the Agreement.
- In order to secure the Loan, the County will execute and deliver to the MDA a Promissory Note (the "Note"). Failure of the County to meet its repayment obligations shall result in the forfeiture of homestead exemption annual tax loss reimbursement in an amount sufficient to repay obligations due pursuant to Section 57-93-1 of the Act.
- The Loan shall not be deemed indebtedness within the meaning specified in Section 19-9-5, Mississippi Code of 1972, as amended.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE COUNTY, AS FOLLOWS:

Section 1. The Governing Body of the County does hereby declare its intention to authorize and approve a Loan from the MDA in the principal amount not to exceed Three Million Dollars (\$3,000,000) for the purpose of making loans to existing industries to deploy long term fixed assets.

Section 2. The Loan will be secured by a Note executed and delivered by the County to MDA. Pursuant to Section 57-93-1 of the Act, failure of the County to meet its repayment obligations shall result in the forfeiture of homestead exemption annual tax loss reimbursement in an amount sufficient to repay obligations due until such time as the indebtedness has been discharged or arrangements to discharge such indebtedness satisfactory to the MDA have been made.

Section 3. The Governing Body proposes to authorize and approve the Loan from the MDA in the amount and for the aforesaid purposes at a meeting of the Governing Body to be held at its regular meeting place at the County Courthouse in Iuka, Mississippi at 9:00 a.m. on the 2nd day of August, 2021, or at some meeting held subsequent thereto. If twenty percent (20%) or fifteen hundred (1,500), whichever is less, of the qualified electors in the County shall file a written protest with the Clerk of the County against the authorization and approval for the Loan on or before the aforesaid date and hour, then the Loan shall not be entered into unless authorized at an election on the question of authorizing and approving the Loan. Such election shall be called and held as provided by law. If no protest is filed, then the Loan may be entered into without an election on the question of authorizing and approving the Loan at any time within a period of two (2) years after the date above specified.

Section 4. This Resolution shall be published once a week for at least four (4) consecutive weeks in the Tishomingo County News, a newspaper published in the City of Iuka, Tishomingo County, Mississippi and having a general circulation in the County and qualified under the provisions of Section 13-3-31, Mississippi Code of 1972, as amended. The first publication of this Resolution shall be made not less than twenty-one (21) days prior to August 02, 2021 and the last publication shall be made not more than seven (7) days prior to such date, said Resolution to be published on July 08, 15, 22, and 29, 2021.

Section 5. The Clerk of the County shall be and is hereby directed to procure from the publisher of the aforesaid newspaper the customary proof of said publication of this Resolution and have the same before the Governing Body on the date and hour specified in Section 3 hereof.

Supervisor Nicky McRae seconded the motion to adopt the foregoing Resolution, and the vote thereupon was as follows:





CONSERVATION CORNER The Dog Days of Summer

Editor's note: I grew up hearing this saying all my life!

While growing up in the Mississippi Delta, I was accustomed to hearing the saying that we were in "the dog days of summer." I just knew we were in the hot days of summer. I heard it again and began to wonder what the phrase actually meant. After doing some research, this is what I found.

In ancient times, when the night sky was not obscured by artificial lights and smog, different groups of peoples in different parts of the world drew images in the sky by "connecting the dots" of stars. They saw images of bears (Ursa Major and Ursa Minor), twins (Gemini), a bull (Taurus), and others, including dogs (Canis Major and Canis Minor).

The brightest of the stars in Canis Major (the big dog) is Sirius, which also happens to be the brightest star in the night sky. In fact, it is so bright that the ancient Romans thought that the earth received heat from it.

In the summer, however, Sirius, the "dog star," rises and sets with the sun. During late July Sirius is in conjunction with the sun, and the ancients believed that its heat added to the heat of the sun, creating a stretch of hot and sultry weather. They named this period of time, from 20 days before the conjunction to 20 days after, "dog days" after the "dog star."

The conjunction of Sirius with the sun varies somewhat with latitude. And the "precession of the equinoxes" (a gradual drifting of the constellations over time) means that the constellations today are not in exactly the same place in the sky as they were in ancient Rome. Although it is certainly the warmest period of the summer, the heat is not due to the added radiation from a far-away star, regardless of its brightness. It is a direct result of the earth's tilt. According to *The Old Farmer's Almanac*, dog days occur during the period between July 3 and August 11. The Merriam-Webster dictionary defines them as "the period between early July and early September when the hot sultry weather of summer usually occurs in the Northern hemisphere."

If you ask some of your friends, you will usually find that many people believe the phrase is in reference to the conspicuous laziness of domesticated dogs (who are in danger of overheating with too much exercise) during the hottest days of the summer. When speaking of "dog days" there seems to be a connotation of lying or "dogging" around, or being "dog tired" on these hot and humid days.

Although these meanings have nothing to do with the original source of the phrase, they may have been attached to the phrase in recent years due to common usage or misunderstanding of the origin of the phrase.





Paula Skinner explores Chalk Mine near Iuka

Chalk Mine Hollow (Iuka, Mississippi)

Joseph, Paula, Dorothy and Josie Skinner of Burnsville are no strangers to adventure. They frequently travel by boat to different designations in Tishomingo County. On this particular day, located between Hills of the Bear and Eastport (Pickwick Lake), this abandoned chalk mine covers about the same area as the footprint of a big boxed retail store and includes three long tunnels, which are connected by numerous passageways. Originally used during the Civil War to mine for chalk which was used by the Confederates in the manufacturing of gunpowder to supply it's troops. Back in the old days you could still see the remains of the mine tracks and cross-ties. The mine was in operation until around 1890. During its working years chunks of Tripoli (chalk) were removed and transported by rail car tramway across Bear Creek. The cars of Tripoli were then transported by mule and cart to a mill in Riverton and were shipped out by rail at the Riverton Train Depot. It is also told that the caves were used to treat wounded at some point during the Civil War although that may be unlikely due to the fact that injured troops convalesced at private homes-turned-hospitals in nearby towns like Corinth and Iuka. It was most likely used for shelter however.

NEMCC ONCE AGAIN BREAKS SCHOOL RECORD MOST ACADEMIC ALL-MACCC SELECTIONS

JACKSON, Miss. - The standard of excellence in the classroom among Northeast Mississippi Community College's student-athletes did not change during the 2020-21 school year despite challenges associated with the worldwide coronavirus pandemic. Fifty-seven young men and women representing all six competitive athletic programs at Northeast were recognized with Academic All-Mississippi Association of Community Colleges Conference (MACCC) honors.

It is the third consecutive year that Northeast has either tied or broken the school record for most Academic All-MACCC selections. The previous mark was 50 during the 2019-20 season.

"We are so very proud of these honorees," said Northeast athletic director Kent Farris. "I would like to commend our coach-

ing staffs and our success coaches Leigh Treloar and Jillian Guy for making sure that our student-athletes succeed."

The MACCC acknowledges both freshmen and sophomores from each of its 15 member institutions with scholastic accolades on an annual basis. Athletes must complete 24 cumulative hours between the fall and spring semesters or only 12 cumulative hours if in their final season of eligibility.

Nominees with a grade point average (GPA) between 3.25 and 3.79 receive the Academic All-MACCC award while those with a GPA of 3.8 or higher earn Distinguished Academic All-MACCC laurels.

The football program had the most winners for the second consecutive year with 17. Baseball was not far behind with 16 while softball had 10 of the 17 members on its active roster garner this dis-

inction.
