Local Guardsmen Staff Sgt. Robert Jason Belue Dies at Camp Shelby

Member of the Mississippi National Guard, Staff Sgt. Robert Jason Belue, 44, of Iuka, Mississippi, died Thursday, August 26th, 2021, while experiencing a medical emergency during a physical fitness test. Belue reportedly died while being taken by ambulance to the West General Hospital, according to officials.

Mississippi Governor Tate issued a statement regarding the passing of Staff Sgt. Belue and prayed for the friends and family of Staff Sgt. Robert Jason Belue of Iuka. He served with honor and dignity - including deployments with the 155th Armored Brigade Combat Team for 24 years. Elee and family are thankful for his service to our nation! May his soul rest in peace.

Staff Sgt. Belue served our country with exceptional honor and integrity earning several awards and decorations during his 24 years of



service including the Army Commendation Medal, Army Achievement Medal (2nd Award), Army Good Conduct Medal, National Defense Service Medal, Army Reserve Component Achievement Medal, Meritorious Unit Commendation, Navy Unit Commendation, Army Service Ribbon, Overseas Service Ribbon (2nd Award), Armed Forces Reserve Medal (2nd Award), Global War on Terrorism Service Medal, the Combat Action Badge, and Iraq Campaign Medal (w/ 4 campaign stars). He served on three deployments with the 155th Armored Brigade Combat Team, Mississippi National Guard in support of Operation Iraqi Freedom in 2005 and again for Operation Enduring Freedom in 2009, then Operation Spartan Shield 2018-2019.

The Mississippi National Guard Soldiers and Airmen honor the legacy of Staff Sgt. Belue and his contributions to our state and nation. Our thoughts and prayers are with his family and fellow Gunslingers."

Wilson Charged with Intent to Sell

On August 24th, 2021, Deputies with the Tishomingo County Sheriff's Department stopped Danny Lane Wilson on HWY 365 in Burnsville for careless driving and crossing into the oncoming lane. Deputies did a warrant check and found Mr. Wilson had a warrant in Iuka. He was placed under arrest. During the arrest, he attempted

to throw a bag of alleged methamphetamine on the ground. Deputies retrieved the substance and found baggies, scales, and other items which led them to believe that some of the alleged methamphetamine was to be sold as well. Danny was transported to the Tishomingo County Jail, where he was later charged with felony possession

of methamphetamine with intent to sell. The methamphetamine weighed approximately an ounce.

Services for Former Iuka Businessman Jimmy Marlin


James Alvin Marlin, 88, passed away peacefully on Friday, August 27, 2021 at his home in Iuka with family and friends surrounding him. He was a former Iuka businessman, owning the Chevrolet Dealership in Iuka and also served his community and state in various, both elected and appointed positions.

Jimmy, known by his friends as Skillet, graduated from Iuka High School in 1951. He attended Itawamba Jr. College and then decided to join the United States Army where he served his country as a Tank Commander in the Korean War. He was in the "Hell On Wheels" division.

After serving his time, he moved to Tupelo where he started his business career. Jimmy became a very successful businessman selling and trading cars. He co-owned the Lincoln-Mercury dealership which he later bought and managed. Years later, Jimmy moved back to Iuka where he took an active part in promot-

ing his hometown. He served on many boards and committees and co-owned and operated the Marlin-Moore Chevrolet dealership. Mr. Marlin served on the A&I board for the State of Mississippi and served as Game and Fish Commissioner for six years. For eleven years he was on the Tombigbee Water Management Board. He worked as an investigator for the State Insurance Commissioner, and was active in the Development Foundations for Tishomingo, Alcorn, Prentiss and Lee counties. Mr. Marlin served as president of the board for NASA Facilities Operations (Tri-State Commerce Park) and served on the TCEPA board for more than fifteen years where he served as President.

Jimmy was a Christian and a member of Harmony Hill Baptist Church in Burnsville, MS. He enjoyed hunting and fishing and was an avid nature lover. He loved to tell how he was instrumental in bringing turkey back to Tishomingo County. One of



his fondest stories to tell was how he and Elvis Presley were friends. Jimmy was deeply loved and admired by his family and friends and never met a stranger.

Mr. Marlin was born on October 16, 1932 in Fawn Grove, MS, the son of the late Theron Kendall (T.K.) and Vivian Lucas Marlin. He was preceded in death by his parents, his son, Mike Marlin, a nephew Ken

Vehicle Accident Claims the Life of a Belmont Man

According to Tishomingo County Coroner, Mack Wile, James Robert Montgomery, 69, of Belmont, died on August 30th 2021, as a result of the injuries he sustained in a one vehicle accident. The accident occurred at 8 a.m. on highway 4 near the Natchez Trace Parkway. Dennis Montgomery was driving east bound in a 2007 Ford Solstice; he was the only person in the vehicle.

It appears that Montgomery failed to negotiate a turn near the Natchez Trace Parkway overpass and the vehicle went airborne, rolled and the driver was ejected from the vehicle. He was found by a passing motorist and was pronounced dead at the scene.

The Mississippi Highway Patrol is investigating the accident and Deaton Funeral Home will be in charge of the funeral arrangements.

Letter to the Editor

At about 6:25 pm on Saturday, August 21, 2021, as I was preparing a meal in my kitchen on North Pearl Street in Iuka, we heard a brief siren and a loud boom just before we lost power. It was quite disconcerting to us and rather than seeking shelter, we ran to the front porch to see what was happening. Suffice it to say, by the time we got there, the damage had been done. What we witnessed was a street full of confused and devastated people with power lines lying in the middle of the street and cars atop one another along North Pearl. We live adjacent to Cutshall Funeral Home. I always heard people say that a tornado sounds like a train. There was no sound to this one.

My granddaughter, Megann, and her friend, Sabrina, happened to be

here. Sabrina is a nurse. She and I, along with my granddaughter, surveyed the situation and saw a neighbor, a widow, who stood on her front steps and who looked confused and in shock. We made our way down to her house, crossing downed power lines and climbing under tumbled trees and brought her to our house. It seemed that shock allowed us to only consider a small surrounding for the moment and though it was apparent that there was catastrophic damage in our area we simply could not grasp anything beyond what we saw.

As we ventured further, it became apparent that a tremendous amount of damage had been done to our "neighbor's neighbor." What I saw there shook me to the core. I saw one vehicle atop another. I saw longtime family friends who were just

beginning to realize that they'd lost most of their worldly possessions, and all I could say was, "Do you need anything and is there anything I can do?" I realized that I had Nothing. I had nothing to offer at that point except an assurance that we were in this together.

Pearl Street and its residents were in shock. We wandered about, taking pictures, checking on each other, wondering if the rest of the town had had similar damage. But mostly, we thought of ourselves, thinking that surely, we were the only ones to have been hit in such an indiscriminate kind of way.

The light of day and the ability to venture beyond our neighborhood showed us that Pearl Street was indeed not alone in its destruction. Streets to the east and to the west of Pearl were af-

fect. Streets as far north as Constitution Dr. had not been spared. And oh, our place of remembrance, the place where our parents and grandparents had been laid to rest, that place sustained perhaps the most damage of all. Damage that those who reside there no longer would have a voice to speak for themselves.

So, what do we do? For many years Oak Grove Cemetery has been declining. My parents, my grandparents, and my brother-in-law are buried there. Even when I did not live here, I made the effort to return to make certain that their graves were cared for and that seasonal arrangements were laid

Now what? Oak Grove Cemetery is decimated. Hundred plus year-old graves have been toppled. The majority of the decades year old cedar trees lay on their sides. The

Gazebo, that many of us drove through, stood for pictures, and maybe even have had someone tell another for the first time that they loved them, was toppled.

It is doubtful that any person reading this letter was not affected by the events of August 21, 2021. You all have a story to tell. Yet, the story I hope to tell is that we can use this time to bond together, to find ourselves in a position to put our often-petty differences aside and agree that together, we are stronger than we are apart.

We are a city of individuals. We are a city in need. We are a city that can rebuild. And I will say that our Mayor, Joel Robertson, has been there every step of the way. He was on Pearl Street the night of the 21st and I've seen him daily working

NOTICE OF A PUBLIC HEARING ON THE PROPOSED BUDGET AND PROPOSED TAX LEVIES FOR THE UPCOMING FISCAL YEAR FOR THE TOWN OF BURNSVILLE

The Town of Burnsville will hold a public hearing on proposed budget and proposed tax levies for fiscal year 2022 on September 7, 2021, 6 p.m. at Burnsville City Center.

The Town of Burnsville is now operating with a projected total budget revenue of \$1,900,900. 3.69 percent or \$70,000 of such revenue is obtained through ad valorem taxes. In the next fiscal year, the proposed budget has total projected revenue of \$3,743,700.00. Of that amount, 1.9 percent or \$70,000 is proposed to be financed through a total ad valorem tax levy.

The decision to not increase the ad valorem tax millage rate for fiscal year 2022 above the current fiscal year's ad valorem tax millage rate means you will not pay more ad valorem taxes on your home, automobile tag, utilities, business fixtures and equipment and rental real property unless the assessed value of your property has increased for fiscal year 2022.

Any citizen of the Town of Burnsville is invited to attend this public hearing on the proposed budget and tax levies for fiscal year 2022 and will be allowed to speak a reasonable amount of time and offer tangible evidence before any vote is taken.

A millage rate of 22 will produce the same amount of revenue from ad valorem taxes as was collected the prior year. The millage rate for the prior year was 22.



Braves Fall in Season Opener

Iuka, Miss. --- The Tishomingo County Braves fell in the 2021 Season opener at Braves Stadium to the visiting Manassas Mustangs 33 to 13 (0-1).

The Braves began the game with a lot of energy as Freshman Linebacker Chase Poling set the early with a vicious tackle on the Kickoff off of Senior Kicker Daniel's foot. His set the Mustangs with sub-par field position. The Mustangs, not deterred, went on an offensive drive that ate more than half of the quarter and reached Braves Red Zone. A Hopkins interception of the Mustangs' hand gave the Braves all at their own 10-line. The Braves were putting together an offensive drive and were to midfield when to consecutive plays giving penalty and a Braves Fumble ended scoring threat.

For the remainder of the first half, the Mustangs find some success

up the middle of the self-proclaimed "Wrecking Crew" Defense, something that did not happen much last season. Bryan Scales came alive with 44 yards rushing on just four carries in the Second Quarter. However, the Mustangs scored on three of their remaining four drives of the first half to take a 19 to zero lead into the locker room at half-time.

As has been the case in the Russo-era, the Braves never gave up and even clawed back to within 12 with two Fourth Quarter scores. Senior Quarterback Blake Counce found Junior Running Back Chandler Williams for a 50-yard Touchdown Pass and Daniel added the PAT out of the Hold of Gage Tackett. Hopkins again stripped a Mustang at the 1-yard line to set up a Counce one yard Touchdown Rush. Braves Stadium came alive when the Braves recovered an On-side Kick, however an off-sides penalty negated the recovery. The Mustangs would add one more score

late to put the game away. Russo lauded the play of linemen Austin Hairrell, Caleb Curtis, and McKinley Davis on Offense and Caleb Bonds on Defense. He also added that Freshmen Poling, Chase Booker, and Owen Nash stood out to him as well before watching film. He also applauded the play of Counce, who had almost 200 All-Purpose Yards, with over 100 yards rushing on the night. Poling paced the Defense with an impressive 17 tackles on the evening.

Head Coach Richard Russo had this to say of the evening, "Tonight is unacceptable and that starts with me. The product that was on the field was nothing like we practiced. We have to overcome our lack of experience and do it quickly. The lone positive was we never quit and played with relentless effort for four quarters no matter what the scoreboard said. However, the penalties and the lack of techniques has got to be fixed and fixed immediately. I have a feeling







Today is Friday the twenty-seventh day of August, 2021, but to me it has seemed like an unfinished day. All day from the time I shut off the alarm clock until right now, my thoughts have been a day I'm likely going to remember always.

The last sibling of my dad's, Eunice Page Quinn, was laid to rest beside her husband, Uncle Edward Quinn, in the Rutledge Salem Cemetery at ten o'clock.

I had gone to bed last night undecided as to what should I do? Should I go to my last living aunt's funeral or should I keep on hibernating to avoid getting exposed to Covid? I knew what Aunt Eunice would say, "Ruth, stay at home. At your age you don't need to have a battle with Covid."

I haven't got to go see her in over a year. I'd write her pretty often and I'd hear from her through her family. They were using I Phone and standing outside her room where they could see her and she could see them. No visiting or touching allowed. Her children had each a designated day to visit her even before the Covid restrictions.

Aunt Eunice was born

2-4-1920, and my dad and mom married 3-27-1921. She was the 10th baby of Will and Mae Page and the pet of her five living siblings.

Digress: Will and Mae Page have two baby boys and two baby girls buried at Bethlehem. Their names were Flora, Lora, Willard and David. These were from 1 to 3 years old except Willard. He was the twin of Uncle Millard Page and died at birth. My dad said Flora was the prettiest baby he ever saw. She had black curly hair.

I called my niece at East Prentiss this morning. She had decided not to go to the funeral and I, too, had decided not to go. I know I will never get settled because I didn't go to the grave-side service but I know if she could talk to me, she would say "You did what you should have done. Don't worry, you have too many memories to entertain you for you to get bored."

At 96 + 10 months, we will soon have an eternity to be together. You are with all your siblings, husband, parents, uncles, aunts, nieces, nephews and a host of friends already.

God has blessed Aunt

Eunice beyond measure - physically, spiritually, and materially.

Paraphrasing for Aunt Eunice, "I have enjoyed my journey here in this beautiful state and lived to enjoy my gands, great-grands and great-great-grands. After losing my parents and husband, enjoying the newcomers has pretty much filled my days.

It hurt me so badly to lose my two grand-sons but God had comforted me by my knowing they are in Heaven awaiting the arrival of each of us some day. I'll have to welcome all of you if you have put your trust in Jesus. They stand and smile as Jesus opens wide His arms and says welcome home MaMaw Eunice. These young men have so many they want you to meet."

Me, I want to help fill the void I know you children feel. So if you need to talk? Just give me a visit or call. Janette, Larry, Rick, and Vickie, all of you were students of mine except Larry. Sorry, Larry, I moved to Memphis and look what you missed. Just ask Janette, Rick and Vickie. They can fill you in. It may have been Rick who drew my picture writing on the chalkboard, with my dress above

my knees and my hose being held up above my knees with a garter - belt. The picture was mailed to one of my students in the hospital in Memphis and posted on the bulletin board where those passing got laughs even in the orthopedic hall and it didn't hurt me one bit!!

Laughter is good for healing. Keep all those memories and continue to share with each other. Love like you've never loved before. God is love. He restores and heals. Trust Him.



One of Iuka's First Brick Buildings Damaged by Tornado

One of Iuka's oldest brick structures was damaged by the tornado that hit Iuka unexpectedly on Saturday morning, August 21st. The building which houses law offices of Nicholas and Adrienne Phillips was built by former J. C. Jourdan in 1894. The old building was an unbelievable blow to the back of the building, causing an office on the second floor of the brick structure to fall into the alleyway in front of the building.

The beautiful brick building has survived over 100 years and has been a big part of Iuka's history.

Historic Building Becomes Phillips' Law Office


Adrienne and I bought the building in which our law office is located in the 1980s. The building pillars reflect the year 1896, which is presumably the year it was constructed. Prior to our purchasing it, the main floor had been the home of Jourdan Hardware for many decades. My dad recalled that the Selective Service (Draft) Board was housed in the front half of the top floor at one time, and then the phone company had its exchange equipment on that space later. Because we still lived in the Jackson, Mississippi area at the time, we rented the street-level retail space to J. A. Tucker Furniture Company.

When we moved to Iuka in 1989, we built a law office in the south half of the main floor. Subsequently, when more attorneys came into the office, we expanded that space to include the front half of the top floor. When that expansion was complete, the office included the reception area, a copy/file room, two visiting offices, a library/conference

room, a kitchen, two restrooms, an exercise space, offices for staff, three storage rooms, and three work offices for attorneys. For five years, Edward Jones Investments occupied the north side of the main floor. That part of the building is now used by Adrienne for quilting. For a number of years, we made that space available to the Needle Chasers Quilting Guild for the storage of quilt show equipment.

The recent tornado damaged primarily two rooms in the law office space and the back wall of the building on the second floor which is rented by friends for storage purposes. The other damages should be taken care of easily. And to put it in perspective, the minor difficulties we have experienced are nothing compared to those friends and neighbors in Iuka whose homes were destroyed. No property loss can possibly compare to the destruction of a home. We are just grateful that there were no injuries sustained and that we live in a community where so many have pulled together to help one another in a time of need.

Going forward, we plan to repair the damages to our building as soon as possible so that we can resume law practice—and quilting!

That brief time has been part of my life. I have started each year for over three decades.

As the years have passed, I have come to realize that attending to this simple task has helped me to begin each day with a special attention to how I plan to spend my time for the rest of the day.

Imagine my profound dismay when I thought that watch had been destroyed. The tornado that damaged my office building blew a window and part of a wall over on my desk, pulverizing a nearby bookcase, the computer monitor, two lamps, a

chair, and everything on the desk, including (I initially feared) that watch. Simply put, my office looked like a war zone. For the two days following the storm, my mind continued to turn to the fate of that watch. Finally, I decided to see if I could find it under all the rubble. It was almost with tears of joy that I located it, still in the glass bell which was supporting the weight of a shutter and thus protecting that timeless timepiece.



