





Church of Our Savior To Be Open For Dickens Christmas

The Church of our Savior, located on Eastport Street in Iuka, is one of the oldest places of worship in Tishomingo County. A small Episcopal congregation began worshipping in Iuka in 1866, but did not have a space of their own. Subsequently, Col. R.W. Price, a Methodist, donated land on which to build a church. Building commenced with the plans being provided by James B. Cook, a Memphis architect. The building was formally consecrated on September 28, 1873.

The structure exemplifies the "Carpenter Gothic" style of religious architecture which is fairly common among southern Episcopal churches. Displayed above the entrance to the church are two

Christian symbols: the cross and a sign of the Trinity. The stained glass window behind the altar was installed in 1910 by Robert C. Brice, a communicant who lived in Memphis and was an accomplished artist. The building had been had by the Railroad and the Hotel.

This historic building is now home to a Lutheran congregation. Services are held each Sunday at 4 p.m. In conjunction with the Dickens Christmas celebration in Iuka on December 17, there will be a special service in the church at 6 p.m. using the Dickens period. All are welcome to attend this special





Isaiah 52:13-15 says, "Behold My Servant shall deal prudently, He shall be exalted and extolled, and be very high. As many were astonished at Thee; His visage was so marred more than any man, and His form more than the sons of men; So shall He sprinkle many nations; the kings shall shut their mouths at Him: for that which had not been told them shall they see; and that which they

had not heard shall they consider. "The first part of our passage speaks of the suffering of Jesus; the second part speaks of His exaltation over the kings of the earth. I think that we all realize that kings, governors and potentates misused Him at His first coming. Soldiers mocked Him and spit in His face. Thorns composed His crown just before He was crucified, after having been beaten, slapped, ridiculed and shamefully handled. There is a day coming when this will not be

the case with Jesus. He will never suffer again; He will never be crucified again, but He will come again with a writing on His vesture and His thigh that says: "King of kings and Lord of lords" (Revelation 19:16). Contrary to much modern opinion, this day has not yet arrived, moreover, it is not to be "spiritualized", as some suppose. Jesus will come in the same fashion as He went away, and that is in a literal, yet glorified, body (Acts 1:10-11). Our verses also speak of Jesus "sprinkling many nations", and that certainly is not speaking of something that takes place in heaven! Our word "sprinkle" means: to give satisfaction, so Jesus is

coming to satisfy the hunger of nations for correct leadership and government. To suppose that this has already happened is to cover one's head with a bag and to refuse to see what is clearly prophesied in Scripture throughout the Bible. God means to bring this earth under His control; that is a part of the reason Jesus died, alone with the matter of paying for our sins. The world



UDC Met at Library

The United Daughters of the Confederacy, John Marshall Stone Chapter met November 15th at the Iuka Public Library. There were 2 members present and we completed UDC rituals. All resolutions were given. Our Program was "The Eubanks Soldier".

Jason (25) and his brother Darley (19) ended in the Company H August 16th, 1861. There were 10 companies that made the 14th South Carolina Infantry. Jason was a private and reserved and Darley was a prankster. Jason's mind he had fought the war before he joined his father in to let him join. The soldiers were fed 5 times a day in the heat. Most of the soldiers had no military training.

At first the brothers ate home regularly, after six weeks the letters quit coming. This caused his parents many sleepless nights. Mary Eubanks remembered the joy of finally receiving a letter telling her know they had survived the battle. But most of the letter broke her heart. It told of their hardships and told of being hungry and suffering from malnutrition due to food shortage. After reading the letters their father loaded up a wagon filled with rations. He took enough food to last the boys several days. He also took feed for his mules, a rifle and ammunition. It was going to take 10 to 12 days to reach his sons. He got so cold his hands got so numb during the journey that he had to sometimes fall off the wagon.

On January 1 the 14th Carolina came under fire, killing 9 and wounding 15 others. The

the sky when the soldiers' father stopped his mules in front of a farmhouse near the area he thought they would be, he was told that they were about a mile away. As he came near the camp he was stopped by a soldier. He asked his name and what was under the canvas covered wagon. Joe Eubanks could tell that the soldier knew of his sons by the look in his eyes.

Joe waited for him to tell where he could find his sons. The soldier stood there, his eyes fixed on Joe, he looked surprised. The soldier then dropped his head and told him to follow the road. What he saw was not a camp but several lean-tos, a poncho here and there held up frame made of sticks. The soldier's uniforms were dirty, torn and many blood soaked. He was lead to the unit's commanding officer Lieutenant Pickett. Pickett stood there and finally told him his sons had both been killed that day, January 1, 1862, during the raid on the Port Royal Ferry. Pickett told him all about the battle and they would be burying his two sons with the rest of the man. But the father told him he would be taking his two sons home for burial.

They were buried in Springs Methodist Church, Aikens County. They were laid side by side in a single grave, where they had first placed their lives in the hands of God. On their headstone it reads:

Our sons have left this world of woe
For regions of eternal love;
Twas God who called them from below,
To join in praising Him above.


