Coleman Park Studios opens near Pickwick Lake and Tri-State Commerce Park

A new set of residential suites near Coleman Park and Tri-State Commerce Park are now open.

Coleman Park Studios includes ten furnished units with kitchenettes, laundry, patios, and grills aimed at filling the need of many companies to house workers for extended stays, explained Henry Harris, local supervisor for the construction firm of Joiner and Raynard Construction, LLC.

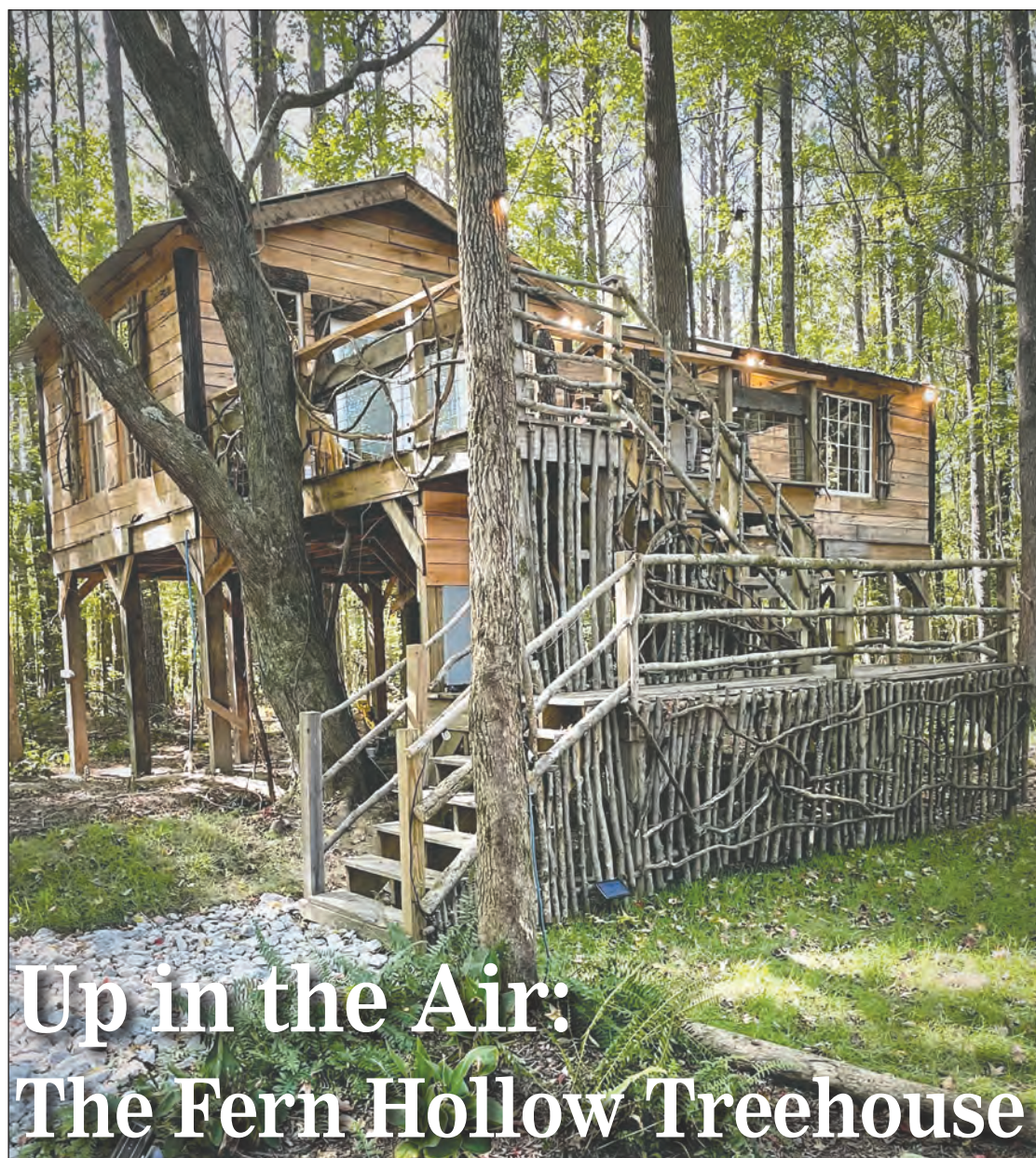
Each unit has sofa beds and two bunk beds, and all the furnishings necessary for just a weekend fishing trip or an extended stay for a construction or business trip. Coleman State Park is just down the road from the units, as are companies like Northrop Grumman.

Thanks to company administrator Tammy Reeves, the units have homey touches like Pickwick Lake pillows and even lake and Park photography on display from local photographers. Together, the team, including construction supervisor Bo Johnson, and a crew that does everything from painting and hooking up televisions to making up beds, got the units ready for guests in the last two weeks.

"We've had a lot of interest from local companies because there are very few options for people to stay," said Harris. "We want them to be a home away from home for folks coming in to work at Tri-State, or coming to fish with a guide. These are just a small part of what we are doing, but they were easy to get done first, and we are working toward finishing the hotels now."

The hotels are the two Iuka hotels that Joiner and Raynard started renovating at the beginning of 2022. They already completed the renovated *Tishomingo County News* building downtown, which also houses their local construction offices. Their headquarters are in south Florida, but owner

Up in the Air: The Fern Hollow Treehouse

Hint: it's more impressive in person

After two years of construction, the Fern Hollow Treehouse in Tishomingo is complete and available for a unique outdoor experience. As the pictures online began to spread from local realtor/owner Debra Kay, many people began sharing the details of what this treehouse had to offer. And to let you in on a little secret, it's more impressive in person.

As I approached the property, I drove through the gated entrance deeper into the woods. Like something out of a movie, the forest magically opened up and inside sat a treehouse, surrounded by naturally growing ferns encompassing the property. Individualized outdoor spaces include hammocks, an large fire pit, and an outdoor dining area, all made out of materials sourced directly from the property. I could feel a sense of calm come over me, just as the space was designed to do. You truly get a sense of being completely off the grid while surrounding by nature.

With no official floor plans designed, Debra created much of it from her own imagination, which made

Absentee ballots now available for Nov. 8th general election

Circuit Clerk's office open Saturday for voter registration

Absentee ballots are now available for the November 8th General Election at the Tishomingo County Circuit Clerk's office in the county courthouse.

You may come to the Circuit Clerk's office to vote by absentee ballot Monday – Friday, 8 a.m. to 5 p.m. All voters who vote by absentee in the Circuit Clerk's office will be required to show a photo ID. Absentee ballots may also be requested and sent by mail if the voter meets the necessary criteria. All mailed absentee ballots must be received by 5 p.m. on November 15, 2022 and postmarked on or before election day to be eligible to be counted.

Saturday, November 5, 2022 will be the last day to vote an absentee ballot in person at the Circuit Clerk's office. We encourage those who need to vote absentee by mail to call our office as soon as possible to have sufficient time to go through the absentee by mail process. No absentee ballots may be hand delivered to anyone.

Still time to register to vote!

The Circuit Clerk's Office will be open till noon on Saturday, October 8th, for voter registration.

The last day to register and be eligible to vote in the November 8th general election is Monday, October 10th at 5 p.m.

The November 8th sample ballot is in this edition for your review ahead of visiting the polls.

it difficult to source labor to help. With a little sweat equity, along with a few spirited people willing to make the creation come to life, she created the treehouse. Set high upon the property, the treehouse is actually split into two different spaces, divided by a catwalk. As you enter the house, you come into a living/kitchen space with all the amenities you would need to stay comfortably. A small studio space includes a refrigerator, TV, cookspace, and sink area to create a simple meal. Upon exiting to the catwalk, you are suspended above the woods on your way into the bedroom space. This includes a large bed, beautiful open windows, and the most dreamy soaking tub overlooking the private woods to the back of the property. Both areas come with a built in fireplace to keep the cozy spirit throughout the year. And for those wondering, it also comes with internet if you simply must connect to the outside world.



As I asked Debra about some of the design elements, she explained she would begin constructing a space, but often switch directions as it came to life. The railings, originally, had wire put around them for safety and stability, but she began adding vines and tree branches as she found them in and around the property. Most touching are some of the wood pieces that were created from a tree that was taken from her mother's yard. The tree fell due to a storm and her father helped get it transported. That sense of using what you have and tying it to history was instilled in her early in life and she continues to incorporate it into the properties she helps design.

Debra currently owns three rental properties with a fourth in the works in downtown Tishomingo. All of her properties feature a cabin design with a natural experience. When asked why she does short term rentals, she explained that it's a way to share her town with people visiting but to also gain an experience back from whoever rents as they are on a journey as well.

If you're looking for a relaxing experience, close to the state parks, look no further than the treehouse. You can reserve your stay through AirBnB. I guarantee you will not be disappointed and neither will any visitor on your adventure.

Julien Raynard comes monthly to check progress, and Andy Joiner is on the ground in Iuka, working daily with Harris and the construction crews on all the projects.

Joiner and Raynard hoped to have the hotels open by now, but have been dealing with crew and material shortages like all construction projects. Last week, their corporate offices were decimated by hurricane Ian, and

everyone down there is working on picking up the pieces. All the people are unhurt, but the cleanup from the devastation has just begun.

"We are glad to get this project completed, it's a bright spot during a very difficult time, and we appreciate everyone asking about our associates in Florida," said Harris.

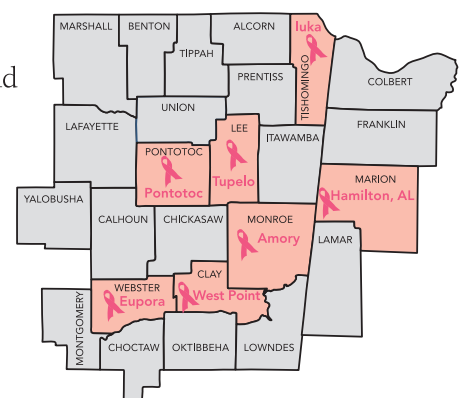

As human beings, we like to have continuity. We need to have confidence that things are where we left them. We need to feel like we have a reasonable amount of control over the things we care about. We put our car in the garage because we want to protect it from the weather, theft, and vandalism. We put our gold, cash, and precious items in a safe that only we can open. I don't shoot my Granddaddy's old guns, but you can bet that I protect them like the priceless items that they are. Upon death, we put the bodies of our precious loved ones in a casket or urn and keep them in a cemetery or other special, designated place in order to maintain their dignity and our connection with them. We can't tolerate the idea of throwing away precious items just because we rarely or never use them anymore. They have a place, and we need to know that they are in that place.

Not long ago, my family had the difficult experience of having to put down our dog, Caesar. Caesar was an enormous black Labrador Retriever, and he was the very definition of a good boy. Caesar lived for his family and when he got too sick to carry on with comfort and dignity, his family made the right choice for him. Caesar was not just a dog. He was part of our family, and his memory still is. Caesar is buried

right behind my house in the designated pet cemetery where all our furry family members eventually end up. Caesar didn't become trash the moment he drew his last breath. Like my deceased human family, Caesar is in his place.

As many of you know, I was born to be a funeral director. Like my mother, grandparents, and great-grandparents before me, my career chose me at conception. As much as I fought to do what I wanted to do, I was always led back to where I belong. And now, I am in my place. Being in my place has taught me about what we value and what we expect from those we entrust with things that are precious to us. When a family leaves the remains of their loved one in my care, they expect me to understand that what I am caring for is more than just remains. I am caring for the hands that stroked their forehead when they were sick. I am entrusted with the face that was there when they awoke every day. I am sheltering the arms that held them when they couldn't hold it together themselves. It's more than a body. It's a precious, valuable connection to a relationship that will never die. I am entrusted to make sure that everything ends up where it's supposed to go. Everything has a place.

It should come as no surprise to anyone at this point that we have an animal problem in our county. There is a never-ending supply of unwanted, lost, or stray animals that must be dealt with by someone. Most of us don't like thinking about what happens to those animals, and I can assure you that if you investigate it, you won't like what you find out. What you will find out is that we don't have as much of an animal problem as we do a people problem. Out of sight, out of mind is a powerful motivator to do nothing. So, when images recently surfaced of dead pets allegedly being dumped in the household garbage area of the local county landfill, many people were shocked and outraged, and naturally wanted to find out who is at fault.

The truth is that this is a common practice in many cities and counties. The truth is that it is not the animals, but the humans who are the problem. The truth is that the least among us have no place. When they are gathered up and summarily killed because they are unwanted or euthanized by a caring family that doesn't have the space or ability to properly dispose of these animals, the bodies pile up and have nowhere to go. The humans don't value them enough to



even have a designated area of the landfill to humanely and hygienically dispose of them. They become, in effect, garbage.

We immediately try to blame the animal rescues, the veterinarians, and law enforcement, but that blame is misplaced. The blame is ours. Our elected officials make the decisions about these issues, and we, the voters, have chosen these people to represent us. Our elected officials are a reflection of our own values. It wouldn't cost anything to designate an area for proper disposal of animals. We have a gigantic hole in the middle of the county that we already shove old refrigerators, furniture, and construction waste into. We already have the backhoes, dump trucks, and bulldozers to move the dirt. What we don't have is the understanding by those in control that this matters to us. And until we, as voters, make our concerns known, nothing will change. We can, and must, do better. Everything has a place, including the least of us.

District Attorney John Weddle visits Tishomingo County Republicans

On Tuesday, September 27th, the Tishomingo County Republican Party met at Sparks Drive-In in Belmont. The special guest for the evening was District Attorney John Weddle.

The meeting was begun with the "10 Minutes of Hope" presentation by Pastor Ron Norvel of the 1st district at New Salem Baptist Church north of Iuka. Pastor Norvel was very passionate about where the hope of humanity comes from, the Lord Jesus Christ. The group was inspired to put God first in every decision and love with the heart of Christ.

Colonel Ghannon Burton of www.MFMA.us spoke about the Brian Flowers campaign for Congress in the 1st Congressional District and urged everyone to help defeat Representative Bennie Thompson.

School Board Member Stacey Stepp gave a report on the recent happenings at the School Board. The group was encouraged that children will continue to be taught reading, writing, math and history, and not things that are being pushed by a radical minority at the national level. The group thanked the School Board for standing bravely for our community principles.

The keynote speaker was District Attorney John Weddle who was accompanied by Assistant DA Clay Cummings. Senator Sparks and Representative Carpenter were on hand along with Circuit Clerk Josh McNatt, Supervisors Greg Collier, Nicky McRae, and Supervisor Eric Booker as was Chief Mike Kemp and Chief Donald Ray Thomas. DA Weddle reported that his office is aggressively pursuing drug dealers and doing everything they can to help local law enforcement to deal with an obvious problem in Tishomingo County. He praised the Sheriff's office and local Police Departments for being vigilant and focused on not only meth and other drugs, but also on Fentanyl. Three persons died in Tishomingo County alone recently due to overdoses of the drug. Colonel Burton spoke up that the equivalent of three

Vietnam's worth of Americans have died due to the drug problem.

The District Attorney has been focused on many other areas of concern as well. It is clear that he and his office have turned up the heat on crime and will continue to do so. It is critical that we maintain leadership in our district and state that will fight for our children and citizens.

DA Weddle honored the group by presenting the Segars Award for Conservatism to Mr. Noah Carpenter and Mrs. Sheila Phifer.

Bassmaster Kayak Series wraps 2022 season on Pickwick Lake

COUNCE, Tenn. — Talented kayak anglers from around the country take to the waters of Pickwick Lake, Tenn., October 8-9 for the final regular-season stop of the Yamaha Rightwaters Bassmaster Kayak Series powered by TourneyX season.

Competition starts each day at 6:30 a.m. CT, with lines out at 2:30 p.m. An award ceremony will be held Sunday at The Lodge at Pickwick Landing at 4:00 p.m.

The Tennessee B.A.S.S. Nation ranks Pickwick as the best lake in the state and, in the recent Bassmaster Magazine ranking of the country's 100 Best Bass Lakes, beautiful scenery paired with a chance to catch a trophy trifecta — smallmouth, largemouth and spotted bass of above-average size — helped Pickwick claim the No. 16 spot in the Southeastern division.

Not only will the Old Town Bassmaster Kayak Series Angler of the Year be crowned, but it will be the final chance to qualify for the Kayak Series Championship that will be held on Chickamauga Lake in conjunction with the 2023 Academy Sports + Outdoors Bassmaster Classic in Knoxville, Tenn.

Sitting atop the field with 972 points in the Angler of the Year race is Justin Largen of Roanoke, Va., who won the

second event at Florida's Harris Chain of Lakes and followed that up with Top 10 finishes in the next two tournaments at Oklahoma's Grand Lake and Lewis Smith Lake in Alabama.

"When I saw B.A.S.S. was doing an Angler of the Year, I signed up for all of them right away," Largen said. "The win was huge for me. It was my first win at a national level and there were a bunch of big names fishing. It was a huge confidence boost.

"Going into Grand and into Smith, they weren't places I have fished before and I didn't have a ton of confidence, but my goal was to be competitive and stay relevant. Don't have a bomb and take myself out of it. To be leading it feels great."

Largen is followed closely by West Virginia angler Larry Edwards (967 points) and Garrett Morgan (950), who led the AOY standings through the first three events and took the victory in the season's first tournament at Lake Fork.

Instead of a standard weigh-in that requires scales measuring pounds and ounces, anglers will practice "catch, photograph and release" to determine the kayak tournament standings.

When an angler catches a bass, he or she will photograph it lying on an approved measuring board and submit

the photo through a special mobile app provided by TourneyX. The boards will measure each bass in inches down to a quarter of an inch, and the angler with

the longest five-bass limit will win.

The tournament is being hosted by the Hardin County Convention and Visitors Bureau.

will be expanding into the space in the building on Constitution Drive that about one-third of the county's registered voters use each election. The election commission and McNatt have determined that the Boy Scout building on Paul Edmondson Drive will be the site of all future elections for that precinct, and will be advising all November 8th voters of that change.

Some changes to accommodate accessibility and parking will be made to the building with funds designated to do that, reported McNatt.

In other board news:

The board approved sending Black

Knight Data and Analytics county property information. The tax assessor's office does this each year, and just needed board approval.

The board approved funding and proceeding with a new county website, based on Prentiss County's site. There's a \$950 initial setup fee and then \$189 monthly payment. At the board's urging, Peyton Cummings office will pay that.

Supervisor Nicky McRae warned that the site "better not be used for politicking." Cummings assured the board it was an information site for the public and will include things like forms, archived documents and county newspapers, and records for public

review.

The board approved final payments of \$4,867 for Dean McRae Engineering and \$88,626 for Pearson Construction for the completed Golden Fire Department building. Fifth District Supervisor Greg Collier and involved parties have a walk-through scheduled for this week, he said.

The board approved a state mandated raise for youth court judge Joey Cobb, which was already included in the

budget, assured Cummings.

Joe Spencer of JR's Wholesale visited with the supervisors and told them his wholesale/surplus store had many items they or their crews might need like tools, protective gear and supplies.

The board approved the plat for Deer Park, a subdivision off Constitution Drive in Iuka being developed by Joiner and Raynard.

Two easy soups to warm your souls on fall weekends

On fall or winter weekends for years, we have been making a good pot of hearty soup on Friday evenings, and eating it throughout the weekend. Once that first cool morning shows up, we whip those recipe books down and start looking at recipes we haven't made since April. Red beans and rice, beef stew, chicken noodle soup, potato soup or one of several excellent chili recipes my husband makes are meals that are like coming home after a long hot summer!

The one place I don't relish change for the sake of change in my life is the food I eat. If it's already a favorite, why

would I put green peppers, or sausage, or cheese, or my husband's eternal suggestion - artichoke hearts - in it? But, I admit, he's usually right.

So when I saw lasagna soup come over my Instagram, I thought, I already make good lasagna, why would I try that? Well, we did, and it's a winner. Definitely a keeper recipe for us!

I'm also keen to try this weekend a favorite Chicken Tortilla Soup recipe that we start in the crock pot in them mornings. It fills the house with yummy smells and by the time I'm home from work, it's ready!

I never got on the "tortilla soup"

wagon for years, because that just sounds like a soggy mess. But curiously, this has no tortillas in it - but we do eat it with tortilla chips alongside.

Try one of these this weekend and sit outside on the porch, or in the yard to eat it! Maybe arrange or carve a pumpkin and embrace fall!



Lasagna soup is a bit easier than actual lasagna, and just as good. Pair with some good homemade bread, or pick up a baguette or garlic bread from the store.

Lasagna Soup

- 2 Tbsp olive oil, divided
 - 2 lbs lean ground beef (or 1 beef, 1 sausage)
 - 1 diced yellow onion
 - 3 cloves minced garlic
 - 4 1/2 cups low sodium chicken broth (+ extra if you need to thin out)
 - 1 (14.5 oz) can diced tomatoes
 - 1 (14.5 oz) can crushed tomatoes
 - 2 1/2 Tbsp. tomato paste
 - 1 1/2 tsp. basil
 - 1 tsp. oregano
 - 1/2 tsp. rosemary
 - 1/2 tsp. thyme
 - 1/2 tsp of red pepper flakes
 - Salt and pepper to taste
 - 8 lasagna noodles broken up
 - 1 1/4 cups mozzarella
 - 1/2 cup Parmesan
 - 8 oz ricotta cheese
 - 2 Tbsp parsley
- Heat 1 Tbsp olive oil in pit over medium heat. Brown ground beef, season with salt and pepper, drain and set aside.
Heat remaining oil and add onion and cook for 4 minutes, then add garlic and cook another 30 seconds.
Add chicken broth, diced tomatoes, crushed tomatoes, tomato paste, basil, oregano, rosemary, thyme, ground beef, pepper and season with salt and pepper. Bring to a boil, add in lasagna noodles, then reduce heat to medium-low, cover, and simmer for 20 minutes.
In a bowl, mix mozzarella, Parmesan, ricotta and a little parsley.
Ladle soup into bowl, dollop with cheese mixture and watch that oooney goodness melt into the soup. Enjoy!



This chicken tortilla soup is the easiest soup to make, and so worth waiting for!

Chicken Tortilla Soup

- 1 pound boneless, skinless chicken breasts
 - 2 (10.75 oz.) cans condensed cream of chicken soup
 - 1 cup salsa (I prefer Frontera Chipotle)
 - 2 cups frozen corn
 - 1 can black beans, drained and rinsed
 - 1 1/2 cups chicken broth or water
 - 1 Tbs. Southwest seasoning (we used Brooks' Ancho Chile Fiesta Rub)
 - 1 Tbs. dried cilantro (or 1/4 cup fresh, chopped)
 - salt and pepper
 - 1 cup shredded cheddar cheese
 - tortilla strips
 - green onions
 - diced tomatoes
- In a slow cooker/crock pot, place chicken breasts, and then all the other ingredients except cheese. Stir to combine, and cook on Low for 6 hours.
Stir occasionally if you can - I have some trouble with it sticking if I totally ignore it.
After 6 hours, pull out the chicken and place on a plate. It should be cooked through - if not, put it back on. Using two forks, shred the chicken, and then put it back in the soup. Add cheese, and stir until combined.
Serve with any or all of the toppings.

UDC Program about hospitals in wartime

The John Marshall Stone Chapter, Chapter 394 met at the Iuka Public Library September 26th at 2 p.m. We completed the UDC rituals and each officer gave their report and all was approved. Dues were collected and letters sent out to members that didn't attend. Old and new business discussed was how to improve and grow our membership. We signed cards and sent out to those having birthdays. We also voted for Vicky Durham to buy a book of stamps when needed. We had four members present.

Our September program was presented by President Sharon Hairrell. The topic was "Caring for the Soldiers - Wayside Hospitals, Field Hospitals and Receiving Hospitals." The beginning of the war for the South brought confusion and disease. Many caught pneumonia, tuberculosis, scurvy, measles, chicken pox, yellow fever, scarlet fever, typhoid fever and rheumatism fever. More died from diseases than wounds.

The camps were neither clean nor sanitary, and the water was not clear or fit to drink. They were lucky to get a complete bath once or twice a month. They did wash face and hands daily but with contaminated water. Food was another source of a health issue. They had very little if any fresh vegetables and fruit.

Samuel Preston Moore was born in Charleston, SC, in 1813 and graduated from the Medical College of the State of South Carolina in 1834. While serving in Texas during the Mexican War (1846-1848), Moore met Jefferson Davis, future president of the Confederacy.

When South Carolina seceded from the Union, Moore resigned his commission as surgeon in the U.S. Army and returned to Little Rock to open a private practice. Soon after returning to Arkansas, Moore began receiving requests from Jefferson Davis to join the Confederate army. In his correspondence to Moore, Davis

described the deplorable conditions caused by the overwhelming number of casualties and a lack of Southern physicians trained in military medicine. Moore accepted the position of acting surgeon general on July 30, 1861, and was confirmed by the Confederate Senate in November of that same year.

Moore's job was to organize personnel, start hospitals, and secure medical supplies and equipment. This was not easy and he had to deal with shortages of everything. He needed trained medical personnel and they were hard to find. There were many that were not properly trained. He formed a board to help weed out the quacks and the incompetent.

Women would smuggle supplies in under their hoop skirts and in doll heads. They used blackberry wine to fight fatigue, many plants were used for drugs.

There were many different hospitals. A yellow flag marked the hospital as one with smallpox. Wayside locations cared for the sick and Field care for the wounded and sick, before being transferred to the general hospital. Receiving had 32 beds wards connected to groups of 45 beds to form a general hospital.

Women begin doing nursing duties and so did some soldiers as they got better until they rejoined their troops. Nursing carried a wide range of duties including custodial duties, bathing soldiers, cooking, laundry, and dressing wounds. If hospitals were overcrowded, home care was given.

Hospitals not only needed drugs and equipment, but also dishes, spoons, bottles, straw for beds, and milk and fresh food. Many of those that did not given supplies gave money to help buy supplies.

§ 2635.101 Basic obligation of public service.

- (a) **Public service is a public trust** Each employee has a responsibility to the United States Government and its citizens **to place loyalty to the Constitution, laws and ethical principles above private gain**. To ensure that every citizen can have complete confidence in the integrity of the Federal Government, **each employee shall respect and adhere to the principles of ethical conduct set forth in this section**, as well as the implementing standards contained in this part and in supplemental agency regulations.
- (b) **General principles.** The following general principles apply to every employee and may form the basis for the standards contained in this part. Where a situation is not covered by the standards set forth in this part, employees shall apply the principles set forth in this section in determining whether their conduct is proper.
- Public service is a public trust**, requiring employees to place loyalty to the Constitution, the laws and ethical principles **above private gain**.
 - Employees **shall not hold financial interests that conflict with the conscientious performance of duty**.
 - Employees shall not engage in financial transactions **using nonpublic Government information or allow the improper use of such information to further any private interest**. [Insider Trading]
 - An employee shall not, except as permitted by subpart B of this part, **solicit or accept any gift or other item of monetary value from any person or entity seeking official action from, doing business with, or conducting activities regulated by the employee's agency**, or whose interests may be substantially affected by the performance or nonperformance of the employee's duties.
 - Employees **shall put forth honest effort** in the performance of their duties.
 - Employees **shall not knowingly make unauthorized commitments or promises of any kind** purporting to bind the Government.
 - Employees shall not use public office for private gain**
 - Employees **shall act impartially and not give preferential treatment** to any private organization or individual.
 - Employees shall protect and conserve Federal property and **shall not use it for other than authorized activities**
 - Employees shall not engage in outside employment or activities, including seeking or negotiating for employment, that conflict with official Government duties and responsibilities.
 - Employees **shall disclose waste, fraud, abuse, and corruption** to appropriate authorities.
 - Employees **shall satisfy in good faith their obligations as citizens**, including all just financial obligations, especially those - such as Federal, State, or local taxes - that are imposed by law.
 - Employees shall adhere to all laws and regulations that provide **equal opportunity for all Americans** regardless of race, color, religion, sex, national origin, age, or handicap
 - Employees **shall endeavor to avoid any actions creating the appearance that they are violating the law or the ethical standards set forth in this part**. Whether particular circumstances create an appearance that the law or these standards have been violated **shall be determined from the perspective of a reasonable person with knowledge of the relevant facts**.

(c) **Related statutes.** In addition to the standards of ethical conduct set forth in this part, **there are conflict of interest statutes that prohibit certain conduct. Criminal conflict of interest statutes of general applicability to all employees, 18 U.S.C. 201, 203, 205, 208, and 209**, are summarized in the appropriate subparts of this part and must be taken into consideration in determining whether conduct is proper. Citations to other generally applicable statutes relating to employee conduct are set forth in subpart I and employees are further cautioned that **there may be additional statutory and regulatory restrictions applicable to them generally or as employee of their specific agencies**. Because an employee is considered to be **on notice of the requirements of any statute**, an employee should not rely upon any description or synopsis of a statutory restriction, but should refer to **the statute itself and obtain the advice of an agency ethics official as needed**.

Joseph Scott, Jr. and Jeff Lovelace claim title at World Championship of Catfishing

Pickwick Lake was once again the location for the 2022 World Championship of Catfishing (WCC). Savannah Tennessee carries the moniker, "The Catfish Capital of the World." The main reason for that designation is the annual National Catfish Derby and World Championship of Catfishing that has taken place there along the Tennessee River for 81 years.

Savannah is a great trophy catfish destination and anglers like to fish the area. Some of the top names in catfishing are usually competing in the event.

The event includes the month-long National Catfish Derby that awards a Big Fish award every week for a month preceding the championship. This year's National Catfish Derby winners are:

Week 1 Colby Hutton - 27.2

Week 2 Jeff Lovelace - 38.2

Week 3 Amy Butler - 31.00

Week 4 Rick Murphy - 31.00

The 2022 WCC competition included some of the best catfish anglers in the nation. The dynamic duo of Phil King and Phil Haynie won the event in both 2020 and 2022. They were back to defend their championship.

First Place

Joseph Scott Junior from Dyersburg, Tennessee, and Jeff Lovelace from Iuka, Mississippi teamed up to earn the first place check with a bag weighing 93 pounds. As one of the top three teams, they also earned a berth in the King Kat Classic to be held November 4th and 5th in Decatur, Alabama, on Wheeler Lake and the Tennessee River.

Junior and Lovelace fished this tournament last year on the river side of the dam with little success. This year they decided to try their luck on Pickwick Lake.

"The odds were against us," suggested Junior. "We were going up against anglers like Larry Muse and Mike Follin; Steve Douglas and Paula Curtis Smith; Phil King and Phil Haynie; Cedric Poyner and Wayne Reed just to name a few."

Junior and Lovelace didn't pre-fish. They used their time to scan different locations in an attempt to set a strategy.

"We figured out that the fish were spread out a bit," reported Junior. "So, we decided to spend most of our time the day before the tournament catching fresh bait. We had a decent stretch of lake picked out to drag our planner boards and cover as much water as we could."

On tournament day the team launched their SeaArk and started dragging Parks Planner Boards in 18 feet of water. They gradually worked their way to 35 feet.

"We were catching fish about every 25 to 30 minutes," Junior said. "The first fish hit the planner board with an open spool as we were letting it get far away from the boat. It was a scramble to get it before it backlashed the reel."

"We rigged Boss Hog Rods with 30- to 50-pound Slime Line," explained Junior. "We added a 3- to 5-foot leader and a Kirby Float. The terminal tackle was finished off with a Dale's 12/0 Circle Hook and a 4-ounce Bobby Weight from Partners in Slime."



Everything was going smooth until around 9 am when Lovelace hooked into a decent fish and Junior grabbed the net. As he hurried to the rear of the SeaArk his phone case caught on the console and the phone fell out just as his foot was coming up on the deck. You guessed it, he kicked the phone into the lake. Not to be diverted he continued to land the fish.

"We continued to drag river channel ledges," added Junior. "About 2 pm we got into an awful snag and lost rigs on 6 rods. Five of our Parks Planner boards ended up in a complete mess when our batteries finally ran out."

The team worked through the mess of lines and boards to find a 22-pound blue on one of the lines. That fish let them cull one fish and left them with a total weight of 93 pounds to claim the top spot. The biggest fish in their bag came to the boat at about 7 am. It weighed 43.2 pounds, just 4 ounces shy of the winning Big Fish. They caught 12 fish on the day.

"We want to give a shoutout to Meat Hunter Rods," concluded Junior. "Also, to SeaArk Boats, Parks Planner Boards, Smackdown Rod Holders, Dale's Tackle, River Rat Reel Repair, and Partners in Slime."
