The Tishomingo County community mourns the loss of "Tommy Jack" Ramsey who died Tuesday from complications of being struck by a vehicle crossing the street to attend Wednesday night services at Iuka Baptist Church last week.

Funeral/memorial arrangements will be released at tishco.news when they are available, later Wednesday from Cutshall Funeral Home.

Ramsey served on the Northeast Mississippi Community College Board of Trustees since 1983 and has been chairman since 2006. Dr. Ricky Ford, NEMCC President, recalled Ramsey's professionalism in the role, and



Driver survives collision with log truck Thursday morning

A driver on Highway 350 Thursday morning is miraculously alive after colliding with a log

According to Deputy Sheriff Ryan Glover, the driver was eastbound on Highway 350 at about 7:30 a.m. Thursday when she collided with a log truck that had just entered the highway from the road near Fairview Church. The angle of the sun at that time effectively blinded her and she likely hit the loaded truck at full speed, it appeared, said Glover.

Logs extending from the back of the truck went all the way through her windshield through the back window, and she survived because two went on either side of her head. Her car hit so hard it damaged the bumper of the log truck.

The driver, a Ms. Goodman, was taken from the scene by ambulance, with injuries to her shoulder, Glover reported. The truck driver was unhurt.

years as president of Northeast," said Ford Tuesday afternoon in an interview. "He was a phenomenal person to work with, always cordial, and polite, and above all, passionate about Northeast and moving the college forward. He was serious about making Northeast the premier

institution it is."

Ramsey was a retired banker with First American National Bank in Iuka. He worked in lending and human resources.

According to Iuka Police Chief Randy Stringer, the accident happened just before 6:30 p.m. Wednesday evening

October 26th. Ramsey, 78, was crossing Eastport Street going south to the church when he was hit by a minivan headed east on Eastport.

Ramsey was in critical condition at Regional One in Memphis for several days but finally succumbed to multiple injuries, the most serious

being head trauma.



This week's Pet of the Week is Stella McRae. She's an 18-month-old Scottish Deerhound who enjoys living on the farm with Kirby and Pamela McRae, her fur-sister Rosie, and her new deerhound buddy, Dilsey, 12 weeks She loves laying around like a lazy teenager, but also enjoys her public outings like Iuka Heritage Day, where people often remark on her size (she's nearly 30 inches tall), and ask if she's an Irish wolfhound (no!). She is active in the show ring, and has 5 points (of 15) toward her confirmation championship. She already has her AKC Canine Good Citizen Advanced and Urban titles, for which she demonstrated being a good girl in public, in restaurants, stores and hotels, and even elevators.

Deerhounds are an ancient breed that has hardly changed since they were developed by Scottish nobles to hunt large red deer. They were one of the first breeds shown in early dog shows in Britain in the 1800s, which saved the breed, as the development of more advanced

firearms made them not as necessary to hunting. They have a devoted following in Britain and America, as they are laid-back and devoted companions. Today, they participate in competitive coursing events and love to run when they are not curled up on a cozy bed or sofa.

Scottish deerhounds are rare, but are seen more and more often in media, like Disney's "Brave," The Crown TV series, and even recently on Saturday Night Live! One of Stella's British kin portrayed Sirius Black in Harry Potter/The Order of the Phoenix. American dog lovers may have seen "Claire," one of the top deerhounds in the country win back-to-back Best in Show at the televised National Dog Show in 2020 and 2021.

With a small gene pool since it's a rare breed, Deerhounds have special health issues breeders and owners take care to be aware of. Dr. Perkins keeps this information on file, and is always willing to go the extra mile for our show dogs.

Pumpkin-Cranberry Streusel Quick Bread

Cake

3 cups all-purpose flour

- 1 tbs. plus 2 tsp. pumpkin-pie spice
- 2 tsp baking soda
- 1 ½ tsp salt
- 3 cups sugar
- 1 (15-oz) can pumpkin puree
- 4 large room-temperature eggs
- 1 cup vegetable oil
- ½ cup evaporated milk
- 1 cup fresh or frozen cranberries or half fresh/frozen and half dried

Streusel Topping

- ¼ cup all-purpose flour
- ¼ cup sugar
- ¼ cup packed light-brown sugar
- ½ tsp cinnamon

2 tbs melted butter

1/2 cup coarsely chopped pecans

To make the streusel: In a small bowl, combine ¼ cup all-purpose flour, ¼ cup sugar, ¼ cup packed light-brown sugar, ½ teaspoon cinnamon, 2 tablespoons melted butter and ½ cup coarsely chopped pecans. Set aside.

To make the cake: Heat the oven to 350 degrees. Coat two 9x5-inch loaf pans with cooking spray and set aside.

In a medium bowl, whisk together 3 cups all-purpose flour, 1 tablespoon plus 2 teaspoons pumpkin-pie spice, 2 teaspoons baking soda and 1 1/2 teaspoons salt and set aside.

In a separate large bowl, beat

together just until blended 3 cups sugar, 1 (15-oz) can pumpkin puree, 4 large room-temperature eggs, 1 cup vegetable oil and 1/2 cup evaporated milk. Add flour mixture to pumpkin and stir just until moistened and no streaks of flour are visible. Fold in 1 cup fresh or frozen cranberries (or half fresh or frozen and half dried cranberries). Divide batter between prepared loaf pans.

Bake 60 to 65 minutes or until toothpick inserted in center comes out clean, but start checking at 50 minutes because all ovens cook differently. Cool in pans on wire racks for 10 minutes. Remove from pans to cool completely on wire racks.



November 2022 wild hog control program application period open now

JACKSON - Commissioner of Agriculture and Commerce Andy Gipson announced that the Mississippi Department of Agriculture and Commerce (MDAC) is accepting a new round of applications for its Wild Hog Control Program (WHCP) beginning today, November 1, 2022. The application period will close on Monday, November 14. Landowners and property managers in all Mississippi counties are eligible for the application period.

In Mississippi alone, wild hogs cause more than \$60 million in damages annually. Through the WHCP, MDAC provides "smart" wild hog traps to landowners and managers for the control of wild hogs on private agricultural and forestry lands in Mississippi. MDAC provides the training necessary to use the "smart" traps and

technical guidance regarding the most effective methods to trap and control wild hogs on private lands.

"I am proud of the assistance that we offer to farmers and land managers through the Wild Hog Control Program," said Commissioner Gipson. "Now that most crops have been harvested across the state, farmers normally have more time to devote to battling this nuisance animal."

Applications must be completed and submitted online at www.mdac. ms.gov/whcp. Submitted applications will be evaluated based on the number of acres available for trapping, historical agricultural losses caused by wild hogs on the property and current trapping efforts on the property. One trap per 500 acres is recommended, depending on landscape and land use.


"We've had a lot of interest from local companies because there are very few options for people to stay," said Harris.

A small representative group stayed for awards. What an exciting night it was. We are all





Season preview: New look Lady Tigers ready for action under Rhodes

Northeast Mississippi Community College women's basketball team will showcase an almost an entirely new look during the upcoming 2022-23 campaign.

It starts at the top for the Lady Tigers with Chelsey Rhodes now directing the program as its head coach. Her former Delta State University teammate Aspriona Gilbert has joined the staff as an assistant as well.

"We're so excited just to get it going," said Rhodes. "I think this team meshes well together. One thing that's really important is they like each other. Chemistry goes a long way in basketball.'

Eleven newcomers litter Northeast's roster. The only common denominators for the Lady Tigers compared to last season are four returners in JaQuasia Dorrough, Kaitlyn Lindsey, Ella Mask and Andrea Watson.

Dorrough headlines that group as a reigning All-Mississippi Association of Community Colleges Conference (MACCC) selection. She came close to averaging a doubledouble with 15.1 points and 8.9 rebounds.

Dorrough scored in double figures during 15 of her 16 appearances as a freshman. She had six double-doubles, including a 14-point and 11-rebound effort against Pearl River Community College in the region playoffs.

The Calhoun City native tied a season-best with 25 points during back-to-back matchups against East Central Community College and Southern (La.) University at Shreveport in late February.

"Quay had a great year last year and she's getting better," Rhodes said. "She's stepping up and making sure that everybody is working hard and holding each other accountable. That's really, really big."

Mask is turning into one of Northeast's go-to leaders according to Rhodes. The Alcorn Central High School graduate started in all 23 games that she played in last year and had the second most assists on the team with 2.7 per

"She leads by example automatically, but now she's starting to even speak up at times and I'm really enjoying that," said Rhodes. "Defensively, offensively, whatever you ask of her she'll be able to do it for you."

Lindsey, who topped the Lady Tigers with 1.3 blocks and was second behind only Dorrough with 5.8 boards one season ago, and Watson are both Independence High School alumnae.

Hannah Campbell transferred to Northeast from Northwest Mississippi Community College. She was selected as the Most Valuable Player (MVP) for New Site High School in the 2021 Mississippi High School Activities Association (MHSAA) Class 2A championship game with 19 points in a

Taitiana Beene brought another MVP award back to Prentiss County one year later. She scored 17 points and added four steals as Booneville High School captured the 2022 MHSAA Class 3A title inside the Mississippi Coliseum.

Another three-point threat that ended her prep career at "The Big House" is Madison Bennett. She had 26 points in Tishomingo County High School's MHSAA Class 4A semifinal triumph over Pass Christian High School last winter.

The Lady Tigers

signed four Capital Preps All-State selections in Byhalia's Jasmine Malone, Madison Miller of Nettleton, Beene and Bennett. Malone and Miller were recognized as top 20 players to watch by Scorebook Live ahead of their respective senior campaigns.

Jerrilyn Richardson and Alexis Rowe are Northeast's out-of-state representatives this year. Richardson of Memphis, Tenn., was a two-time All-Metro recipient from The Daily Memphian.

Rowe originally committed to Delta State. She was tabbed as one of the top seniors in her home state by Scorebook Live after helping Jacksonville (Ark.) High School reach the state quarterfinals.

JaKeria Hawkins joins the Lady Tigers after breaking the Lake Cormorant High School record for most points in a single game. She poured in 43 points last November against Lewisburg High School.

Rounding out the lineup for Northeast are local products Madison Gardner of Saltillo, Karizma Norphlet from Oxford and Ripley's Amy Rodgers. Each of them qualified for the playoffs during their final high

"I really can't say anything bad about any of these kids because they're on the daily making us so proud,' Rhodes said. "They understand that we want what's best for them. We're trying to get them prepared for what's next and we want to win ball games."

The Lady Tigers christen the new campaign by hosting Wallace State (Ala.) Community College at Hanceville on Tuesday, November 1. Tipoff is scheduled for 6 p.m. inside historic Bonner Arnold Coliseum.


