## Booker, Seaton win local races

County turnout low: 37 percent of registered voters participated

Eric Booker and Jessica Seaton were the winners in Tuesdays local races for 1st Districtu Supervisor and 2nd District School Board, respectively.

Eric Booker retained his First District Supervisor seat with 61 percent of the vote against Joey Price's 38 percent. It was a non-partisan election to fill the incomplete term of Brandon Grisham, who died earlier this year. see Jessica complete Seaton was successful in County her bid for the **Election** second district Results school board seat with 64 on page 6 percent of the vote. Whitney Kilgore had 34 percent. "Thanks to all the supporters, and family and friends who have been with me through this," said Booker of the projected win. "I just want to thank everyone for coming out and voting. I appreciate the support! I look forward to being a voice for our parents, children and staff," said first time candidate Seaton, 32. She may have made history as the youngest person elected to the county school board ever. More certainly, she is the youngest current county elected official, said Josh McNatt, Circuit Clerk. The First District congressional seat was also on the ballot, and in county, incumbent Trent Kelly got 90 percent of the vote over challenger Dianne Black. Kelly

mule in corn and cotton fields. Like most boys, Thurman wanted a rifle. His dad gave him

enough time off to work for a neighbor to purchase a used, single shot .22 rifle. He worked six days for 50 cents a day to pay for the three-dollar rifle. He also came to own a used bicycle when he was seventeen. War had already commenced.

Shortly after his eighteenth birthday, he received the Uncle Sam greeting and was drafted into the US Army. His basic training was in Florida. Soon he was on his way to Germany.

## Thurman Epps, continued from front


His overseas trip lasted fifteen days to arrive at English Harbor near London, England. From there, he went across the English Channel to Le Havre, France which was already occupied by Germany. He was considered a replacement in the 1st Division of the 26th Infantry, known as

the Bloody Red 1. Thurman advanced rapidly to the rank of platoon sergeant which is a four-stripe sergeant. It was obvious that the quiet man from Golden had upside potential in the military should he have chosen. His closest call was when he was sleeping in a tent, and a German bullet passed through.

He stated that had he been sitting up, the bullet would have struck him.

In all, Thurman served thirty-nine months which included four waivers (extensions).

An absolutely spellbinding aspect of his service was during the Nuremburg trials. These trials were for Nazi war criminals. One time, he



After the war in Europe ended and he was on a ship headed back to New York, a powerful storm on the Atlantic struck. For five days, the anchor was down. Most on board were violently ill. One time in the chow line, a very sick solder vomited on Thurman's meal---no lunch that day!

As the skies cleared and the voyage continued, they came upon a capsized cargo ship. They stood by the capsized ship until additional help could arrive.

From New York, he was sent to Ft. Dix, New Jersey, to complete his tour and discharge. He was awarded the victory medal, good conduct medal, one battle star and two citations.

the love of his life, Nita Nix. at a Tishomingo State Park dance. They were married on January 6, 1950. Nita had been working for Omar J. Bullen at Red Bay Wholesale. She later taught for eight years at Dennis School. After the Dennis School was consolidated into Belmont School, Nita chose to take a job at L.P Allen & Sons Hardware replacing the leaving Lestine Fowler in 1959.

After Thurman gave up on farming, he took a job at Blue Bell where he worked for 23 years. He retired in 1982. The Epps built their home in Golden, designed by Nita in 1959. Sadly, Nita died in January 1997.

At age 96, Thurman does his own outdoor work---says it keeps him out of the recliner. If you know anything about Thurman, you know how neat his home and grounds are.

Thurman never has anything bad to say about anyone---nor do I hear from others about him. He is liked by everyone. He quietly served overtime voluntarily in our country's service. He is a model citizen who has more than paid his dues. He is deserving of our admiration and respect. My wishes for many happy returns, Thurman!

## Hammering Down the Truth

Today is mid-term election day in America. We will know the results soon enough for some, and not soon enough for others, depending on how we feel about the accuracy of the vote or only counting the ones that

## Tigers secure ninth consecutive season-opening victory

GALLATIN, Tenn. - Trey Tate showed no signs of an athlete that had not played in an official basketball game in some 19 months.

Tate scored a team-best 21 points as Northeast Mississippi Community College got its 2022-23 campaign underway with a 91-81 win over Volunteer State (Tenn.) Community College on Saturday, November 5 at the Pickel Field House.

"(My teammates) found me. They gave me the ball and I knocked them down," Tate said. "It felt good coming out and making shots. This is a good dub and a good learning experience."

"Honestly, it doesn't shock me that he scored because of the way he's been playing in the preseason," said Northeast head coach Cord Wright. "We plugged him in the starting lineup over the last week. He's responded and given us no reason to take him out."

Tate was one of seven Tigers to make their debuts against the Pioneers. Corey Stephenson led the group of true freshmen with 20 points and six

rebounds in a team-high 36 minutes of action.

Northeast, which appears at No. 21 in the preseason National Junior College Athletic Association (NJCAA) Division I poll, trailed early after Volunteer State made five three-pointers in the first six

minutes.

The Tigers (1-0) finally took their inaugural lead of the matchup at 24-23 with just over nine minutes remaining before the intermission following an offensive rebound and putback by Keithean Brooks.

Northeast used a 10-0 run moments later to jump ahead by a 36-28 margin. Isaiah Regular christened the spurt with a layup that was assisted by Allen Hughes while Stephenson and Tate combined for the remaining eight points.

The Tigers pushed their advantage to double-digits for the first time moments later at 40-30 after a pair of Tate free throws. Northeast eventually took a 47-34 lead into the locker room at halftime.

The Pioneers (0-2) made things interesting late after cutting their deficit to 81-80 with 2:48 remaining in the contest. However, the Tigers scored 10 of the final 11 points to secure a hard fought victory.

This was Northeast's ninth consecutive season opening triumph dating back to 2014. It was the first time that the Tigers started a new year on the road since visiting Dyersburg State (Tenn.) Community College during Wright's inaugural campaign.

Jalin Rice and Brooks were sensational for Northeast as well. The sophomore duo combined for 28 points while Brooks approached a doubledouble with a career-high nine rebounds.

The Tigers play their first home game of the year on Monday, November 7 against East Central Community College. Tipoff is scheduled for 6 p.m. inside Bonner Arnold Coliseum.

## Hunter Safety programs promote responsible, ethical conduct

It's that time of year that we take to the fields, woodlands, and waters not only to experience the excitement of hunting, but also to enjoy the beauty of Mississippi's outdoors. The increasing criticism of today's hunting problems points directly at the misuse of the privilege of hunting. Tomorrow's privileges may rely on our ability to correct such misuse through education and example. Hunter education is a step in the right direction.

Mississippi's hunter education programs promote responsible, ethical conduct, emphasize the importance of wildlife management, and encourage the safe handling of firearms and ammunition. Students of hunter education courses develop a better understanding of their responsibilities to the wildlife resource, the landowner, other hunters, and themselves. In addition, statistics prove that the number of hunting accidents is significantly lower for individuals who have completed a hunter education course.

In 1988, a law was passed by the Mississippi Legislature that requires all persons born on or after January 1, 1972, to complete a hunter education course prior to purchasing a hunting license.

A course in hunter education provides one with many facts about hunting such as hunter ethics and responsibility, the history of firearms. firearms handling and safety, accident prevention, ammunition safety, ballistic and range, hypothermia, marksmanship, safe shooting zones, water safety, and wildlife identification. Hunter education also teaches the importance of wildlife management and conservation, as well as game care, specialty hunting (muzzle loading, bow hunting, and handguns), first aid, and survival.

Written laws cannot ensure the safety of all hunters; therefore, each hunter should follow an unwritten code of ethics. Hunters' codes are based on respect for wildlife, the land we live on, and others' rights, as well as for themselves.

Irresponsible hunters give a bad public image of all hunters. There are



many things a responsible hunter can do to improve their image. Hunters should always leave fences and gates as they found them. When livestock is allowed to get loose, the landowner ends up doing additional work. Thoughtless use of vehicles often damages fields and roads. A good sportsman would never leave litter behind. Also, never practice your aim by shooting bottles, insulators, or

road signs. These actions cause damage and debris that other people have to correct or pay for.

Always be respectful and try to leave conditions better than you found them.

## Not the end of Daylight Savings... yet. But it's a good idea

We set our clocks back last Sunday. This may be the last time ever.

Earlier this year, the U. S. Senate unanimously voted to make Daylight Savings Time (DST) year-round.

Senator Marco Rubio from Florida spoke in favor of the Sunshine Protection Act. "One has to ask themselves after a while: Why do we keep doing it?" Mr. Rubio said. "The majority of the American people's preference is just to stop the back-andforth changing."

According to the New York Times, not a single senator objected. Some audibly celebrated.

"Yes!" exclaimed Senator Kyrsten Sinema, Democrat of Arizona, who flashed a big smile and clenched both her fists in triumph as she presided over the chamber.

The act has gotten stalled in the U. S. House of Representatives, as it grapples with bigger problems such as inflation.

And now there is debate about whether Standard Time or Daylight Savings Time should be made permanent. Mexico, after a lengthy debate in its senate, chose to make standard time permanent. Indeed, 60 percent of the world is on permanent standard time.

There are all sorts of studies showing that disrupting our daily schedules causes all sorts of bad things — lost sleep, anxiety, depression, increased accidents, increased stroke, and heart attacks, etc. One study estimated a cost of \$434 million a year.

As much power as we have given Congress, they do not have the power to create an extra hour of daylight. So you can just set your clocks back and do everything one hour earlier and, voila, everything is the same! Unfortunately, many of us must conform to external times set by schools, churches, and workplaces.

The American Academy of Sleep Medicine says standard time is more closely attuned to our bodies.

"Daylight Savings Time disrupts the body's natural circadian rhythms and impacts sleep," said AASM President Jennifer Martin, a licensed clinical psychologist, in a press release. "Standard Time provides a better opportunity to get the right duration of high-quality, restful sleep on a regular basis, which improves our cognition, mood, cardiovascular health, and overall well-being."

A Monmouth University poll conducted in March found that 61 percent want to ditch the twice-yearly changing of the clocks, compared to 35 percent who want to keep the status quo.

Fifty-nine percent of adults

surveyed by YouGov said they would like to see DST made permanent, compared to 19 percent who want Standard Time permanent.

I'm with the majority. I'd much rather have the extra daylight after work than before work.

With dark coming earlier, there are far more pedestrians walking neighborhood streets in the dark for exercise. Many of these streets are poorly lit and lack sidewalks.

I am amazed at how few pedestrians walk at night without reflective clothing or LED lights. Even worse, they often have earbuds in and can't hear oncoming traffic. That's a recipe for disaster. Drivers struck and killed an estimated 7,485 people on foot in 2021 – the most pedestrian deaths in a single year in four decades and an average of 20 deaths every day, according to a new estimate released today by the

Governors Highway Safety Association. That figure represents a striking rise from a decade earlier when 4,109 pedestrians were killed in traffic.

Our streets are poorly lit. Night after night, I watch neighbors walking at night with no reflective clothing. To aging eyes on a dim street, they might as well be invisible.

In our neighborhood, the speed limit is 25 miles an hour. If you get hit at that speed, there is a 15 percent chance of death. Serious injury is likely.

Ninety percent of a driver's reaction depends on vision, and we were just not engineered to see very well in the dark.

The typical 50-year-old driver needs twice as much light to see as well after dark as a 30-year-old. Yet few pedestrians are even aware of this, much less factoring it into their walking precautions. If you are walking at night, don't listen to music. It's too dangerous. And please wear some type of reflective clothing.

I drive very slowly at night and I still have scary moments when I am far too close to pedestrians who have failed to wear reflective clothing. Sometimes I will roll down my window and tell them, "Y'all are invisible to me. Please wear reflective clothing!" I'm not trying to be rude. I'm trying to save their lives.

Add speeding and quiet electric cars to this equation and it equals even more deaths. Far too many people speed through neighborhoods. Is a few seconds of time savings really worth the potential trauma of hitting a pedestrian?

## Need Larger Doses of Insulin? Smoking May Be Responsible

M. Smith, a 42-yearold man who lives in Madison County decided to quit smoking because he watched the combination of diabetes and smoking damage his father's body. "I quit smoking on February 14, 2022. It was hard at first, but I am so glad I did it," Smith added, "I've seen how my dad keeps smoking, keeps using more and more insulin, and still feels awful most days."

"Mississippians who smoke are 30 to 40 percent more likely to develop type 2 diabetes than those who don't smoke.", said Victor Sutton, Ph.D., Director of Preventive Health and Health Equity at the Mississippi State Department of Health.

Every year approximately 20,433 Mississippians are diagnosed with diabetes, and in 2020 Mississippi reported 20.1% of its adult population smoked daily, according to The Centers for Disease Control and Prevention (CDC).

"Quitting smoking is always a healthy choice," said Sonya Sanderson, Director of the Mississippi Tobacco-Free Coalition of Prentiss and Tishomingo Counties. Sanderson reminds all Mississippians that the Health Department stands ready to support you on your smoke-free journey.

"Quitting smoking was difficult, and I'm so glad I did it. I don't have diabetes, but my dad does. I've watched him get sicker and sicker. I don't want my life to be like that." said Rusty.

The CDC states that chemicals found in cigarettes cause cellular inflammation which results in less responsive to insulin. Diabetics who smoke require higher doses of insulin to manage their blood sugar levels.

"One call to 1-800-QUIT-NOW can change your life for the better. We offer one on one support and want to see you succeed," said Mrs. Sanderson.

## Letters from Home

luka soldier kept every letter sent to him during WWII, and brought them home

Today, our servicemen are so fortunate to have the internet to communicate with their loved ones and even video chat with them across the world. Written words have been replaced.

During the Korean War, Vietnam War, World War II and I, this was not the case! Pieces of lined paper, postcards, stamps, and pencils were the norm for writing loved ones.

I am so blessed to have the many letters that were sent to my uncle L. D. Daugherty during his time serving in

World War II at Fort McCellan, Ala., Camp Van Dorn, Miss., Camp Breckinridge, Ky., England and Germany. L. D. cherished each letter and arrived back in Tishomingo County after the war with most of the letters and cards that were sent to him. He also brought home "spoils of war" he collected.

L. D. had a little leather bag he carried with him and returned with it filled with letters. Soon after he passed away in 1995, my aunt Willard, L.D.'s wife, came bringing the little bag to my mother at the paper office. She said, "I know he would want you to have this."

The bag had traveled around the world with him, and safely returned with him even though he was wounded in France, only to be sent back to the front lines after his recovery in England. He had proudly served in the 83rd "Thunderbolt" Infantry Division and Dudgar Patrick when he returned from the war and they lived a long, happy life together east of Burnsville.

In a letter from Jesse Sparks, who I believe was a barber, he wrote:

"everything around here is just about the same as ever except not as many men and boys around here, but we who are here are trying to hold everything down, be good and write to us. Your old friend, Jesse Sparks."

One letter from my grandmother said,

"Got your letter last night. I hate to know you are having such cold weather up there. John Storment says Loyd is in Wyoming where it is from 10 to 30 below zero, he seemed so worried about him."

#### She adds,

"Well, Dorlon Edmondson has gone across. Jewel has come home."

On an American Red Cross letterhead: 8/11/44 England

"Dear Mamma and Daddy,

Guess you will be surprised to hear I'm in England again. I got wounded in France but I'm in a hospital and doing just fine, so don't worry. I can't tell you anything about it, until the War Department notifies you. If there is anything in the Army that resembles home in the least way, this is it. A fellow don't feel right having somebody to wait on him."

One of the most interesting letters is from my aunt Elizabeth, called Sister by the family. She wrote L. D. often as they were near the same age. She wrote about the Mineral Springs Hotel burning on Wednesday morning.

"It started about 12:15 no one knows how it started, sure was a fire, the Corinth fire truck came but it was too far gone to do anything with. I woke up when the Corinth fire truck siren came in about 1:30. Mr. Jourdan, Talmadge and Miram are in Hot Springs, Arkansas. There was plenty of stuff burned."

**Memories preserved** - These letters from L.D. Daugherty's collection have been preserved since he returned to luka from the war. The collection includes items he picked up along the way like the small Nazi pennant.

I assumed he met in France or Germany. I can't read the letters, but I guess our young soldiers had time to meet the local girls. I am sure it helped their morale.

I have only gone through a few of the letters, but, to me, they are so interesting to read. It must have been like getting a "news paper from home at mail call." I recognize so many names mentioned in the letters that are now gone but were once friends from Iuka.

Every Veteran's Day over the past

years I have enjoyed so much honoring the veterans and hearing their stories in *The Vidette*, so again this year I honor my relatives on this Veteran's Day: Howard Biggs, Jesse Biggs, L. D. Daugherty, D. S. Daugherty, Johnny McVay and his brother-in-law, Hamp Watson, all served in World War II; Johnny Biggs, U. S. Army; and Charles Biggs, Vietnam War.

Thank you to all who served.



received a Purple Heart.

Although I haven't read all the letters due to their delicate conditions, I have read enough to know he received news of what was going on in Iuka: from the weather - to who had left for the service and who had died in town. In one letter my grandmother told of someone dying in the neighborhood and when they dug her grave, another body was in the grave – only in a country cemetery and small town would this be BIG NEWS!

I have picked out a few interesting tidbits I have found while reading them:

L. D.'s friend, Joyce Cummings joined the army the same day and both applied for the paratroopers. Joyce was picked for the special group, and L. D. wasn't. There are letters from Joyce, who was from Burnsville, and the two kept up with each other all during the war and even when they returned home. One letter in particular from Joyce, who was stationed in Camp Polk, Louisiana, was interesting. Joyce writes of receiving another letter from "that Patrick girl" and even sent the letter on to L. D. to read. He also spoke of receiving letters from the "Dotson girl" and the "Gurley girl." Needless to say, Mr. Joyce married

"Ben Busby is out of the Navy he had some kind of Rheumatism and he got a discharge. Perry Joe Pruitt is here, he came home yesterday."

In later years P. Joe Pruitt told of running into L.D. at a train station in Germany. One recognized the other's voice and they were thrilled to see each other. They went to get ice cream and missed the train. They told that no one lived to get off the train! Lucky Mississippi boys - both lived to be old men.


In one letter from my grandmother she wrote,

"Everett Cutshall is getting worse, they have moved him from Booneville Hospital to the Baptist Hospital in Memphis. If you have a card, send it to him, he always asks about you. I don't think his people have much hope for him. Laurie Ree Mars is also in Memphis Hospital very sick. Love, Mother"

(Not sure what was wrong with Everett; he and his wife Maxine operated the local ambulance service and funeral home for many years after the war, he must have pulled through!) He also had letters and photos of girls

## A letter never sent

#### by Kirby McRae

Many years ago my Aunt Elsie McRae Mohundro gave me a binder containing the front pages of significant days in history published in the Memphis Commercial Appeal. On the day after the attack at Pearl Harbor, December 8, 1941, she had written that Delbert had already been drafted and Edward would join soon after; both were her brothers. She closed with "This was a sad day."

With two brothers in service and two more gone from home and too old to fight, Aunt Elsie eventually left for Memphis to work at Firestone and help the war effort. Later another brother, William, joined the Army hoping to prevent the last available son and my father, Alvis McRae, the youngest of nine children, from being drafted.

As the war ground on, my grandmother Altie Blunt McRae began to get concerned over her baby boy being drafted. So she sat down and penned a letter to Mr. Price Billingsley, a member of the local draft board who was also her first cousin. In her letter, she explained that her husband was at an advanced age (over 70), and of her remaining two sons at home one had suffered from infantile paralysis as a child and the other was her

youngest. Without him, she wrote, there would be no one to work the farm.

Eventually, my father, her baby boy, would catch the bus to Memphis and join the Navy. So with four sons in service at the same time, she concentrated on the upkeep of the home and continuing to write to her sons, who were faithful to write back. They had even worked out a code so they could inform the family where they were without the letters getting censored!

After the war was over and all sons were back at home safe (although Edward was wounded by a sniper), my grandmother gave the original letter she had written to my father - she never mailed the request to her cousin! It is a treasured document in our family.

Throughout the years, similar scenes of sacrifices made on behalf of our Country have occurred many, many times. In this hyper-divided state our Country is currently in, maybe on this Veterans' Day, we should all stop to

And we should never forget and always remember that from the Revolutionary War through the Global War on Terror over 1.1 million Americans have lost their lives protecting and defending our County.


