

Memphis man sentenced to 12 years after death of father and child on Pickwick Lake

SAVANNAH, Tenn. --- A Memphis resident pleaded guilty to two counts of vehicular homicide by intoxication charges from a boating collision on Pickwick Lake which resulted in two fatalities.

On November 14, 2022, 34-year old Matthew Swearengen pleaded guilty to two counts of vehicular homicide by intoxication charges at the Hardin County Courthouse. Swearengen is sentenced to serve 12 years in jail, have his driver's license revoked for three years, and have his vessel operating privileges revoked for ten years. Morgan Reynolds, Assistant District Attorney with the 24th Judicial District Attorney's office, prosecuted the case.

On August 15, 2020, Swearengen operated a personal watercraft (PWC) in Dry Creek that collided with an unsuspecting PWC occupied by David Carter (40) and his daughter, Olivia Carter (6). The collision resulted in the death of David and Olivia.

Nicole Carter, the wife of David

"Today is closure for our family and friends. It's been a long, emotionally draining two years for all of us, but we are thankful for the TWRA investigators, district attorney, witnesses, and everyone involved who helped bring justice for David and Olivia. What happened to David and Olivia could have been prevented. What started as a fun, family day out on the water ended in the worst way possible, all because someone decided to consume alcohol and then operate a watercraft. This one terrible decision forever changed and impacted the lives of so many people. You may think this could never happen to you, but trust me, it can. I am begging you; please do not operate any form of motorized vehicle while under the influence of alcohol. The damages left behind will forever impact our daily lives."

The Tennessee Wildlife Resources Agency wants to remind the public about the dangers of boating under the

influence. Alcohol is the leading contributing factor to recreational boating deaths. TWRA officers are constantly on patrol, looking for impaired operators.



Well, it's time for Autumn poems to come to an end since we are into November, overnight lows are in the 20s, and Thanksgiving is next week! But before we end this I need to remind you that the art of poetry is not easy, and the poems we read are not easily written. As William Faulkner told The Paris Review in 1956 -"Maybe every novelist wants to write poetry first, finds he can't, and then tries the short story, which is the most demanding form after poetry. And, failing at that, only then does he take up novel writing." This after starting with two books of poetry that failed, pushing him to the short story, then novels, and eventually the Nobel Prize for literature.

We need to appreciate good poetry, which reminds me that I should thank my teachers, especially Ms. Ruth Dawson and Anne Taylor, for trying their best to get us crazy students to pay attention and accept good literature. You may not have thought so then, but at times we were listening.

I will end the Autumn poems with one set to music, a fine song written by Joni Mitchell and originally recorded by Tom Rush in 1968. He first took the song to Judy Collins but she was not interested in it, so he changed the pronouns and recorded it himself. Ms. Mitchell was from Canada but settled down and completed some of her most acclaimed songs while living in Los Angeles' Laurel Canyon area in the early '70s. The Canyon was the center of counterculture attitudes in the mid-60s and early '70s, with residents such as Cass Elliot, Jim Morrison, The Byrds, Buffalo Springfield, the Eagles, Neil Young, Brian Wilson,

Jackson Brown, James Taylor, and many more. In fact, the house she lived in was immortalized in the Crosby, Stills, and Nash song "Our House" (1970,) written by her then-lover Graham Nash.

I promise the words to this poem will move you out of Autumn and toward Winter - after reading them find Tom Rush on Youtube, Spotify, or however you listen to music and see what you think.



State gives away billions in incentives for industrial prospect; refuses to address rural hospital peril

Like an alcoholic unable to resist a full gleaming bottle of Jack Daniels or a sex addict unable to resist the lure of a porn site, the Mississippi political establishment has given another quarter billion dollars to another big company to build a manufacturing plant.

They stayed on the wagon for a good six years, far longer than any prior period of crony capitalism abstinence. But the lure of the big announcement about the big plant using other peoples' money proved too hard to resist. They gave in.

The state gave \$263 million in incentives to Continental Tire in 2016 for a \$1.4 billion investment promising 2,500 jobs. This go-round, an unnamed aluminum plant will get \$247 million for 1,000 jobs. That's a cost of \$247,000 a job.

As usual, this was all rushed through in secrecy. A one-day special session was held and the proposal was passed with only a handful of dissenting votes. Madison representative Joel Bomgar was one of those. He deserves a medal for political bravery.

Like a broken record, this happens again and again. And like a broken record, I will write yet another column about why this is terrible public policy.

Our governor, Tate Reeves, the chief promoter of the plan, knows it's terrible public policy. He says it in nearly every speech he gives, something like: "Government's role is not to pick winners and losers but to get out of the way and let the free market work unencumbered by governmental interference." I've heard him say that line a dozen times.

But just like an alcoholic who knows

his behavior is bad and destructive, Reeves et al just couldn't help themselves. It was just too hard to resist.

All that limelight. The big press conferences. The excitement. The money. The high-powered meetings. The public adulation. The reservoir of campaign contributions. It was just too . . . hard . . . to . . . resist!

Even Lieutenant Governor Delbert Hosemann succumbed. Like Reeves, he knows better. In fact, Hosemann has proposed a fair and equitable economic development plan that would give incentives equally and fairly to all companies that create new jobs. But the lure of landing the big one overpowered his senses, like the perfume of a harlot overcomes an inebriated married man late at night in a bar on a business trip.

There is no evidence anywhere that company-specific tax breaks for megaplants are good for the long-term health of a state. In fact, the studies show the opposite. The more a state plays favorites subsidizing mega-plants, the slower the state's job growth over the long term. The European Union doesn't allow these deals. The United States should do the same.

The non-profit Tax Foundation sums it up nicely:

"States that make the mistake of relying too heavily on incentives will find that this makes it more difficult to maintain competitive tax burdens on established operations. Even worse, some of the investment decisions businesses make in response to the availability of those incentives will be less economically efficient than the ones they would have made in their absence, with businesses adjusting

their economic decision-making to take advantage of tax incentives even when, absent that incentive, they would make a different choice.

"Policymakers that resist the pressure to create or expand targeted carveouts in the tax code—and ultimately work to phase out these carveouts over time-will find they have more revenue flexibility to create a tax system that treats all businesses favorably, regardless of industry or how long they have been in operation, and without distorting the economic decision-making of those firms. States that maintain a competitive underlying tax code will then find they can attract business investment and experience strong long-term economic growth without picking winners and losers and without cluttering their tax code with complex carveouts, a goal all states should work to achieve."

Simple common sense should expose the negative effects of these companyspecific tax breaks. How is it fair to give one company huge subsidies and tax breaks while all the other companies have to pay taxes and build their own plants?

These deals make one company very happy, but they send a horrible message to every other company: The Mississippi government does not play fair. It's not what you know, it's who you know.

Crony capitalism reigns in Mississippi.

Every manager in Mississippi will tell you that their greatest challenge is hiring good people. If the government gives huge incentives to one company, they are able to hire the best workers away from existing companies, causing the unsubsidized companies to suffer and decline. The state of Mississippi is just robbing Peter to pay Paul.

Mississippi has thousands of small, mid-size and large employers. They all have to compete, hire employees, raise capital, build facilities and make a profit. How is it fair to reward just a handful of politically connected companies with huge tax breaks? The other companies have to make up the difference.

I have read the contracts with these companies. In some cases, the state pays for the private jet transportation of its corporate executives. Typically, if the company does not fulfill its promises, there are minimal consequences. If Mississippi voters really knew how these deals go down, they would be outraged.

To be sure, voters are part of the problem. They get excited by big deals just like the politicians. But in a democratic republic, the elected leaders are supposed to exercise prudence, fairness and judgement. Instead, our leaders get swept away just like the public.

And for Pete's sake, why are these deals rushed through in secrecy? There is absolutely no defense of that.

Meanwhile, our Republican leadership has turned down \$7 billion in federal Medicaid funding on the grounds that it's "socialized medicine."

Apparently, Reeves thinks it's perfectly fine to give government money to steel plants while turning down federal money that would keep our rural hospitals open and provide health coverage for the working poor. Go figure that one out.

Make a list of important phone numbers. Clothing such as rain gear, jackets, sturdy shoes or boots, and work gloves. Special needs items for infants, small children, and elderly family members with disabilities. First Aid kit filled with all the necessary items. Nonperishable food, non-electric can opener, water at least a gallon per person per day, paper plates, napkins, cups, and utensils. Important documents such as insurance cards, medical records, banking and credit card information, and all other legal documents such as birth, marriage, and social security card. Set of car and house keys. Copy of will. Information on meds, the name of the drug and dosage. All these items should be in a waterproof container. Keep vehicle tanks filled with gasoline. If you have any pets, have food and water to last at least 7 days, proper identification and medical records, carrier or cage, leash and water and food bowls as well as any medication. Decide if it is safe to evacuate or shelter in place. Call 911 and explain the situation and provide first aid for any injured people. Take photos of damage

History

Central Consolidated School: 1927 - 1960

In the spring of 1927, a vote of the qualified electors and patrons of the Helton, Patrick and Harmony school district was taken on the issue of consolidation of the three schools, with previsions for other neighboring schools to come in later, if they so desired.

Land was acquired from the Ayer and Lord Tie Company who owned a large tract of land on Highway 25, four and one half miles north of Iuka, Mississppi.

Three trustees; one from each of the aforementioned school districts, were appointed. They were: M. E. Hudson, Charlie Grisham and E. F. Parnell.

Much work and responsibility fell on these three men, as there was some stiff opposition to the idea of consolidation. However, negotiations were made and the Ross Bassett Construction Company of Alcorn County was hired to erect the

building, which was ready for use by the latter part of October, 1927.

The name Central Consolidated School was chosen because of its central location among the three school districts.

George Bacon, a graduate of Mississippi Southern, was elected as principal,

with Olen Tigner, Mary Harwell, Flora Bell Branson, and Birdie Mae (Gray) Cutshall as his helpers.

Grades one through ten were taught there the first two years by Mr. Bacon. Due to the Depression and short finances, only four or five month terms were held.

By the fall of 1929, high school students were allowed to attend Iuka High School, and were transported there by bus during the regular term at Central, but they had to furnish their own transportation and pay tuition the first and last two months of the nine month term at Iuka.

School buses were constructed locally. No factory made buses were in Tishomingo County at that time. Only three buses were used at first. Many students walked from one to two miles to school. Due to bad road conditions, some bus drivers used covered wagons to supplement their routes.

Mr. O. C. Miller was County Superintendent at this time, and through his efforts and urgent invitation from three trustees, our State Superintendent of Education attended the closing day of the first session of school in March, 1928. The day was one of dedication. Pictures were taken, and a bountiful lunch was spread at the noon hour. The afternoon program consisted of talks by patrons and teachers followed by an address by the State Superintendent of Education, W. F. Bond.

Later, some neighboring schools,



Bethel, Hubbard Salem, and Walker Cutoff decided to consolidate with Central.

The school has furnished some renowned ball players, some politicians, preachers, teachers, and community leaders. Some have entered the business world, and distinguished themselves in their careers, because of their early training.

Following are names of those who served as principal of Central School: George Bacon, Arden Adams, Rev. J. C. Nelson, Olen Tigner, Dewey Locke, R. C. Grisham, Archie Clark, J. W. Mitchell, George W. Stricklen, O. C. Oaks, Zeb Yow, Hector Bishop, Perry White, Cleston Scruggs, and Benny Curtis.


