Board OKs new roof for courthouse

At the regular first Monday meeting of the Tishomingo County Board of Supervisors, the board directed engineers to go ahead with the bid package preparation to replace the roof of the courthouse.

Engineers presented an architect's rendering of the proposed roof back in September and had a different one Monday to show, which includes louver vents and an added gable on the front side of the roof. It also includes a rain-handling system, explained engineer Kent Geno, and not gutters.

The rough estimate for the new standing-seam metal roof is about \$620,000 to \$700,000 Geno said. The county will pay for it in part with \$400,000 allocated by the state from money Tishomingo County has been paid for keeping other counties' inmates, thanks to legislation pushed through by Senator Daniel Sparks, explained Chancery Court Clerk Peyton Cummings. The color will be determined after the successful contractor provides color samples to choose from.

The board spoke to Nick Phillips and Harold Lomenick from the Tishomingo County Historical and Genealogical Society about possible improvements to the circa 1880 Old Tishomingo Courthouse, including making the upstairs more accessible and useful for staging dramas and other events.

Second District Supervisor Nicky

McRae said the arts council and others should not have to go to Jacinto in Alcorn County to stage productions, as the Tishomingo Arts Council recently did with a production of Steel Magnolias, which featured a few actors from his district.

Lomenick and Phillips were in agreement, and willing to support things like installing an exterior elevator and making HVAC and electrical improvements.

"It's your building, we just hold the keys," said Lomenick. "As long as it can house the museum and be used for things like the drama productions, we are behind you."

According to previous meetings, the

county has about \$380,000 available through a Community Heritage Preservation Grant and matching county funds to make the changes. The board said they would get with Dean McRae Engineering to look at proposals made for the changes a few years ago.

The leader of the Iuka Airport Board, Rick Owen came and updated the Board on improvements over the past several years to the Iuka Airport, including tree removal, a new AWOS (Automatic Weather Observing System) that allows pilots near the airport to get weather reports, and a GPS approach that aids in landing. Owens reported there are 24 occupied hangars at the airport.

Christmas parade. The temperature was downright mild and the rain held off. We have had some parades in the past where the rain was so bad only the most dedicated of parade entries braved the journey. Who are the most determined parade entries? The mommas of the young

beauty pageant winners, of course! They ain't going to let a little drizzle rob their 18-month-and-younger beauty of riding propped up on the back of a borrowed Camaro bumping Grandma Got Run Over by a Reindeer louder than that song was ever meant to be played.

The Iuka Christmas parade is famous, of course, for always ending with Santa Claus riding on top of the municipal fire truck. Lord knows there would be a lot of disappointed children if there was ever a house fire during the Christmas parade. I would hope they wouldn't drop Santa off and have him walk the rest of the way, as traditionally several horse riders trot just before Santa on the fire truck. And no one wants to march behind a bunch of horses, as the presents they drop aren't wrapped in a box and stepping in a big enough pile of it will make you cuss so much you end up on your own naughty list.

Conservation Corner Hypothermia still a possibility, even here in Mississippi

While for the most part we live in a warm state, Mississippi can get very cold, especially when considering our high humidity. For example, a few years ago a friend came to visit from Colorado and wanted to go for a jog early one January morning. I told him it was cold-about 35 degrees Fahrenheitand he reminded he was from Colorado and

could handle it. When he returned, he said if felt much colder than what he was familiar with out West

When we are in a cold environment, our bodies can lose heat faster than it can generate it. The body will adjust by constricting blood vessels at the surface of the skin, shutting down perspiration and increasing muscular activity, which we call shivering. This

is the beginning of hypothermia. Hypothermia is one of the leading causes of death among outdoorsmen. Wind-chill can also greatly reduce the time it takes for hypothermia to set in.

Some symptoms of hypothermia (defined as a body temperature of less than 95 degrees Fahrenheit) may also include slurred speech, incoherence, numbness, and impaired gait.

Shivering is valuable clue, but hypothermic individuals whose body temperature is lower than 90 degrees Fahrenheit may not shiver or even feel cold. The individual may appear corpse-like due to the pale color of his or her skin, lack of spontaneous motion, and a faint pulse.

Odds are, medical attention is needed, but until that can be accomplished, you need to begin gradually



re-warming the affected person. First, remove all wet clothing and place the victim in dry blankets in a warm environment. Offer warm, non-alcoholic fluids. Movement involving the victim must be limited and done gently. The goal should be to get the victim to a hospital as soon as possible, for the potential complications are many and some can even be fatal.

To help prevent hypothermia from happening to you, wear suitable clothing and protect your exposed areas. Mittens are preferred over gloves. Wear multiple layers of loose clothing. Wearing two pairs of socks-cotton next to skin, wool on top-will help protect your feet. Wear a scarf or head covering.

the sleeping bag will help keep one warm too.

Remember that certain persons are very susceptible-the elderly, those with circulatory problems (peripheral vascular disease, diabetes, peripheral neuropathy, Raynaud's syndrome), and those on certain medications such as beta-blockers (for hypertension and/ or heart problems). You certainly want to stay on your medication, but be aware that it may put you at increased risk for cold injury should you have prolonged exposure to the cold.

Copied by Charlotte Biggs McVay from an article written by Larry Thompson that appeared in the Miami Herald around 1968. Larry Thompson was an American

humor columnist and newspaper reporter who died in 1973. The article was brought by the news office by Bettye Nelson many years ago. Bettye was married to Col. O. C. Nelson of Iuka and they made their home in Florida before retiring to Iuka.

The Nelsons always subscribed to The Vidette. Bettye and O.C. were both very active in the city of Iuka after they moved their family here and are both buried in the Oak Grove Cemetery. This article is proof that word concerning our city does get around.

Chief luka Started It

Life with Larry Thompson

I made casual mention of Iuka, Mississippi, principally because of its unusual name.

I keep saying that our readers have been everywhere. The information I have received about Iuka proves that you can't know a city or hamlet by just driving through it. Some of the most unlikely places have romantic or historic backgrounds.

Mrs. Gerald Songer, 2222 SW 19th Ave., gave this sidelight:

"An Illinois regiment fought in a battle of Iuka, Miss., during the Civil War. After the war, quite a few veterans settled in a small town in southern Illinois and renamed it in honor of that battle. Iuka, Illinois, celebrated its centennial last year.

"Oh, yes! My husband was born in Iuka, Illinois."

WE DIDN'T INTEND to revive the Civil War or go to Illinois, so let's get back to Mississippi.

Lillian Thomas, 1216 Milan Ave., Coral Gables, who was born and raised in Iuka, Mississippi points out that Dick Merrill, the famous pilot, also was born there, but that it has more reasons for fame than that.

She continues: "Iuka has been the scene, long ago, of happy evenings as people from Memphis and other cities came to dance at the Mineral Springs Hotel. Later the old ballroom became the "General X" room for daily meetings of the professors of Iuka Normal Institute and students from all over the South." Mrs. Thomas enclosed a clipping from the Memphis Commercial Appeal



about Iuka.

According to this story, the town is named for a Chickasaw chief. More than 200 years ago Chief Iuka came to the seven mineral springs there, drank from them, and his health so improved that he lived there with his tribe for many years. Later a town grew up around the springs. The town thrived until the Civil War.

Here is an excerpt from the article: "The Civil War devastated Iuka, but Union and Southern soldiers alike spread the fame of its magical waters. When the great yellow fever scourge of 1878 covered the South, Iuka became

a refugee center and its springs a Mecca for the sick...The springs gained national fame. "By 1880, Iuka had become a famous

spa. Wealthy health seekers poured into the fashionable watering place. Luxury hotels and boarding hotels appeared and the springs were roofed with fancy pavilions in what had become Mineral Spring Park, until September each year.

"During the day visitors took the water or strolled under the elms and oaks of the park. In the evening they attended concerts at the park bandstand or danced in the gas lit ballroom of the Mineral Springs Hotel to the music of world famous orchestras..."Iuka seemed destined to ride the crest of good fortune forever."

away and the once magnificent Mineral Springs Hotel caught fire and burned to the ground. After that the town virtually forgot its springs and the park.'

This is the story of the rise and fall of Iuka, Mississippi.

But now a group of businessmen have a campaign going to restore things almost as they were. The springs would be cleaned so they would gush again; a

large pavilion would cover them; there would be walkways and a stream fed by the springs.

Iuka will rise again!

(It is interesting to note that the "Nelson boys" O. C. and Merle both served in World War II and grew up in the home place of Dick Merrill, which stands across from the Iuka Middle School)
