

Qualifying begins soon for 2023 county elections

Qualifying for county and state elected offices will begin on January 3rd. 2023 at 8 a.m. and ends on February 1st at 5 p.m. The 2023 primary election will be held on Tuesday, August 8th with a runoff, if necessary, on August 29. The general election will be held on Tuesday, November 7, 2023.

Though a few candidates have announced they will be running, Tishomingo County Circuit Clerk Josh McNatt affirmed that no one had yet submitted qualifying papers, or been qualified.

McNatt said the circuit clerk's office will have the qualifying paper work available for county-level offices. Candidates for statewide office and the legislature will go through their respective state party executive committees or with the secretary of state. The circuit clerk's office will receive the qualifying papers and fees for the local Republican and Democrat Party candidates as well as independent candidates. Each party's executive committee will determine candidates to be qualified, and the independent candidates will be reviewed by the county election commission.

Although independent candidates won't have an election until the November general election, they also have to meet the February 1st deadline to qualify. Along with the qualifying fee, independent candidates are required to collect petitions signed by registered voters who live within the district or county from which they are seeking election. The number of signatures varies based on the office.

Based on conversations with local candidates, all seem to be running as Republicans this time, except for one running as independent. Historically in Tishomingo County, everyone ran on the same ticket in the county, which was Democrat, which saved county money by not having two primaries and then

potential party runoffs. Whoever won in August was usually the winner and the November election was just a technicality, as no one ran as Republican, or Independent, or presumably any other party. If this turns out to be the case in 2023, the situation will be similar in all but one race.

In addition to the qualifying paperwork, candidates must fill out a statement of economic interest online within 15 days of qualifying. The candidates also have deadlines to file campaign finance reports. If the campaign finance reports are not filed on time candidates can be fined and cannot be declared the winner. In order to qualify, candidates must meet the general qualifications and the qualifications specific to the office as set by state law. If you have questions about seeking office or the process to qualify, please contact the Circuit Clerk's Office at 662 423-7026.




to stop at Brooks Grocery. She knows if there's a visit in town, cookies will be delivered upon my return.



A private service will be held at a later date.





Make this Cinnamon Star Bread for Christmas guests

by Pamela McRae

First of all, my thanks for the support for these little recipes I include as often as possible in the paper. Since we changed ownership in February, I've received more complements and comments about the recipe pages than any other feature or news items in the new Vidette!

Now, I don't want to step on toes, but we do real food, for the most part in our family. My kids were raised learning to make real biscuits, from scratch, and peeling real potatoes, often from their daddy's garden to make mashed potatoes. I know it's easier sometimes to use things like canned biscuits, or potato flakes, and I'm not trying to throw shade, but we just try to do "real" food as often as possible in my kitchen, and I've apparently passed that down to my kids.

So, imagine my daughter's face when at her first Thanksgiving ever with her fiance's family she completed preparation of a whole turkey with turkey gravy (she's long been the turkey cooker for our thanksgivings) and asked what else she could make next. His mama said how about the potatoes?

And handed her a box. Of potato

flakes. I imagine her looking like a calf at a new gate. She said she wasn't even aware of such things.

Fortunately for her, her Army captain fiancé jumped into action, grabbed the box and made the mashed potatoes for their Thanksgiving dinner. She reports they were tasty!

When she called, disillusioned with life, and a bit hurt I had failed to educate her about potato flakes, I assured her I had possessed some in my pantry in 2018 when I made the bread recipe below. After using the half cup for the recipe, they remained until they were out of date.

She has a lot to learn about married life, and blending cultures, and keeping the peace, and hopefully, she will be able to teach him a little about gardening. And growing potatoes, thanks to the foundations we provided.

He's got a potato peeler in his stocking as we speak.

The bread below was easier to make than it looks, and was pretty tasty. Give it a try and impress your guests

Especially the ones who buy potatoes in boxes.

Merry Christmas.

Cinnamon Star Bread

2 cups unbleached all-purpose flour 1/2 cup instant mashed potato flakes 1/4 cup Baker's Special Dry Milk or

3/4 cup + 2 to 4 tablespoons lukewarm water, enough to make a soft, smooth dough

1/4 cup (4 tablespoons) unsalted butter, at room temperature

- 1 teaspoon vanilla extract
- 2 teaspoons instant yeast

nonfat dry milk

- 2 tablespoons sugar
- 1 teaspoon salt
- FILLING
- 1 large egg, beaten
- $1/2\ \mathrm{cup}\ \mathrm{sugar}$

 $1\ table spoon\ cinnamon$

First, measure the flour by gently spooning it into a cup, then sweeping off any excess. Next, sift the flour, potato flour, and dry milk through a strainer; this is an important step to prevent lumps in the dough. (If you're using instant mashed potatoes rather than potato flour you can skip this sifting step.)

To make the dough: Combine all of the dough ingredients and mix and knead — by hand, mixer, or bread machine — to make a soft, smooth dough.

Place the dough in a lightly greased bowl, cover, and let it rise for 60 minutes, until it's nearly doubled in bulk.

Divide the dough into four equal pieces. Shape each piece into a ball, cover the balls, and allow them to rest for 15 minutes.

On a lightly greased or floured work surface, roll one piece of dough into a 10" circle. Place the circle on a piece of parchment, brush a thin coat of beaten egg on the surface, then evenly



sprinkle with 1/3 of the cinnamon-sugar, leaving 1/4" of bare dough around the perimeter.

Roll out a second circle the same size as the first, and place it on top of the filling-covered circle. Repeat the layering process — egg, cinnamon sugar, dough circle — leaving the top circle bare.

Place a 2 1/2" to 3" round cutter in the center of the dough circle as a guide. With a bench knife or sharp knife, cut the circle into 16 equal strips, from the cutter to the edge, through all the layers.

Using two hands, pick up two adjacent strips and twist them away from each other twice so that the top side is facing up again. Repeat with the remaining strips of dough so that you end up with eight pairs of strips.

Pinch the pairs of strips together to create a star-like shape with eight points. Remove the cutter.

Transfer the star on the parchment to



Impress your guests - this star shaping technique can be used with other bread recipes, too.

a baking sheet. Cover the star and let it rise until it becomes noticeably puffy, about 45 minutes.

While the star is rising, preheat the oven to $400^{\circ}\mathrm{F}$.

Brush the star with a thin coat of the beaten egg. Bake it for 12 to 15 minutes, until it's nicely golden with dark brown cinnamon streaks; the center should register 200°F on a digital thermometer. Remove the loaf from the oven and allow it to cool for about 10 minutes before serving. Dust with confectioners' sugar

Store any leftover bread, well wrapped in plastic, at room temperature for several days. Freeze for longer storage.

and serve warm or at room temperature.


