Year in Review

New COVID Regulations for the Tishomingo County School District

The Tishomingo County School District Board of Education recently updated its CO-VID-19 protocols. With everchanging CDC guidance, the board is seeking to establish as much normalcy and consistency in the school setting as possible in the midst of the pandemic. "It is a very difficult situation when you are trying to balance sickness in the community as well as learning for students. We have seen the effect the pandemic has had on student learning, and our goal is to preserve the student learning environment as much as possible at this point," stated Superintendent Christie Holly.

The following COVID policy changes as it relates to isolation/quarantine protocols were passed by the TCSD Board on Monday, January 10th.

An individual who is exhibiting COVID-19 symptoms should be tested.

A COVID-positive individual (documented by a medical professional) must isolate for 5

An individual who is being treated as COVID-positive although testing negative (documented by a medical professional) should isolate for 5 days.

After day 5, the individual may return to the school environment if symptoms are improving AND he/she has been fever-free for 24 hours (without

fever-reducing medications).

It is strongly recommended the individual wear a mask for 5 days upon return.

Students who are not actively sick or not showing symptomswill NOT have to quarantine and are expected to come to school daily.

Schools will notify parents if a positive case has occurred in the classroom in which their child is a member. However, unless a student is showing symptoms, he/she will NOT have to quarantine.

Masks are not required at this time in any TCSD school, but are welcome for any individual who wants to wear one. "If parents have questions, we ask they look at our COVID page on our district website or contact their school administration or nurse for more information. We encourage parents to keep their child home if he/ she doesn't feel well and to go get tested for COVID and flu. With both widely present in our community, it is best practice to be proactive with any illness at this time. However, we want to keep kids who are not sick in our schools so they can learn and not get further behind," explained Holly. "Learning loss is a real problem so we need our kids in school now more than

Former MDCPS Worker Sentenced to 8 Years in Prison

A Tishomingo County Resident, Lauren Rose Caveness, was sentenced at the Tishomingo County Courthouse on Wednesday, January 5th 2022, to eight years in prison after she was convicted of exploitation of a minor, sexual battery, and contributing to the delinquency

of a minor. Circuit Court Judge, Kelly Mims handed down the sentence last week. Lauren Caveness, 27, of Tishomingo, was sentenced to 1 year MDOC/ 1 year to serve, and 40 years MDOC/32 years suspended/8 years to serve and 30 years MDOC/22 years suspended/8 years to serve/ 5 years post release supervision.

Caveness was employed by the Mississippi Department of Child Protective Services when she was arrested in 2020 after an extensive investigation. The Tishomingo County Sheriff's Office, along with the MD-CPS Special Investigation Unit and the Mississippi Attorney General's Office, conducted a



months-long investigation into allegations of improper conduct by Caveness.

During the investigation, it was discovered that the now former employee had allegedly been involved in inappropriate situations with juveniles under her care. Cavness was indicted by a Grand Jury on September 23, 2020. Prior to the sentencing last Wednesday, Cavness had been out on a \$70,000 bond.







The Great Resignation and the Hourly Wage

A young adult lady in Johnson county, Kentucky was recently faithfully working her convenient store register job. She had a line of patrons buying drinks and paying for gasoline. Someone asked her how much money she made? "Nine dollars an hour," she said. "I've worked here over two years and the pay has been \$9 an hour. I've asked for a raise. I work hard. I'm here almost all the time. A manager from the chain of stores always says, "We are looking into it." She said, "I have to find another job because I can't take care of myself and my children on \$9 an hour."

A patron in line who was only buying a cup of coffee with a \$20 bill took the cash she had just handed him in change and said to her, "Please take this and buy some lunch today." The lady said, "Uh, no, I don't want that," but the man insisted and she accepted it with tears coming from her eyes. "Thank you, thank you so much she said to the man. I've never had anybody to do anything like this for me in my life.'

It was good to see a random act of kindness but the episode was a real case scenario of how hard life is for many Americans just like this lady, working for low hourly wages.

On January 5th, the US Department of Labor released its Job Openings and Labor Turnover Summary (JOLTS), revealing that the number of resignations reached 4.5 million in November. The number increased by 370,000, matching September's quit rate record high of 3% indicating that the Great Resignation isn't showing signs of stopping.

Will the Johnson County lady quit her Job? She will, if she can find a better paying one. Unfortunately, in this area of the country that's not easy to do. She may have to move in order to make more money. Many employers across the country have had to raise what they are offering in order to find and keep good employees. Thus, many of the Americans who did quit their jobs in November did so because of the lure of better pay in other places.
