TCHS Lady Braves Win 2022 Division 1-4A Regular Season Championship

On Jan. 14th the Lady Braves basketball team traveled to Caledonia for a regular season division game. The Lady Braves took a 31-point lead into halftime and never looked back.

The TCHS Braves also got the win against Caledonia, 58-54.

On Jan. 18th the Lady Braves traveled to Corinth for another regular season 42 division game, and just like in Caledonia, the Lady Braves took a big lead into halftime leading 44-21. They finished the game with a 74-37 win, Madison Bennett had 6-3 pointers on her way to her game high 28 points with Lexi Kennedy adding

The TCHS Braves fell to Corinth 51-61.


On Friday Jan. 21st the Lady Braves welcomed Shannon to town for a big regular season division game which saw the Lady Braves cruise to a 59-point win, 81-22. 13 Lady Braves scored on a night #00 Lexi Kennedy getting 2 of her, game high, 13 points where the starters spent a lot of the game getting to cheer their teammates on. Lexi Kennedy led the scoring with 13 points while Clara Garland added 12 and Reese Moore had 11. At the end of the night, the Lady Braves were 23-0 on the season and 8-0 in regular season division play which clinched the 2022 Division 1-4A championship for the Lady Braves. This is the second year in a row for a regular season championship win for the team.

The TCHS Braves lost a hard-fought game, to Shannon, 57-62.

The Lady Braves have 5 regular season games left, and only 2 home games, one this Friday, Jan. 28th against Caledonia and Feb. 1st against cross county rivals, Belmont, so get out there and support our Lady Braves as they make the push to the playoffs.

The tournament is scheduled for the second week of February.



County, Tennessee along the river means boaters are beginning to putter about, the peach trees at Shiloh are starting to bud, and soon the echoes of cannon firing will be booming.

Yes, April is the anniversary of the pivotal Civil War battle at Shiloh, one of the most critical battles in American history. Some of the biggest figures of the Civil War were there: Grant, Sherman, Johnston, Beauregard, Forrest, Bragg, Buell- all fought there. Grant would write in his memoirs, before Shiloh, Americans on both sides of the Mason Dixon line believed that the war could still be a short affair. This April marks the 160th anniversary of the famous siege and several events are popping up to recognize the historic confrontation. Celebrate with locals, historians, and reenactors in the first weeks of April.

Come experience the battle reenactments near Shiloh National Park staged on the 330-acre grounds hosted by the 1st Division/Southern enactors Association the first weekend in April. These trained volunteers showcase artillery and cavalry demonstrations, living history programs, and real time battle scenarios. Reenactment location is off Joe Dillion Road, Michie, Tennessee.

The same weekend in Savannah, TN on April 2, the Hardin County Convention and Visitors Bureau will host their annual Generals Breakfast at Cherry Mansion. Cherry Mansion came of note during the Civil War when General Ulysses S. Grant made his headquarters at the home during the Battle of Shiloh.

"General US Grant, portrayed by historian Dr. Curt Fields, will be joined at his headquarters by his rival, Confederate General P.G.T. Beauregard, portrayed by historian Larry McCluney, Jr. These first-person living history portrayals are a unique and fun recounting of historical events and famous people, making for some great storytelling!", said Tourism Director Beth Pippin.

Pippin added this event has grown each year over the last ten years and there is a limited number of tickets available sold in advance only. The breakfast is an outside venue under a heated tent enclo-

The day's events continue during the 160th anniversary by offering a visit to the Tennessee River Museum in downtown Savannah, open everyday for tours. "We are celebrating Grant's Bicentennial as he turns 200 years old this April", shared tourism director Pippin, 'again with Dr. Fields portraying Grant on stage at the theater telling stories of his life as a soldier and President." Just northbound of Shiloh and Savannah in the river town of Saltillo, Tennessee on April 8-10 will be the Tennessee River Primitive Art and Weaponry/History Festival. This fun-filled 3-day event is packed full of reenactors of Native American, Mountain Men, French and Indian War, Revolutionary War and Civil War periods.

Hosted by the City of Saltillo at the community center in downtown Saltillo there will be food and art vendors, and reenactor campsites for attendees to enjoy.

Event organizer Mike Fields said "We will have demonstrations many throughout the weekend!! Cannon firings, flint lock musket firings, ancestral drums, stories, wood carvings....not to mention the food!!! Plus many, many vendors and craftsman that will be on site. Make plans to come out and enjoy!!"

"One never gets too old to dream." I'm a good example; Here I am gliding, gracefully, down this beautiful ski-slope in the Swaziland Alps. Long blond hair blowing in the wind, brisk wind biting my cheeks, and with the young ski teacher/ trainer leading me on- a feeling I hoped would never end. Not a care in the world, and I didn't care. It was a care-free fall from the highest peak in the Alps. The next goal was to try mountain climbing. Whoa!

Oops! The trainer turned me loose and I looked down in to a deep ravine, opened my eyes with a start, and Surprise. I looked at the clock? Nine o'clock. "Ruth, where have you been?" I smiled at the thought. "On a dream fairy ski ride with this young trainer in the Switzerland Alps!" I must have been watching TV too much, but as long as I'm skiing? Let it be.

Reality sets in. I had shared yesterday that I have a few snow-storm stories that you might get a few good laughs. Laughs? Laughter is like a dose of medicine. Remember? It is good for us.

World War II had ended and my brother-inlaw, Dorlan Edmondson was home. He and wife jewel had rented a little house on highway 25, just north-east of where the state shed is today. Thinking back seventy plus years ago Chester and I were spending the night with him and Jewel and Carolyn. There was no radio to listen to, no TV, certainly,

but we played rook, made popcorn balls and peanut candy and we had time to

Bedtime came and Chester and I slept in an unsealed room with no heat. Only a wood heater to heat the entire house, but we had plenty of quilts to stay warm. All that night I had felt something touching my face. I'd just rub it off and never really wake up. The next morning on the cross-piece at the head of the bed there were several inches of snow banked up. The wind had blown it through the cracks and the room was cold enough that it didn't thaw and those mists had covered my face and I slept right through it.

The little house has been remolded and a yard faces across the front. I'm sure it has been sealed, insulated and heated through-out today. It is very neat. But I'll always remember the big snow. Pleasant memories.

In the late 40's or early 50's my daddy was very sick. He had spent several days at the Cosby Clinic after surgery. He had come home and it came a big snow that night. There were foods that came from the grocery-store that he had to have. We knew we had to check on him. No telephone. But Chester, his brother, Ray and I loaded into our K-56 International new truck and headed to Dad's and Mom's. They lived just south of Mt. Glory Church. We made it fine until we came to the hill just south of Sidney and Irma Dawson's. The road was covered with fallen and broken

pine trees. We had carried an ax. There was no going around them because there were banks on each side of the road. We three worked up a sweat clearing the road. There were no first responders, wreaker, no cell phones, but a road that needed to be cleared for us to pass through. Work? We did and a few other places too.

This incident reminded me of a poem I'm going to paraphrase.

An elderly man came to an old bridge that needed repair. He began to build a new bridge. A couple of young men came along. "why are you building that bridge? You aren't going to be needing it long?" "Oh, I know but there are many like you who are going to need to come over. I am building this for them."


May we live in such a way that our lives will eliminate the bumps that they otherwise would encounter along the way. If that be the care? We will not have lived in vain.

UDC Met for Christmas Meeting

John Marshall Stone Chapter 394, met at "Lil Smokies" in Iuka for their Christmas/December meeting. We enjoyed our meal and we and talked our Christmas about plans.

We then started our December meeting. We completed UDC rituals and our officers gave their reports. Vicky Durham read a letter from Robert E. Lee to one of his daughters on Christmas day. Our December program was presented by Sharon Hairrell and it was on the topic of "Meet Edward Porter Alxander".

Known as Porter he was born May 26, 1835 and his loving and strict Presbyterian parents. He had nine brothers and sisters. He was a handful growing up. He was full of mischief and was always playing jokes.

As a young boy he developed a strong desire to join West Point and become a soldier. He studied hard and tried several times to gain an appointment. Finally at the age of 18 he got his appointment. The first year did not start out well. Learning life at West Point was hard for him. His mistakes took their toll. He received many demerits. By the end of the term of his second year he moved up to third in his class of 38. He graduated in 1857. He went home on leave for three months and then returned to West Point. He was assigned to Company A Engineers. His duties were supervising his men, drills, and taking care of court-martial duties. He enjoyed teaching but wanted some adventure. He took part in the Utah War. He then returned to West Point awaiting other assignments.

While awaiting new orders he met two Virginia belles, Bettie and Gussie Mason. He immediately was hit by the love bug. Bettie and Porter became engaged. His father did not approve and was very mad that he had talked to him first but Porter would not budge. He was married April 3, 1860. After a 3 month leave they returned to West Point.

His plans changed after arriving at West Point. He was to go to Washington at once. During the one month trip to Washington his wife had the fever and it left her weak.

His new orders were to report to Alcatraz Island. He reported to McPherson and it was there he resigned.

He had made plans to return to Georgia but on the way home he met Leroy Walker, the Confederate Secretary of State. Walker offered him the job of Captain of Engineers and he accepted. He promised to report as soon as he took his wife back to Washington.

From that time on he took part in every major campaign in the Eastern Theater.

Porter was only 30 years old when the war ended. He died in Savannah on April 28, 1910 at the age of 74. He was buried at Magnolia Cemetery in Augusta; His boyhood home still stands in Washington, Georgia.




